MUNICIPAL COUNCIL NOTICES.

Minutes of Proceedings of a Meeting of the Municipal Council of Galle held at the Municipal Office on November 17, 1894, at 3.30 p.m.

Present:—The Chairman (R. W. Ievers, Esq.); R. L. Symes, Esq.; W. Abeyasundera, Esq.; C. P. Hayley, Esq.; Hon. P. D. Anthonisz, C.M.G.; D. G. Goonewardena, Esq.; H. E. H. Hayes, Esq.; Dr. J. Attygalle; N. Dias Abeyasinha, Esq.; and C. L. M. Abdul Carim, Esq.

1. The Minutes of Meeting held on November 3 were confirmed.

2. Pursuant to notice Mr. R. L. Symes asked "Why sundry works sanctioned and ordered to be done have not been commenced? and moved that they be pressed on more energetically."

Seconded by Mr. H. E. H. Hayes.

The Chairman stated that a number of the works referred to are near completion, others are in progress; and explained the reasons why some have not yet been commenced.

3. Pursuant to notice the Hon. Dr. Anthonisz moved "That a steam roller for the use of the Municipal roads be purchased from Messrs. Richardson & Cruddas, of Bombay, and that if the funds of the Municipality are insufficient to incur the expenditure next year, to inquire from Messrs. Richardson & Cruddas whether they would allow the cost to be paid in two or three yearly instalments."

Seconded by Mr. W. Abeyasundera.

Resolved,—That in the opinion of the Council it is desirable that a steam roller be provided.

Resolved,—That inquiry be made from Messrs. Aveling & Porter at what cost they can supply a 10-ton roller landed at Galle.

4. Pursuant to notice the Hon. Dr. Anthonisz moved "That the latrine and scavenging carts be housed and protected from the weather within the walled enclosure in Talbot town, and that the attention of the Municipal Inspector be invited to the insanitary state in which the enclosure is kept at present."

Seconded by Mr. C. L. M. Abdul Carim.—Carried.

5. Pursuant to notice the Hon. Dr. Anthonisz moved "That a shelter for the latrine coolies be built in Talbot town not far from the bathing wells."

Seconded by Mr. C. L. M. Abdul Carim.—Carried.

6. Pursuant to notice Mr. C. P. Hayley moved "That Government be requested to compel the Railway Contractor to construct drains across the railway line running over the Circular road and elsewhere where necessary."

Seconded by Mr. H. E. H. Hayes.—Carried.

Resolved,—That in addition to this the Government be requested to instruct the Resident Engineer to pave the crossings with wood up to the level of the tops of the rails.

7. Submitted a letter from the Atapattu Mudaliyar asking permission to erect a madama in the Victoria park.

Resolved,—That the Council is unable to comply with the request.

8. Submitted a letter from the Provincial Engineer, dated October 23 (24), 1894, No. 189, on improvement of sanitation of Galle Fort.

9. Submitted accounts and reports on progress of work for October, 1894.

10. Submitted Auditor's report for October, 1894.

11. By leave of Council the Hon. Dr. Anthonisz moved "That the Council desires, on the eve of the retirement of the Chairman from office, to record its regret at his removal from a post which he filled with so much advantage to the public, and to express its sense of the obligation under which he has laid the Council by his strict and prompt attention to business. The Council cannot pass unnoticed the uniform kindness and courtesy which they all received at his hands. They would take this opportunity of congratulating him on his well-deserved promotion, and wish him all prosperity in his new sphere of labour."

In making this motion Dr. Anthonisz dwelt on the valuable advice and suggestions the Council received from the Chairman at their meetings, on the services rendered by him in the improvement of the sanitation of the town, and on his labours on the occasion of the opening of the railway to Galle and the reception given to His Excellency the Governor on that occasion—a function the success of which was mainly due to his personal and unremitting attention. Dr. Anthonisz congratulated him at being chosen to fill the important and trusted post as Principal Assistant to His Excellency the Lieutenant-Governor, and wished him higher honours in the future.

Seconded by Mr. W. Abeyesundere.—Carried.

The Chairman replied thanking Dr. Anthonisz and the Council for the very kind manner in which they regarded his work as Chairman, and expressed his regret that owing to his frequent absence from Galle on special duty he had been unable to devote so much of his time to the interests of the Municipality as he desired. He gratefully acknowledged the assistance he had from the Members in discharging his duty; and was very pleased, in saying farewell, that their relations had always been of the most cordial and pleasant character.

(a) Metalled 255½ lines and gravelled 357 lines.

(b) Repaired superficially 1,711 squares of road; trimmed sides 169 lines; cleared side drains 676 lines; and filled ruts and holes in Old Gate road, New Gate road, Ward street, Sea street, Kitulanpittia road, Circular road, and Hirimbure road.

(c) Repaired bridges at Miliduwa, Attoya, Hirimbure cross road, Hume road, Kepu-ela, and Bope; supplied eight iron rails for foot-bridge into Victoria park.

(d) Built two scavenging carts and one smallpox cart.

(e) Repaired two scavenging carts, five water carts, six iron hand-carts, one wooden hand-cart, and one latrine cart.

(f) Repaired slaughter-house, bathing wells, cattle-pound shed, Fort market, Kaluwella latrine, meat market, balcony latrine, betel shed near Old Gate, fish auction shed.

(g) Built a sewer in Pedlar street; cleared side drains; repaired drain in Great Moderbay street; built new side drains in Parava street; repaired side drain in Rampart road.

(h) Repaired esplanade drain; building a groin at the mouth of the Petigala-ela.

(j) Embanking Parana-ela and made a road over the reclaimed ground; used 1,700 cocoanut stakes; cleared Kepu-ela; underpinning canal wall.

(k) Built a cart shed at Cotton Garden, a refreshment shed at Havelock place, and one opposite the Police Court; set broken glass on Park wall; repaired railings near new gate; clearing Fort sewers; built a refreshment shed at Havelock place; formed a carriage stand opposite the railway station; repaired clock tower; painting garden seats.

(l) Repaired and improved Fort market.

(m) Supplied iron gratings to arches over doors and windows; bolts to doors; a screen across the room; and railings to outer verandah.

(n) Repaired sea bathing-place near Eolus Bastion and at Victoria park.

I.—පිහිටීම.

පහත සඳහන්වෙන නිල මෙසින් නියමකරණ ලද්දේය.

- (i.) සෞඛ්‍යසභාවට ලේඛනි හා ගණන්කාර නිලයක්ද.
- (ii.) කුරුස්සන දේවල් පරික්ෂාකර බලන මූලාදාන නිලයක්ද.
- (iii.) පියොන්කාරයෙක්ය.

II.—වැඩ ක්‍රමය.

1. සභාවේ යෝජනාවක්පිට නියෝගකර ආණ්ඩුවේ ගැසට්පත්‍රයේ ප්‍රසිද්ධකරනට යෙදෙන ප්‍රකාර මහලුවේ සෞඛ්‍යසභාව, ලේඛනිතැනගේ කන්තෝරුවේ එක්කෝ වෙනයම් ස්ථානවලදී රැස් වෙතට යෙදෙන්නේ මෙ සභාවේ ඊට ප්‍රථම රැස්වීමකදී විශේෂලෙස වෙනයම් දිනයකට නොහොත් වේලාවකට රැස්වීම වෙනස් නොකලේනම් සෑම මාස්වලම දෙවෙනි හතරවෙනි සෙනසුරුදු දින වලදී පස්වරු 2ටය.

2. සෑහෙන පහසු ස්ථානයක් සපයාගන්නාතුරු ලේඛනිතැනගේ කන්තෝරුව මෙවකට කඩනට දෙසෙන්ගේ මුද්‍රබද්ද අයකරන ස්ථානයේ ධාන්‍ය සැලෙහිය. එහිදී (සභාසම්මුතිය රැස් නොවෙන නිවාඩු දිනවලදී හා සෙනසුරුදු දිනවලදී හැර) සෑමදූම වැඩකරගැනීමට කන්තෝරුව 10යේ පටන් 5 වනතුරු ඇරඹෙනට යෙදේ.

III.—අයදුම්පත්‍ර යතාදිය.

1. සභාවේ යම් සමාජිකයෙක් ඔප්පුකරනට යෙදෙන අයදුම්පත්‍රයක් එක්කෝ වෙනයම් ලිය විල්ලක අඩංගුකරණ සියල්ල අවංකව තිබෙන බවට වගකීම ඔහුපිටය. ලිඛිත නැතැත්තාගේ අනහන හා පදිංචි ස්ථානයන් සඳහන්නොවී තිබෙන අයදුම්පත්‍ර පිලිනොගනු ලැබේ.

2. අයදුම්පත්‍රයක් එක්කෝ වෙනයම් ලියවිල්ලක් ඔප්පුකරනවිට, එහි අදහස ප්‍රකෘතව කියා දිය යුතුයි. එය හරියාකාර සඳහන්කරණලද යම් සමාජිකයෙකුගේ යෝජනාවක්පිට, එකියනලද ලිය විල්ල කියවනටද නැද්ද යනබව ප්‍රශ්නකරනට යෙදේ.

IV.—ප්‍රශ්න සහ යෝජනාවල්.

1. ප්‍රශ්නයක් ඇතිමට එක්කෝ යෝජනාවක් කිරීමට කැමතිවූ යම් සමාජිකයෙක් ඇද්ද ඔහු විසින් (සභාවේ අවසරපිට, යම් කරුණක් ගැණ තරඟ කළාවක් කරණ අතරේදී එක්කෝ අදිස්සි කරුණකදී මිස නැතහොත්) එබඳු ප්‍රශ්නය එක්කෝ යෝජනාව කරනට යෙදෙනබව සභාවේ යම් ප්‍රථම රැස්වීමකදී එක්කෝ ලුහුඹෙන්ම ඔහු විසින් එකී ප්‍රශ්නය විචාරනට නොහොත් එකී යෝජනාව කරනට අදහස්කරගෙන සිටින දිනයට දවස් දෙකකට මත්තෙන් සභාවේ ලේඛමතැනට එබව ලියවිල්ලකින් දැන්වීම යුතුය.

2. එබඳු දැන්වීමක් කරණ සෑම සමාජිකවරු විසින්ම ඒ සමගම ඔහු අභිප්‍රාකර තිබෙන ප්‍රශ්නය එක්කෝ යෝජනාවෙන් පිටපතක් ලේඛමතැනට භාරදිය යුතුයි.

V.—ආඥා සහ පැවැත්වීම් සටහන්කිරීම.

1. ලේකමතැන විසින් ආඥාපොතක් තබාගන එහි එක එක රැස්වීමේදී කළාකර විභාගකල යුතු කරුණු සටහන්කර, එකින්එක පිලිවෙලට ඉලක්කම්කරනට ඕනෑවා සහ ආඥාපොතේ යොදා තිබෙන පිලිවෙල ප්‍රකාර එතනදී පැවැත්වියයුතු කරුණු පිලිවෙලට අඩංගුකරණලද දැන්වීමක් එකී සමමුතිය රැස්වීමට දවස් දෙකකටවත් මත්තෙන් එක එක සමාජිකතැනට භාරදෙන්නට එක්කෝ ඔහු පදිංචි සභාවේ කිබනට ඕනෑය.

2. කාරණ ලුහුඹෙන් සටහන්කිරීමේ පොතය කියනලද පොතක් ඔහු විසින් තබාගන, එහි එක එක සභාරැස්වීමේදී කාරණ සිදුවෙන ආකාර පිලිවෙලට සටහන්කල යුතුයි. තවද ඔහු විසින් දිනෙන්දින නමැති තවත් පොතක් තබාගන එහි සභාවේදී කලක් දේද ආඥා සඳරකල විට පැහැ දිලිලිය සටහන්කලයුතු ඒවා එහි සටහන්කරවනට ඕනෑය. මෙබඳු පොත සෞඛ්‍යසභා ආඥාපණයේ 20 වෙනි ක්‍රමය පිට ප්‍රධානතැන සහ එවකට ඉදිරිපිට සිටින එක සමාජිකයෙක් විසින්ද අනෙක් කර තබාගතයුතු පොත වේ.

I.—சபைஸ்தாபனம்.

சங்கசபையின் உத்தியோகஸ்தர்கள் :—

1. சக்கிடுத்தாரும் கனிதரும்.
2. பட்டண சீர்திருத்தங்களை பரிசோதனைசெய்பவர் அல்லது இன்ஸ்பெக்டர்.
3. சேவுகள் ஒருவன்.

II.—வேலைகளை நடத்தும் முறைமைகள்.

1. மாசாந்தம் இரண்டாம் நாலாம் சனிக்கிழமைகளில் இரண்டு மணிக்கு போட்டில் சக்கிடுத்தாருடைய கந்தோரில் அல்லது சங்கத்தாரினால் நிசமனஞ்செய்து அரசாட்சியாரின் “கலெற்” பத்திரிகையில் பிரசுரித்தப்பட்டதெய. இடத்தில் அல்லது விசேஷமாக அவ்விதமாக நிசமனம் பண்ணும் மறுநாட்களிலும் சங்கம்கூடப்படும்.

2. சக்கிடுத்தாருடைய கந்தோர் அதற்கு உருந்த வசதியான இடமொன்று தெரிந்து கொள்ளப்படும் வரைக்கும் தற்காலம் இரேகு தானியசாலையில் வைக்கப்படும். அவருடைய கந்தோர் ஓய்வுநாட்களிலும் சங்கம்கூடாத சனிக்கிழமைகளிலுந்தவிர மறுநாட்களிலெல்லாம் பத்தமணி துவக்கம் று மணிவரைக்கும் சங்கத்தின் வேலைகளை நடத்திவருபதற்காக திறப்பட்டிருக்கும்.

III.—பெட்டிசங்கள் முதலியன.

1. பெட்டிசங்கள் முதலிய சகல பத்திரங்களையும் சங்கத்திற்கு முன்பதாக கவனிப்புக்கு கொண்டுவரும் சங்கத்தலைவரே அவைகள் சங்கையான விதமாக எழுதப்பட்டிருக்கிற தென்பதைப்பற்றி பொறுப்பாளியாக இருப்பார். பெட்டிசம் எழுதுபவருடைய கையொப்பமும் அவர் இருக்கும் இடமும் போடுபட்டிராத பெட்டிசங்களை ஏர்த்துக்கொள்ளப்படாது.

2. பெட்டிசங்கள் அல்லது மறுவித பத்திரங்கள் கொடுபடும் நேரத்தில் அவைகள் எது காரணத்தைப்பற்றி கொடுபடுகிறதென்பதை சங்ககமாக சங்கத்தாருக்கு விளங்குகொடுக்கவேண்டியது. அதன்பின்னால் அவ்வித பத்திரத்தை சங்கத்தின் முன்பதாக வாசிக்க வேண்டியதோன்ற கேள்விகேட்டுத் தீர்மானப்படுத்தப்படும்.

IV.—கேள்விகளும் மோஷன்களும்.

1. ஏதேனும் ஓர் கேள்விகேட்க அல்லது மோஷன் செய்யப் பிரியப்படும் சங்கத்தலைவர் சங்கம்கூட இரண்டு நாளைக்கேனும் முன்பதாக சங்கத்தின் சக்கித்தாருக்கு எழுத்தில் அவ்வித கேள்வியை அல்லது மோஷனை (motion) அறியக்கொடுக்கவேண்டியது. ஆனால் ஒரு காரணத்தைப்பற்றி தற்ககவணிப்பு பேச்சு நடக்கிற நேரத்தில் அதைப்பற்றி பேசக்கூடும், அல்லது சங்கத்தாருடைய உத்தரவுடனும் பேசலாம்.

2. அவ்விதம் சக்கித்தாருக்கு அறியக் கொடுக்கும் வேளையில் தான்கேட்கும் கேள்வி அல்லது மோஷன் (motion) உடைய கொப்பி ஒன்றும் அவர்வசம் கொடுத்தல் வேண்டும்.

V.—கட்டளைகளும் நடைபெற்றுவருங் காரணங்களை பதிவுசெய்தலும்.

1. சக்கித்தார் ஓடர் பொத்தகம் (Order Book) வைக்கவேண்டியது. அதில் சங்கத்தில் நடைபெறும் சகல காரணங்களும் ஒழுங்கின் பிரமாணமாக இலக்கமிட்டு எழுதிவைக்கப்படும். சங்கம்கூடும் நாளைக்குமுன்பதாகவும் இரண்டு நாளைக்கு முறையாமலும் கூடும் சங்கத்தின் முன்பதாக வணிப்புக்கு கொண்டுவரப்படும் காரணங்களை எழுதி அதைப்பற்றி நொத்திசொன்றை சக்கித்தார் சங்கத்தலைவர் ஒவ்வொருவருக்கும் கொடுக்கவேண்டியது, அல்லது அவர்களுடைய இருப்பிடங்களில் கொடுபடச்செய்தல் வேண்டும்.

2. சக்கித்தார் மின்னிற் பொத்தகம் (Minute Book) வைக்கவேண்டியது. அதில் ஒவ்வொரு சங்கத்தின் கூட்டத்தின் முன்பதாக நடக்கும் காரணங்களை ஒழுங்குமுறைப்படி உடன்கேட்டு பதிதல்வேண்டும். இன்னமும் ஜேர்னல் (Journal) என்னும் ஒரு பொத்தகமும் அவரினால் வைக்கப்படும், அதில் சங்கத்தாரால் பேசி தெரிந்து ஏற்பாடுசெய்துகொள்ளப்படும் சகல காரணங்களும் சரிவர அவரினால் பதிவுசெய்யப்படும். சபையையும் சங்கத்தலைவரில் ஒருவரும் அந்தப் பொத்தகத்தில் கையொப்பமிடப்பட வேண்டியது. லோக்கல்போட்டின் கட்டளைச்சட்டத்தின் 20 ம பிரிவின்கீழ் பேசப்பட்டிருக்கும் பொத்தகம் இதுதான்.

3. சக்கித்தார் இன்னும் முறைப்பாடு பொத்தகம் (Complaint Book) என்னும் ஒன்றும் வைக்கவேண்டியது. இந்தப்பொத்தகம் சங்கம்கூடும்நாள்களில் சங்கத்தாரால் பார்வையிடப்படும், சனிக்கிழமைகள் ஓய்வுநாள் பெருநாட்கள் சங்கம்கூடும் நாட்கள் தவிர மறுநாட்களில் பதினொரு மணிதுவக்கம் மூன்று மணி யளவுக்கும் பட்டணத்தின் குடிசனங்களில் எவரும் அதைப் பார்வையிடப் பிரியமுள்ளவர்களுக்கு காண்பிக்கப்படும். அவ்விதமாக பார்வையிட விரும்புவோர் தனது சரியான பேரையும் விலர்சத்தையும் சக்கித்தாருக்கு கொடுத்து பார்வையிட வேண்டியது.

VI.—பணக்கணக்குகள்.

1. சங்கத்தினுடைய சகல கணக்கு காரணங்களும் சக்கித்தாரால் வைக்கப்படும். காசுப்பொத்தகம் (Cash Book), லெட்டர் (Ledger) பொத்தகம், ஓடர் பொத்தகம் (Order Book) என்னும் மூன்று பொத்தகங்கள் உண்டு. அவைகளில் சங்கத்தின் வரவுசெலவு பணத்தொகைகளை சரிமுறைமையுடன் சக்கித்தாரால் பதிவுசெய்யப்படும்.

2. சங்கத்தின் பணத்தொகைகள் முழுவதும் டிஸ்திரிக்டில் உதவி ஏசன்றரிடத்தில் சங்கத்தின் பேரினால் போட்டுவைக்கப்படும். அத்தொகை பணங்களின் கணக்கு பாஸ பொத்தகம் (Pass Book) என்னும் ஒரு பொத்தகத்தில் பதிவுசெய்து அதிலிருக்கும் கணக்கு சரியென்பதற்கு அத்தாட்சியாக அதற் உதவி ஏசன்றருடைய கையொப்பமும் எடுத்து சங்கம்கூடும் நாள்களில் அப்பொத்தகத்தை சங்கத்தாரால் பார்வையிடும்படி வைக்கவேண்டியது.

3. செலவு பணங்கள் சங்கத்தின் சபை நாயகருடைய உத்தரவின்படிக்கும் அவருடைய ஓடரின் (orders) பிரகாரம் கொடுக்கப்படும். அவ்வித பணங்கள் பெற்றுக்கொள்பவருடைய ற சீத்தும் வாங்கவேண்டியது.

VII.—இன்ஸ்பெக்டர் உத்தியோகத்தரின் கடமைகள்.

1. இன்ஸ்பெக்டர் உத்தியோகம்பெற்றவர் சங்கத்தின் கட்டளைகளுக்கு அமைந்து சங்கத்தின் எல்லைகளுக்கு உட்பட்ட இடங்களுக்குள் சகல காரணங்களுக்கும் பார்வையிடவேண்டியது. கஅளக் க ஆண்டின் எம் நொம்பர் கட்டளைச்சட்டத்தின் சொல்லப்பட்டிருக்கும் தத்துவங்கள் உதவிகள் அவருக்கு கிடைக்கப்படும். சங்கத்தின் எல்லைக்குட்பட்ட இடங்களில் அவர் நடப்பிக்கவேண்டிய விசேஷ கடமைகளாவன :—

3. சாப்பாட்டுக்காக விற்பனவுசெய்யப்படும் எவ்வித சாமான்கள் வஸ்துக்கள் வைத்திருக்கும் கடைகள் சாய்ப்புகள் முதலிய சகல ஸ்தானங்களையும் அவ்விடமிருக்கும் வஸ்துக்களையும் பரிசோதனை செய்தல்வேண்டியதும், இறைச்சி மீன்முதலிய சகலவித மாமிஷங்கள் அல்லது போசனத்துக்கடுத்த எவ்விதசாமான்களையும் விற்பனவுசெய்யுமிடங்களில் அல்லது விற்பனவுக்கு கொண்டுவரும் வளிகளில் அல்லது அவைகளிருக்கிற தோணிகள், வத்தைகள், குல்லாக்கள் முதலிய சகல இடங்களிலும் பரிசோதனைசெய்யவேண்டியதும், அவ்வித பரிசோதனை செய்யும்வேளையில் ஏதும் நாறின, அழுகின, அல்லது வேறேதோ காரணத்தினாலும் போசனத்துக்கு தகாத வஸ்துக்களென அறிந்தால் அவ்வித சாமான்களையும் அதனுடையவரையும் உடனே பொலிஸ் நீதவான்முன்பதாக கொண்டிபோய் ரூயப்பிரமாண ஒழுங்கின்படி பிராதுசெய்து தண்டனைக்கு ளராக்க எத்தனஞ்செய்யவேண்டியதும், இவ்வித துணைச்சட்டங்களின் கீழ்நடத்தும் பிராது காரணங்களினைவற்றையும் உடனே சங்கத்துக்கு நிப்போட்டுச்செய்தல்வேண்டியதும்.

4. தினந்தோறும் தெருக்கள், ஓளுங்கைகள், வெளியிடங்கள், குளிகள், கான்கள், கிணறுகள், மதவுகள், கக்கசுகள், ஊத்தைக் கிடங்குகள் முதலிய சகலவிதமான இடங்களைப் பரிசோதனைப்பண்ணிவர வேண்டியதும், அவ்விதமான இடங்களில் சனசவுக்கிய காரணங்களுக்கு மாறான காரணங்களிருக்கச் சம்பவித்தால் அவற்றைச் சங்கத்துக்கு நிப்போட்டுச்செய்து அவைகளுக்கு சேர்வையான காரணங்களை கட்டளைச்சட்ட ஒழுங்கின்படி முயற்சிசெய்து சீர்திருத்தங்களுக்குத் தகுந்த ஒழுங்குகள்செய்து வரவேண்டியதும்.

5. முறைக்குமுறை மேலே சொல்லப்படும் பிரகாரம் தேள்வையான நோங்களிலும் நாட்சளிலும் விடுகள், கட்டிடங்கள், கோப்புகள், கிணறுகள், குளிகள், கக்கசுகள், ஊத்தைக் குண்டுகள், மதவுகள், கான்கள் முதலிய சகல விதமான இடங்களையும் பரிசோதிக்க வேண்டியதும், அவ்வித பரிசோதனை செய்யும் வேளைகளில் அவ்வித இடங்களுள்ளவர்கள் ஏதேனும் தடங்கல்செய்யுங்காலம் அவ்வித தடங்கல்பற்றி சங்கத்தின் சபைநாயகருக்கு அல்லது அவர் இல்லாத நேரம் சங்கத்தின் தலைவர் ஒருவருக்கு நிப்போட்டுச்செய்தலும் வேண்டியது.

6. நாள்தோறும்செய்யும் பரிசோதனை காரணங்களை சங்கத்துக்கு நிப்போட்டுச் செய்தல்வேண்டியதும்.

7. இன்னும் பிரதானமாக சங்கத்தின் துணைச்சட்டங்களுக்குமாறான ஏதோர் செய்கைகளையும் கஅசுகம் ஆண்டின் எந் நொம்பரைக்கொண்ட கட்டளைச்சட்டத்திற்கு விரோதமான சகல செய்கைகளையும் மாடு ஆடுகளறுக்கும் (Butchers' Ordinance) கட்டளைச்சட்டத்திற்கு விரோதமான செய்கைகளையும், வெடிமருந்து (Gunpowder Ordinance) கட்டளைச்சட்டத்திற்கு விரோதமான செய்கைகளையும், கஅசுகம் ஆண்டின் கூளங்குப்பை (Nuisances Ordinance of 1862) கட்டளைச்சட்டத்திற்கு விரோதமான செய்கைகளையும், இன்னும் சனசவுக்கியத்தின் நிமித்தம் சங்கத்தினால் செய்யவேண்டியிருப்பதாக காணப்படும் ஏதோர் காரணங்களையும் சங்கத்திற்கு நிப்போட்டுச்செய்தல்வேண்டியதும்.

8. சங்கத்தினால் முடிக்கப்படும் ஏதோர் நொத்தீசுகளை அந்தந்த ஆட்களுக்கு கொடுக்கவும் அல்லது கொடுபடச்செய்தலும் அவ்வித ஆட்களில்லாதுபோனால் அப்படிப்பட்ட நொத்தீசுகளை அவர் இருக்குமிடத்தில் அல்லது அவர் வளமையாக வேலைநடத்திவருமிடங்களில் வெளியாங்கமான இடத்தில் அடித்துவைக்க அல்லது பதினாறு வயசுக்குள்படாத அவ்விடமிருக்கும் ஒருவனிடம் கொடுத்து அதைப்பற்றி உடனே சங்கத்துக்கு நிப்போட்டுச்செய்தலும் வேண்டியது.

9. சங்கத்தின் சட்டங்களுக்கு விரோதமான செய்கைகளை செய்வோன் ஒவ்வொருவனுக்கும் சபைநாயகரின் உத்தரவுடன் அல்லது அவர் இல்லாதவேளையில் சங்கத்தலைவர் ஒருவருடைய உத்தரவுடன் பிராதுசெய்து செய்து வளக்கு நடத்தி அதின் சூடிவைப்பற்றி சங்கத்துக்கு நிப்போட்டுச்செய்தல் வேண்டியதும்.

10. தனது உத்தியோக முறைமைகளின்படி அறவுசெய்யும் பணத்தொகைகளை சபைநாயகருக்கு ஒப்புக்கொடுத்து கணக்கு காண்பிக்கவேண்டியதும்.

11. சங்கத்தினால் கட்டளை இடப்படும் சகல விதமான வேலைகளையும் ஒழுங்காக நடத்தவும் அவைகளின்போல் செய்யப்படும் செலவுகளை பொலிஸ் நீதவானுக்கு முன்பதாக நிச்சயப்படுத்தவேண்டியதும், அவ்விதமான செலவுகளை எவ்வசமாக அறவுசெய்கிறதற்காக வழக்கிடுதல்வேண்டியிருந்தால் அப்படிச்செய்து அறவுசெய்தல் வேண்டியதும் அவ்வுத்தியோகத்தரின் கட்டமைகளே.

X.—வேலைகள் நடப்பிக்கும் முறைமைகள்.

1. லோக்கல் போட்டென் னும் சனசவுக்கிய சங்கத்தின் கட்டளைச்சட்டங்களைக் கொண்டு நடப்பிக்கவேண்டியிருக்கும் ஏதோர் வேலைகளையும் சங்கத்தின் சபைநாயகருடைய தத்துவம் பெற்ற எவரே னும் ஞாயமென நேரங்களில் எவ்விதமான இடங்களிலும் வளிகள் பாதைகளிலும் சென்று தேள்வையான தளபாடங்களை அவ்விடம் கொண்டுபோய் செய்யவேண்டியதாக காண்கிற எந்த வேலைகளுஞ்செய்து பாலங்கள், வேலிகள், காண்கள், மதவுகள், அணைகட்டு, வரம்பு முதலியவைகளை கட்ட அல்லது பழுதுபார்க்கவேண்டிய சகல காரணங்களையும் நடப்பிக்கவும்.

2. வளிகள், பாதைகள், ரோட்டுகள் முதலியவைகளை சபைநாயகருடைய தத்துவத்தைக்கொண்டு துறப்பிப்பவர் அல்லது அவற்றைச்சேர்ந்த பாலங்கள், அடைப்புகள், காண்கள், மதவுகள், வரம்புகளைக்கட்டும் வேலைகளில் அவ்வித வேலையினீட்டம் வெட்டுப்படும் மண்ணை அல்லது கூளங் குப்பைகளை அல்லது மறுவிதமான எவ்வித சாமான்களையும் அவ்வித வேலைக்கும் இடங்களுக்கு அருகாமையாக இருக்கும் நிலங்கள்காணிகளில் போட்டுவைக்கலாம், ஆனால் ஞாயமான நாட்களுக்குள்ளாக அவ்விதம் போடுப்பட்டவைகளை சங்கத்தின் கணக்கில் எடுத்து அவ்வித காணி நிலங்களை முன்னிருந்த நிலைபாத்தில் வைக்கவேண்டியது.

3. சங்கத்தின் சபைநாயகரிடம் எழுத்தின்பேரால் தத்துவம்பெற்ற எவரும் திறக்கவேண்டியதாக இருக்கும் வளி ரோட்டுகளுக்கு கிட்பொனமாக இருக்கும் இடங்களில் அவ்வித வேலையை நடத்தும்பொருட்டு அவ்வித வேலைகளை நடப்பிக்குங்காலம்வரைக்கும் தேள்வையான வளிகளைத் துறந்துக்கொள்ளக்கூடும். ஆனால் அவ்விதமான வளிகள், வீடுகள், கட்டுக்கொப்புகள் இருக்குமிடங்களில் அல்லது நிலைபாறமாக அடைபட்டிருக்கும் தோட்டங்கள் முதலிய இடங்களில் துறக்கப்படாது.

4. சங்கத்தின் சபைநாயகரால் எழுத்தின்பேரால் தத்துவம்பெற்ற எவரும் வளிகள், ரோட்டுகள், பாதைகளுக்கு இடைஞ்சலாக வளர்ந்திருக்கும் மரங்கள் செடிகள் பத்தைகளை அல்லது கொப்புக்கள் கொடிகள் முதலியவைகளை வெட்டவும் அவைகளை அருகாமையாயிருக்கும் நிலங்கள் காணிகளில் போட்டிவைக்கலாம். அவ்வித வேலைகளுக்குத் தேள்வையான தளபாடங்களைக்கொண்டு அவ்வித இடங்கள் காணிகளுக்குள்ளென்று அவ்வேலைகளை நடப்பிக்கலாம். ஆனால் அளகு சவுந்தரியம் பொருந்திய அல்லது பிரயோசனமுள்ள மரங்கள் கொடி கொப்புக்களை சபைநாயகரின் விசேஷ உத்தரவில்லாமல் வெட்டப்படாது.

5. சபைநாயகருடைய தத்துவம்பெற்ற எவரும் எவ்வித வளிகள் ரோட்டுகளிலும் தேள்வையான வேலைகளிலும் இடங்களிலும் தேள்வையென்று காணப்படுகிற வேலிகள், அடைப்புகள், காண்கள், குளிகள் அணைவரம்புகள் முதலியவைகளைக் கட்டுவிக்கலாம். அவ்வித காண்கள், வேலிகள், அடைப்புகள் கட்டப்பட்டிருக்கும் இடங்களுக்கு உருத்தாளர் அவைகளைப் பவுத்திரமாகப் பார்வையிட்டு பழுதுபார்த்து வைக்கவேண்டியது.

6. சபைநாயகரிடத்தில் எழுத்தின்பேரில் தத்துவம்பெற்ற எவரும் எவ்விதமான ரோட்டுகள் வளிகளுக்கு அருகாமையாய் இருக்கும் காணிகளில் அவ்வித ரோட்டுகள் வளிகளைச் செப்பிடுபதற்காக தேள்வையென்று காணப்படுகிற எவ்வித காண்களையும் நீரோட்ட வாய்க்காலங்களையும் கட்டவும் துப்பரவுசெய்யவும்கூடும்.

7. மேலேகாணப்பட்டிருக்கும் விதமாக தத்துவம்பெற்ற அதிகாரி அல்லது உத்தியோகத்தார் எவ்வகையான ரோட்டுகள், வளிகளில், அவ்விடம்செய்ய இருக்கும் வேலைகளுக்குத் தேள்வையான சாமான்கள் தளபாடங்களை அந்த ரோட்டு அல்லது வளிகளில் அவ்வேலை நடக்குங்காலங்களில் வைத்திருக்கலாம். ஆனால் அந்த வளிகளி் போக்குவரத்துச்செய்யும் சனங்களுக்கு அவைகளினாலே யாதாமொரு இடைகூறுகள் நேரிடாமல் ஞாயமான முன்னெச்சரிப்புச்செய்து அவ்வித வேலைகளை நடத்திவரவேண்டியது.

8. நீர்கொழும்பு பிரதான பெருவளி (Main street) யும், கவர் ரோட்டுகள் (two branch roads) இரண்டும், கைமல (Kaymal) என்னும் வெட்டாறும் இஞ்சினீர் கந்தோரின் பராமரிப்புக்குள் இருப்பதால்-மேலே சொல்லப்பட்டிருக்குந் துணைச்சட்டங்களின் காணப்பட்டிருக்கும் யாதாமொரு காரணங்களுக்கு அவைகள் உள்பட்டனவையல்ல.

XI.—எல்லைக்குள்ளொற்றிச் செல்லுதலும் மறுவித அடைப்புகள் இடையூறுகளும்.

1. வளிகள், தெருக்கல், ரோட்டுகள் அல்லது எவ்விதமான பாதைகளில் எல்லைகளுக்குள் உள்ளொற்றிச்சென்று ஏதேனுமொரு கட்டிடங்களை அடைப்புகளை அல்லது மறுவிதமான இடையூறுகளை எவரும் செய்திருக்கிறதாக சங்கத்திற்கு தெரியப்படும் வேலைகளில் சங்கத்தின் சக்கிடுத்தாருடைய கையொப்பத்துடன் அவ்விதமான இடங்களுக்கு உரித்துடுவோருக்கு நொத்தீசு அனுப்பி அவ்விடத்துக்கு அவருக்கு இருக்கும் உறுத்தைப்பற்றிய உறுதிகள், ஒப்புதிகள், முதலிய சகல அத்தாட்சி ஒப்பினைப்பத்திரங்களை பத்து நாளைக்குள்ளாக சங்கத்தால் நிசமனஞ்செய்யும் இடத்தில் கொண்டுவந்து தனது உரித்தைக் காண்பிக்கவேண்டியது. அவ்விதமாக நொத்தீசு கிடைத்தபின் பத்து நாளைக்குள் அவ்விதம் செய்யாமலிருந்தால் அல்லது அந்த இடத்

தகு உரித்திடுவோர் ஆர் என்று அறிக்கைஇட்டு அல்லது அவ்விதமான உறுதிகள் எழுத்துக்கள் ஆர்வசம் இருக்குதென்பதை அறிவிக்கவேண்டியது. அவ்விதமான உறுதிகள் எழுத்துக்களைக் காண்பிக்க அல்லது தனது உறுத்தைப்போச முன்பதாக வராமலும், அவ்வித நொத்தீசுக்கு சரிமான உத்தரவு கொடாமலிருக்கும் எவரும் பத்து ரூபாய்க்கு மேற்படாத ஓர் தெண்டத்துக்கு உட்படுவார். சங்கத்தின் உத்தியோகத்தற்கு அல்லது சபைநாயகரின் தத்துவம்பெற்ற எவரும் அவ்விதமான இடங்களுக்குச்சென்று அவ்வித சகல இடங்களையும் அளவுசெய்து அவ்விதமான கட்டிடங்கள் அடைப்புகள் எல்லைக்குள்ளொற்றி கட்டுப்பட்டிருக்கிறதோ என்பதை ஆராய்ந்தறிதல்கூடும்.

2. மேலேசொல்லப்பட்ட விதமான உறுதிகள் ஒப்பனைகளை சங்கத்தால் கட்டளைசெய்கிற இடத்தில் அல்லது அவ்விதமான இடையூறுகள் செய்யப்பட்டதாக காண்கிற இடங்களில் உறுத்தாளி கொண்டுவந்து காண்பிக்கவேண்டியது. அவ்விதமான ஒப்பனைகள் எழுத்துகளைச் சோதனைப்பண்ணிபார்க்க இடங்கொடுக்கப்பிரியப்படாதவர் பத்து ரூபாய்க்கு மேற்படாத ஓர் தெண்டத்துக்கு உட்படுவார்.

3. மேலேசொல்லிய பிரகாரம் ஏதொரு இடையூறுகள், தடைகள் உள்ளொற்றிச்செல்லுதல்கள், எவ்விதமான வளிகள், ரோட்டுகளில் இருப்பதாக சங்கத்தினால் தீர்மானம்பண்ணப்பட்டால் அதைப்பற்றிச் சங்கத்தின் சக்கிடுத்தார் அவ்வித இடங்களுக்கு உறுத்திடுவோனுக்கு நொத்தீசு அனுப்பி அவற்றைப்பற்றி அளவுகாரணஞ்செய்தவற்றை சங்கத்தால் நிசமனம்பண்ணும் இடத்தில்வந்து பார்வையிடவும், அதுமுதல் முப்பது நாளைக்குள்ளாக அவ்விடத்திற்கு அவருக்கு இருக்கும் உறுத்தைப்பற்றிப் பிராதுசெய்யும்படிக்கு அவ்வித நொத்தீசினால் அறிவிக்கவேண்டியது. அவ்விதமாக சொல்லப்பட்ட நாட்களுக்குள் பிராதுசெய்து தனது உரிமையை ஸ்தாபிக்க எத்தனஞ்செய்யாமல் விடுங்காலம், சங்கத்தினுடைய கட்டளையின்பேரில் அவ்விதமான அடைப்புகள் கட்டிடங்களை உடைத்து எடுத்துப்போடப்படும்.

4. பெரிய கரத்தைகளில் அல்லது தனிமாட்டுக்கரத்தைகளில் கூளங்கள், ஊத்தைகள், செங்கல்லு, கழக்கல்லு, கருங்கல்லுகளை அல்லது மறுவித ஏதேனும் சாமான்களை வளிகளுக்கு இடையூறுவாக்கடிய மாதிரியாக அல்லது அவ்வளிகளில் போக்குவரத்துச்செய்பவர்களுக்கு மனவேதனை உண்டிபடக்கூடும் மாதிரியாக சங்கத்தின் எல்லைக்கு உட்பட்ட எவ்விதமான ரோட்டுவளிகளில் கொண்டிபோகச்சம்பவித்தால் அப்படிச்செய்கிறவர் பத்து ரூபாய்க்கு மேற்படாத ஒரு தெண்டத்துக்கு உட்படுவார்.

5. இதன்பின்னால் சொல்லப்படும் மாதிரியான யாதாமொரு காரணத்தையும் எவரும் செய்வது கட்டளைச்சட்டத்திற்கு விரோதமென்பதை அறியவேண்டியது :—

(1) சங்கத்தின் எல்லைக்குட்பட்ட எவ்வித இடங்கள் ரோட்டுகளில் இருபது அடிக்கு மேற்கொண்ட வெட்டுமரங்களை கரத்தைகளில் அதன்பின்னுக்கு வேறொரு கரத்தையில் அதை அணைத்து ஏற்றி பவுத்திராஞ்செய்யாமல் கொண்டிபோகப்படாது.

Minutes of Proceedings of a Meeting of the Municipal Council of Kandy held at the Town Hall on Saturday, November 17, 1894, at 8.30 o'clock a.m.

Present:—Hon. Allanson Bailey, Chairman; H. J. Deslandes, Esq.; J. B. Siebel, Esq.; J. H. Sproule, Esq.; J. N. d'Esterre, Esq.; Edwin Beven, Esq.; Barnes de Alwis, Esq.

- The Minutes of Proceedings of the Meeting held on September 22 last were read and confirmed.
- The following documents were laid on the table:—General Statements of Receipts and Disbursements on account of the Municipal Fund; also separate Statements in respect of the General Revenue, Police Assessment, and Water-rate Accounts from close of 1893 to September 30 and October 31, 1894; Progress Reports of Work done brought up to the same dates; Returns of Work done by the Municipal Magistrate, and of Cases instituted by the several Inspectors during the months of September and October; and also Health Officer's reports.

Resolved,—That the several statements be forwarded to the Colonial Secretary, as required by section 90 of the Ordinance No. 7 of 1887, with the Minutes of Proceedings of this Meeting; and also Health Officer's reports.

3. The Chairman submitted Supplemental Budget No. 4, which had obtained the approval of the Standing Committee, and a copy furnished to each Member as required by section 113.

4. In respect of taxes and water-rate to be levied during 1895, it was resolved that the tax or rate for the maintenance of police and incidental charges for 1895 be fixed at 5 per cent. on the annual value of all houses and buildings of every description, and of all lands and tenements, under section 127 of the Ordinance No. 7 of 1887, and that the sanction of His Excellency the Governor in Executive Council be applied for.

5. Resolved,—That the water-rate for 1895 be fixed at six per cent. under section 5 of the Ordinance No. 18 of 1884.

6. Read the following minute and recommendation of the Standing Committee on the correspondence relating to the excessive consumption of water at the Military Barracks:—

Copy of Resolution No. 4 of September 22, 1894.

“Read letter No. 2539/1 of September 8 from the Deputy Assistant Adjutant-General (b) in reply to the Secretary's letter of August 27, on subject of the excessive consumption of water by the Troops.

“After careful consideration it was resolved that the Deputy Assistant Adjutant-General be informed that the quantity of water shown as consumed was taken from the meter provided by the Royal Engineer's Department, and that it is not likely that the instrument has registered more than passed through the pipes; that when the Council consented to accept Rs. 500 per annum for water supplied it was clearly understood that the quantity to be consumed would be about 1,500,000 gallons per annum. The fact that a meter was provided shows that the supply was not to be absolutely unlimited. If an appreciably larger quantity is required a proportionately larger amount must be annually paid.

“The Council have no objection to the proposal that there should be two meters, and that the quantity used should be checked at each.

“Considering all the circumstances, the Standing Committee recommend that the Council should waive the claim for past excessive consumption, but must insist that in future the implied agreement that the consumption should be about 1,500,000 gallons be adhered to.”

Resolved, unanimously, that the recommendation of the Standing Committee be adopted, viz., that the claim against the Military authorities for excessive consumption of water in the past be waived, and that the Council insist in future that the implied agreement that the consumption should be about 1,500,000 gallons be adhered to, and that if an appreciably larger quantity of water is required a larger sum should be paid.

Resolved,—That attention be invited to the Chairman's letter No. 683 of 28th September to the Deputy Assistant Adjutant-General (b), and he be requested to state whether the Council's terms for a supply of water to the barracks is agreed to.

7. Read letter from Captain A. Caldwell of the Army Service Corps on subject of the future registering of the consumption of water.

The Secretary stated that a 3-inch meter was being fixed on the branch pipe supplying water to the barracks.

Resolved,—That the readings of the Council's meter and that supplied by the Royal Engineer's Department be taken simultaneously at the commencement of each month and a statement submitted.

8. Read letter No. 31 of October 4 from the Colonial Secretary in reply to the Chairman's letter No. 57 of September 28, forwarding a copy of the Council's resolution of September 22 on the subject of the vote passed by the Legislative Council of a sum of Rs. 5,000 “for repairs to and renewal of drains, Trincomalee street,” but of which only Rs. 2,500 will be expended, as the Council have been required to contribute Rs. 2,500 towards the work, leaving therefore Rs. 2,500 unappropriated.

It is stated, in reply, that it will be possible to make available the unexpended balance of Rs. 2,500, the vote for repairs to drains, Trincomalee street, on repairs of other drains along the principal thoroughfares now in charge of the Public Works Department, if all the circumstances of those drains are the same as those of the drains in Trincomalee street.

The Secretary submitted the following list of drains along main thoroughfares requiring improvement on which the unexpended sum referred to might be spent:—

Ward Street.—New side drains on either side in cement concrete, from the Club premises to junction of Market street.

Peradeniya Road.—New side drain in brick or cement concrete, from the junction of Halloluwa road to the junction of the Slaughter-house road and even beyond it, on either side of the road. New side drain at Getambe on either side; the invert of the drains from near the Post Office to junction of the Bihorowekanda road to be plastered in cement on either side.

Malabar Street.—Portions of the side drain required to be built in brick or cement concrete.

Katugastota Road.—The invert of the existing brick drain on the eastern side to be plastered in cement, and a new brick drain in cement concrete on the western side.

Resolved,—That it be pointed out, in reply, that drains along the main thoroughfares, and which are in charge of the Public Works Department as per list furnished, are in want of improvement or reconstruction, and that the Government be asked that the available sum of Rs. 2,500 may be brought forward for expenditure next year.

Resolved,—That the number of licenses being limited to four, be confirmed in accordance with the recorded opinions of Members.
