PROCLAMATIONS BY THE GOVERNOR.

In the Name of Her Majesty VICTORIA, of the United Kingdom of Great Britain and Ireland Queen, Defender of the Faith.

PROCLAMATION.

By His Excellency Sir Arthur Elibank Havelock, Knight Grand Cross of the Most Distinguished Order of Saint Michael and Saint George, Governor and Commander-in-Chief in and over the Island of Ceylon, with the Dependencies thereof.

WHEREAS by the 19th section of "The Forest Ordinances, 1885 and 1892," it is enacted that when the following events have occurred, viz.:—

- (a) The period fixed under section 7 for preferring claims has elapsed, and all claims, if any, made within such period have been disposed of by the Forest Settlement Officer; and
- (b) If such claims have been made, the periods fixed for appealing from the orders passed on such claims have elapsed, and all appeals, if any, presented within such period have been disposed of by the Supreme Court; and
- (c) All lands, if any, to be included in the proposed forest which may be acquired under section 13 have become vested in the Crown—

the Governor shall, by Proclamation to be published in the Government Gazette, specify the limits of the forest which it is intended to reserve, and declare the same to be reserved from a date to be fixed by such Proclamation:

And whereas all things necessary for declaring the forest hereunto mentioned to be a reserved forest have been fulfilled, and all times have elapsed, and it is expedient to specify the limits of such forest:

Now know Ye that We, the said Governor, do by this Our Proclamation declare the forest lots 8,062, 8,079, T $551\frac{1}{2}$, O $552\frac{1}{2}$, W $550\frac{1}{2}$ in preliminary plan 9,265, and lots in preliminary plan 10,049, in extent 962 acres 1 rood 32 perches, called Mitirigala Mukalana; lot 8,078 in preliminary plan 9,265, in extent 197 acres 1 acre 36 perches, called Kalaotuwewa Mukalana; lot 8,059 in preliminary plan 9,265, in extent 104 acres 8 perches, called Pallagalaotuwalanda,—in all 1,263 acres 3 roods 36 perches, more particularly described in the schedule hereto to be a reserved forest as from and after the First day of June, 1895, reserving nevertheless to the public the right of way along the following footpaths within the said forest, and described in preliminary plan 9.265:

- (1) A reservation, 40 ft. wide, along the ancient footpath from Mitirigala to the Three Kóralés, being an old established path leading to Ruwanwella passing east and west through the middle of the forest.
- (2) A reservation, 40 ft. wide, along the footpath to the south of lot 8,079 along the banks of the Kelani-ganga and close to it, between the Mitirigala-oya and Indimaladola.
- (3) A reservation, 40 ft. wide, along the footpath near Mitirigala-oya on the east of the Kolaotuwawa Mukalana, lot 8,078, so far as it passes through this land.
 (4) A three-foot footpath passing through the northern portion of Pallagalaotuwawalanda,
 - lot 8,059, between the gardens called Kahatagahalanda and Watdeniyawatta.
- (5) A three-foot reservation for outlet path leading from the north-west corner of lot X 550 to the boundary of the reserve.

Reserving also to the villagers of Mitirigala the right to use the water of all the streams in the forest shown on preliminary plan 9,265, for the purposes of irrigation only.

Given at Kandy, in the said Island of Ceylon, this Eighteenth day of May, in the year of our Lord One thousand Eight hundred Ninety-five.

THEREAS by section 2 of the Ordinance No. 9 of 1887 it is enacted that it shall be lawful for the Governor, with the advice of the Executive Council, by Proclamation to be for that purpose published in the Government Gazette, to bring any town or towns, whether mentioned in the schedule to the principal Ordinance or not, under the operation of the said Ordinance, and to define the limits of such town or towns respectively for the purposes of the said Ordinance, and such Proclamation to amend, alter, or revoke as and whenever the Governor shall, with the like advice, determine:

And whereas by a Proclamation dated the 27th January, 1895, the town of Kegalla, in the Province of Sabaragamuwa, was brought under the operation of the said Ordinance, and the limits of the said town were, for the purposes of the said Ordinance, defined in such Proclamation:

And whereas it is expedient to amend the said Proclamation of the 27th January, 1895, as respects the limits of the said town of Kégalla, and to re-define the limits of the said town for the

purposes aforesaid:

Now know Ye that We, the said Governor, with the advice of the Executive Council, do hereby amend the Proclamation of the said 27th January, 1895, aforesaid, by altering the limits of the said town as defined therein, and We do hereby define, for the purposes of the said Ordinance, the limits of the said town of Kégalla to be those set out in the schedule hereto as from and after the First day of June, 1895.

Given at Kandy, in the said Island of Ceylon, this Eighteenth day of May, in the year of our Lord One thousand Eight hundred and Ninety-five.

SCHEDULE.

North.—By a straight line from the 7th milepost on the road from Polgahawela to the Kandy road to a point 12 chains north-north-east of the 49th milestone on the Kandy road.

North-East.—From the point 12 chains north-north-east of the 49th milestone on the Kandy road to a point on the bridle road leading from Mipitiya bridge on the Kandy high road to the bridle path leading to Rambukkana,

12 chains along that path from the Mipitiya bridge.

South.—Along the bridle path to the Mipitiya bridge; thence along bridle path to the junction with the Circular road; thence along the Circular road to the junction with the Bulatkohopitiya road; thence across the bridge over the Anguruwela-oya; thence along the Cemetery road to the new cemetery; thence along the southern and western boundaries of the cemetery till it joins the Cemetery road again; thence along the Cemetery road to its junction with the Kandy road; thence along the Kandy road to the junction of the Polgahawela road.
