to bring under scrutiny the widespread convictions referred to above. Such an objective on its own would not have justified this effort however. It was undertaken because it was possible at the same time, as the "Introduction" by the compilers explains, to serve other useful and positive purposes. It will be a useful bibliographical guide, albeit with obvious limitations, to all students and scholars interested in the history, culture, economy and society of Sri Lanka; and will assist discerning reviewers to identify areas of neglect and the terra incognita in the available canvas of knowledge. It will also serve as a catalogue or record of the publications which personnel in the Faculties of Arts and Oriental Studies at Peradeniya have turned out. Broadly assessed, this catalogue will, in my view, reveal that research at Peradeniya has neither been burnt out nor burnt to a frizzle; and that the somnolence which the Peradeniya Campus is commonly accused of is, at best, a part-truth. In brief, the Faculties of Arts and Oriental Studies at Peradeniya have not modelled themselves on Rip Van Winkle. But neither have they functioned as a hothouse of research. There have been several areas of inactivity. The Nation is perhaps entitled to have expected a greater output, and a more incisive and perceptive output; though in this expectation the Nation should not forget the many burdens it has cast on the university personnel and the fact that the Universities in Sri Lanka have always been undergraduate institutions which provided little infra-structural support for post-graduate or postdoctoral programmes.

Though this may be an age of computers, statistics and numbers, it will do violence to my profession if I am to ask readers to treat lists of publications and mere numbers as adequate proof of a good research and writing record. Obviously, conclusions would have to be based on the content of the publications. "Quality," that nebulous and elusive nymph, should be one's goddess. And by what criteria can one assess quality? To reiterate that trite phrase, "socially relevant research," is to beg the question, because it does not define the criteria for assessing relevance. There is no simple answer, of course. Indeed, the very search for quality and for criteria of assessment admits of different interpretations and ideological clashes. This search will in itself be a contribution to knowledge. It is hoped that those readers who delve into this volume and some of the publications listed within its pages will survey the scene with a discriminatory eye. Furthermore, it is hoped that some readers will be activated to challenge some of the interpretations and conclusions that have been presented in published works, or alternatively to extend them into newer, even dizzy heights; and in doing so to support their views with solid bunds and buttresses of empirical data. In this fashion, both with dialectics and with pyramidical building work, we can expand the body of literature on Sri Lanka and push forward the frontiers of knowledge.

Hopefully, the teachers at Peradeniya will continue to be among the pathfinders working at the frontier and the builders consolidating behind them. Peradeniya can then lay claim to being a hothouse in the best sense of

the word. That, it is not ... as yet. Its potentialities have been muffled and constricted by outside forces and by the several passengers it has carried, or carries. Nevertheless, this volume reveals a development which augurs well for the future: since the late 1950's the output of research has increased apace -- even allowing for the expansion in staff. If this speaks relatively well for the younger generations, it was in fact made possible by the selfless labour of the older generations of teachers in the 1940's and 1950's who trained a newer lot for tasks ahead with admirable dedication, much patience and great skill. Whatever be the causal force, this is a heartening trend that needs to be sustained and supported. So, as you leaf through these pages, ye readers, you might consider whether the Arts dons at Peradeniya are turning over a new leaf! and whether they are in the process of creating several academic bonfires destined to service the economic and cultural progress of Sri Lanka and the intellectual joy of this secular world!

## INTRODUCTION

The need for a bibliography of writings by the academic staff of the University of Ceylon, Peradeniya has been recognised for some time. Even within academic circles in Peradeniya itself, the specialised nature of the teaching and research interests of many have left them largely unaware of what their colleagues in other faculties (or even in other departments of the same faculty) were contributing to the general body of knowledge. This is particularly unfortunate in the fields of social sciences and humanities partly because most contributions in these spheres are written in non-technical language and therefore can be read without great difficulty by non-specialists and partly because of the possibilities of inter-disciplinary contact and co-operation possible within these spheres. The rapid expansion of university education and of university faculties in the 1960's made the need for a bibliography even greater. It is hoped that the present work will be a first step towards greater dissemination in the university community of information on work done by fellow-academics.

This bibliography, however, has a wider purpose which is perhaps as important. The concepts relating to and indeed the very approaches to the study of various disciplines are changing fast in the modern world. Opinions and attitudes accepted a decade ago are being challenged successfully today. If the growing educated community of Ceylon and the students who obtained their university training in years past are to make their maximum contribution to the development of their country they should at

least be aware of these trends. This argument is particularly applicable to the fields covered in this bibliography, for members of the faculties of Oriental Studies and Arts have by and large concentrated on problems relating to Ceylon. University research is all the more valuable when it makes an impact on the community and this bibliography should therefore be viewed partly as an effort to make the work of Peradeniya academics more widely known.

An effort to list the publications of University personnel has been made earlier. The Annual Reports to the [University] Council, 1942-1966 and the Annual Reports to the Board of Regents (1966- ) give a list of publications (and proposed publications) of staff members of all faculties of the university. However, these lists are scattered in a number of issues (many of them out of print today) and the last few years have yet to be covered. Moreover, these lists are incomplete even for the years they cover.

When work on the project of listing publications by university personnel was first started, it was proposed to list all the publications of all the teaching staff of the Faculties of Arts and Oriental Studies in all the universities (and university campuses) of Ceylon. However, limitations in both financial and library resources as well as the need to keep the bibliography within a reasonable size for purposes of publication compelled us to confine ourselves to work done by academics at the Peradeniya Campus. Although the first few students and faculty members took up residence in Peradeniya as early as 1949, the date

eventually chosen as the starting point of the bibliography was 1952 in which year the majority of the students and staff of the relevant faculties moved up to Peradeniya from the campus in Colombo. The decision to restrict the bibliography to work done by Peradeniya academics after 1952 meant the exclusion of works published by them before that date and also of those published after they left Peradeniya to join the newly established Vidyodaya and Vidyalandara Universities, the Colombo campus of the University of Ceylon and other universities abroad. Thus the publications listed under the names of a number of dons might well be a fraction of their total academic production.

Other problems arose. Were the writings of temporary assistant lecturers to be included? Many of the lecturers in this grade had been in service at Peradeniya only for a year or two before leaving to take up other appointments. Few of them had time to do any original work and moreover records regarding this category were very scanty and difficult to obtain. Their work was therefore excluded except in cases when they subsequently joined the permanent staff. There was also the question of specialists who had been attached to Peradeniya for short periods for full-time teaching. These, however, were almost invariably members of the faculty during their tenure and their writings were eventually included.

As material for the bibliography was collected we gradually became convinced that a mere comprehensive listing of all publications produced by university dons in the relevant faculties would serve little purpose for it would

have brought together works written at very different levels for distinctly different groups of people. Books written for use in primary and secondary schools and articles in the press for instance though they might conceivably have involved greater efforts and resulted in greater overall benefits than articles written to scholarly journals could not be said to offer much to those who were seeking new perspectives in the study of humanities and social sciences. As important was the question of bulk. Inclusion of all types of material produced by Peradeniya would have at least quadrupled the size of this bibliography and made the task of publishing it well-nigh impossible.

It was therefore decided to limit the bibliography to one of research work. As such all school text-books, articles in student journals and in the newspapers and pamphlets written for popular consumption have been omitted. In the selection of items included were assisted by the advice of many friends and colleagues but of course the final responsibility for the choice lies with the compilers and not with the Ceylon Studies Seminar or any of its members.

The difficulties in collecting and checking the items listed proved considerable, especially as some of the dons could not be reached due to a variety of reasons and a minority of the others failed to respond to repeated requests for information. Furthermore, as the contributions of Peradeniya academics have appeared in journals in many parts of the world and cover a wide range of subjects the absence of an adequate bibliographical tool to help us in

our work was a great disadvantage. Even the fairly comprehensive collection at the University Library, Peradeniya which was used to check entries did not contain some of the key items. In an effort to counter these disadvantages the first typed draft of this bibliography was made available for examination at the University Library, Peradeniya during March - April 1974 and this did prove somewhat rewarding. We have tried to check as many of the entries as possible but especially in the case of unpublished theses and works accepted for publication we have often had to rely on information provided by the authors.

The bibliography of research work is arranged according to subject, the subject classification itself being designed to serve as the best possible guide to the existing literature. Within each subject category all publications -- whether books or periodical articles or unpublished theses are listed under the name of the author. As we have dispensed with added entries and cross references to save space readers interested in a particular field would be well advised to check the sections in related fields to obtain complete coverage.

The three appendices that follow the main bibliography provide lists of books for university reading, translations and creative writing. It may be noted here that in these sections only books are listed so that the very numerous articles written for undergraduate reading, translations of less than book length and the vast number of poems, short stories and the like which have been produced at Peradeniya have all been omitted. We would have

liked to include at least the last of these categories but the material was so scattered and showed such a variety in quality that we were eventually deterred.

In collecting the information contained in this volume we were greatly aided by the enthusiastic co-operation of a large number of academics. In particular mention must be made of that indefatigable don, Michael Roberts who kept us on our toes by constantly asking us how the project was getting along and who gave us much practical assistance and Mr. Y.M. Iqbal of the University Library, Peradeniya whose painstaking investigations uncovered many items of interest and value.


