## DRAFT ORDINANCES.

### MINUTE.

The following Draft of a proposed Ordinance is published  
for general information :—

**An Ordinance to amend "The Marriage Registration  
Ordinance, 1895."**

Preamble.

**W**HEREAS it is expedient to amend the Ordinance No. 2 of 1895, intituled "An Ordinance to consolidate and amend the Laws relating to the registration of Marriages other than the Marriages of Kandyans and Muhammadans," hereinafter referred to as "the principal Ordinance," by repealing section 15 thereof: Be it therefore enacted by the Governor of Ceylon, by and with the advice and consent of the Legislative Council thereof, as follows:

Ordinance to be construed as one with Ordinance No. 2 of 1895.

1 This Ordinance and the principal Ordinance shall be construed and read as one Ordinance, and may be cited collectively as "The Marriage Registration Ordinances, 1895 and 1896."

Repealing clause.

2 Section 15 of the principal Ordinance is hereby repealed.
