## MINUTE.

## The following Draft of a proposed Ordinance is published for general information :—

#### An Ordinance to amend "The Marriage Registration Ordinance, 1895."

Preamble.

WHEREAS it is expedient to amend the Ordinance No. 2 of 1895, intituled "An Ordinance to consolidate and amend the Laws relating to the registration of Marriages other than the Marriages of Kandyans and Muhammadans," hereinafter referred to as "the principal Ordinance," by repealing section 15 thereof: Be it therefore enacted by the Governor of Ceylon, by and with the advice and consent of the Legislative Council thereof, as follows:

1 This Ordinance and the principal Ordinance shall be construed and read as one Ordinance, and may be cited collectively as "The Marriage Registration Ordinances, 1895 and 1896."

2 Section 15 of the principal Ordinance is hereby repealed.

The soil and plantation of Ambagahawatta. Half part of the garden Gontinnagewatta, with the 5. planter's share of the second and third plantations thereof. 6. Seven-tenths part of Dangahawatta alias Mudiyan-segewatta and the tiled house standing thereon.

Claim Rs. 566.75 with interest on Rs. 80 at 12 per cent. per annum from January 1, 1893.
