On and after September 15, 1900, a fixed white dioptric light of the 5th order will be exhibited at Malpe from a rock painted white on Deria Bahadur Ghur Island.

This light will be displayed only from September 15 to May 31 each year, and on its exhibition the present light at Malpe will be discontinued.

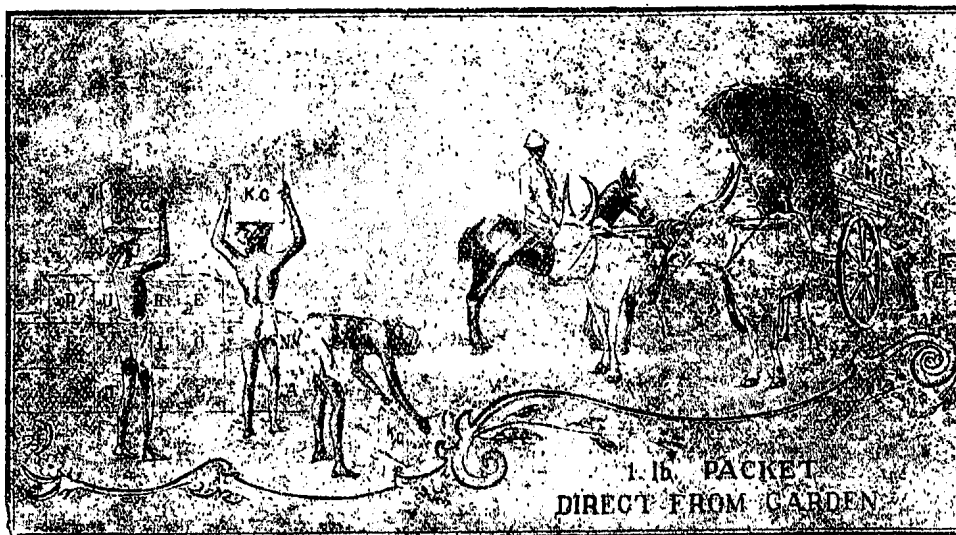
