# PROCLAMATION.

By His Excellency the Right Honourable Sir J. WEST RIDGEWAY, Knight Grand Cross of the Most Distinguished Order of Saint Michael and Saint George, Knight Commander of the Most Honourable Order of the Bath, Knight Commander of the Most Exalted Order of the Star of India, Governor and Commander-in-Chief in over the Island of Ceylon, with the Dependencies thereof.

WEST RIDGEWAY.

WHEREAS by "The Courts Ordinance, 1889," it is amongst other things provided that Criminal 1 Sessions of the Supreme Court shall be holden by one of the Judges thereof, or by a Commissioner of Assize duly appointed under the provisions of the said Ordinance, for each of the Circuits into which the Island is divided for the purposes of the administration of justice, for the hearing, trying, and determining all prosecutions which shall be commenced against any person for or in respect of any crime or offence or alleged crime or offence—

For the Southern Circuit twice at least at Galle and such other places in such Circuit as the Governor, after previous consultation with the Judges, shall appoint; such Sessions commencing at Galle on the 25th day of April and the 15th day of September in every year:

And whereas by the said Ordinance it is also provided that it shall be competent for the Governor for sufficient reasons to him appearing, after previous consultation with the Judges, to alter the dates fixed by the said Ordinance for holding Criminal Sessions of the said Court at any of the places therein mentioned and to fix any other date for the commencement thereof:

And whereas it appears to Us expedient to alter as hereinafter set out the date fixed for holding the Second Criminal Sessions of the Supreme Court at Galle, viz., the 15th day of September :

Now know Ye that We, the said Governor, for sufficient reasons to Us appearing, and after previous consultation with the Judges of the Supreme Court, do hereby direct and appoint that the Sessions of the Supreme Court appointed by the said Ordinance to be holden at Galle on the 15th day of September shall, instead of that date, commence to be holden this year at Galle on Monday, the Fifth day of November.

Given at Nuwara Eliya, in the said Island of Ceylon, this Tenth day of September, in the year of our Lord One thousand Nine hundred.

W HEREAS by section 17 of "The Police Ordinance, 1865," it is amongst other things enacted that whenever the Government Agent shall forward an application of the nature described in sections 15 and 16 of the said Ordinance to Government, together with his report as to the necessity for locating a police force in any district, and as to the number of men to compose such force, and the amount in money required for its upkeep, it shall be lawful for the Governor, with the advice and consent of the Executive Council, by Proclamation in the *Government Gazette*, to establish a police force in such district from such time as shall be therein named, and to introduce therein such of the clauses of the said Ordinance as the Governor and Council shall consider expedient :

And whereas the Government Agent of the Central Province did forward to Government an application of the nature described in sections 15 and 16 of the said Ordinance, together with his report as to the necessity for locating a police force in the district of Yatawatte in the Central Province, and as to the number of men to compose such force, and the amount in money required for its upkeep, as required by the said section 17 of the said Ordinance :

Now know Ye that We, the Governor, with the advice and consent of the Executive Council, do hereby establish a police force in the said district of Yatawatte, in the Central Province, as from and after the First day of October, One thousand Nine hundred, and We do hereby introduce the following clauses of "The Police Ordinance, 1865" in the said district, namely, all the clauses of Ordinance No. 16 of 1865, except 33, 34, 35, 36, 37, 38, 39, 49, 80 and the following up to 97, inclusive.

And the said district shall, for the purposes of the said Police Ordinance, 1865, consist of and comprise all lands and high roads included within the external boundaries of the estates specified in the schedule hereto.

Forms of conditions of sale with lists of taverns can be obtained at any Kachcheri in the Island. Any further information required will be supplied by the Hon. the Government Agent, Western Province, on application made to him either personally or by letter.

Tenderers who cannot speak English and wish to communicate with the Board must bring their own interpreters.

No tender will be considered unless the tenderer is present in person or by his authorized agent at the Council Chamber, and is prepared to deposit forthwith the amount of one month's rent as tendered by him.

Various alterations have been introduced in the new conditions of sale, and intending purchasers are advised to obtain copies before putting in their tenders.

Purchasers of these rents will be allowed to sell arrack at any price not below Rs. 4.50 per gallon. Forms of tender can be obtained free of charge on application personally or by letter to the Government Agent, Colombo.

# By-laws regarding Carriages licensed to ply for Hire within the Limits of the Local Board of Kalutara.

1. The licensed owner shall produce the horse and carriage at the Local Board Office on the first Monday or Tuesday of every month, between the hours of 2 and 3 in the afternoon, for inspection and report by the inspector.

2. The number of persons to be carried in each licensed carriage shall be painted in a conspicuous part on the outside of each carriage, and shall at all times be plainly and distinctly visible and legible.

3. Every carriage shall have and carry two good and sufficient lamps, one on either side of the driver, ready for lighting, and the same shall be lighted if the carriage be used between the hours of 6 r.M. and 5.30 A.M.

4. A table of fares, as fixed by the by-laws, printed on a card or plate, shall be fixed inside some conspicuous part of every carriage plying for hire, and such card or plate shall be left so affixed and legible and undefaced during all the time the carriage shall ply or be used for hire.

5. No carriage which is unsafe, or in bad repair or otherwise unfit for the accommodation and convenience of passengers, shall be used.

6. Every driver shall wear a jacket or coat and shall carry a badge, such badge to be provided by the Assistant Government Agent, and to bear the number of the carriage license.

7. The rates chargeable are those appearing in the Schedule A hereto annexed.

#### Notice of Change of Horse.

8. The owner of any licensed carriage who desires to use a horse other than that described in the license issued in respect of such carriage shall give notice of such change to the Chairman, and forward his license to the Local Board Office for insertion of the description of such horse and send the animal to the Local Board Office for inspection by the person authorized by the Chairman to inspect the same on any day (except Saturdays, Sundays, and holidays) between the hours of 11 A.M. and 3 P.M.

### Owner or Driver of Carriage bound to let the same for Hire.

9. The owner or driver of every licensed carriage shall be bound at all times to let such carriage for hire, whether the same be on a public stand or at the residence of the owner, or at any other place wheresoever, to any person applying for the same, and to carry such person from any one place to any other place on any carriage road within the limits of the Local Board, unless the said carriage shall have been previously engaged, or unless he has some other reasonable cause for refusing. Provided that the proof that there was reasonable cause for refusing shall lie on the person refusing, and that any person so applying for such carriage shall, upon demand being thereto made, immediately or before such carriage is used, tender to the owner or driver the fare authorized by law, and provided further that no owner or driver of any licensed carriage shall be compelled to carry passengers more than ten miles during any period of twelve hours.

## Refusal of Driver to hire after Engagements.

10. After a licensed carriage has been engaged by any person, the owner or driver thereof shall be bound to carry out his engagement, and shall not, after refusing to carry or convey the person by whom the said conveyance was first engaged, thereafter hire the said carriage to another.

Board of Trade (Fisheries and Harbour Department), London, August 24, 1900.

The Board of Trade have received, through the Secretary of State for Foreign Affairs, a copy of a Despatch from Her Majesty's Consul-General for Siam, enclosing the following Quarantine Notice, viz. :--

#### NOTICE.

Whereas bubonic plague has broken out in Hongkong and elsewhere, and it is desirable, as a matter of urgency, to take measures to prevent its spread to this kingdom.

The undersigned, Her Britannic Majesty's Acting Consul-General, under and by virtue of the powers in that behalf conferred upon him by section 84 of Her Majesty's Order in Council, 1889, has ordained that the Quarantine Regulation of September 29, 1899, shall be repealed, and has made in its place the following Regulation for the peace, order, and good government of Her Majesty's subjects being within the dominions of the King of Siam :--

#### **Regulation**:

1. The Island of Koh Phai shall be and is hereby declared the Quarantine and Inspection Station for the purpose of the present Regulation.

Any vessel which, having cleared from Hongkong, Hainan, or Manila, arrives in Siamese waters on or after the date of the present Regulation, shall call at the said station and shall, before receiving pratique, stay there until a period of nine full days shall have elapsed from the time of her leaving Honkong, or until released by the Health Officer.
 Any vessel which, having cleared from any Chinese port. arrives in Siamese waters on or

3. Any vessel which, having cleared from any Chinese port, arrives in Siamese waters on or after the date of the present Regulation, shall call at the said station, and shall stay there until such time as the Health Officer shall have boarded her and given her pratique.

4. No person, other than the Health Officer or one of his assistants, shall communicate from any ship coming from Hongkong, Manila, or any Chinese port, with the land, or from the land with such ship, or from such ship with other ships, or from other ships with such ship, before she has received pratique.

5. The Master or other persons having the control of any vessel in quarantine shall give the Health Officer such information about the vessel and the voyage and the health of the crew and passengers and otherwise as the Health Officer may require, and shall answer fully and truly questions put to him by the Health Officer, and shall, if required by the Health Officer, furnish the necessary boats and appliances for the landing of the passengers or crew at the quarantine station, and shall, in a general way, give the Health Officer all necessary assistance to enable him to grant pratique to the vessel.

6. The Health Officer may board any vessel arriving in Siamese waters and inspect every person in the vessel. He may, if he thinks necessary, call for inspection of the ship's bills of health, emigration papers, or other documents which he may require to enable him to grant pratique, and he shall use every lawful means which to him may seem expedient for ascertaining the sanitary condition of the vessel and persons therein.

7. No customs officer on duty at Koh-Si-Chang or at Paknam shall allow any ship coming from Hongkong, Manila, or any Chinese port, either to lighten at Koh-Si-Chang or to proceed to Bangkok without producing the certificate of health delivered at Koh Phai, but all said ships which shall produce such certificates shall be at liberty to lighten at Koh-Si-Chang and to proceed to Bangkok or elsewhere without any further examination.

8. The Health Officer shall be and is hereby empowered to deal with all infected vessels and persons as he may think proper to prevent the spreading of the disease.

9. Any and all persons committing a breach of the present Regulation or assisting in any way in the commission of such breach, and the Master, Captain, or other person having the control of any vessel or boat, on board of which such breach has been committed, or which has been in any way engaged in the commission of such breach, shall be severally liable to a fine not exceeding one hundred pounds, or to imprisonment not exceeding three months, or to both such punishments.

10. Any cost incurred by the Government, in the maintenance of any person removed to the quarantine station at Koh Phai, shall be repaid by the agents of the vessel.

Law respecting the Commercial Relations with the British Empire, of June 30, 1900.

Translation.

We, William, by the grace of God, German Emperor, King of Prussia, decree in the name of the Empire, with the assent of the Federal Council and the Imperial Diet, for the period after July 30, 1900, what follows :---

The Federal Council is empowered to grant to the subjects and products of the United Kingdom of Great Britain and Ireland as also to the subjects and products of British Colonies and Foreign Possessions, until July 30, 1901, the same advantages as are accorded by the Empire to the subjects and products of the most-favoured nation.

SIR,-WITH reference to your despatch No. 453 (Miscellaneous) of the 21st November last, signifying the willingness of your Government to adhere to the Convention for the renewal of the Commercial Treaty of 1885 between the United Kingdom and Uruguay, a copy of which was enclosed in my circular despatch of the 27th of September, 1899, I have the honour to inform you that on the 9th June last the ratifications of the Convention for the prolongation of the Treaty were exchanged by Her Majesty's Minister at Monte Video with the Minister for Foreign Affairs of the Uruguayan Republic on behalf of the High Contracting parties.

I have further to inform you that the Uruguayan Minister for Foreign Affairs has acknowledged the receipt of the notification of the British Minister respecting the adhesion of the Colony under your Government.
