Japan-Kiusiu-Genkai nada-Non-existence of Rock.

With reference to Notice to Mariners No. 236, dated With reference to Notice to Mariners No. 236, dated November 7 last, issued by this office, the British Admiralty has given further notice (No. 691 of 1898) that the rock reported to lie about 5 miles north-eastward of Yebosi has been unsuccessfully searched for. The position and surrounding area for about a mile were closely sounded and a look-out kept at the masthead without any indication of shoal water being observed. The local fishermen also state that no rock exists here. The local fishermen also state that no rock exists hereabouts, though a tide race having the appearance of broken water is sometimes seen northward of Yebosi.
