IN terms of section 8 of the Ordinance No. 5 of 1899, I hereby give notice that the licenses for the sale by retail of opium within the limits of the Municipality of Colombo for the year commencing January 1, 1900, will be four in number. The said licenses will be put up to sale by public auction at this office at noon on Monday, November 20, 1899, and they will be issued in accordance with the provisions of the said Ordinance, and on the following conditions :---

That the licensee shall cause to be painted or affixed in some conspicuous part of his shop his name, the number of the shop, and the words "Licensed to sell Opium by Retail."
That no person other than the licensee shall sell or expose for sale any opium under his license, either as a state of the history of

agent or servant of such licensee, unless the name of such agent or servant be registered in the office of the Municipal Council with the sanction of the Chairman.

3. Wholesale licenses will be issued only to retail dealers.

That no opium shall be sold between the hours of 8 at night and 6 in the morning.

2. That the place licensed shall be subject to inspection, and that no disorderly conduct be permitted therein.

3. That the place licensed be always kept clean.

That the place licensed have no internal communication with other rooms or passages, and that the interior 4. thereof be open to public view. 5.

That the quantity to be sold at any one time to any individual, except to a licensed retail vendor, shall not exceed 180 grains.

That no opium be sold to any individual apparently under the age of 15 years. 6.

That opium shall not be consumed on the premises. That opium offered for sale shall not be adulterated or deteriorated in any way. 8. 9.

That wearing apparel or other goods shall not be received in barter for opium.

10. That the licensee shall affix in some conspicuous place of his shop a board with his name, the number of the shop, and the words "Licensed to Sell Opium by Retail" painted on it. 11. That no person other than the licensee shall sell or expose for sale any opium under his license, either as agent or servant of the licensee, unless the name of such agent or servant be first registered in the Municipal Office. 12. That daily accounts shall be kept in a form to be prescribed by the Chairman, Municipal Council, Galle,
