In the Name of Her Majesty VICTORIA, of the United Kingdom of Great Britain and Ireland, Queen, Defender of the Faith.

PROCLAMATION.

By His Excellency Sir EDWARD NOEL WALKER, Knight Commander of the Most Distinguished Order of Saint Michael and Saint George, Lieutenant-Governor in and over the Island of Ceylon, with the Dependencies thereof.

E. NOEL WALKER.

HEREAS by the 19th section of the Forest Ordinance, No. 10 of 1885, as amended by the 6th section of Ordinance No. 1 of 1892, it is enacted that whenever the following events have occurred, viz.:-

- (a) The period fixed under section 7 of the said Forest Ordinance, No. 10 of 1885, for preferring claims has elapsed, and all claims (if any) made within such period have been disposed of by the Forest Settlement Officer; and
- (b) If such claims have been made, the period fixed for appealing from the orders passed on such claims have elapsed, and all appeals (if any) presented within such period have been disposed of by the Supreme Court; and
 (c) All lands (if any) to be included in the proposed forest which may be acquired under

section 13 of the last-mentioned Ordinance have become vested in the Crown-

the Governor shall, by Proclamation to be published in the Government Gazette, specify the limits of the forest which it is intended to reserve, and declare the same to be reserved from a date fixed by such Proclamation:

And whereas all things necessary for declaring the forest hereunder mentioned to be a reserved forest have been fulfilled, and all times hereinbefore recited have elapsed, and it is expedient to specify the limits of such forest:

Now know all Men that We, the said Governor, do by this Our Proclamation proclaim the forest, the limits of which are set forth in the schedule hereto subjoined, to be a reserved forest as from and after the First day of August, 1899, reserving, nevertheless, to the public the following right of way:—The footpath running across lot 458 and between lots 457 and 459 in preliminary plan No. 228.

And We do hereby further specify the limits of the said reserved forest to be those set forth in the said schedule.

Given at Colombo, in the said Island of Ceylon, this Twenty-ninth day of June, in the year of our Lord One thousand Eight hundred and Ninety-nine.

SIR,—I HAVE the honour to inform you that Her Majesty will not be advised to exercise her powers of disallowance in respect of Ordinance No. 15 of 1898 of the Legislature of Ceylon, entitled "An Ordinance for consolidating and amending the Procedure of the Courts of Criminal Judicature," a transcript of which accompanied your despatch No. 397 of the 23rd November last.

2. I have learnt with satisfaction that this valuable piece of legislation has been added to the Statute Book of Ceylon, and I would ask you to express to the Attorney-General and his colleagues on the Sub-Committee of the Legislative Council my appreciation of their labours in connection with it.

Assize of Bread and Regulation of Bakeries.

- 1. Walls to be plastered. Floor cemented, and Drainage provided.—The walls of every bakery shall be plastered with chunam and whitewashed, the floor cemented, and drainage sufficiently provided.
- 2. No Bakery to be within 30 ft. of a Cesspit or Latrine.—No bakery shall be within 30 ft. of any cesspit or latrine, nor in a position where bad odours wafted therefrom shall reach it.
- 3. No Bakery to be used for other purpose. No place used as a bakery shall be used for any other purpose whatsoever.
 - 4. Utensils to be kept clean.—All utensils and other furniture shall be kept clean.
- 5. Materi Is used to be wholesome.—The flour, water, and other materials used in the manufacture of bread shall be good and wholesome.
- 6. Removal of Refuse and flushing of Drains.—All refuse and dirt in and about the premises shall be swept off and the drains well flushed.
- 7. Persons uffering from loath one or contagious disease not to be employed in Bakery. No person suffering from a contagious or loathsome disease, or who has recently been in attendance on such person, or who is unwashed or otherwise unclean, shall be employed in a bakery.

Tenders should be submitted in duplicate, the original being forwarded to the Principal Civil Medical Officer and the duplicate direct to the Hon. the Auditor-General, both being required to be forwarded at the same time.

3. The tenders are to be made upon forms which will be supplied upon application to the Principal Civil Medical Officer and Inspector-General of Hospitals, and no tender will be considered unless it is furnished on the recognized form, and the tender and the schedules attached thereto, each signed in the presence of two respectable witnesses. Each tender should be for provi-

sioning one hospital only.

4. Every tenderer will be required to make a deposit (on applying for forms) of Rs. 500; and should any person decline to enter into the contract and bond after he has tendered, or fail to furnish approved security, such deposit will be forfeited to the Crown. All other deposits will be returned after the contract has been signed. The deposit must be made at the Treasury or Kachcheri, and the deposit receipt must be produced to the officer issuing the form as his authority for making the issue.

5. Provisions should be of the best quality, approvable

by the Medical Officer of the hospital.

6. When required, samples must be deposited.
7. The successful tenderers will be required to give cash security as given opposite the name of each station and to sign the bond given in the tender for the due fulfilment of each contract within a fortnight from date of notification of acceptance of the tenders. The amount deposited for tender forms will form part of the cash security, which will be deposited in the Colombo Kachcheri to credit of the Hon. the Treasurer. Those contractors who are required to furnish security to the extent of Rs. 500 and over may have their securities lodged in fixed deposits, if they so desire, in any one of the local banks, which they must elect, the deposit being in the name of the Hon. the Treasurer. It is left to the option of the successful tenderer to substitute at any time thereafter for cash deposited by him approved title deeds and to enter into a fresh security bond at his expense.

8. In case any person makes any alterations in his tender before forwarding it, such alteration should invariably bear his initials, otherwise the tender will be

treated as informal and rejected.

9. Any further information can be obtained on application to the Principal Civil Medical Officer and Inspector-

General of Hospitals.

10. The Government reserves to itself the right, without question, of rejecting any or all tenders, and the right of accepting any portion of a tender.
