## **NOTICES UNDER THE WASTE LANDS ORDINANCES.**

[Notice under Ordinances No. 1 of 1897 and No. 1 of 1899.]

**T**AKE notice, that unless within three months from the 31st day of March, 1900, the persons, if any, who claim any interest in the lands hereinafter mentioned or in any one or more of such lands, appear before me at the Kegalla Kachcheri and make claim to the said lands or any of them or to some interest therein :

I, Bertram Hill, Assistant Government Agent for the District of Kegalla, in the Province of Sabaragamuwa, in pursuance of the powers in me vested by Ordinances No. 1 of 1897 and No. 1 of 1899, shall declare by writing under my hand that the said lands or such of them, to which no claim has been made, are the property of the Crown.

*Description of Lands referred to.*

The following lots, both situated in the village Tilijagoda in Kanduaha patti of Paranakuru korale, in the Kegalla District, as described in the annexed plan:—

1. Lot 1,348 on preliminary plan 519 called Karawattahenamukalana and Hangurumalamukalana, in extent 32 acres and 37 perches; and bounded on the north by a portion of Kahatennehena, and the village boundary of Tiyambarahena village; on the east by Pokunugalawatta, land described on title plan 183,476 called Hangarumalamukalana, Wandurumeeyehena, Pannambemulahena, and Migahamulahena *alias* Morawillehena and Paranawatta; on the south by Balawakotuwehena (reservation) and Hanganmalehena ( $\frac{P.P.519}{1,350}$ ) and a portion of Wallagahahena (reservation); on the west by Wallagahahena (reservation), Kahatennehena, Galakotuwehena, and Hara-attehena, and the village boundary of Tiyambarahena village.

2. Lot 1,350 on preliminary plan 519 called Hanganemalahena, in extent 2 rods and 18 perches; and bounded on the north by Karawattahenamukalana and Hangarumalamukalana (<sup>P. P. 519</sup><sub>1,348</sub>); on the east by Balawakotuwehena (reservation); on the south by Gurugoda-oya; on the west by Wallagahahena (reservation).


