## **NOTICES UNDER THE WASTE LANDS ORDINANCES.**

[Notice under Ordinances No. 1 of 1897 and No. 1 of 1899.]

**T**AKE notice, that unless within three months from the 30th day of November, 1899, the persons, if any, who claim any interest in the lands hereinafter mentioned or in any one or more of such lands, appear before me at the Kegalla Kachcheri and make claim to the said lands or any of them or to some interest therein:

Lot 3,765 on preliminary plan No. 7,655, called Nawinnemukalana, situate in the village Deldeniya in Deyaladahamuna patty of Kinigoda korale, in the Kegalla District, containing in extent 26 acres and 1 rood, as described in the annexed plan, and bounded as follows : on the north by Nawinne-ela ; on the east by Talagahayaye-ela, Muruttetennekumbura claimed by M. Dingiri Etana, Hurugewatta claimed by Puncha, Aswedduwa, Muruttennekumbura claimed by Hunugedara Puncha, and a water-course ; on the south by Hanukotuwatenne-ela ; on the west by korale boundary of Beligal korale and the temple land appearing on title plan No. 67,212.


