### NOTICES UNDER THE WASTE LANDS ORDINANCES.

[Notice under Ordinances No. 1 of 1897 and No. 1 of 1899.]

**T**AKE notice, that unless within three months from the 19th day of May, 1900, the persons, if any, who claim any interest in the lands hereinafter mentioned or in any one or more of such lands, appear before me at the Kegalla Kachcheri and make claim to the said lands or any of them or to some interest therein :

I, Bertram Hill, Assistant Government Agent for the District of Kegalla, in the Province of Sabaragamuwa, in pursuance of the powers in me vested by Ordinances No. 1 of 1897 and No. 1 of 1899, shall declare by writing under my hand that the said lands or such of them, to which no claim has been made, are the property of the Crown.

#### Description of Lands referred to.

The following lots, all situated in the village Kotagama in Medmededaliya patti of Kinigoda korale, in the Kegalla District, as described in the annexed plan :—

Lots 2,052 and 2,053 on preliminary plan 675, called Dodankotuganmaimehena, aggregating in extent 1 acre 1 rood and 5 perches ; and bounded on the north by Eriyagollehena ; on the east by the village boundary of Kiriwandeniya and Batahirapola mukalana ; on the south by land described on T. P. 177,892 called Dodankotuganmaimehena ; on the west by a reservation and a portion of Eriyagollehena.

2. Lots 2,054, 2,055, J 86, 2,056, 2,057, and 2,058, called Dodankotuganmaimehena, aggregating in extent 42 acres 3 roods and 27 perches ; and bounded on the north by land described on T. P. 177,892 called Dodankotuganmaimehena ; on the east by the village boundary of Kiriwandeniya, Batahirapola mukalana, Batahirapolahena, Batahirapola mukalana, and Batahirapolahena ; on the south by Dodankoheshena ; on the west by Dodankohela, the Crown land called Munamalgahamulahinna-mukalana, Pinunwaleaswedduma, Pinunwalahena, a reservation, a ditch, and Radadeniyawatta.

[N.B.—Land described on T. P. 177,893 called Dodankotuganmaimehena, included within the aforesaid boundaries, is excluded from this notice.]


3. Lot 2,212 on P. P. 770, called Ettarigalpottahena, in extent 3 acres and 35 perches ; and bounded on the north by Malandeniya malakadahena ; on the east by Etterigalpottehena ; on the south by Maha-oya ; on the west by Kumburapillewa and Oyagawamadinagekumbura.

4. Lot 2,315 on P. P. 807, called Hapuambikandehena, in extent 1 acre 2 roods and 26 perches ; and bounded on the north by a portion of Hapuambewatta and Damolokeshena ; on the east by a portion of Demanhandyakanda ; on the south by Demanhandyakanda, Crown land called Riddihenkandemukalana and the village boundary of Todagama village ; on the west by Hapuambewatta.
