Walapane.—Paddy : harvesting, with good results. No work on chenas. There were three rainy days during the month. There was a fair supply of fruits and vegetables. Health of population : chickenpox was prevailing during the month. Health of cattle : hoof-and-mouth disease prevailed in some villages.

Uda Hewaheta.—Paddy harvesting ; good result expected. No work on chenas. Health of population : satisfactory. Health of cattle : murrain and hoof-and-mouth disease prevailed in some villages.

NORTHERN PROVINCE.

JAFFNA DISTRICT.

Rainfall : nil. As registered at the Public Works Department Office, Jaffna.

Weather : there was no rain during the month. The south-west monsoon was blowing hard.

Paddy cultivation : ploughing and manuring carried on.

Dry grain cultivation : thinaï, sami, and kurakkan are in plants, and the prospects are fair.

Tobacco cultivation : the crop has been fully harvested and cured. An increased demand in Travancore for the Jaffna tobacco has increased the price locally. The inferior kinds are being purchased and sent to Colombo, Kandy, and Galle in the Island.

Health of people : good, with the exception of a few cases of fever.

Health of cattle : good.

Prices of staple articles : rice, Rs. 3.50 per bushel ; paddy, Re. 1.50 per bushel ; payaru, Rs. 3.75 per bushel ; kurakkan, Re. 1.36 per bushel ; samy, Rs. 1.25 per bushel.

MANNAR DISTRICT.

Weather : wind from south-west. Excepting a slight drizzling on the 5th, there was no rain.

Agriculture : sirupokam cultivation in plant ; kalapokam paddy stacks being threshed.

Health of people : fever prevailing

Health of cattle : satisfactory.

Prices of grain : rice, Rs. 4.25 per bushel ; paddy, Re. 1.25 per bushel.

PROVINCE OF SABARAGAMUWA.

RATNAPURA DISTRICT.

Paddy : the yala crops in Kuruwiti korale are in ear. In Nawadun and Atakalan korales they are from two to three months old. In Kolonna, Kadawata, and Meda korales they are still young. In Kukulukorale the crops are full grown ; prospect are favourable.

The maha crops in Kolonna korale are approaching maturity. In Kuruwiti, Nawadun, and Atakalan korales the fields for maha harvest are being prepared for cultivation. Owing to rinderpest in Nawadun korale the inability to procure cattle for ploughing purpose is likely to result in the abandonment of some fields.

Fine grain : in Kuruwiti, Nawadun, and Atakalan korales chenas are being prepared and sown for the maha harvest. In Nawadun korale yala crop is two months old. In Kolonna korale tana chenas are getting ripe and in blossom. In Kukulukorale el-wi and fine grain crops are full grown. In Kuruwiti korale crops on owiti are young ; prospects are favourable.

The health of the people in general is satisfactory ; fever prevails in Kuruwiti korale to some extent.

Cattle murrain prevails in some villages of Kuruwiti and Nawadun korales, but is decreasing. Hoof-and-mouth disease has appeared in Kumburugamuwa and Kolonna in the Kolonna korale.

KEGALLA DISTRICT.

Paddy : yala fields have been sown. Fields are being ploughed for maha cultivation.

Dry grain : chenas are being prepared for sowing hill paddy and kurakkan, but the present weather interferes with the progress of work.

Prices : paddy, Re. 1.50 per bushel ; hill paddy, Re. 1.25 per bushel ; kurakkan, Re. 1 to Re. 1.25 per bushel ; amu, 75 cents per bushel.

Cattle disease : murrain is still prevailing at Malawita and Mideniya villages in Paranakuru korale. It has also broken out at Hapuwita, a village adjoining Mideniya. Fifty-six cases were reported from these villages during the month, out of which thirty-seven proved fatal, one recovered, and eighteen are under treatment. No fresh cases have been reported from Tolangomuwa in Beligal korale since the 14th. Four cases occurred there during the month, all of which proved fatal. Undugoda in Paranakuru korale is now free from the disease. Every precaution is being taken to prevent the spread of the disease.

Health of people : fever prevails throughout the district ; it is reported to be on the decrease in Three Korales and Lower Bulatgama ; fever powders are being distributed. Two cases of chickenpox were reported from Parusella in Atulugam korale.

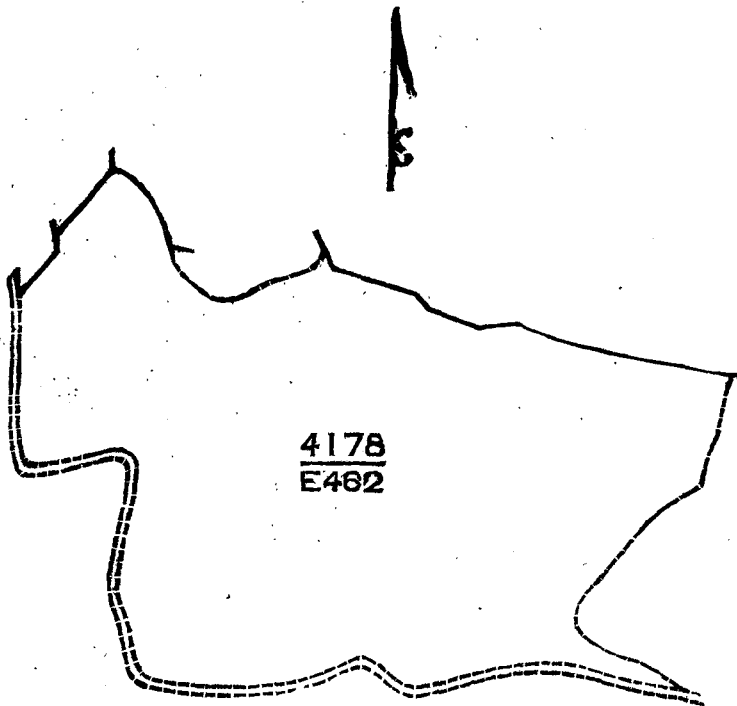
