Ceylon Medical College.

JUNIOR DEPARTMENT.

PRELIMINARY EXAMINATION for candidates A desiring admission into the Junior Department of the Ceylon Medical College will be held on August 28 and 29, at the College and at the offices of the Colonial Surgeons in Jaffna, Galle, Kandy, Badulla, and Batticaloa, at 9 A.M. each day.

The subjects will be as follows:-

- (a) English Language, including Reading, Dictation, Grammar, and Composition.
- (b) Arithmetic, up to and inclusive of Decimal Fractions.
