GREETING.

WHEREAS Charles Alphonse Lienard Von Lynar, of Batticaloa, has under the provisions of "The Naturalization Ordinance, 1890," applied to Us, Sir Edward Noel Walker, Knight Commander of the Most Distinguished Order of Saint Michael and Saint George, Lieutenant-Jovernor of Ceylon, in Our Executive Council, that the privileges of naturalization may, in terms of the said Ordinance, be conferred on the said Charles Alphonse Lienard Von Lynar, and We n Executive Council, acting in pursuance of the powers in Us vested by section 3 of the said Ordinance, have made an Order bearing date the Fifteenth day of August, One thousand Eight fundred and Ninety-nine, granting such application:

And whereas the said Charles Alphonse Lienard Von Lynar has taken the oath of illegiance prescribed by section 4 of the said Ordinance, and has produced to Us a certificate of his having taken and subscribed such oath and of the date of his taking and subscribing the same, and We are satisfied that the said Charles Alphonse Lienard Von Lynar has taken the prescribed oath within the period specified in the said section of the said Ordinance:

Now know Ye that We do hereby grant to the said Charles Alphonse Lienard Von Lynar all the rights and privileges of a British subject, and declare that the said Charles Alphonse Lienard Von Lynar shall, within the limits of this Colony, be entitled to all political and other rights, powers, and privileges, and be subject to all obligations to which a natural-born British subject is entitled or subject.

Time and Place of Meeting and Order to be observed thereat.

- 1. The ordinary meetings of the Board shall be held on such days and at such time and place as the Board shall from time to time by resolution determine, provided that it shall be lawful for the Board to adjourn any meeting to any other day or hour. resolution determining the time and place of the ordinary meetings shall be published for general information in the Government Gazette, and a copy thereof affixed at the office of the Board
- 2. For all purposes connected with the Board at its meetings the precedence and seniority of the members shall be regulated as follows:-

) The ex-officio Chairman.

- (b) The members appointed by the Governor, in the order in which they have been gazetted.
- (c) The elected members, in the order of the priority of their elections.
- 3. The Chairman shall preserve order and decide on all disputed points of order.
- 4. As soon after the hour appointed for any meeting (whether ordinary or special) as a quorum shall assemble, the member entitled to preside shall take the chair, and the Board shall proceed to business. Should a quorum not be present at the expiration of half an hour from the time appointed for the meeting, the meeting shall stand adjourned, if an ordinary meeting, to the day appointed for the next ordinary meeting, or, if a special meeting, sine die.
- 5. Any member desiring to ask a question or to make a motion, unless in the course of discussion or in case of emergency by special leave of the Board, shall give notice of such question or motion either at some previous meeting of the Board or by notice in writing at least four days before the day on which he intends to ask such question or make such motion.
- Every member in giving such notice shall deliver to the Secretary a copy of such question or motion.
- 7. All questions asked and motions made at a meeting shall be made in the order of the notices thereof unless the Board shall unanimously decide otherwise.
- 8. A motion negatived at a meeting shall not be again made until after the expiration of at least three months, and no motion in any way contrary to one passed by the Board at a meeting shall be entertained until after the expiration of the same period.
- Any member presenting a petition or other communication will be held responsible for its contents being throughout respectful, and no document shall be laid before the Board unless the name and address of the drawer be legibly recorded on it.
- 10. When a petition or other communication is presented, the purport thereof shall be concisely stated, and on the motion of any member duly seconded the question shall be put whether or not the document shall be read.
- 11. The business of the ordinary meetings of the Board shall be conducted in the following order :-
 - (a) The minutes of the former meeting shall be read and confirmed after being, if necessary, corrected.
 (b) Memorials, petitions, or other communications addressed to the Board shall
 - be laid before the meeting and orders made thereon
 - (c) The other business shall be considered in the order set down in the Order Book hereafter mentioned.
- 12. The Secretary shall keep an Order Book in which shall be entered and numbered in succession the subjects to be brought under discussion at each meeting, and he shall serve on each member or leave at his residence two days at least before each meeting a notice containing the order of the day copied from the Order Book.
- 13. He shall keep a book to be called a Minute Book, in which shall be minuted during each sitting in the order in which they occur the proceedings of the Board. And he shall keep another book to be called the Journal, in which he shall cause all minutes of proceedings to be fairly transcribed, and such Journal shall form the book required to be kept and to be signed by the Chairman and one member then present under the 23rd section of this Ordinance.
- 14. The secretary shall also keep and submit to the Board at every meeting a Complaint Book, and he shall provide that this book shall be accessible to the public at his office between the hours of 11 A.M. and 4 P.M. on every week day, excepting Saturday and holidays, and excepting also on such days as the Board may sit. Every inhabitant of the town shall have access to this book on his furnishing the Secretary with his correct name and address.
- The Secretary shall at each sitting of the Board lay on the table all reports made to the Chairman by the Inspector and other officers of the Board, and notes of any action taken thereon by the Chairman since the last previous meeting of the Board.

Sanitation and General Conservancy.

- All owners, tenants, occupiers, or lessees of lands situated within the limits of the Local Board shall keep the same clean and free from all rank and noisome vegetation, as well as from all refuse and rubbish.
- 17. All householders, tenants, or occupiers of any dwelling-house, boutique, or shop within the town should deposit the dirt, ashes, sweepings, rubbish, or other refuse from their premises, in proper boxes or other receptacles, and place them on the roadside of their respective dwellings, shops, or boutiques, between the hours of 6 A.M. and 8 A.M. to be removed by the scavenger; and it shall not be lawful for any person to place or cause to be placed such dust, ashes, rubbish, sweepings, or other refuse in any street, unless the same shall be contained in boxes or other receptacles as aforesaid, or after the hours notified by the Board, and every such person shall remove such boxes or receptacles within the space of one hour after the same shall have been emptied by the scavenger.
- 18. No person or persons shall keep for the purpose of hiring or renting out any cattle shed or halting place for cattle within the limits of the town without a permit from the Board. Such permit may impose such conditions as the Board shall consider necessary for the preservation of public health, and the person or persons keeping such cattle shed or halting place for cattle, shall be bound to observe such conditions. Any permit issued under this by-law shall be free of charge.
- 19. The owner of every public cattle stall shall have the same covered with a suitable roof and paved with brick, stone, cement, or asphalt, and provided with suitable drains and receptacles for conveying and receiving manure, and he shall cause such stall to be daily washed and kept clean, and to be whitewashed at least once in three months.

Supervision and Control of Private Markets.

- The keeper, lessee, or any person in charge of a fish market shall daily clean and wash the stalls and floor.
- 21. No person shall sell or expose for sale in any fish market or stall any provisions or things other than fish.
- 22. No licensed butcher shall sell or expose for sale meat, mutton, or pork, in any other place than the place appointed by the Local Board.
- All bakeries in the town should be kept clean. No bakery will be allowed to be kept in a building the walls of which are not plastered and whitewashed with lime and the roof of such dwelling tiled.
- 24. No person affected with or suffering from any cutaneous, contagious, or infectious disease shall occupy any stall, seat, or place in any boutique or market, or expose for sale thereat any provisions whatsoever.
- 25. It shall be lawful for any inspector, headman, or any officer, on the orders of the Chairman of the Local Board, to order the removal from a public or private market of any meat, fish, vegetable, or fruit certified by the Medical Officer of the station to be unfit for human consumption and to order its burial at the expense of the owner.
- 26. No person shall bathe in the Minuwangoda-oya, except at such place or places therein as shall be set apart as bathing places by the Local Board, of which due notice shall be given, and persons suffering from scabies (itch) and other infectious diseases, or who have recently recovered therefrom, shall not be permitted to bathe or wash or in any way to use the water at such bathing place or places or at any public well.

Fishing.

- 27. It shall not be lawful for any person to catch fish by nets, baskets, or by draining water in the Minuwangoda-oya, without the permission of the Chairman of the Local Board, Fishing by rods is not prohibited.
- 28. No person shall use dynamite for the purpose of catching fish in the Minuwangoda-ova. Waste or Public Lands.
- 29. No horse, cattle, sheep, goat, or swine shall be tethered or grazed upon any public ground vested in the Board without a license from the Chairman. Such license may be granted by the Chairman for a month or any shorter period, and shall be subject to such fees as the Board shall from time to time fix.
- 30. Any person authorized in writing by the Chairman may seize any horse, sheep, goat, or other animal which he may find tethered or grazing without such license as aforesaid on any waste or public ground within the town. No animal so seized shall be released except on payment of a fee of cents fifty and the charges leviable for pounding it in the pound, if it has been so impounded.
- 31. The Board may lease or let out the public grazing grounds for any period not exceeding twelve months on any conditions made by the Board.
- 32. All cattle, sheep, or goats straying on the public roads within the town shall when seized be placed in the pound established by the Board for that purpose, and the following charges shall be paid before removal of any animal so imponnded :-

For occupation ... 6 cents a head for a day or part of a day.

For food, if supplied ... 6

33. Every owner or occupier of a house, garden, building, or land, within the limits of the Local Board, shall have the boundaries of the same well defined, and such house, garden, building, or land shall be enclosed by a fence.

Dangerous and Offensive Trades. 34. It shall not be lawful for any person to keep a tannery to clean or cure any hides within the Local Board limits without special permission from the Local Board.

Regulations respecting Naval Cadets.

For the information of Candidates.

1. Appointments to Naval Cadetships will be made by limited competition, with the under-mentioned exceptions:

Six Cadetships given annually to sons of gentlemen in the Colonies, on the recommendation of the

Secretary of State for the Colonies.

Service Cadetships, the total number of which is not to exceed seven in any one year. Service Cadets will be selected by the Board of Admiralty from (a) sons of officers of the Army, Navy, or Marines who have been killed in action, or who have been lost at sea on active service, or killed on duty, or who have died of wounds received in action or injuries received on duty within six months from the date of such action or injury, (b) sons of officers of the Navy who have performed long or distinguished service, and who hold or have held rank or relative rank on the Active List not lower than that of Commander. Not more than three Service Cadets will be nominated annually under

Clause (b).

Applications for Service Cadetships should be addressed to the Military Secretary, Horse Guards, if the candidate is the son of an officer of the Army; to the Secretary of the Admiralty, if the candidate is the son of an officer of the Navy or Marines; and to the Military Secretary, India Office, if the candidate is the son of an officer of the Indian Army.

Colonial and Service Cadets will be entered on qualifying as specified in paragraph 10, and will in all other respects be subjected to these Regulations.

Candidates must be of pure European descent, and the sons either of natural-born British subjects or of

If any doubt arises upon this question, the burden of clear proof that he is qualified will rest upon the candidate himself.

The educational examination of all candidates will be conducted by the Civil Service Commissioners (address Cannon Row, Westminster), who will deal with all questions connected with such examination and will announce the results. A fee of 11. will be required from each candidate.

2. Except in special circumstances, not more than one-third of the number of candidates actually presenting

themselves before the Civil Service Commissioners will be entered.

- 3. All nominations of candidates for Naval Cadetships are made by the First Lord, with the exception of a limited number which are at the disposal of individual members of the Board and of the Secretaries to the Board of
- Admiralty.

 A Flag Officer or a Commodore, First Class, appointed to the chief command of a station, or to a separate command, and a Captain, on first appointment as such to the command of a ship, will be allowed to nominate one candidate, provided the privilege is exercised within six months of appointment and that the candidate is not less than 13 years of age when nominated. The examination of candidates will not take place until they are eligible by

No Captain will be entitled to nominate more than one candidate during the time he holds the rank of Captain, but a Flag Officer or a Commodore, First Class, may claim the privilege each time he is appointed to a command as above. In the event of a candidate's nomination being cancelled before he has commenced the examination, the Officer who nominated him will be allowed to select another candidate for the same or following examination.

4. The nomination will be made three times a year, as soon as convenient after the report of the last examination has been received from the Civil Service Commissioners.

5. The examinations will be held in London and at Portsmouth, in March, July, and November, about six weeks before the commencement of each term, and the appointments will date from the 15th May, 15th September, 15th January, following respectively, and the terms will commence as shown in Regulation 15.

6. A candidate will not be eligible for the examination in March, who is less than 14½ or more than 15½ years of age on May 15 following, nor who is the Examination in July or November, who is not within those limits of age on September or January 15, following respectively.

7. Every candidate must be in good health and free from any physical defect of body, impediment of speech, defect of sight or hearing, and also from any predisposition to constitutional or hereditary disease or weakness of any kind, and in all respects well-developed and active in proportion to his age. Before being examined by the Civil Service Commissioners, he will be required to pass the medical examination according to the prescribed regulations, Service Commissioners, he will be required to pass the medical examination according to the prescribed regulations, and must have been found physically fit for the Navy; rejection at such examination will finally exclude him from

8. The candidate will be required to produce (1) a Registrar's certificate of the date of his birth, or a declaration thereof made before a magistrate (a certificate of Baptism will not be accepted); (2) a certificate of good conduct from the masters of the school or schools at which he may have been educated during the two previous years, or, if educated at home, from his tutor or the clergyman of the parish in which he resides; and (3) proofs of good

health.

9. Candidates will be examined in the following subjects grouped in Class I. In order to qualify for admission as Naval Cadet, candidates must obtain such an aggregate of the marks in Arithmetic, Algebra, and Geometry combined, and also in the subjects of Class I. as a whole, as shall satisfy the Civil Service Commissioners.

Candidates will be permitted to present themselves for examination also in Drawing and one other subject under Class II., for which they will be able to gain additional marks :-

A candidate who fails to qualify will not be entitled to another trial, but will be allowed to compete at the next examination, if he receives a

qualify will not be entitled to another trial, but will be allowed to compete at the next examination, if he receives a fresh nomination and is still within the limits of age.\(\)

12. A candidate who, owing to illness, fails to appear at the examination for which he has obtained his nomination, may receive another nomination, provided he is still within the limits of age.

13. For all Cadets entered under these regulations the payments will be at the rate of £75 per annum for the period in the "Britannia," to be paid every term in advance to the Cashier of the Bank of England, on receipt of claim from the Accountant-General of the Navy. But the Lords Commissioners of the Admiralty reserve the power of selecting, from among the Cadets entered at each examination, a number, not to exceed six, being sons of officers of the Navy, Army, or Marines, or of Civil Officers under the Board of Admiralty, with respect to whom the annual payment will be £40 only. In this selection their Lordship will have regard solely to the pecuniary circumstances of the Cadet. of the Cadet.

Applications for the reduced scale must be received at the Admiralty not later than 1st January, 15th April, and 1st September.

14. In addition to the annual payments mentioned in the foregoing paragraph, the parent or guardian will be charged with the personal expenses incurred by the Cadet for washing, repairing boots and cloths, hair cutting, pocket-

money, &c.

15. The period of training on board the "Britannia" will be four terms; there will be three terms in each year. The first term of each year will be approximately from 14th January to 14th April; the second, from 5th May

to 5th August; and the third, from 16th September to 16th December.

The vacations will be four weeks at Christmas, three weeks at Easter, and six weeks at Midsummer.

16. (a) Reports of progress in Seamanship, Mathematics, Navigation and Technical subjects, will be made to the Admiralty at the end of each term, and an intermediate examination will be held at the end of the second term.

(b) Cadets who are reported at the end of any term as having made unsatisfactory progress through idleness or want of attention, will be "warned," and in the event of a second report to the same effect being received they will be liable to be discharged.

(c) Cadets who fail at the final examination to obtain 45 per cent. of the maxima marks in the Mathematical subjects, including the Theory of Navigation and Nautical Astronomy, or in Seamanship and 40 per cent. in Charts, Instruments, French, Steam and Drawing combined, will be ordered to be withdrawn.

(d) Reports of conduct will be made to the Admiralty at the end of each term or at any time during the period of training on board, if considered desirable. Cadets, who are reported to the Admiralty at any time for unsatisfactory conduct, will be "warned," and should they again be reported they will be liable to be discharged. Any Cadet, however, who is reported for unsatisfactory conduct during his final term, will be liable to be discharged without being allowed to present himself at the examination for passing out of the "Britannia.

(e) Any Cadet who shall at any time appear to their Lordships to be unfit for the Naval Service, for any reason whatever, will be moved from the "Britannia," and it must be understood that this rule will apply to those who are considered unfit from insufficient physical development or weakness of con-

stitution, although no actual organic disease may have been developed.

17. It is to be distinctly understood that the period of training on board the "Britannia" is a time of probation, and the parent or guardian of every Cadet will be required to sign a declaration (on the admission of the Cadet to the "Britannia"), to the effect that he shall be immediately withdrawn on the receipt of an official intimation of his being considered unfit for the Navy.

18. Cadets will, on passing out of the "Britannia," rank according to the amount of sea time they obtain at their final examination, and those who obtain equal amounts of sea time will rank in the order of merit in which they

pass out of the "Britannia."

19. The parent or guardian of every Cadet will be required to provide outfit under the regulations in force.
20. No pay will be allowed by Government to Cadets in the "Britannia." The pocket-money allowed to Cadets will be charged to the parents.

21. As only Cadets who are able to swim are permitted to use the boats belonging to H.M.S. "Britannia," the Lords Commissioners of the Admiralty desire to impress upon parents and guardians the importance of Cadets being

taught to swim before they join the Training Ship, so as to enable them to obtain the full benefits of use of the boats.

The age on entry having been raised, it is hoped that boys who are members of the Church of England will, if possible, be confirmed before joining the "Britannia." The demands made upon the time of Cadets owing to the shortened period of training, will render it difficult to prepare such a large number for confirmation with the necessary care.

Section 30, sub-section (19 a): "For prohibition of Cess-pools and establishment and regulation of Closets on the dry-earth system.

1. Board may order cess-pools to be closed and dry-earth closets substituted.—The Assistant Government Agent, when specially empowered thereto by resolution of the Board, may by notice in writing require the owner or occupier of any house or building or land having a cess-pool on his premises to close such cess-pool, and to substitute a dry-earth closet therefor.

2. Permission to bury in private premises.—Permission may be granted in writing by the Assistant Government Agent to any householder to have night soil from his own premises buried or otherwise disposed of on his own premises.

3. Removal of night soil to the depôt.—Every person (unless specially exempted in writing therefor by the Assistant Government Agent under by-law No. 2), on whose premises the dry-earth system is in operation, is hereby required to cause the daily removal of night soil to a depôt appointed by the Board for the disposal of night soil.

4. Name of person removing night soil to be registered at the office of the Board, &c.—Any householder not having received written permission under by-law No. 2 may employ any person for the purpose of the removal and disposal of night soil. Provided that in the case of such private arrangements being entered into the name of such

that in the case of such private arrangements being entered into the name of such person so employed shall be registered at the office of the Board, and the place to which the night soil shall be removed, and the method in which it is disposed of, shall be submitted to the Board for approval.

Permission may be refused by the Assistant Government Agent to authorize the use

of any place for the disposal of night soil.
