Forms of conditions of sale with lists of taverns can be obtained at any Kachcheri in the Island. Any further information required will be supplied by the Hon. the Government Agent, Western Province, on application made to him either personally or by letter.

Tenderers who cannot speak English and wish to communicate with the Board must bring their own interpreters.

No tender will be considered unless the tenderer is present in person or by his authorized agent at the Council Chamber, and is prepared to deposit forthwith the amount of one month's rent as tendered by him.

Various alterations have been introduced in the new conditions of sale, and intending purchasers are advised to obtain copies before putting in their tenders.

Purchasers of these rents will be allowed to sell arrack at any price not below Rs 4.50 per gallon.

And notice is hereby further given that the purchasers of the Arrack Rent of the Kandy Town and Gravets will be required to pay. in terms of the provisions of the Ordinance No. 9 of 1892, a stamp duty of Rs. 500 for each and every license issued under the Ordinance No. 13 of 1891 to sell arrack by retail at each and every tavern situated within the limits of the Municipality of Kandy.

The forest is about 4 miles from Vavuniya, and logs can be transported either to Jaffna (92 miles), Trincomalee (56 miles), Matale (98 miles), or Vankalai (53 miles). Tenders are invited for the purchase of the trees stamped as they stand in the block. Offers will be received for the purchase of (a) all the trees in the whole block; (b) all the trees of any particular

species in the whole block.

Tenders will not be received for a limited number of trees to be selected out of the block.

Offers may be made of lump sum or rates per tree, or per cubic foot. It should be stated in tender how payment of the purchase money will be made, and within what time the trees purchased will be felled and removed from the forests.

In the event of a rate per cubic foot being accepted, 20 per cent. off breast-high measurements will be allowed for bark, &c., off cubic contents, calculated from actual measurements of felled trees.

No tender will be accepted unless a deposit is made at time of tendering of 50 cents for every tree proposed to be purchased.

Lists of measurements of trees may be obtained at 25 cents per 100 trees on application to the Assistant Conservator of Forests, Northern Circle, Vavuniya, who will furnish any further information which may be required. Tenders will be received by the Conservator of Forests, Colombo, up to noon on April 27 next, who does not

bind himself to accept the highest or any tender.

Trees marked as sound are to the best of the Assistant Conservator's belief sound, but they are not guaranteed as such.

6. Boiled lime will be measured and paid for by weight.

8. The person whose tender has been accepted by Government will be required to bear the expense of having security bonds prepared for the due performance of his contract, which bonds will be subject to the approval of the Attorney-General, but may be drawn by the tenderer's own lawyers, in which case the name or stamp of the Proctor who drafted the bond should be affixed to the document. But if a contractor submits a security bond which does not bear the name or stamp of the lawyer who drafted it, he will be required to pay a fee of Rs. 10.50 to the Attorney-General for approving such bond.

9. The security bond should be furnished within two weeks of acceptance of tender being notified.

10. All alterations or erasures in tenders should bear the initials of the tenderers, otherwise the tenders will be treated as informal and rejected.
