PROCLAMATION BY THE GOVERNOR.

IN the Name of Her Majesty VICTORIA, of the United Kingdom of Great Britain and Ireland, Queen, Defender of the Faith.

PROCLAMATION.

By His Excellency the Right Honourable Sir J. WEST RIDGEWAY, Knight Grand Cross of the Most Distinguished Order of Saint Michael and Saint George, Knight Commander of the Most Honourable Order of the Bath, Knight Commander of the Most Exalted Order of the Star of India, Governor and Commander-in-Chief in and over the Island of Ceylon, with the Dependencies thereof.

WEST RIDGEWAY.

WHEREAS by section 34 of "The Forest Ordinance, 1885," it is enacted that the Governor may, by Proclamation in the *Gazette*, constitute any portion of forest or village forest for the benefit of any village community or group of village communities, and may in like manner vary or cancel any such Proclamation :

And whereas by a Proclamation bearing date the Thirtieth day of January, One thousand Eight hundred and Ninety-three the portion of forest specified in the schedule thereto was constituted a village forest for the benefit of the village community of Delgomuwa in the Udapattu of Kuruwiti korale, Province of Sabaragamuwa :

And whereas it is expedient to exclude from the said Proclamation the portions of land described in the schedule hereto and to that extent to vary the said Proclamation :

Now know Ye that We, the said Governor, do hereby vary the said Proclamation and declare that the allosments of land marked A 5014, A 5014, and B 5044 in preliminary plan No. 3,935, dated Thirtieth September, One thousand Eight hundred and Ninety-eight, and in the schedule hereto more fully described, shall be excluded from and deemed to form no part of the village forest constituted by the aforesaid Proclamation of Thirtieth January, One thousand Eight hundred and Ninety-three, and We do in all other respects confirm the said Proclamation.
