



1. CHARTERED INSTITUTE OF MANAGEMENT ACCOUNTANTS- UK (CIMA)

Every thing you need to know about registering as a CIMA Student.

- The basic qualifications required to register as a CIMA student are;
 - Local examinations:

G.C.E Ordinary level -3 credit passes including Mathematics and English and, G.C.E. Advanced level -2 credit passes or,

London examinations:

A minimum of 2 G.C.E subjects at Advanced level [Grades A - E] supported by passes in 3 subjects at GCSE [Grade C and above]. Two of the subject passes at either level must be in English and Mathematics.

- Alternative English Language requirements:
 - * International English Language Testing System (IELTS)
 - 6.5 overall and not less than 6.0 in each of the reading and writing sections.
 - * Test of English as a Foreign Language (TOEFL)

Paper based test: 600 accompanied by a score of 4 in the Test of Written English (TWE): Computer based test: 250.

- ⇒ There is no age limit for one to register as a student.
- The following professional Qualifications are accepted as an entry qualification to register as a student:
 - University Degree
 - Australian Computer Society Certificate
 - Diploma in Business Studies from the Institute of Commercial Management
 - Institute of Financial Accountants Certificate
 - Association of accounting Technicians (AAT)
 - NCC Diploma in Computer Studies
 - NIBM Diploma in Computer Studies
 - International Association of Book Keepers (IAB)
- ⇒ If you do not have any of the above qualifications but have working experience in accountancy, please contact the CIMA Sri Lanka division for details.

3. COLOMBO INTERNATIONAL NAUTICAL AND ENGINEERING COLLEGE (CINEC)

CINEC is offering the following four courses at present;

1. Marine engineer officer cadets

- ➡ The basic requirements to become a Marine Engineer;
 - > Have a sense of responsibility
 - ➤ G.C.E (O/L) examination: 5 credit passes, including Mathematics, Science and English G.C.E (A/L) examination: 3 passes in Science subjects
 - > Have an aptitude for engineering
 - ➤ Below 22 years of age
- ➡ Duration: 3 1/2 years.
- ⇒ The training programme consisting of five phases:
 - Phase I 12 months theory and practical training at CINEC
 - Phase II 12 months Sea training on board merchant vessels
 - Phase III 03 months theory and practical training at CINEC

2. Marine electrical officer training programme

- → The entry qualification to become a Marine Electrical Officer:

 - Either N.D.T/ N.C.T (Exemption from Phase I) or
 - ➤ G.C.E (O/L) + 2 years of govt. approved Technical Education or
 - ➤ G.C.E (A/L) 3 passes in Science Stream
- Duration: 6 months (full time)

Monthly Installment (can be paid monthly) - Rs.8,312 X 6

3. Marine engineer officer on watch (Motor Man)

- This course will enable you to obtain a CDC in order to sail on board, merchant ships as an engine room hand. With further education and sea service you can become a Marine Engineer.
- ★ The entry qualifications are:
 - ➤ Should have passed G.C.E (O/L)
 - Age over 18 years
 - > Should be in sound health to serve on board ships.
- Duration: 3 months (Full time)

 During this 3 months, theory and practical training will be given in the field of Marine Engineering.
- Course Fees:

1 st Installment upon enrollment	-Rs. 11,250
2 nd Installment end of 1 st month	-Rs. 11,250

- Carrier path to become a Marine Engineer:
 - > 9 months sea service
 - > 3 day course at college
 - ➤ 15 months sea service
 - > 3 months course at college
 - ▶ 6 months sea service

On successful completion of above; candidate will be eligible to appear for the certificate of competency Examination Officer in charge of engine room watch, held by the shipping division of Sri Lanka.

With this qualification you can become a marine engineer. With further examinations and experience you can become a Chief Engineer of a merchant ship.

4. Officer cadets (Deck)

- The basic requirements for this course are:
 - Dynamic young school leavers
 - > Have a sense of responsibility and should physically fit
 - ➤ G.C.E (O/L) Examination 5 Credits passes including Mathematics, Science and English
 - ➢ G.C.E (A/L) Examination 3 passes in Science subjects. (Preferably pure and applied Maths, Physics)
 - ➤ Be below 21 years age
 - Have good eye sight (vision and color)
- You must start the course at CINEC and trained for 4 months and then placed on board foreign merchant vessels for sea training, prior to coming back to CINEC for further training. Total sea training will be 27 months and shore based training for 15 months.

If you have the necessary qualifications and if you impress the selection board your placement on a ship for sea training will be guaranteed.

Course Fee:

During the sea training you will be paid an allowance of approximately US \$ 200 per month.

- ₩ith further sea going experience and two more examinations i.e. in about 8 years could become a captain of a ship.

4. ASSOCIATION OF ACCOUNTING TECHNICIANS (AAT)

- How many stages are there to complete the examination requirements?
 There are three stages in AAT SL examinations.
- How often the exams are held in a year?
 All three stages of examinations are held twice a year in June and December.
- What is the entry qualification requirement for student registration?
 - a) Persons under 18 years of age:
 Six passes at the G.C.E O/L examination with three credit passes including a pass including a pass in mathematics or commerce and accounts in one/two sittings or G.C.E A/L Examination 2 passes.
 - b) Persons over 18 years of age: Six passes at the G.C.E O/L examination or N.C.G.E. examination in one / two sittings; or Two passes at the G.C.E A/L examination ;or Five years experience as an Accounts clerk/ Audit clerk/ Book keeper/ Accounts trainee in a recognized establishment; or Any other equivalent or higher qualification.
- Can I take up the course in Tamil?
 Medium: Sinhala, Tamil and English.
- Can I get exemption from any stage or subject based on my past academic performance?
 Exemptions from subjects of the Associations examinations are available on the basis of:
 - * Passes at G.C.E A/L in specific subjects
 - * Degree awarded by recognized Universities
 - * Diplomas and Certificates awarded by Advanced Technical Institutes and Technical Colleges in Sri Lanka
 - * Passes at Examinations of other professional Institutes.
- Is AAT a recognized qualification?
 Recognition of AAT (SL) qualification by professional institutes and Universities.
- Exemptions from examinations of the Institute of Chartered Accountants of Sri Lanka. If
 you have passed the stage III examination and also obtained a pass in the Business
 Communication II paper are eligible for exemption from the Foundation Examination of
 ICASL.

ii. Exemptions from Examinations of other Professional Bodies:

Passed Finalist – Entitled to exemption from stage I, if you have sat and passed all relevant papers.

Passed only stage II of AAT - Registration with CIMA (U.K)

- iii. Recognition by Universities:
- University of Colombo

 Those who have passed the stage

Those who have passed the stage III examination and have four years post qualified experience are eligible for the Executive Diploma in Business Administration at the faculty of Graduate studies, University of Colombo.

- Open university:
 - (a) Who have passed the stage I examination are eligible to apply for registration for the Diploma in Management of the Open University of Sri Lanka.
 - (b) Who have passed the stage III examination are eligible to apply for registration for the LLB Degree in the Open University.
- O University of Sri Jeyewardenepura:

Who have passed the stage III examination are eligible to register for the External B.Com Degree at the University of Sri Jeyewardenepura.

O Deakin University – Australia:

Who have passed the stage II/ Diploma Examination are eligible to register for the Bachelor of commerce Degree at the Deakin University in Australia.

Wollongong University – Australia:

Who have passed the Diploma or Stage II are recognized for entry into bachelor of Commerce program at the University of Wollongong.
