Pacific Ocean-Fiji Islands-Regarding Leading Lights in Suva Harbour,

The Government of the Fiji islands have given notice, The Government of the Fijl Islands have given notice, dated Suva, August 25, 1899, that on September 29, 1898, the red catoptric lower leading light into Suva harbour was replaced by a fourth order red diop-tric light. The arc of visibility is from N. 50° W. to N. 28° E. (magnetic), and can be seen, on a dark night with a clear atmosphere, at a distance of fourteen miles. On June 16, 1899, the white catoptric upper leading light into Suva harbour was replaced by a fourth order white dioptric light. The arc of visibility is from N. 45° W. to N. 45° E. (magnetic), and can be seen, on a dark night with a clear atmosphere, at a distance of twentyfour miles.

Australia, South Coast-Port Adelaide River-Intended alteration in the position of the Lighthouse.

The British Admiralty has given notice (No. 604 of 1899) that it is intended to remove Port Adelaide river lighthouse from its present position at the entrance to the river to a site in the vicinity of the bell buoy on the outer end of Wonga shoal.

Approximate present position: lat. 34° 48' S., long. 138° 28' E.


