Pacific Ocean—Fiji Islands—Regarding Leading Lights in Suva Harbour.

The Government of the Fiji islands have given notice, dated Suva, August 25, 1899, that on September 29, 1898, the red catoptric lower leading light into Suva harbour was replaced by a fourth order red dioptric light. The arc of visibility is from N. 50° W. to N. 28° E. (magnetic), and can be seen, on a dark night with a clear atmosphere, at a distance of fourteen miles.

On June 16, 1899, the white catoptric upper leading light into Suva harbour was replaced by a fourth order white dioptric light. The arc of visibility is from N. 45° W. to N. 45° E. (magnetic), and can be seen, on a dark night with a clear atmosphere, at a distance of twenty-four miles.

Australia, South—Napean Bay—Kangaroo Island—Buoy placed on the Wreck of the "Fanny M."

The President, Marine Board, Port Adelaide, has given notice (No. 11 of 1899) that a small green wreck buoy, with cage and ball, has been placed 30 ft. north of the wreck of the barque Fanny M. in 9 ft. Australia, South Coast—Port Adelaide River—Intended alteration in the position of the Lighthouse.

The British Admiralty has given notice (No. 604 of 1899) that it is intended to remove Port Adelaide river lighthouse from its present position at the entrance to the river to a site in the vicinity of the bell buoy on the outer end of Wonga shoal.

Approximate present position: lat. 34° 48' S., long. 138° 28' E.

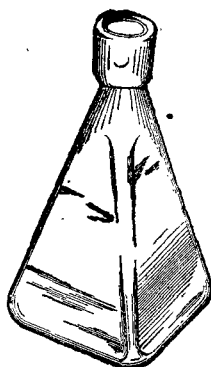

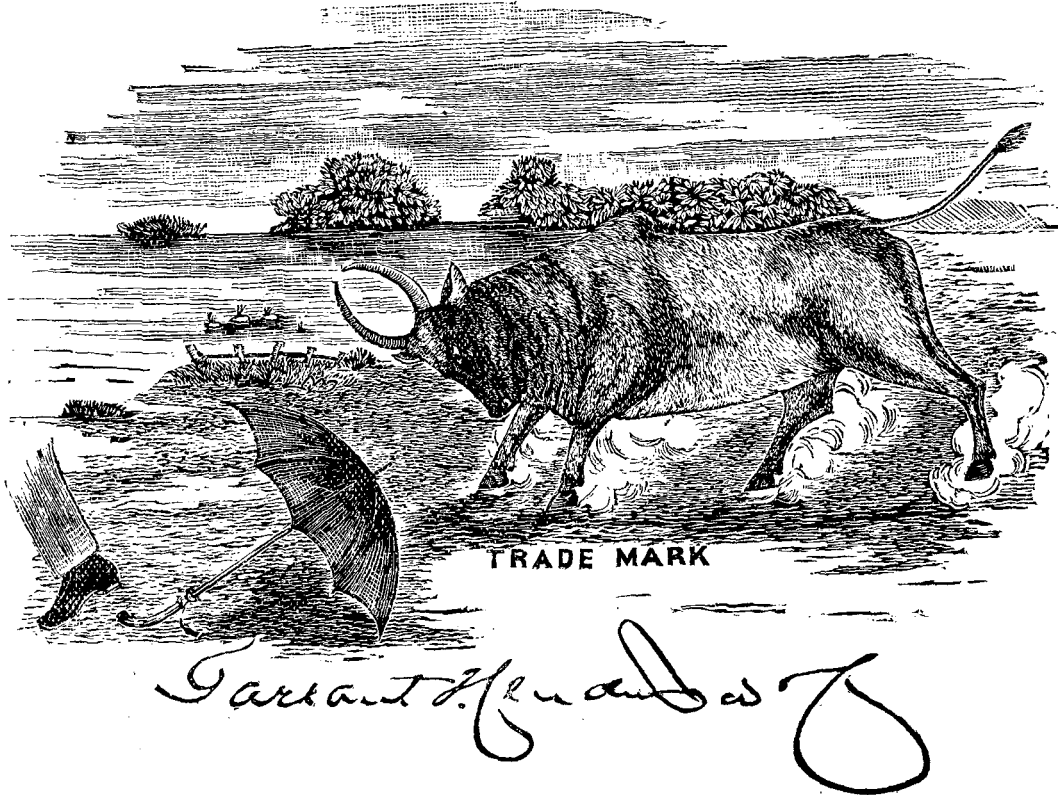
