WHEREAS by section 2 of "The Small Towns Sanitary Ordinance, 1892," it is enacted that it shall be lawful for the Governor, with the advice of the Executive Council, by Proclamation to be for that purpose published in the *Government Gazette*, to bring any town or village mentioned in the schedule thereto under the operation of the said Ordinance; and to define the limits of such town or village for the purposes of the said Ordinance:

And whereas it is expedient to bring the town of Kégalla, in the Province of Sabaragamuwa, a town mentioned in the said schedule, under the operation of the said Ordinance:

Now therefore know Ye that We, the said Governor, with the advice of the Executive Council, under and by virtue of the powers by the said section of the said Ordinance in Us vested, do hereby

bring, as from and after the 1st day of January, 1894, the town of Kégalla aforesaid under the operation of the said Ordinance, and define the limits of the said town for the purposes of the said Ordinance to be those set out in the schedule hereto.

Given at Colombo, in the said Island of Ceylon, this Ninth day of December, in the year of our Lord One thousand Eight hundred and Ninety-three.

*Definition of Limits of Kégalla Sanitary Town.*

1. The high road leading from Colombo to Kandy from the 47 $\frac{3}{4}$  milepost to the 50th milepost, with an extent of 10 chains on either side of the road.
2. The high road leading from Kégalla to Bulatkohopitiya from its commencement to the half-milepost, with an extent of 5 chains on either side.

WHEREAS by the 3rd section of "The Local Board of Health and Improvement Ordinance, 1876," it is enacted that it shall be lawful for the Governor, with the advice of the Executive Council, by Proclamation to be for that purpose published in the *Government Gazette*, to bring any of the towns mentioned in the schedule to the said Ordinance annexed under the operation of the said Ordinance, and to define the limits of such town or towns respectively for the purposes of the said Ordinance, and such Proclamation to amend, alter, or revoke as and whenever the Governor shall, with like advice, determine :

And whereas by a Proclamation dated the 13th day of August, 1884, the town of Trincomalee, in the Eastern Province, a town mentioned in the schedule aforesaid, was brought under the operation of the said Ordinance, and the limits of the said town were, for the purposes of the said Ordinance, defined in such Proclamation :

And whereas by a subsequent Proclamation dated the 17th November, 1892, the Proclamation of the 13th August, 1884, aforesaid was amended as respects the limits of the said town of Trincomalee, and the limits of the said town, for the purposes of the said Ordinance, redefined therein :

And whereas it is expedient to amend the Proclamation of the 17th November, 1892, aforesaid as respects the limits of the said town of Trincomalee, and to redefine the limits of the said town for the purposes aforesaid :

Now know Ye that We, the said Governor, with the advice of the Executive Council, do hereby amend the Proclamation of the said 17th November, 1892, aforesaid by altering the limits of the said town as defined therein, and We do hereby define, for the purposes of the said Ordinance, the limits of the said town of Trincomalee to be those set out in the schedule hereto, as from and after the 1st day of January, 1894.

Given at Colombo, in the said Island of Ceylon, this Thirtieth day of November, in the year of our Lord One thousand Eight hundred and Ninety-three.

SCHEDULE.

*East and North-east.*—Dutch Bay, Fort Frederick, and Back Bay up to a line taken from the junction of Love lane with the coast road to the sea.

*North and North-west.*—Line taken from the junction of Love lane with the coast road, along Love lane as far as Tattakkaikkulam, and thence to the northern edge of the tank and along it, and thence in a straight line to the Anurádhapura road, and thence along the Anurádhapura road to the Kandy road, and along the Kandy road to the junction with Orr's Hill road.

*West and South-west.*—Yard cove and inner harbour.

*South.*—The canal on Admiralty Flats as far as Dhobies' tank, and thence the surveyed line forming War Department boundary to the sea.

*China, East Coast—Turnabout Island.—Rocky Bank to the Westward of Turnabout Island reported.*

The British Admiralty has given notice (No. 537 of 1893) that H.M.S. Caroline has examined a recently reported rocky bank westward of Turnabout island.

Hai tan bank is 5 cables long in a north-east and south-west direction, 3 cables broad, and has depths of 6 to 10 fathoms on it. From its centre Turnabout lighthouse bears about E.  $\frac{1}{2}$  S. ( $S. 86^{\circ} E.$ ), distant  $2\frac{2}{3}$  miles.

At low water there is a very heavy tide rip, and the water is much discoloured over the patch.

*South Pacific Ocean—Rotumah Island.—Shoals Westward of Chilha Point and South-Westward of Atana Islands.*

Notice to Mariners No. 538 of 1893 issued by the British Admiralty is republished.

The following information has been received from H.M.S. Rapid:—

1.—A shoal, with a depth of 9 ft. on it, circular in shape and about a cable in diameter, lies about three-quarters of a mile westward of Chilha point, the west extreme of Rotumah.

Position, to be considered doubtful: latitude  $12^{\circ} 29' 30'' S.$ , longitude  $176^{\circ} 59' 30'' E.$

2.—A shoal is reported to extend about 4 miles south-westward from the Atana islands, westward of Rotumah, with a rock, on which the sea does not break, situated on the shoal about 2 miles from the islands. The distance to which the shoal extends from the islands is not known, and it may be found to be further than 4 miles.

Information has been received from the master of the Dutch steamer Soerabaya that it is supposed that the English barque Clan Grant lies sunk on the following bearings :—

The barque was anchored there in 18 fathoms water, and when the Soerabaya was in the vicinity it was still driving, but already sunk till the deck.

## NOTICES UNDER THE FOREST ORDINANCE.

**W**HEREAS by the 6th section of Ordinance No. 10 of 1885 it is enacted that whenever it is proposed to constitute any land a reserved forest, notice thereof shall be published in the *Government Gazette*—

- (a) specifying, as nearly as possible, the situation and limits of such land ;
- (b) declaring that it is proposed to constitute such land a reserved forest ;
- (c) naming an officer (hereinafter called "The Forest Settlement Officer"), who shall be appointed by the Governor, to inquire into and determine the existence, nature, and extent of any rights claimed by or alleged to exist in favour of any person in or over any land comprised within such limits, and any claims relating to the practice within such limits of chena cultivation, and to deal with the same as provided in Chapter II. of the said Ordinance :

**W**HEREAS by the 6th section of Ordinance No. 10 of 1885 it is enacted that whenever it is proposed to constitute any land a reserved forest, notice thereof shall be published in the *Government Gazette*—

- (a) specifying, as nearly as possible, the situation and limits of such land ;
- (b) declaring that it is proposed to constitute such land a reserved forest ;

And whereas it is proposed to constitute certain land situated in the villages of Uda Mahaiyawa, Watapoluwa, Diwulwewa, Arappola, in Yatinuwara, Gangawata kóralé, hereinafter defined a reserved forest: Notice is hereby given (1) that it proposed to constitute the said land as situated and within the limits defined, known as Udawattelle in the schedule hereunder written, a reserved forest; (2) that Mr. Herbert Rayner Freeman is the Officer appointed the Forest Settlement Officer of the reserved forest aforesaid:—

SCHEDULE.

*Northern Boundary.*—The forest boundary on the north side commences where Russell path branches off from Lady Horton's walk. This path forms the boundary until it strikes title plan 79,186, thence the boundary follows the sothern boundary of title plan 79,186, the western and souther boundary of title plan 82,798, the southern and eastern boundary of title plan 98,020 until it strikes Torrington road, from this point the forest boundary marches with this road until it strikes the Bandarage Tenne-ela, then it follows the ela until the southern boundary of lot 11,122 (claimed by Mr. A. *Eastern Boundary.*—Lady Anderson's road forms the boundary until the point where the northern boundary of title plan 50,073 is touched, it then follows the northern and western boundaries of title plan 50,073, the western and southern boundaries of title plan 50,614, when it again strikes Lady Anderson's road, it follows this road for a short distance and marches along the northern boundary of title plan 50,074, it then follows the western boundaries of title plans 50,074, 50,165, 50,128, 50,129, 50,130, and of Galketiawatta claimed by Haramanis Zoysa, until it strikes Lady Anderson's road.

*Southern Boundary.*—From this point the forest boundary marches along the northern boundaries of lands claimed by Wewawattagedera Kalu, Pangwelakumbura claimed by Munasinghe Gravets Mohandiram, a strip of chena land claimed by Pinghami Wattrale, it then follows along the eastern and northern boundary of title plan 80,312 when it strikes Lady Macarthy's road, it then marches along this road until it touches the northern boundary of land claimed by Messrs. Soysa & Co., it follows this boundary until it strikes the path to the eastern redoubt.

*Western Boundary.*—From this point the forest boundary follows the path to the eastern redoubt for a short distance when it strikes Lady Horton's walk, it then follows Lady Horton's walk until Russell path is reached.

MUNICIPAL COUNCIL NOTICES.

Minutes of Proceedings of a Meeting of the Municipal Council of Kandy held in the Town Hall on Saturday, November 25, 1893, at 8 o'clock a.m.

Present :—Hon. P. A. Templer, Chairman ; R. D. Ormsby, Esq. ; J. B. Siebel, Esq. ; J. N. d'Esterre, Esq. ; J. H. Sproule, Esq. ; E. Beven, Esq. ; B. de Alwis, Esq.

1. The Minutes of Proceedings of the Meeting held on October 14 were read and confirmed.

2. The following documents, which had been circulated and seen by the several Members, were laid on the table :—General Statement of Receipts and Disbursements on account of the Municipal Fund ; also separate statements in respect of the General Revenue, Police Assessment, and Water-rate accounts from close of 1892 to October 31 ; also Progress Report of Works done brought up to the same date ; Return of Work done by the Municipal Magistrate and of Cases instituted by the several Inspectors during the month of October ; and Health Officer's Report for the same month.

Resolved,—That the several statements be forwarded, together with Minutes of Proceedings of this Meeting, to Government as required by the 90th section of the Ordinance, together with Health Officer's report.

Read letter No. 39, dated November 14, from the Colonial Secretary, in reply to the Chairman's letter No. 56 of October 27, on the subject of the upkeep of the Trincomalee street barrel drains, the expense connected with the repair and maintenance of which His Excellency the Governor is of opinion the Municipal Council should bear in so far as they are required for sanitary purposes.

On a motion by Mr. J. H. Sproule, seconded by Mr. E. Beven, it was unanimously resolved :—

That His Excellency the Governor be asked to reconsider the matter—the plea of poverty was one the force of which His Excellency's predecessors did acknowledge and appreciate, as being the result of failing sources of revenue by causes such as pointed out in the Chairman's letter No. 56/164 of October 27 last. The Council fail to perceive the materiality of the argument based on the difficulty of obtaining residential houses in Kandy ; such scarcity of houses has in no way affected the assessment thereon, and as a matter of fact it has not brought about an increase in the value of or rental charged for houses in the Municipality ; the slight increase shown on page N 11 of the Administration Report for 1892 being produced not by residential properties but the enlargement and improvement of business premises.

4. Letter dated October 9 from Members of the Municipal Office staff, with regard to rules for pension and gratuities as provided for under section 62 of the Municipal Councils Ordinance, and which had been circulated by the Council's order (9) of October 14, was submitted.

Resolved unanimously that application be made to His Excellency the Governor in Executive Council to prescribe rules analogous to those in force in the Municipalities of Colombo and Galle under section 62 of the Ordinance No. 7 of 1887.

5. The draft of the amendment of the Municipal Councils Ordinance, 1887, was submitted. After a short discussion the notice of the Chairman was invited to the amendments proposed by the Committee in their report dated June 11, 1893, especially with regard to registration of mortgages, and which had been forwarded to Government. The Chairman undertook to look into the matter.

6. The Chairman submitted printed copy of the Annual Administration Report for 1892, a copy of which had been furnished to each Councillor.

No resolution was passed thereon.

7. The following letters from the Government Agent, which had been circulated, in respect of the sales of Toll rents were submitted : No. 50 of October 21, No. 53 of November 7, and No. 57 of November 22.

## MUNICIPALITY OF GALLE.

## Minutes of Proceedings of a Meeting of the Municipal Council of Galle held at the Municipal Office on November 11, 1893, at 4 p.m.

*Present*.—The Chairman; H. J. Deslandes, Esq.; Dr. W. Dias; W. E. de Vos, Esq.; W. Abeyasundera, Esq.; and N. Dias Abeyasinhe, Esq.

1. Read and confirmed Minutes of last Meeting.

2. The Chairman brought up for consideration the position of the Council in regard to the water supply, and invited an expression of the views of the Council on the question as it now stood.

Moved by Mr. W. E. de Vos, "that in view of the fact that a competent scientific authority has, after an analysis of the water, pronounced it unfit for human consumption, the Council is of opinion that water should no longer be issued to the public, nor the water-rate levied for the present; and further that measures be at once taken at the expense of the Council for the improvements of the water as advised by the Chief Engineer of the Colombo Waterworks."

Seconded by Mr. W. Abeyasundera.—Carried.

Resolved,—That Mr. Ewart be consulted as to the measures necessary to be taken.

Resolved,—That the water-rate collected be refunded to the payers.

3. The Administration Report for 1892 was laid on the table, after being duly circulated among the Members of the Council.

4. Submitted a report of the Attorney-General with connected papers recommending an alteration in the wording of the by-law, chapter XVIII, section 22 (6), proposed to be amended.

Resolved,—That the alteration suggested by the Attorney-General be agreed to.

5. Submitted for consideration the draft of a proposed Ordinance to amend the Municipal Councils Ordinance, 1887.

Resolved,—That the attention of Government be invited to the recommendations made by this Council in their letter to the Hon. the Colonial Secretary, No. 30 of June 27, 1892, with the request that they be incorporated in the proposed Ordinance.

6. The Chairman submitted an extract from a letter from the late Chairman, Municipal Council, Galle, recommending a loan of Rs. 10,000 being taken for carrying on necessary improvements in the town.

Resolved,—That the Council is unanimously of opinion that no loan be taken, however urgent the need, as long as the interest on the Waterworks loan has to be provided for from the general revenue.

7. Submitted a letter No. 2,013 of September 24 last, from the Superintendent of Police, Southern Province, proposing that certain conditions be introduced into the licenses issued for the sale of opium.

Resolved,—(1) That that the conditions proposed by the Superintendent of Police be approved and inserted in the licenses to be issued next year.

(2) That for the year 1894 one wholesale license and four retail licenses be issued.

(3) That the licenses be sold by auction in terms of Ordinance No. 2 of 1893.

(4) That the Superintendent of Police be consulted as to the most suitable positions for the retail shops, having regard to the convenience of those who use the drug.

8. Submitted the following recommendations of the Standing Committee:—

August 26, 1893.—Resolved that it be recommended to the Council in terms of 114 of the Municipal Councils Ordinance that the following transfer of votes be made:—

Rs. 1,800 from "Waterworks account" to head "Interest to Waterworks Loan."

Rs. 1,400 from "New Roads" to head "Interest to Waterworks Loan."

Rs. 776.38 from "Clearing Canal" to head "Interest to Waterworks Loan."

Rs. 55 from "New Lamps" to "Arresting Commutation Defaulters."

Rs. 5 from "New Lamps" to head "Tin Plates for Carts."

Rs. 50 from "Commission to Collectors" to head "Stationery and Printing in No. 2 Account."

November 11, 1893.—Resolved that transfers be made of the following votes to meet the cost of supporting the Bope bridge:—Rs. 200 from repair of roads, Rs. 60 from repair of Municipal buildings, Rs. 260 from minor works, Rs. 260 from new roads, Rs. 200 from improvement of markets.

Resolved,—That these recommendations be approved.

9. Submitted results of sale of the Gintota and Morawak korale road toll for 1894.

Resolved,—That the offer of Don Daniel Samarawickrema of Rs. 1,925 for the Morawak korale road toll and that of Kumarawado Niccoris Arachchi of Rs. 5,560 for the Gintota toll be accepted.

10. Submitted results of sale of rents for 1894.

Resolved,—That the offer of Meepe Gamage Robert of Rs. 3,000 for the rent of the fish auction shed and that of Cassim Segosa of Rs. 185 for the rent of the Talbot Town bathing wells be accepted.

11. Submitted accounts for the month of September, 1893.

12. Submitted Superintendent's reports of road work and progress of works for September, 1893.

## Sanitary Officer's Report for the Quarter ended September 30, 1893.

*General Health*.—The general health has been comparatively good. There was no smallpox during the quarter. Only two cases of chickenpox were reported in July. There were few cases of measles too. Dysentery was prevailing in the different wards.

My remarks in the last report about the different wards still hold good, as the defects pointed out have not been remedied as yet, and the improvements suggested have not been carried out except in a few instances.

*The Drainage* in the wards generally is most unsatisfactory, and very much neglected. In Hirimbura road the side drains are as a rule grievously neglected. In most places they are choked up by vegetation, and no longer serve as drains. After a heavy shower, on account of the incapacity of the drains to conduct the water, the roads get

under water, and these neglected drains become the cause of a public nuisance. In Ward No. 2 the road opposite the cattle-pound gets under water after a heavy shower. There should be a built drain opposite the cemetery and continued as far as the junction of Matara road.

The *Latrines* are kept clean, but they are not free from smells, and will remain so until cemented drains are provided to carry away the washings, which otherwise impregnate the surrounding soil and give off offensive smells. Another cause of the stench is the insufficiency of dry earth. A third cause is that those using the latrines wash into the tubs and constantly dirty the seat and floor.

*Street Sweeping* was on the whole satisfactory.

*Scavenging*.—The bulls for the carts used to be sent very late, and the overseer and the Inspector of Ward No. 2 complained to me that there was unnecessary delay on this account.

*Slaughtering of Cattle*.—The quality of the cattle in the pound was good.
