## DRAFT ORDINANCES.

## MINUTE.

The following Draft of a proposed Ordinance is published for general information :—

An Ordinance to abolish the Import Duty on certain kinds of Metals.

Preamble.

WHEREAS it is expedient to abolish the import duty on metals intended for use in local manufactures, levied under the Ordinance No. 17 of 1869 : Be it therefore enacted by the Governor of Ceylon, by and with the advice and consent of the Legislative Council thereof, as follows :

Abolition of Customs duty on certain metals.

1 From and after the coming into operation of this Ordinance there shall cease to be levied the several duties of Customs respectively set forth in figures against the different classes of metals specified in the schedule hereto annexed, anything in the Ordinance No. 17 of 1869 to the contrary notwithstanding.

Commencement of Ordinance.

2 This Ordinance shall commence and come into operation on the day of , 1894.
