China Sea—Tong King Gulf,
(1) Intended Light on Kulao Rai (Pulo Canton).

The British Admiralty has given notice (No. 338 of 1897) that a lighthouse constructed of steel is in course of crection on the east side of Kulao Rai (pulo Canton), from which a quick flashing light will be exhibited, at an elevation of about 164 ft. above the ground.

Approximate position, lat. 15° 23½' N., long. 109° 6' E.

(2) New Lighthouse constructing on Hon Dau.

Also, that a new lighthouse is in course of erection on Hon Dau, in approximately lat. 20° 40′ N., long. 106°

(3) Intended Light on Cape Tourane.

Also, that when the new lighthouse on Hon Dau is completed, the light (fixed white) now shown there will be transferred to Cape Tourane, in approximately lat. 16° 7½' N., long. 108° 18½' E.

China Sea—Tung Hai or Eastern Sea—Non-existence of Nine Fathoms Bank.

With reference to Notice to Mariners No. 238, dated November 20, 1896, issued by this office, the British Admiralty has given further notice (No. 340 of 1897) that information has been received from the Commanderin-Chief on the China Station, dated April 23, 1897, that H.M.S. Plover sounded over an area of 4 miles in every direction around the position given, and found no indication of any extension or shoaling of the Great Yang Tse bank, or shoal, in the vicinity. As the nature of the bottom was reported to be black mud, and the bank if existent cannot therefore be small, the reported soundings of 9 fathoms have been expunged from the Charts.


