PROCLAMATIONS BY THE GOVERNOR.

In the Name of Her Majesty VICTORIA, of the United Kingdom of Great Britain and Ireland, Queen, Defender of the Faith.

PROCLAMATION.

By His Excellency the Right Honourable Sir J. WEST RIDGEWAY, Knight Commander of the Most Honourable Order of the Bath, Knight Commander of the Most Exalted Order of the Star of India, Governor and Commander-in-Chief in and over the Island of Ceylon, with the Dependencies thereof.

WEST RIDGEWAY.

WHEREAS by section 4 of the Ordinance No. 3 of 1889 it is enacted that for the purposes of the said Ordinance it shall be lawful for the Governor, with the advice of the Executive Council, by Proclamation to be by him issued and published in the Government Gazette, to establish so many provinces as to him may appear expedient, and to divide such provinces into districts and sub-districts, and to declare which of such districts shall be deemed to be the principal district, and with the like advice and in like manner to alter and vary the number and limits of any such provinces, districts, or sub-districts:

And whereas by Proclamations dated the 15th day of November, 1889, and 28th day of February, 1890, the Governor, with the advice of the Executive Council, has established provinces and divided them into districts and sub-districts for the purposes of the said Ordinance:

And whereas it is expedient to alter the limits of the Province of Kandy and of the Province of Ratnapura, established as aforesaid, and to establish an additional Province to be called the Province of Kegalla, for the purposes of the said Ordinance:

Now know Ye that We, the said Governor, with the advice of the Executive Council, do, for the purposes of the above Ordinance, by this Our Proclamation establish the Province of Kegalla and vary the limits of the Province of Kandy and of the Province of Ratnapura, and divide the said three provinces into the districts and sub-districts set forth in the schedule hereunto annexed, and do hereby declare that such of the said districts shall respectively, be deemed to be principal districts for the purposes of this Ordinance as are therein expressed to be principal districts.

Given at Colombo, in the said Island of Ceylon, this First day of July, in the year of our Lord One thousand Eight hundred and Ninety-eight.

WHEREAS by sub-section (1) of section 238 of "The Merchant Shipping Act, 1894," it is provided that, where it appears to Her Majesty that due facilities are or will be given by the Government of any foreign country for recovering and apprehending seamen who desert from British merchant-ships in that country, Her Majesty may, by Order in Council, stating that such facilities are or will be given, declare that that section shall apply in the case of such foreign country, subject to any limitations, conditions, and qualifications contained in the Order:

And whereas it appears to Her Majesty that due facilities are given by the Government of Japan for recovering and apprehending seamen who desert from British merchant-ships in that country:

And whereas Her Majesty was pleased, by and with the advice of Her Privy Council, on the 3rd day of February, 1898, to pass a *Provisional* Order applying section 238 of "The Merchant Shipping Act, 1894," in the case of Japan:

And whereas the provisions of section 1 of "The Rules Publication Act, 1893," have been complied with:

Now therefore Her Majesty, by virtue of the power vested in Her by the herein-before recited sub-section (1) of section 238 of "The Merchant Shipping Act, 1894," and by and with the advice of Her Privy Council, is pleased to order and declare, and it is hereby ordered and declared, that the said section 238 of "The Merchant Shipping Act, 1894," shall apply in the case of Japan.

And the Secretary of State for the Home Department, the Secretary of State for the Colonies, and the Secretary of State for India in Council, are to give the necessary directions herein accordingly.

SIR,—WITH reference to my circular despatches of 15th July, 1895, 18th February, 1896, 23rd February, 1897, and 15th May, 1897, respecting Colonial nominations for Naval Cadetships, I have the honour to transmit to you a copy* of a letter from the Admiralty stating that the Civil Service Commissioners have pointed out that the reprints of the papers set at the examinations would be of assistance to candidates in the Colonies in preparing for the examination, and enclosing certain papers on the subject.

You will have the goodness to bring this matter to the knowledge of applicants for nominations, and point out to them where the reprints can be purchased. If, however, there should not be sufficient time for the applicants to provide themselves with copies from this country, it may be desirable that you should lend copies to parents and schoolmasters for a limited period, in order to enable them to judge of the qualifications of students, and facilitate the commencement of an

adequate preparation.

SIR,—I AM commanded by my Lords Commissioners of the Admiralty to acquaint you, for the information of the Secretary of State for the Colonies, that it has been pointed out by the Civil Service Commissioners that copies of the reprints of the papers set at examinations for Cadetships in the Royal Navy would be of assistance to candidates in the Colonies in preparing for the examination, and would afford some criterion by which they might estimate the chances of their success.

RULES.

1. Every male inhabitant between the ages of 18 and 55 of the subdivision shall be liable to contribute labour annually, not exceeding ten days' labour in any one year, in respect of all the purposes mentioned in sub-sections (1), (2), (13), (16), and (17) of section 6 of the Ordinance No. 24 of 1889, viz., the construction, maintenance, and protection of village paths, bridges, edandas, ambalams, madams, spouts, wells, watering

and bathing places, &c.

2. It shall be the duty of every headman to inform the committee whenever it is necessary to call out labour for one or more of the purposes enumerated in rule No 1, and on receipt of such information the committee shall, after inquiry, prepare a list setting forth the nature of work or works and the probable cost and the names of the villages interested, and shall determine the number of days' labour to be imposed in

respect of each work.

3. Wherever a school teacher has been provided by Government at the request of the inhabitants of a village, it shall be the duty of the inhabitants of the villages interested (which villages shall be defined in manner provided by rule No. 2) to construct and

keep in repair the school building.

4. Wherever a school and teacher have been provided, the parents or guardians of children shall be bound to send such of their children as are between 7 and 13 years of age in the case of Moors, and between the ages of 5 and 13 in the case of Tamils and Sinhalese, to the school provided, for five days at least in each week for nine months of the year, provided that the school is within three miles of the house of such parent or

guardian.
5. No person shall kill or take fish by means of poison, dynamite, or other

explosives from village tanks.

6. Bulls intended to be reserved for breeding purposes shall be submitted for the approval of the committee, and if approved, a certificate of approval shall be given by the

7. On or before the 15th January in each year, every owner of cattle shall give to the police vidane or arachchi of the village wherein he resides a list of all the cattle in his possession, showing the sex, age, colour, and brandmarks of each, distinguishing buffaloes from black cattle. Any cattle-owner failing to furnish a list within the time specified shall be liable to a fine of 50 cents a head of all cattle not reported by him, and if such owner fails to furnish the list when thereafter demanded by the police vidane or arachchi, he shall be liable to a fine not exceeding ten rupees.

8. On or before the 1st March in every year, every police vidane shall send to the President of the Village Tribunal a register of all cattle in his division framed from the Any police vidane neglecting, without sufficient reason, to furnish a cattle owners' lists. register within the time specified shall be liable to a fine not exceeding ten rupees.

All cattle shall be branded before attaining the age of eighteen months. unbranded cattle exceeding the age of eighteen months found at large may be seized and taken to the President of the Village Tribunal, by whom such cattle may be sold if not claimed within thirty days and the charges for securing the same may be paid.

10. If the village vidane or arachchi has any doubt as to the ownership of any animal brought before him to be branded, he shall refer the question to the President.

Black cattle once branded with the communal brand shall never be re-branded, or have their brandmarks altered, added to, or oblierated. Buffaloes may be re-branded when the marks become illegible; but this shall only be done in the presence of the village vidane, who shall report the circumstances to the committee within one

Every person who shall acquire any head of cattle in any way, except by inheritance or unless it be born in his penfold, shall obtain a cattle voucher in the Form A in the schedule annexed hereto, to be executed by the village vidane within whose jurisdiction the village of the person from whom the cattle is acquired is situated. certificate shall be issued subject to the rules laid down by the Government Agent. If the cattle thus acquired does not bear a communal brand, the purchaser or person acquiring it shall produce it before the village vidane or arachchi, who shall cause it to be branded with the brand of the village where the person acquiring resides, and shall report the circumstances within one week-to the committee.

All agreements for the future sale of cattle shall be in writing, and signed by

the parties concerned in presence of the village vidane.

14. Cattle bearing altered or defaced brandmarks and stray cattle shall be produced by the headman of the village in which they are found before the President, who shall, if there is no satisfactory proof of ownership, cause them to be sold, and shall credit the proceeds to the communal fund; provided that if any person shall within six months of the sale prove his title to the animal to the satisfaction of the said President, it shall be competent for him, with the approval of the Government Agent, to order the payment to the claimant of the proceeds of the sale after deducting all costs incurred.

15. No cattle shall be removed from one village to another or from one pattu to another between the hours of 6 P.M. and 6 A.M. without the written permission of

the village vidane.

16. Any person losing an animal shall within seven days of the loss report the same with full particulars to the vidane or arachchi of his village. The vidane or arachchi shall forward a list of lost animals every fortnight to the udaiyar of his division. The udaiyar shall make a list of lost animals in his division, and shall forward it monthly to the kachcheri through the vannia, sending at the same time a copy to the President for publication

17. When a head of cattle possessed on a voucher dies or is missing for a space of one month, the owner thereof shall return the voucher within two weeks to the kachcheri, or

to the udaiyar, who shall forward it to the kachcheri, without delay

To prevent cattle trespass, landowners shall fence and watch their fields and hen and surround their gardens with a fence or ditch, and cattle owners shall tie or pen their cattle at night, and in the day shall suspend a stick across their necks or tie them together in pairs, and shall su pend wooden bells to the necks of buffaloes.

No cattle shall be tethered upon any cart road or in such a manner as will

allow them to stray on the road.

20. Cattle seized for trespass and not claimed from the local headman within forty eight hours shall be sent to the President. If unclaimed within fourteen days, the

President or Chairman shall sell the same at public auction after due notice.

21. The carcases of all cattle that have died of disease shall be buried by the owners thereof without loss of time. The village headmen shall bury carcases of which

the owners are absent or cannot be ascertained.

22. No cattle shall be removed from any village where there is cattle disease.

23. Every proprietor of cattle or herdsman shall separate every diseased head of cattle belonging to him or in his charge from the common herd and put it into a secluded place to be determined by the village vidane or arachchi, and disinfect such place by fire or otherwise as the committee may direct; and it shall be lawful for the Chairman of the Committee to cause any head of cattle suffering from any contagious or infectious disease which is found not properly segregated to be destroyed and buried at the expense of the owner.

24. Every proprietor of cattle or herdsman who has a case of murrain or other cattle disease among his cattle shall report the same to the village vidane arachchi or udaiyar without delay, and such vidane arachchi or udaiyar shall report the same

forthwith to the vanniah.

The boundaries of all private lands shall be marked by fences, ditches, or stones according to the custom of the subdivision. Such boundaries shall be put up by the owners of both sides thereof. Any person ordered by the committee so to mark the boundary who shall refuse or neglect to comply with the order shall be guilty of an offence.

No person shall alter, deface, or wilfully injure any such boundary

Persons residing on either side of a road shall not put dirt, rubbish, timber, mate copperah, arecanut, or any other commodity in or upon the same or commit nuisance, and they shall not keep carts standing on the road longer than is necessary for the loading or unloading of the same.

28. Proprietors of paddy fields shall see that all the public paths leading through their

fields are not less than 3 ft. in width.

29. No person shall obstruct any village path, road, river, water-course, lake or ela, or through carelessness or malice injure any village path, road, river, water-course, lake or ela, or other village property.

30. The paths between several villages in the district shall be kept clear by the joint labour of the villagers; the people of each village shall clear the path leading from it to the limit prescribed by ancient custom. It shall be the duty of the police vidanes or arachchi to see that the paths are kept clear and to call out labour when necessary.

31. No persons infected with any contagious disease shall wash themselves or their

clothes in any public bathing-place.

32. No person shall befoul a village ela, village well, or spring of water used for drinking purposes by the inhabitants of any village.

2. Tenders should be submitted in duplicate, the original being forwarded to the Principal Civil Medical Officer and the duplicate direct to the Hon. the Auditor-General, both being required to be forwarded at the same

3. The tenders are to be made upon forms which will be supplied upon application to the Principal Civil Medical Officer and Inspector-General of Hospitals, or to the Medical Officer in charge of the respective hospitals, and no tender will be considered unless it is furnished on the recognized form, and the tender and the schedules attached thereto each signed in the presence of two Each tender should be for provirespectable witnesses. sioning one hospital only.

4. Every tenderer will be required to make a deposit (on applying for forms) of half the amount of security for hospitals where Rs. 400 or under are required, and Rs. 200 for hospitals where security over Rs. 400 is required; and should any person decline to enter into the contract and bond after he has tendered, or fail to furnish approved security, such deposit will be forfeited to the Crown. All other deposits will be returned after the contract has been signed. The deposit must be made at the Treasury or Kachcheri, and the deposit receipt must be produce to the officer issuing the form as his authority for making the issue. In stations where there are no Kachcheries the deposit must be made to the Medical Officer in charge of the hospital.

5. Provisions should be of the best quality, approvable

by the Medical Officer of the hospital.

6. When required, samples must be deposited.

The successful tenderers will be required to give cash security as given opposite the name of each station, and to sign the bond given in the tender for the due fulfilment of each contract within a fortnight from date of notification of acceptance of the tenders. The amount of notification of acceptance of the tenders. deposited for tender forms will form part of the cash security, which will be deposited in the Colombo

Kachcheri to credit of the Hon, the Treasurer. contractors who are required to furnish security to the extent of Rs. 500 and over may have their securties lodged in fixed deposits, if they so desire, in any one of the local Banks which they must elect, the deposit being in the name of the Hon. the Treasurer. It is left to the option of the successful tenderer to substitute at any time thereafter for cash deposited by him approved title deeds and to enter into a fresh security bond at his expense.

8. In case any person makes any alterations in his tender before forwarding it, such alteration should invariably bear his initials; otherwise the tender will be

treated as informal and rejected.

Inspector-General of Hospitals.
