# MUNICIPAL COUNCIL NOTICES.

### MUNICIPALITY OF KANDY.

Minutes of Proceedings of a Meeting of the Municipal Council of Kandy held in the Town Hall on Saturday, August 19, 1899, at 8.30 o'clock a.m., in accordance with Notice dated August 14, 1899.

Present:-The Hon, Mr. Allanson Bailey; Chairman; J. H. Sproule, Esq.; W. D. Gibbon, Esq.; E. Beven, Esq.; and Dr. J. Craib.

1. The Minutes of Proceedings of the Meeting held on July 15 last were read, confirmed, and signed by the

Chairman. 2. The tollowing documents were submitted :--Statement of Receipts and Disbursements on account of the Municipal Fund and Water-rate Accounts from close of 1898 to July 31 ; Progress Report of Works done brought up to the same date ; Returns of Cases instituted by the several Inspectors during the month of July ; and Health Officer's Report and Diary for the same month.

Resolved,—That the several statements, together with the Minutes of Proceedings of this Meeting, as required by section 90 of the Municipal Councils' Ordinance, No. 7 of 1887; and the Health Officer's report, be forwarded to the Colonial Secretary for publication in the *Government Gazette*. With reference to the Health Officer's report, it was ordered that the attention of the Health Officer be called to

the fact, as stated to the Council, that only eight carts are employed and that the scavenging is badly done, and carried on all day instead of being finished within a certain time; ordered, also, that the Inspectors be directed to enforce the by-law about the use of covered boxes for rubbish (by-law 10 of chapter XIII.). With regard to the increase in the number of buffaloes slaughtered, it was ordered that the Health Officer be informed that the Council does not approve of so many buffaloes being slaughtered.

  - (b) Reports by the several Inspectors on laundries visited during July.
  - Return of duties of Municipal police. (c)
  - (d) Statement showing the distribution of police on Municipal duties during July.

The following correspondence was submitted and read :-

- (a) Letter No. 43 dated July 7; from the Colonial Secretary, calling attention to unanswered petitions.
  (b) Letter No. 44 dated July 11, from the Colonial Secretary, inviting attention to memorial signed by Mr. L. Northway and others respecting extension of Municipal limits. Read Chairman's report thereon.

#### Sanitary Engineer.

(c) Letter No. 45 dated July 11, from the Colonial Secretary, respecting a Sanitary Engineer for the Municipality, and asking whether the appointment will be a permanent and pensionable one.

Resolved,--That the Colonial Secretary be informed, in reply, that the Council desires that the agreement be for three years. If the Engineer remains in employ of the Council not less than ten years, he will be entitled to a pension according to the rules.

### Loan for Alleys.

(d) Letter No. 46 dated July 13, from the Colonial Secretary, stating that no hope can be held out to the Council of obtaining a loan on lower than the usual terms; also, inquiring what is being done for improvement of alleys.

Resolved,—That the Colonial Secretary be informed, in reply to paragraph 3, that the alleys are being kept as clean as their present condition will allow; that no real improvement can be effected in them until they are paved and drained.

#### Electric Lighting : Government Buildings.

- (e) Letter No. 47 dated July 15, from the Colonial Secretary, respecting electric lighting of Government buildings, with Chairman's reply. (f) Letter No. 48 dated August 8, from the Colonial Secretary, calling for progress returns of collections,
- under the Road Ordinance, to June 30.

#### Drainage, Loan for Improvement of.

(g) Letter No. 49 dated August 10, from the Colonial Secretary, respecting the loan from Government for improvement of the drainage of the town. The Colonial Secretary states that the loan cannot be made until a reference to the Secretary of State is made; and that His Excellency the Lieutenant. Governor cannot apply to the Secretary of State for sanction of the loan until the scheme and estimate is submitted. That the Govarnment is aware of the purposes on which a sum of Rs. 13,731.06 has been spent, but does not understand precisely why this amount is increased to Rs. 16,300.

Resolved,-That the Colonial Secretary be requested to move His Excellency the Lieutenant-Governor to make special application to the Secretary of State to sanction the portion of the loan now applied for, as the expenditure has been already incurred on urgent works. The additional sum of Rs. 2,530 applied for is to meet the cost of rebuilding a drain which was in danger of collapsing.

#### Pension.

D. C. de Saram, as the amount for which Government is liable ; that sanction is given for the amount payable by the Municipality.

Resolved,-That the Municipal Council pay him Rs. 88 per annum, so as to bring the amount up to Rs. 232.

In accordance with notice, Mr. Sproule asked-Who are the members forming the Special Committee who suggested the ordering of water meters ?

Reply.—The Special Committee appointed in January, 1898, to deal with matters connected with the water supply.—The Chairman, Messrs, Gibbon, Philip, Creasy, and Dr. Keyt—recommended that a sufficient number of meters be ordered. The recommendation, which was submitted to the Council at its meeting in March, 1898, was adopted, and the ordering of the necessary meters authorized. Thereupon half the quantity of meters were indented for in June and the remainder in October.

(b) For a return showing the number of houses which had meters placed in them. *Reply.*—Register was laid on the table.

(c) If there will be any objection to table the minutes of the evidence, as respects alleged waste of water recorded in regard to each such house.

Reply.--There is no evidence recorded regarding waste of water. The meters have been fixed in houses in which undue consumption was reported.

(d) How many meters were indented for, and what is the aggregate cost of the same? Reply.—275 meters indented for, estimated to cost Rs. 32,365.

(e) When the Special Committee, appointed at last meeting, will meet to consider this subject? The Chairman stated that meetings of Special Committee had been called for.

July 21.—Present : Chairman and Mr. Beven; no quorum. July 26.—No meeting held, as the Chairman was ill. It was arranged that a meeting should be held on Monday, the 21st instant, at 4 P.M.

6. Mr. Sproule, in pursuance of notice, asked-Whether information was received from residents in Malabar street and from the Council's Inspector about the end of July and the beginning of August of an insufferable nuisance in that street, viz., the side drain near Lambert House, and the drain leading across the street being in a foul and fetid state emitting unwholesome smells, and thereby endangering the health of the neighbourhood, and moved for papers. The motion was seconded by Mr. Beven and carried. *Reply.*—Information was received. The papers were laid on the table.

Mr. Sproule, pursuant to notice, asked-On whom the duty devolves of attending to urgent matters such as the above?

Reply.—It is the Health Officer's duty to report such matters. The Superintendent of Works carries out any work that may be necessary.

Mr. Sproule, in accordance with notice, moved "that in order that immediate attention may be paid to such serious insanitary conditions, the Health Officer be allowed a staff of three coolies, so that he may be enabled promptly to abate the nuisance and remedy matters.' Seconded by Mr. Gibbon.

The Chairman pointed out that to have a permanent force might result in a waste of money, and stated that he has ordered that the Health Officer should be at once supplied with labour to abate nuisances. The motion was thereupon, with the leave of the Council, withdrawn.

7. The following report of the Special Committee appointed on 18th March, to consider the Chairman's Annual Report, was read. Proposed by Mr. Sproule, seconded by Mr. Beven, "that the report just read be adopted"—Carried nem. con,

Read report by Chief Inspector on state of a cesspit on premises No. 11, Trincomalee street, with recommendation by the Health Officer that the cesspit be closed on sanitary grounds. Resolved, on motion of Mr. Beven, seconded by Mr. Sproule, —That the Chairman be specially empowered in accordance with section 209 of the Ordinance No. 7 of 1887, as amended by section 33 of the Ordinance No. 1 of 1896,

to require the owner of the premises (No. 11, Trincomalee street) to close the cesspit on the said premises and to substitute a dry-earth closet.

#### Health Officer's Report for the Month of July, 1899.

SIR,-I HAVE the honour to forward my report for the month of July.

Scavenging .- The scavenging of the town has been satisfactorily performed, despite the difficulties which the contractor had to contend with, consequent on the prevalence of rinderpest among his cattle.

Water Supply.-The water supply has been good and sufficient. The quality of the water continues to be good (vide report of analysis appended).

Food Supply.—Good and ample. During the month 426 cattle, 110 buffaloes, 303 goats, 85 sheep, and 18 pigs were slaughtered. The animals were all carefully inspected and passed by me. The quality of the beef, mutton, and pork exposed for sale was good.

Drainage.—The condition of the drains, I regret to say, was unsatisfactory and insanitary during the latter part. of the month, owing to the drought which prevailed about that time. I am afraid we must be content to put up with this condition of affairs in connection with the drains till they are taken in hand and thoroughly rebuilt and put into more satisfactory sanitary footing.

I would suggest that a special gang of coolies be set apart to look after the sanitary condition of the surface trains during hot weather, so that they may be promptly cleaned and disinfected, when and where necessary.

Alleys .-- The alleys are in the same unsatisfactory condition as when last reported upon.

Laundries.-In fair order, with the exception of those at Katukele.

Dry Fish Boutiques .- Well kept. The articles exposed for sale in them were fit for food.

Bakeries .--- Clean and well kept.

Public Market.—The vegetable stalls are still much in the same unsatisfactory condition as when last reported upon. In other respects the market well kept.

Exposing Shed.—Clean and well kept.

Slaughter House.-In good condition. Clean and well kept.

Latrines.-Well kept. I see that more accommodation is being gradually provided in them for the storage of dry-earth.

Cooly Lines.—A new set of permanent lines has been built on the site opposite the railway stores, which is a great improvement to the former temporary lines. The permanent lines are in good order and well kept. The existing temporary lines should be pulled down by degrees and permanent lines substituted.

*Health.*—The health of the town has been exceptionally good. Rinderpest, I regret to say, prevailed amongst cattle, causing great mortality amongst them. I am informed, however, that the epidemic in the town is abating.

From the examination of the source of the water herein referred to, and the results obtained by analysis, I am of opinion that it is well fitted for all domestic purposes.

The Kandy water has maintained a uniform standard of purity from the time I first analyzed it.
