LAND RESUMPTION NOTICES.

WHEREAS all that allotment of land described in title plan 48,307, known as Andikkadduchchenaivalaru, or Spring Field, situated between Putukkudiruppu and Kirankulam in Manmunai pattu east of the Batticaloa District, Eastern Province, eight miles from the Fort, quarter of a mile from the navigable river called Veddukkadduturai in Kirankulam, and 44 yards from the sea-shore; bounded on the north by land described in survey lot No. 90, east by sea, venpu, or baren land, south by land described in survey lot No. 88, and west by jungle, containing in extent 497 acres more or less, which has been alienated by and on behalf of the Crown and purchased by Simon Keir, Esq., on December 22, 1843, appears to me to have been abandoned by the owner thereof for the last eight years and upwards; and whereas such owner or any person lawfully claiming under him cannot be ascertained, notwithstanding all diligent and reasonable inquiries thereunto made by me:

Now know all Men concerned that I, Francis Conrad Fisher, Government Agent of the Eastern Province, by virtue of the powers vested in me by the Ordinance No. 4 of 1887, and with the sanction of His Excellency the Governor, do hereby declare that if no claim to the said land by any person having a right or able to establish a title thereto is made to me on or before May 1, 1897, the same will be resumed by the Crown in terms of the 3rd clause of the said Ordinance.
