ABSTRACTS OF SEASON REPORTS.

WESTERN PROVINCE.

COLOMBO DISTRICT.

Paddy : the maha harvest has been reaped and threshed ; preparations for the yala are in progress.
Dry grain : no cultivation during the month.
Other products : the supply of vegetables was good and prices were moderate, but fruit was rather scarce and
dear.
Prices of staple products : rice, from Rs. 3.50 to Rs. 4.50 a bushel ; cocoanuts from Rs. 30 to Rs. 36 a thousand.
Rainfall : the rainfall was poor during the month.
Remarks on harvest prospects generally : the maha crop gathered is considered to be good.

NEGOMBO DISTRICT.

Paddy : the maha crops have been gathered ; ploughing of fields for yala has begun in some villages.
Dry grain : nil.
Other products : vegetables and fruit were scarce and dear.
Prices of staple products : rice, from Rs. 3.75 to Rs. 4.75 a bushel ; cocoanuts, from Rs. 30 to Rs. 37.50 a
thousand.
Rainfall : during the month there were only a few showers of rain.
Remarks on harvest prospects generally : the maha crops were good.

KALUTARA DISTRICT.

Paddy : the maha harvest is being reaped, and fields are being prepared for the ensuing yala.
Dry grain : nil.
Other products : fruits and vegetables are scarce throughout the district, except in Rayigam korale, where
vegetables are abundant.
Prices of staples products : imported rice, Rs. 4 to Rs. 5 a bushel ; paddy, Re. 1.50 to Re. 1.75 a bushel ; cocoa-
nuts, Rs. 35 to Rs. 60 a thousand.
Rainfall : light.
Remarks on harvest prospects generally : fair.

CENTRAL PROVINCE.

KANDY DISTRICT.

Paddy, maha : the fields in Uduwara, Yatinuwara, Harispattu, Udapalata, and Uda Bulatgama are being
harvested ; in other divisions crops are in various stages between blossoming and reaping. Crop or prospect of crop :
good in Pata Hewaheta, fair in other divisions, and poor in Uda Bulatgama, where they were damaged by recent
heavy rains.
Yala : nil.
Dry grain, maha : the hill paddy chenas in Tumpane, Harispattu, and Uda Dumbara are being harvested, and
kurakkan chenas in Pata Dumbara and Pata Hewaheta are being reaped ; amu chenas in Yatinuwara are being
harvested. Crop or prospect of crop : good in Harispattu and Pata Hewaheta and fair in other divisions.
Rainfall : sufficient.
Prices : paddy, Re. 1.50 per bushel ; kurakkan, Re. 1.25 per bushel ; cocoanuts, Rs. 6 per 100.

MATALE DISTRICT.

Rainfall registered at Matale : 2.27 inches.
 Paddy : Matale South, crops are being reaped ; Matale North, crops for the most part in ear ; Matale East, Laggala and Gangala, fields in plants and some in bud, and Pallesiyapattu fields are ripening.
 Dry grain : harvested or being harvested ; crops not very satisfactory owing to recent heavy rains.
 Tanks in Matale North full.
 Health of people : good.
 Health of cattle : good. Hoof-and-mouth disease in few villages.

NUWARA ELIYA DISTRICT.

Kotmale.—Maha cultivation : reaping continued ; prospects good. The rain during the middle of the month interfered with the gathering of paddy. No work on chenas. The supply of vegetables in the market was fair, but fruits were scarce.

Uda Hewaheta.—Maha cultivation : paddy plants one month old. There was rain for six days, which was very favourable for the young plants. Kurakkan is ripening.

Walapane.—Sowing for the maha cultivation continued ; the rain, which lasted for nine days, was favourable for the fields already sown. Kurakkan is being gathered.

NORTHERN PROVINCE.

JAFFNA DISTRICT.

Weather : there were some good showers of rain between the 13th and 18th almost throughout the district. The weather was dry by day with heavy dews at night. The rainfall registered at the Public Works Department, Jaffna, was 4.29 inches. The wind was variable during the month.

Paddy, kalapokam, 1897 : reaping and threshing of paddy were general throughout the district, but owing to the rains there had been some inconvenience and trouble experienced by the farmers with slight damage to the crop here and there.

Dry grain crops : varaku and karuttachchamy were reaped, and the outturn reported on the whole fair. The other dry grain crops—ulunthu, kollu, payaru, mondi, and chami—have been cut in some divisions, and the prospects are reported good.

Tobacco : transplanting of tobacco from nurseries is being carried on.

Prices of staple articles : paddy, Re. 1.56 per bushel ; rice, Rs. 4.50 per bushel ; kurakkan, Re. 1.50 per bushel ; varaku, Re. 1.25 per bushel ; tinaichchami, Re. 1.50 per bushel ; panichchami, Re. 1.44 per bushel.

MANNAR DISTRICT.

Rainfall : a few showers of rain fell during the month. Rainfall registered at Mannar, 1.96 in.

State of crops : reaping of the kalapokam crop is going on ; outturn good. Kampampullu and kadakkami in Mannar island reaped and threshed ; crop about 200 bushels.

Price of grain : paddy sells at from Re. 1.25 to Re. 1.50 per bushel ; rice, Rs. 3.50 to Rs. 4.50 per bushel ; kurakkan, Re. 1.25 per bushel.

MULLAITTIVU DISTRICT.

Weather : heavy rain on the 13th and 14th. The days were very hot, and there was dew at night.

State of crops : the heavy rain on the 13th and 14th has damaged the paddy crop a little. Reaping of paddy still continues. Varaku and kurakkan are nearly ripe, and will be reaped soon.

Tobacco plants are being planted and watered.

Health of people : fair.

Health of cattle : good, except in Tunukkai, where the murrain that broke out last month has not yet died out.

Price of grain : paddy, Re. 1.25 per bushel ; rice, Rs. 3 per bushel ; kurakkan, Re. 1 per bushel ; varaku, 62½ cents per bushel ; gingelly, Rs. 4.50 per bushel ; kollu, Rs. 3 per bushel ; payaru, Rs. 4.50 per bushel ; ulunthu, Rs. 4.50 per bushel.

VAVUNIYA DISTRICT.

SOUTHERN PROVINCE.

GALLE DISTRICT.

Paddy and fine grain, maha and yala : maha crop reaped in Talpe pattu, Four Gravets, Akmimana, Gangaboda pattu, and Hinidum pattu, and the harvest was middling. The maha harvest in Bentota-Walallawiti korale and Wellaboda pattu is not yet over ; yala operations in all the districts have begun.

Miscellaneous : jak, plantain, breadfruit, and vegetables are scarce ; cocoanut crop is poor, and price per thousand nuts is Rs. 30.

Price of staple products : rice, from Rs. 4 to Rs. 4.80 per bushel ; paddy, from Re. 1.75 to Rs. 2 ; kurakkan, Rs. 2.50 ; mederi, Rs. 2 ; and amu, Re. 1.50.

Rainfall : 3.90 inches.

Health : satisfactory. A few cases of chickenpox occurred in Talpe and Wellaboda pattus, but none proved fatal.

Cattle : free from disease.

MATARA DISTRICT.

Paddy : fair.

Dry grain : fair.

Prices : paddy, Re. 1.75 per bushel ; fine grain, Re. 1.75 per bushel.

HAMBANTOTA DISTRICT.

[Not received.]

EASTERN PROVINCE.

BATTICALOA DISTRICT.

Paddy : harvesting of early munmari commenced ; crop on the whole good, here and there partly damaged by flood of previous months. Sowing of later munmari over ; crop young, and attacked extensively by caterpillars, which however could not do much harm, as they were drowned by flooding the fields.

Other grains : harvesting over ; not a good crop ; much damaged by heavy rain and flood.

Price of grain : paddy, Re. 1.12½ per bushel ; other grains, Re. 1 per bushel. The price will go down soon when the new paddy comes to the market.

Rainfall : 16.21 inches. The heaviest fall in twenty hours (on 9th and 10th instant) was 10.63 inches.

Health : dysentery and measles still exist. A few cases of cattle murrain in the northern part of the district is reported, but not of a virulent type.

TRINCOMALEE DISTRICT.

Rainfall : 6.25 inches.

Paddy : the munmari crops have been harvested, and the outturn is reported satisfactory, except in a few villages of the Koddiyar pattu, where the cultivation was abandoned having been submerged by flood.

The pimmari cultivation is in progress, and the prospect is on the whole good.

Tobacco : though some damage was done to the cultivation by heavy rain at the onset, the plants look vigorous. The crops, however, will not be harvested till late in the year.

Dry grain : none.

Fishery : fishers from Negombo have just arrived, and have commenced their usual operations.

Price of articles : paddy, Re. 1.56 per bushel ; rice, Rs. 4.50 per bushel ; cassava, 4 cents per lb. ; kurakkan, Rs. 3 per bushel.

Price of wheat flour has risen considerably.

NORTH-WESTERN PROVINCE.

KURUNEGALA DISTRICT.

Wanni Hatpattu.—Paddy : maha crops in various stages ; prospects favourable. Dry grain crops being reaped ; prospects good. There were few light showers of rain about the middle of the month.

Dewamedi Hatpattu.—Paddy : maha crops mostly reaped except bala-wi, which are being reaped, and which in some parts are still young ; prospects good. Chenas being cleared for yala. Health of people and cattle good. Hardly any rain during the month.

Katugampola Hatpattu.—Paddy : maha crops being gathered ; prospects favourable. Dry grain crops being gathered ; prospects good. Health of people good ; health of cattle satisfactory. A few showers of rain fell during the month.

Hiriyala Hatpattu.—Paddy : maha crops in various stages ; prospects good. Dry grain mostly reaped and gathered ; the rest are maturing ; prospects good.

Except a few cases of fever and sore-eyes health of people satisfactory. Health of cattle good.

Dambadeni Hatpattu.—Paddy : maha crops reaped and threshing commenced, prospects favourable. Dry grain crops reaped ; chenans being cleared for yala. Health of people satisfactory ; health of cattle good.

Wendawili Hatpattu.—Paddy : maha crops being gathered ; prospects good. Dry grain crops being gathered ; prospects good. Health of people and cattle good. Not much rain during the month.

PUTTALAM DISTRICT.

Paddy : in Demala Hatpattu the extent cultivated throughout the division is 1,448 acres. The crops are young, earing, ripening, and being gathered, and the prospects are very good. In Akkarai pattu north also the crops are in very good condition. In Pomparippu pattu the crops are in fine condition, of different stages, and some are being harvested and stacked. Two rogue elephants have done much damage to the crops in the villages Pallakandel and Moolakandel ; prospects very good.

In the Puttalam division the crop is mostly being reaped, and is very good. Younger crops in Rajakumara-wanni pattu damaged by flies.

Dry grain : in Demala Hatpattu the extent cultivated is 489 acres ; crops flourishing, and in some of the pattus being gathered. The crops are good in the Puttalam division.

Staple products : the price of rice varied from Rs. 3 to Rs. 4 per bushel ; paddy, from Re. 1.25 to Re. 1.50 per bushel ; and cocoanuts, from Rs. 3.50 to Rs. 4 per hundred.

Rainfall : in earlier part of the month there was a good shower of rain. The rainfall registered in Puttalam is 2.14 inches.

The weather was favourable to health and the crops.

CHILAW DISTRICT.

Pitigal Korale North.—The paddy cultivated in kekulan in this division is being reaped in some of the villages. The recent rain has damaged some of the crop.

Pitigal Korale Central.—The goiyas are now busily engaged in reaping the maha crops. It was not damaged by the recent rain, and the return is fairly good. Fields which were not sown for the maha harvest are now being ploughed for the yala harvest.

Pitigal Korale South.—There have been no sowings of either paddy or fine grain in the division during the month, while the earlier sown paddy of Kamalpalata has been already reaped and gathered in, and that of Otarapalata is nearly so. The crops of the latter are reported to be good. Fields and chenans in Otarapalata are being prepared for yala paddy and fine grain sowing.

NORTH-CENTRAL PROVINCE.

ANURADHAPURA DISTRICT.

Rainfall : at Anuradhapura 1.21 inch. In Nuwaragam, Hurulu, and Kalagam palatas there were a few showers of rain early in the month ; since then the weather has been dry and hot. In Tamankaduwa there has been a fair fall of rain during the month.

Paddy : in Nuwarakalawiya the fields are either being sown or are with young paddy plants, or the crops are earing and maturing. In Tamankaduwa the fields are either being sown or are with young plants. A good harvest is anticipated throughout.

Tanks : in Nuwaragam palata all the tanks have sufficient water for paddy cultivation. In Hurula palata some tanks are full. Those that breached have been repaired and are half full. In Kalagam palata some tanks are full and some are half full. In Tamankaduwa all the tanks are full.

Health of cattle : satisfactory, but for a few occasional cases of murrain in Kalagam palata.

Health of people : there is fever throughout the Province.

PROVINCE OF UVA. •
BADULLA DISTRICT.

Paddy : yala crop-gathered ; yield was good. Paddy plants on malan fields thriving well. Cultivation for maha commenced.

Chenas : Indian corn and kurakkan crop being harvested. The yield has been indifferent, the plants having suffered from the heavy rains in November and December.

Fruit and vegetables : plentiful and cheap.

Weather : has been dry except for a few showers. Fever, chickenpox, measles, and dysentery are prevalent in different parts of the Province.

Health of cattle : a few cases of murrain appeared in Kendagolla village.

• PROVINCE OF SABARAGAMUWA.
RATNAPURA DISTRICT.

Paddy : nearly the whole of the first maha crop throughout the district has been harvested with a fairly good outturn. The second maha fields have been sown, and the plants are progressing well. The yala fields are now being prepared for cultivation ; prospects are favourable.

Fine grain : the chenas cultivated for the maha harvest have been reaped. Crops are reported to be satisfactory everywhere except in Kadawata and Meda korales, where, owing to the drought which prevailed, crops have suffered, and yielded a poor outturn. In Kuruwiti and Kukulu korales owiti lands are now being prepared for cultivation.

Cattle : no murrain among cattle has been reported. The health of the people is satisfactory.

KEGALLA DISTRICT.

Paddy (maha) harvest is nearly over ; the yield is generally good.

Dry grain : amu is being reaped ; the outturn is good.

Prices : paddy, Re. 1.25 to Re. 1.50 per bushel ; hill paddy, Re. 1 to Re. 1.25 per bushel ; kurukkan, 75 cents to Re. 1 per bushel ; mun, Rs. 3.25 to Rs. 3.50 per bushel ; iringu, Rs. 2 to Rs. 2.50 per bushel ; amu 62 cents to 75 cents.

Rainfall : registered at Ambanpitiya, 4 inches ; Ruwanwella, 3.54 inches.

Cattle disease : the district is free from cattle disease.

Health of people is good.

RENT SALES.
