## ABSTRACTS OF SEASON REPORTS.

### ABSTRACTS OF SEASON REPORTS FOR THE MONTH OF MARCH, 1897.

#### WESTERN PROVINCE.

##### COLOMBO DISTRICT.

Paddy : preparations are being made for yala cultivation.

Dry grain : no cultivation worth reporting.

Other products : the supply of vegetables was fair and prices were reasonable, but fruit was rather scarce and dear.

Prices of staple products : rice, from Rs. 3.50 to Rs. 5 a bushel ; cocoanuts, from Rs. 30 to Rs. 35 a thousand.

Rainfall : there was very little rain during the month.

Remarks on harvest prospects generally : the dry weather has retarded the yala cultivation.

##### NEGOMBO DISTRICT.

Paddy : ploughing of fields for yala is in progress.

Dry grain : nil.

Other products : fruit and vegetables were scarce and dear.

Prices of staple products : rice, from Rs. 3.75 to Rs. 4.75 a bushel ; cocoanuts, from Rs. 30 to Rs. 35 a thousand.

Rainfall : very little rain during the month.

Remarks on harvest prospects generally : the drought has hindered preparations for yala cultivation.

##### KALUTARA DISTRICT.

Paddy : the maha harvest was reaped and gathered during the month. Preparations are being made for the yala cultivation.

Dry grain : nil.

Other products : fruits are scarce throughout the district, and so are vegetables except in Rayigam korale, where they are abundant.

Prices of staple products : imported rice, Rs. 3.50 to Rs. 5 a bushel ; country rice, Rs. 4 to Rs. 4.50 a bushel ; cocoanuts, Rs. 35 to Rs. 50 per 1,000.

Rainfall : light.

Remarks on harvest prospects generally : fair.

#### CENTRAL PROVINCE.

##### KANDY DISTRICT.

Paddy, maha : the harvesting of paddy fields in Udunuwara, Yatinuwara, Harispattu, Pata Dumbara, and Uda Dumbara is over ; in Pata Hewaheta some fields are being harvested ; and in others the paddy is just getting ripe ; and in Udapalata they are being threshed. Crop or prospects of crop : good in Pata Hewaheta and fair in other divisions.

Yala : the fields in Udunuwara, Yatinuwara, and Harispattu are being ploughed ; and in Pata Hewaheta they are being sown. Crop or prospects of crop : too early to form an opinion.

Dry grain, maha : in Udunuwara and Yatinuwara chenas are being cleared for hill paddy and kurakkan ; in Pata Dumbara and Pata Hewaheta reaping of kurakkan is over. Crop or prospect of crop : good in Pata Hewaheta and fair in Pata Dumbara.

Yala : in Harispattu, Pata Dumbara, Uda Dumbara, Pata Hewaheta, and Uda Bulatgama chenas are being cleared for kurakkan cultivation.

Rainfall : sufficient.

Prices : paddy, Re. 1.50 per bushel ; kurakkan, Re. 1.25 per bushel ; cocoanuts, Rs. 4 per 100.

##### MATALE DISTRICT.

Rainfall registered at Matale, 2.95 inches.

Paddy, Matale South : maha harvest nearly over ; yala cultivation commenced. Matale East : Gangala fields in blade ; Laggala fields in various stages ; and Pallesiyapattu fields are being reaped. Matale North : maha harvest nearly over ; yala cultivation commenced in two korales. Crops fairly good.

Dry grain : maha crops harvested or being harvested. Few chenas being cleared in Matale South for yala. Tanks in Matale North : more or less half full.

Health of people : good. Measles in a few places.

Health of cattle : good.

NUWARA ELIYA.

[Report not received.]

#### NORTHERN PROVINCE.

##### JAFFNA DISTRICT.

Weather : there were some good partial showers of rain in the Valikamam east, Valikamam north, Valikamam west, Pachchilaipali, and Punakari divisions, and slight rain in the other divisions between the 26th and 28th. The rainfall registered at the Public Works Department, Jaffna, was 0.15 in. The wind was variable during the month. The heat was great during the day as usual.

Paddy, kalapokam, 1897 : reaping of paddy was over in all the divisions, and threshing was continued in the divisions of Pachchilaipali, Karaichchi, Punakari, and Islands.

Dry grain crops : ellu and kurakkan are being sown in some parts.

Tobacco : tobacco mostly in plants, and are being watered from wells and kenies.

Price of staple articles : paddy, Re. 1.56 per bushel ; rice, Rs. 3.75 per bushel ; kurakkan, Re. 1.45 per bushel ; varaku, Re. 1.35 per bushel ; tinaichchami, Re. 1.50 per bushel ; panichchami, Re. 1.40 per bushel.

## MANNAR DISTRICT.

Rainfall: smart showers of rain fell on the 14th and at the close of the month. Rainfall registered at Mannar is 71 in.

Cultivation: reaping of kalapokam paddy crop continues; outturn reported good, though the crop was damaged by flies. The dry grain crops of the Mannar island have been threshed; outturn below average. More rain wanted for sirupokam. Tobacco in plants. Less extent cultivated this year owing to heavy rain. Later planting attacked with the disease called "karadi-noi."

Price of grain: paddy, Re. 1.50 per bushel; rice, Rs. 3.75 per bushel; kurakkan, Re. 1.25 per bushel; kadai-kanni, Re. 1 per bushel; kampampullu, Re. 1 per bushel.

## MULLAITTIVU AND VAVUNIYA.

## SOUTHERN PROVINCE.

## GALLE DISTRICT.

Paddy: sowing for yala is in progress. Dry weather has proved unfavourable to cultivations.

Dry grain: sowing is going on only in Hinidum pattu.

Miscellaneous: breadfruit, jak, plantain, and other vegetables are in fair supply. Coconut crop middling; price per thousand Rs. 35.

Price of staple products: rice, Rs. 4 to Rs. 4.80 per bushel; paddy, Re. 1.75 to Rs. 2 per bushel; kurakkan, Rs. 2.50 per bushel; medefi, Rs. 2 per bushel; and amu, Re. 1.50 per bushel.

Rainfall: 56 in.

Health: satisfactory. Several cases of chickenpox have been reported from Talpe pattu and Four Gravets, but none proved fatal.

Cattle: free from disease.

## MATARA DISTRICT.

Paddy: fair.

Dry grain: fair.

Prices: paddy, Rs. 2 per bushel; fine grain, Re. 1.50 per bushel.

## HAMBANTOTA DISTRICT.

Paddy and fine grain: in West Giruwa pattu ma-wi and fine grain crops have been reaped. Bala-wi is suffering for want of rain.

In East Giruwa pattu: fields are being prepared for yala cultivation. Fields at Tissa are ripe and in blossom;

Walawe and Magama fields in blossom; some reaped.

Rainfall: some heavy showers in East Giruwa and Magam pattus; very little rain in West Giruwa pattu.

Health: general health good.

Cattle: no disease except some foot-and-mouth at Walasmulla.

Price: rice, Rs. 4 to 4.50 per bushel; paddy, Re. 1.50 per bushel; kurakkan, Re. 1.25 to Re. 1.50 per bushel.

## EASTERN PROVINCE.

## BATTICALOA DISTRICT.

Paddy: harvesting of early munmari is still going on. Later munmari good, though slightly damaged by caterpillars. Sowing of early pinmari is in progress. Caterpillars attacked the young plants, but have not done much damage.

Other grains: harvesting over.

Price of grain: paddy gone down to Re. 1 a bushel.

Price of other grains: Re. 1.25 a bushel.

Rainfall: 2.72 inches.

Health: measles and dysentery, which prevailed in town and adjacent villages, is now on the decrease. In the outlying districts, however, it is on the increase.

Cattle murrain is dying out. Only cases of a mild type at present exist.

## TRINCOMALEE DISTRICT.

Rainfall: 1.29 in.

Paddy: the pinmari cultivation in fair progress in the Koddiyar and Kaddukkulam pattus. Lands under Kantalai in the Tambegam division are just being prepared for the cultivation. The early pinmari cultivation in the Koddiyar pattu is in blossom, but has been attacked by insects; the prospect of the cultivation is otherwise good.

Tobacco: crops being harvested, expected to be a fair one.

Dry grain: none.

Fishery: moderate.

Health of people: fever prevails to a great extent, the temperature being excessively high; a few cases of measles reported.

Price of articles: paddy, Re. 1.25 per bushel; rice, Rs. 3.75 per bushel; kurakkan, Rs. 3 per bushel; cassava, Rs. 2.50 per cwt.

## NORTH-WESTERN PROVINCE.

## KURUNEGALA DISTRICT.

Wanni hatpattu: maha paddy crops mostly reaped; remaining crops now ripe and being reaped. Prospects favourable. Dry grain crops all reaped; prospects good. There were a few showers of rain during the month. Health of people and cattle good.

Dewameddi hatpattu: maha paddy crops mostly reaped, except bala-wi, which is, in some parts, still being reaped. Chenas being cleared for yala. There was a shower or two of rain during the month. Health of cattle good, except that there is murrain in one korale. Health of people good.

Dambedeni hatpattu : maha paddy crops being thrashed. Chenas being cleared for yala. Except a few cases of measles and chickenpox health of people good. Health of cattle good.

Hiriyala hatpattu : maha paddy crops mostly reaped, rest maturing and about to be reaped. Chenas being cleared for yala. Health of people good, except a few cases of measles and chickenpox. Health of cattle good.

Katugampola hatpattu : maha paddy crops reaped and stacked. Prospects favourable. Dry grain being gathered. Four showers of rain during the month. Health of people good. Health of cattle good, except that there is murrain in one korale.

Weudawili hatpattu : no crops, nothing sown. There were a few showers of rain during the month. Health of people and cattle good.

#### CHILAW DISTRICT.

Nothern division : maha paddy reaped and stacked in some villages, and in others people are engaged in reaping and gathering. Some delay is due to the recent rains which prevented immediate removal of the crops when reaped to the threshing floor.

Central division : maha crop was gathered in most of the villages during the month, and threshing is going on everywhere. The return is reported to be very much less than last year.

Fields which were not sown for the maha harvest have been sown for the yala harvest in many villages.

Chenas are now being felled and cleared for the yala cultivation. The weather is favourable for both paddy and fine grain cultivation.

Southern division : yala sowings are in progress, and about 158 bushels of paddy have been already sown during the month. There has been no fine grain sowing. The recent showers are expected to prove beneficial to the crops which appear to be thriving.

#### PUTTALAM DISTRICT.

Paddy : in Demala hatpattu 1,448 acres of mud land have been cultivated. The crops are ripening and being gathered, and the prospects are very good. In Akkarai pattu north and Pomparippu pattu also the crops have been reaped and stacked, and are good. In Puttalam pattu the harvest, which is good, is just over. In Akkarai pattu south also the crops are good and are being harvested, some are still young. In Rajakumara Wannipattu much of the crops has been damaged by flies ; the crops are in various stages of growth.

Dry grain : in Demala hatpattu 489 acres of chana land have been cultivated ; the crops have been gathered, and are good ; no fine grain has been cultivated in Kalpitiya district. In the Puttalam division the crops are good, and the harvest is over.

Staple products : the price of rice varied from Rs. 3 to Rs. 4 per bushel ; paddy, from Re. 1.25 to Re. 1.50 per bushel ; kurakkan, Re. 1 per bushel ; and cocoanut, from Rs. 3 to Rs. 4 per 100.

Rainfall : although the sky often looked cloudy, there has not been much rain ; only one good shower fell on the 10th instant. The rainfall registered in Puttalam town is 2.30.

### NORTH-CENTRAL PROVINCE.

#### ANURADHAPURA DISTRICT.

Rainfall : at Anuradhapura .67. There has hardly been any rain throughout the Province during the month.

Paddy : in Nuwaragam palata the fields have been ploughed, and some have been sown for the yala harvest. In Hurulu and Kalagam palatas they are either being sown, or the crops are earing and maturing, whilst others are being reaped. The crops of some fields in Nuwaragam palata are being damaged by flies.

Tanks : in Nuwaragam palata many tanks are still full, and a few from which water has been let out for irrigation purposes are less so. In Hurulu and Kalagam palatas some tanks are full and some are half full. In Tamankaduwa all the tanks are full.

Health of cattle : satisfactory. There are, however, occasional cases of murrain in the Nuwaragam palata.

Health of people : the health of the people during March was satisfactory.

### PROVINCE OF UVA.

#### BADULLA DISTRICT.

Paddy : preparation for the maha harvest is going on, and the malan fields are earing and ripening. Judging from appearances there is likely to be a good harvest.

Kurakkan : gathering of chena crops is nearly over, but the crop is not so plentiful as that of last year, owing to the growth of weeds after the heavy rain at the time of sowing.

Indian corn : crop is fair, and the in-gathering is nearly over.

Weather : dry, with occasional showers of rain.

Health of people : generally good. A few cases of measles in Yatikinda and Udukinda.

Health of cattle : good. A few cases of mouth-and-hoof disease in Yatikinda.

### PROVINCE OF SABARAGAMUWA.

#### RATNAPURA DISTRICT.

Paddy : in Kuruwiti korale the first maha crops have been harvested and the second maha crops are blossoming. The present rains are unfavourable to the blossoming crops. In Nawadun korale maha crops have been gathered with a fairly good outturn. Fields for the yala harvest are being prepared for sowing, and the present weather is favourable for the operations. In Atakalan korale the second maha crops are one to two months old, and the yala fields are about to be sown ; prospects are favourable. In Kolonna korale maha crops are blossoming, and some are half-grown. Fields for the yala are being prepared for sowing. In Kadawata and Meda korales the peramaha crops are being reaped, some are in blossom, and some are just sown. The yala fields are being ploughed ; prospects are favourable. In Kukulu korale yala fields have been sown.

Fine grain : in Kuruwiti korale chenas and owitas are now being prepared for sowing. In Kolonna, Kadawata, and Meda korales maha chena have been reaped and harvested. The outturn was fair.

In Kukulu korale, el-wi chenas for yala harvest are being sown, and preparations are rapidly being made for sowing owiti land.

Cattle : no murrain among cattle has been reported.

The health of the people is satisfactory.

## KEGALLA DISTRICT.

Paddy, maha : harvest is over : the yield is generally good. Ploughing operations for yala have commenced in parts of the district.

Dry grain : chenas are being cleared in parts of the district for hill paddy and kurakkan cultivation.

Prices : paddy Re. 1·12 to Re. 1·25 per bushel ; hill paddy, Re. 1 to Re. 1·12 per bushel ; kurakkan, 75 cents to Re. 1 per bushel ; mun, Rs. 3·25 to Rs. 3·50 per bushel ; iringu, Rs. 2 to Rs. 2·50 per bushel ; amu Rs. 0·62 to 75 cents per bushel.

Rainfall : registered at Ambanpitiya 4·91 (up to 29th) ; at Ruwanwella 5·54 (up to 29th).

Cattle disease : the district is free from cattle disease.

Health of people is good.
