But we seriously think that a journal which professes to provide its readers with authentic intelligence, is guilty of a grave breach of confidence in pandering to the mercenary machinations of such correspondents.

Our readers will not probably have forgotten how strongly some of the London journals, especially the *Times*, condemned the *Publicist* of the French Emperor, as a great political mistake, and one that must tend to weaken his position. We now read that all the Sovereigns of Europe have conveyed their congratulations to the Emperor on the result of the plebiscite, which is felt, and acknowledged to have been an immense gain to the cause of order and progress, as against the partisans of Revolutionary up-heavings.

THE STEAMER COLLINGWOOD.—This steamer which anchored on our roads on Friday evening last, has made a very fair run out to Ceylon, the passage from Liverpool having occupied 37 days. She made the passage through the Suez Canal in eighteen hours, meeting with no difficulties whatever.

ICE.—We understand that it is in contemplation by the Agent of the Tudor Ice Company to land one or two cargoes of Ice at Colombo, when it will be sold at the low price of 14d the pound, and as this description is usually preferred to the machine-made article, we do not doubt that a ready sale will be found for it.

THE ORIENTAL BANK.—Mr. H. J. Dick returned to Ceylon by the last steamer from Europe, and has already proceeded to Kandy, where the Bank's constituents will give him a hearty welcome, as whatever may be written about "Sham Banking" especially in the central capital, we believe Mr. Dick to be free from any such weakness. Mr. Ross has proceeded from Kandy to take charge of the Galle branch of the same Bank. We understand that Mr. Duff will return to Ceylon in December, but not in connection with the Bank.

THE SOUTH GATE.—A Correspondent writes to us enquiring the cause of the completion of the new entrance to the Fort in substitution of the South Gate, urging the great inconvenience of the present entrance through Hospital Square. We can account for the delay only on the supposition that it is caused by the desire to economise labour in the removal of the old materials, to effect which it is desirable that the cabook and earth be not moved more than once, and then to be placed in the precise spot where they are most required. We hope to see the new South entrance completed and opened within a month from this time.

MILITARY.—15th July, 1870. Leave of absence is granted to Captain E. B. St. John, 73rd Regiment, from 1st August 1870, to 31st July 1871, to proceed to England on urgent Private affairs.

DIRECT TAXATION.—The Revenue derived from Commutation, under the "Thoroughfare Ordinance" in 1868, was £2,103,85, 8d. (£16,506 3s. 9d. being Commutation of the year, and £5,597 4s. 11d. balances, and arrears, &c. of former year) and the expenditure £1,462 0s. 8d., including charges for Establishment and Rent Houses.

The steady augmentation of the funds from this source appears to establish two facts: 1st, that there has been an assured increase of the population since the Ordinance No. 8 of 1863 was brought into operation, (the actual contributors to it are 137,220 persons, against 131,355 in 1859); and 2nd, that the population is not, as is often supposed, wholly incapable of intelligent submission to a system of direct taxation.

The partial success of household assessment in the towns and some villages for the support of the Police, seems to confirm the latter view, and makes it probable, that it will not be found impossible, as soon as the survey of the country admits of it, to introduce a general and taxable place of the existing taxes on grain, whether imported, or of native growth; which act as a discouragement to trade, and fall, with undue severity, on a branch of industry, which in the interest of the whole community should be fostered perhaps beyond all others.

The Faddy Tax of the Western Province being set down as yielding £30,000, and the Duty on Grain imported and consumed in it being valued at £50,000, and the area of cultivated land being taken at the Blue Book estimate of 631,827 acres, it will not be a difficulty to perceive that, at the rate of 4s. an acre on all cultivated land, (the Faddy tax probably is equivalent to 7s. per acre on rice lands) a sum could be realized more than sufficient to cover what the Government would be called upon to relinquish. And what is true, in respect of the Western Province, will, I think, be found equally true in respect of the other Provinces, as well as of the Island generally, and justify the adoption of the principle of the existing inequalities of taxation, which, weighing heavily on the local producer of food, have a tendency to perpetuate the dependence of the people for their subsistence on foreign supplies. *Administration Report, 1869.*

TEMPLE SERVICE TENURES.—A correspondent of the *Examiner* writing from Ratnapoora says:—"We have seen numerous notices issued to Tenants describing the nature and extent of services they are bound to perform, and in these writings certain landlords, who are as greedy 'devouring lions,' have taken the precaution of doubling and trebling the services due; and if Mr. Dickson will not discover this fact, it will be nothing less than a leap from the frying-pan to the fire, and the objects of Government will be frustrated. No one agrees to money payment, and a Government which daily sees the enormous number of defaulters under the Road Tax Ordinance ought to have thought of this. The landlords can very easily adduce evidence to prove whatever they wish, and it is an undisputed fact that headmen who hold offices under Government, use their influence and compel the poor tenants to do more than the ordinary services, and such extra exactions when continued or several years, is considered a part of the customary services. If Mr. Dickson will not take this into consideration and make full allowances for the disparity between lord and tenant in their ability to adduce proof, justice will not be done."

AUDULTATION OF COFFEE.—Mr. Harrison has addressed a letter to the Planters' Association on the subject of the adulteration of Coffee in England. He does not believe in the efficacy of any movement that may be made with a view to ask for legislative action on the subject, and says:—"Until public opinion in England is awakened on this subject, and insists upon such a law being enacted as shall make the knowingly tendering or offering for sale or selling of counterfeit food an offence tantamount to the knowingly tendering or uttering counterfeit coin, and punishable in the same manner, we can do nothing to stop adulteration of Coffee."

EDUCATION IN THE WESTERN PROVINCE.—There are 77 Government Schools in the Province, excluding the Academy which costs £2,620 15s. 7d., maintained at an expense to

the public of £4,581 3s. 9d., a portion of which is refunded in the shape of fees levied on the pupils, and affording education to 55,854 children of both sexes. Thirteen of these schools are established within the limits of the Town of Colombo, and are attended by a daily average of 1,020 pupils, and the fees recovered on them amount to £418 17s. 4d.

There can be no question but that these schools would be more generally frequented, if by the introduction of an uniform scale levied on the community, the means of Education were placed more within the reach of the lower classes.

The attempt to interest the people in the projects for the extension of schools, which are under consideration, and to place the necessary funds within the reach of the Government, might be first made in towns and the larger villages, by the imposition of a small household assessment for the support of primary schools, to which pupils should be admitted free from every other charge.

This would not only lighten the cost of education to parents, who already make large sacrifices for the benefit of their children, but would induce others, who are less sensible of the advantages of education, to send their children to school, if only to secure their money's worth; and render possible a large increase of out-station schools, which, owing to more regular inspection, are answering all reasonable expectations, and steadily advancing those brought under their influence, to a higher social and intellectual condition.

The addition to Girls' schools is, however, the great desideratum of the day, and if the new Director of Public Instruction do no more, within the next twelve months, than establish the Normal Schools he contemplates for the training of Teachers, by which Girls' schools can be multiplied, and those for Boys be provided with superior Masters, he will confer a boon on the people of the country which will entitle him to their lasting gratitude, and repair the consequences of the short-sighted policy in 1855, which abolished the only Institution which existed in the Island for qualifying persons for the work of instruction. *Administration Reports 1868.*

the public of £4,581 3s. 9d., a portion of which is refunded in the shape of fees levied on the pupils, and affording education to 55,854 children of both sexes. Thirteen of these schools are established within the limits of the Town of Colombo, and are attended by a daily average of 1,020 pupils, and the fees recovered on them amount to £418 17s. 4d.

There can be no question but that these schools would be more generally frequented, if by the introduction of an uniform scale levied on the community, the means of Education were placed more within the reach of the lower classes.

The attempt to interest the people in the projects for the extension of schools, which are under consideration, and to place the necessary funds within the reach of the Government, might be first made in towns and the larger villages, by the imposition of a small household assessment for the support of primary schools, to which pupils should be admitted free from every other charge.

This would not only lighten the cost of education to parents, who already make large sacrifices for the benefit of their children, but would induce others, who are less sensible of the advantages of education, to send their children to school, if only to secure their money's worth; and render possible a large increase of out-station schools, which, owing to more regular inspection, are answering all reasonable expectations, and steadily advancing those brought under their influence, to a higher social and intellectual condition.

The addition to Girls' schools is, however, the great desideratum of the day, and if the new Director of Public Instruction do no more, within the next twelve months, than establish the Normal Schools he contemplates for the training of Teachers, by which Girls' schools can be multiplied, and those for Boys be provided with superior Masters, he will confer a boon on the people of the country which will entitle him to their lasting gratitude, and repair the consequences of the short-sighted policy in 1855, which abolished the only Institution which existed in the Island for qualifying persons for the work of instruction. *Administration Reports 1868.*
