ABSTRACTS OF SEASON REPORTS FOR THE MONTH OF NOVEMBER, 1898.

#### WESTERN PROVINCE.

COLOMBO AND NEGOMBO DISTRICTS.

Paddy: maha paddy plants are about 4 months old. A fairly good harvest is expected.

Dry grain : no cultivation worth reporting.

Other products : the supply of vegetables was good and prices were moderate, but fruit was rather scarce and dear. Prices of staple products : rice, from Rs. 3 50 to Rs. 5 a bushel ; cocoanuts, from Rs. 28 to Rs. 33 a thousand. Rainfall : during the month the rainfall was abundant.

Remarks on harvest prospects generally : a fairly good maha harvest is expected. Observations on the health of the inhabitants : with the exception of a few cases of dysentery and chickenpox in some parts of the district, the health of the inhabitants was generally good.

#### KALUTARA DISTRICT.

Paddy: the sowing of the maha harvest is over. In the totamunas the plants have been somewhat damaged by the recent flood. In the Pasdan korale west an unusually large extent has been cultivated. The paddy weevil has appeared in last harvest's grain.

Dry grain : nil.

Other products : fruits and vegetables are scarce throughout the district.

Prices of staple products : rice, Rs. 4 to Rs. 5 a bushel in the totamunas and Rayigam korale, and Rs. 5 to Rs. 6 in the Pasdun korales; cocoanuts, Rs. 25 to Rs. 30 per thousand in the totamunas and Rayigam korale, and Rs. 40 to Rs. 50 in Pasdun korales.

Rainfall : heavy. Remarks on harvest prospects generally : fair.

Health of people : good on the whole.

Health of cattle : good. A few cases of murrain have occurred.

#### CENTRAL - PROVINCE.

#### KANDY DISTRICT.

Paddy, maha: the paddy plants in all the divisions are being transplanted. Yala : nil.

Dry grain, maha: hill paddy chenas in Yatinuwara and Pata Dumbara are ripening, and blossoming in Udunuwara. Amu is about to blossom, and in Pata Hewaheta kurakkan plants are in blade.

Yala ; nil.

Rainfall : sufficient.

Prices ; paddy, Re. 1 50 per bushel ; kurakkan, Re. 1-25 per bushel ; rice, Rs. 4 per bushel ; cocoanuts, Rs. 3 50 per 100.

Health of people : good. There were a few cases of chickenpox, measles, and fever in Yatinuwara, Tumpane, and Harispattu.

Health of cattle : good.

#### MATALE DISTRICT.

Rainfall : registered at Matale 7.03 in.

Paddy : maha fields in plants. A few, chiefly godakumbura, are still being sown. Dry grain : sowing nearly over. Weather favourable.

Tanks in Matale north : more or less three-quarter full.

Health of cattle : good.

Health of people : bad. Fever and dysentery prevail to a great extent.

#### NUWARA ELIYA DISTRICT.

Kotmale.--Paddy fields : reaping commenced ; satisfactory results. Kurakkan chenas : reaping continued ; prospects good. There was sufficient rain during the month. Vegetables : there was a good supply, but little or no Health of population : measles was prevailing in some villages. Health of cattle : good. Uda Hewaheta.—Paddy fields : ready for reaping ; an excellent crop is anticipated. Chenas sown with kurakkan fruits.

and Indian corn. Half of the month was wet. Health of population : chickenpox, dysentery, and sore-eyes prevailed in some korales. Health of cattle : satisfactory. Walapane.—Paddy fields : reaping commenced in some korales, with good results. Sowing of kurakkan chenas continued. There were fifteen rainy days during the month. Prices of grain : rice, Rs. 4.25 per bushel ; paddy, Re. 1.871 per bushel ; gram, Rs. 4 per bushel.

Fine grain : some chenas have been sown and the crops are reported to be thriving.

Health of the people : good in East and West Giruwa pattus, but in Magam pattu fever has been reported from several villages.

Health of cattle : cattle are free from disease in East and West Giruwa pattus, and in Magam pattu hoof-and-

mouth disease reported last month is fast disappearing. Weather : the wet season has fully set in, and there was much rain throughout the month.
