Local & General.

—CAVE'S CHRISTMAS NO. We have received a copy of Cave's Monthly Review for December which is very neatly gotten up and is full of suggestions for the best use of one's money for the approaching Christmas season.

—HIGH WAGES. Mr. Geo. D. Murier has received £ 10,000 for a story which is to appear in an American Magazine during the coming year.

—FREE CHURCH OF SCOTLAND. Rev. Wm. Miller L.L.D., Principal of Madras Christian College, has been re-elected Moderator of the General Assembly of the Free Church of Scotland. It is expected that he will leave India for England some time soon.

—DIRECTOR OF PUBLIC INSTRUCTION. A number of Managers from Colombo waited upon the Director of Public Instruction on the 10th inst. and made known their grievances. The *Ceylon Observer* says,—"while expressing sympathy with the Deputation Mr. Coll, we believe, informed the gentlemen that it was too late for him to do anything for them as the revisions had been sanctioned by the Government. The alterations however had not become an operative measure and the Director advised the gentlemen to memorialize Government on the subject, and it is just possible we understand that a *via media* will be found out of the difficulty."

—PT. PEDRO MAGISTRATE. From the *Government Gazette* we learn that Mr. W. L. Kinderley has been appointed Commissioner of Requests and Police Magistrate for Pt. Pedro and Chavagocherry with effect from the 12th inst. Mr. J. J. Cassie Chetty will continue to act for the present.

—ILLEGAL SALE OF INTOXICANTS. In regard to illicit sellers the *Ceylon Patriot* says,—"The illicit seller is often an ally of the tavern keeper. He is only an agent who sells for the tavern keeper in places where the tavern keeper cannot sell himself." Too great vigilance cannot be exercised with regard to this matter.

—WELFARE MISSION. Held a temperance meeting at 7 o'clock last night, and we hope similar agitations will take place at other places.

—ABNORMAL RAINFALL. Batticoota and vicinity came in for something like a cloud burst on the 2nd inst. There was registered the next morning a rainfall of over 9 inches the heaviest rainfall in 24 hours that we have had in the peninsula for years. It is reported that some damage has been done to the paddy crop in Batticoota and the Islands.

—TEACHERS! TEACHERS! Be careful for it is reported that the New Code for 1896 will require intelligent reading in the lower standards, i. e. being able to give definitions of words, and meanings of phrases.

—MR. H. L. WARD. The Burgess member in Council has returned from England and was present at the Council sitting on Wednesday the 11th inst.

—GYMNASIA MEET. The committee appointed to supervise the sports on Christmas met in the District Court House on the evening of the 16th inst.

—EXAMINATIONS. The Cambridge Senior and Junior local Examinations were held in Queen's House in Fort commencing from the 14th inst. Two candidates presented themselves for the examination, one for the senior and the other for the Junior. The Madras Matriculation examination was held in the "Central College" hall on the 16th inst. and following days. There were only three candidates for the examination. The general rush appears to be for the Calcutta examinations, for we understand that there are about 100 students who are prepared to be enlisted for the Calcutta entrance exams.

—JAFFNA NOTES. District Court Mr. F. J. de Lopera, our District Judge, has been promoted as District Judge of Galle, with effect from 16th inst. During the short time, he was in Jaffna, he earned the respect and esteem of the bar and the public for his good qualities.

Mr. H. L. Cameron of Anuradhapura succeeds Mr. Livera in Jaffna but he has not yet arrived and the work of the Court is at a stand still.

Minor Courts Mr. G. W. Woodhouse, Police Magistrate of Jaffna, has been appointed Assistant Collector of Customs and additional Commissioner and Police Magistrate of Trincomalee, but he will continue to act as Police Magistrate of Jaffna until further orders.

THE HOLIDAY SEASON.

Before the next issue of the *Star*, the Christmas holidays will have come and gone. We wish all our readers, (though several days ahead of time) a very "Merry Christmas" and "Happy New Year". May Christmas be a happy day,—a day of receiving and giving gifts, a day of much social enjoyment, and above all a day when the Christ-like spirit will predominate in our hearts and find expression in our lives.

Christmas is the great holiday of Christendom. It is the one day which is almost universally observed. In Europe, America and Australia, and in some parts of Asia and Africa, the day is kept as a public holiday. Every Christian country celebrates the day; and in every non-Christian country it is a day of joy and gladness to those who call the masses the followers of the lowly Nazarene. Even those for whom the day has no significance whatever, come in for a show of its pleasures. It is the one holiday that is common to all.

The origin of Christmas is obscure, but we may trace its growth through many centuries. As our readers are aware, it is celebrated as the birthday of Jesus Christ. Scholars may be divided in opinion as to whether December or a subsequent month was really the month of the nativity. It makes little difference whether we hold the exact day or not, so long as we observe one day as the natal day of our Lord.

The first traces we find of the observance of Christmas as a special day, were at the close of the second century. Tradition tells us that less than a hundred years from that time, in the reign of Diocletian, he heard that many Christians had gathered together in the city to observe the birthday of Jesus Christ. Ordering that the doors of the church in which they were assembled be closed, he set fire to the building, and thus perished a great multitude. Surely in this instance at least it was a day of sorrow and mourning. From the fifth to the eighth centuries interest was awakened in all the festivals of the church which resulted in a more systematic arrangement of the time of these festivals. Dec. 25th was not chosen by chance. There were many reasons for fixing upon that day, the most powerful one being that it was about the time of the winter solstice, the most important part of the year according to the notions of that age, the "beginning of renewed life and activity." The nations of Europe held this day in special esteem; for instance Germany held its Yule feast on that day.

That Christmas day had in its earlier history many of the elements of heathenism is undoubtedly true, but as time passed on Christianity exerted a purifying influence until to-day it is suggestive of none but the highest and purest thoughts. Christmas carols and Christmas trees bring to our minds the Christ child, and awaken feelings of generosity and good will. It is the day of gifts,—a day when all the nobler feelings in the heart of man are aroused,—a day that brings a ray of light and gladness to many a sad and discouraged member of the human family. Above all, it is a day of glad tidings,—a day when we hear the echo of the angelic refrain "Glory to God in the highest, and on earth peace, good will toward men."

In England and America for days and weeks before the 25th there is great activity in the business world. Every department of trade almost gets into the spirit of the days and puts its best foot forward, springing into new life and activity. In one of the large cities the two or three days before Christmas are very busy ones. Every shop window is fairly resplendent with its stores. Crowds of people pass along the streets, their arms filled with bundles. Every where you come across fir trees, some large, some small, and nearly all destined to play a most important part in the festivities of Christmas week. Vehicles of every kind are rushing about hither and thither laden with boxes and bundles suggestive of Christmas cheer. It makes an animated and interesting scene and one not soon to be forgotten.

We wish Jaffna might participate more generally and heartily in the observance of this day. We wish it might be observed more as a day for the interchange of gifts, however trifling they might be. It is looked forward to by many a child in Jaffna as the time when he or she expects some little gift from the lady missionary. Would that it might be a day when all the members of the family could meet in glad reunion to partake of Christmas cheer. Not for anything extravagant do we plead, but for some difference in the day,—an extra curry for example, or a dish of sweetmeats. Above all let us make it a

day of gladness, a day of calling to mind the babe in the manger at Bethlehem, a day of loving remembrance of all the blessings we have received from the Christ child.

THE CEYLON EDUCATIONAL ASSOCIATION.

This Association has been formed, and a number have been enrolled as members. A deputation waited upon H. E. the Lieut. Governor on Tuesday the 17th Inst. and presented a memorial touching upon the proposed changes in the Code. Individual members of the deputation also said a few words in support of the memorial. Sir John Grinlinton who introduced the deputation, also urged its claims.

H. E. the Lieut. Governor, (says the Ceylon Observer in reply stated that while he was prepared to give the views of the Deputation his most careful attention, he could not well reverse the decision of H. E. the Governor, which had been arrived at after due deliberation, nor could he make any alteration in the Code without the advice of the executive Council. He deprecated the idea that there was any intention on the part of Government to rush the proposed changes, and assured the deputatons that when the alterations were proposed it was with the view of strengthening their hands. His Excellency concluded by expressing the hope that the deputation would be satisfied with his assurance that the memorial would receive every consideration.

The Editor of the *Observer* in an editorial comment, fears that this answer is not a very encouraging one for Managers.

We append the rules of the Ceylon Educational Association for the benefit of those who may wish to become members.

The officers elected are Rev. Philip Read M. A. President; The very Rev. Father Collin O. M. L. Vice President; Rev. J. Passmore, Secretary; and the Rev. G. Arndt, M. A. Treasurer.

Applications for membership should be sent to the Secretary.

RULES.

1. The Association shall be called "The Ceylon Educational Association," and its objects shall be to advance and promote the interests of "Grant and aid" schools, and education generally in Ceylon.
2. Each member on being enrolled shall pay, an entrance fee of not less than Rs. 5.
3. The Officers of the Association shall consist of a President, a Vice-President, a Secretary and a Treasurer, who shall be appointed at the Annual General Meeting.
4. A Standing Committee shall also be appointed at the Annual General Meeting, to consist of sixteen members representative of the different educational bodies in the island, together with the officers of the Association.
5. Seven to form a quorum.
6. The Standing Committee shall meet not less than once in 3 months, and a General Meeting shall be summoned once a year, in the month of September.
7. No motion shall be brought before the General Meeting which has not been previously submitted to, and approved by, the Standing Committee not less than three weeks before such General Meeting.
8. The rank of the Standing Committee shall be to act on behalf of the Association during its term of office.
9. The Standing Committee is empowered to summon an extraordinary General Meeting on its own motion, or upon the requisition of at least one-fifth of the members of the Association.
10. No rule of the Association shall be rescinded except by a majority of two-thirds of the members present at the Annual General Meeting.

TREATMENT OF HYDROPHOBIA BY VAPOUR BATH.

As some space was given in your columns a short time ago to draw attention to a method of treating hydrophobia your readers may be interested in the following. On Nov. 2nd a patient was brought in our dispensary, Manipay, with the history that eight days previously he had been bitten by a dog, and it was feared that he was developing hydrophobia. He was in a state of severe mental anxiety, had not slept for some little time, and was suffering great pain in the leg. He had received a punctured wound in the foot five days after the bite of the dog, and this wound was very painful and the foot much swollen. No definite symptoms of hydrophobia were present but as a possible prophylactic he was given a vapour bath lasting for twenty minutes. This was repeated in the evening of the same day. He slept well, and seemed so much better in the morning that we directed attention only to the punctured wound, thinking that he was unduly frightened by the fact that he had been bitten. On the thirteenth day after the bite the patient became much worse and soon definite

symptoms of hydrophobia appeared. The spasm of the muscles of deglutition and respiration was very well marked and the anxiety on the face of the patient was most pitiable. He was given a bath for half an hour at 8 P. M. This was repeated four times, at intervals of four hours, on the following day, Nov. 6. By this time the patient was perfectly quiet, but very weak, as was to be expected. Stimulants were given, and the bath repeated thrice for some what shorter period on the 7th. Twice more, on the next day was the bath used. As all symptoms had now disappeared, simple tonic treatment was given. The patient remained in the hospital for eighteen days longer during which time attention was given only to the wound previously mentioned, and to building up his strength. On the 26th of Nov. he went home quite well. He returned several times to the dispensary to show the injured foot but all trace of hydrophobia had entirely disappeared.

This method of treatment is so simple, that should it prove as effectual in further cases, it is well worth knowing. If those who are in a position to do so would test the efficacy of this line of treatment, and prove its curative value, it would be a boon to our island, where this horrible disease is comparatively common. THE VICEROY AT TANJORE.

The Viceroy and party arrived here and were received at the Station by the Collector who made the principal presentations, whereupon the Municipal address was read by Mr. Murugasam Pillay, Deputy Collector. In reply to it, His Excellency said that he confessed that he always had with some feelings of regret recollections melancholy though they may be memories of the past. If he might be pardoned to introduce an individual experience on an occasion of this sort, he would say that they had a motto in his family which recalled to him somewhat similar recollections. They had always been taught not to regard fallen glories with regret but as stimulants to resolute action, to adapt themselves to circumstances, and to be true to a cause, if individuals might also be true to themselves like themselves. With proper changes rendered necessary by altered circumstances, if they face life men the altered circumstances there might be a bright future, not unworthy of their past greatness. If their position was not one of great oriental pomp to-day they said that they recognized that they shared in the blessing of British rule, its peace and security. At that hour and with such limited time as has been at his disposal, he did not propose to do more than with any detailed observations, but with their permission to proceed to see the sights they had to show him. An address such as theirs couched in terms of loyalty and cordiality could not but evoke sentiments of appreciation and he begged to assure them that he would carry with him the warm recollections of their welcome to Lady Elgin, and himself. The Viceroy then proceeded to the temple and Palace.

NEWS FROM THE WIDE WORLD.

TURKEY. The situation still remains critical. The Sultan disregards the repeated counsels of the Powers. Fresh massacres of Christians have taken place at Aintab. The entire population of the village of Jartian numbering upwards of 200 souls, has been killed.

Cañl Pacha who was recently in and Viceroy, was ordered to retire to the Sultan's palace, but having secured refuge in the British Embassy. The Sultan sent ministers and his Private Secretary, to try to induce him to return promising that nothing should happen to him. Finally after several days he yielded returning home on the 9th inst. A change of the Turkish ministry is expected. The Sultan, after expelling thousands from the Powers has allowed the extra gunboats to pass the Dardanelles.

ALGERIA. There has been severe fighting between the Italians and King Melek the leader of the Slangos. The fighting lasted for six hours, the Italians being defeated with heavy loss, 17 officers, 40 non-commissioned officers and several hundred men were killed including the massacred wounded soldiers. The Italian government has ordered the despatch of 4000 men from Naples as reinforcements. The Slango army numbers some 35000 men.

RUSSIA. Cholera is prevalent in Russia, no fewer than 900 deaths being weekly recorded.

SPAIN. The Spanish government will send next month another reinforcement of 10,000 troops to Cuba.

MADAGASCAR. An anti-European mob attacked the Quaker's mission station at Arivorimano on the 22nd Nov. and massacred and mutilated the missionary Juliano besides his wife and child.

U. S. A. There has been a terrible fire in Chicago. The premises of 10 business houses were destroyed. The loss is estimated at \$2,000,000 sterling. A large fire in New York city is also reported, with heavy loss.

HEAVY GALES & STORMS. Heavy north east gales were experienced in the English Channel last month, and many shipping casualties, and deaths have been reported. In South Russia also terrible storms were experienced in the Black Sea, the damage done being estimated at \$3,000,000. At least 60 persons are reported to have been killed.

Local and General.

JAFFNA TRADING COMPANY. A meeting of the Directors of this company was to be held yesterday the 18th inst. in the town.

JAFFNA MARKETS. The by-laws relating to the markets of the Jaffna district have been published for general information in the Govt. Gazette of the 6th inst. They consist of 24 clauses, and are interesting and useful reading to the traders of Jaffna.

NEW ORDINANCES. His Excellency the Governor has given his assent to the Court of Requests ordinance No. 12 of 1895 and to the Evidence Act No. 14 of 1895. The Government has found a way to carry through these ordinances in Council against strong opposition by the members of the Ceylon bar and the public in general.

JAFFNA SHOWS. The number of the Jaffna shows has of late considerably increased, and more than six Christmas and New Year circulates have been sent out. There is a large and new supply of goods exposed for sale, and every shop vies with the others in splendor.
