The Port Master, Brisbane, has given notice (No. 13 of 1898) that a small sandbank, carrying only 7 ft. at low water, having formed in the line of lights at the North Channel, masters of vessels are advised to pass close to the floating beacon when entering or leaving Port Curtis by that channel.

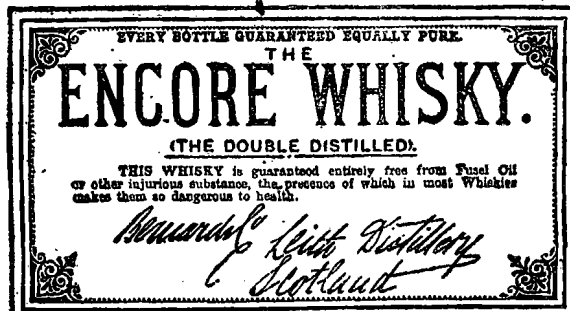
