(5) Ihalamaragahawewa of Moragolla Tulana in Wilachchiya Tulana; bounded on the north by Kalundegama, south by Talgaswewa, east by Katumbulugama, west by Huruwilagama roads.

(6) Helambagaswewa of Wilachchiya Tulana; bounded on the north by Galahitiyawa, south by Mahawilachchiya, east by Mahapuliyanukulam, west by Kuda Puliyanukulam.

(7) Palu Siyambalagaswewa and Hunupolayagama in Galkadawala Tulana of Nuwaragam korale; bounded on the north by Pinugala, south by Helebambagaswewa, east by Tammannagala, west by Malwatuoya.

(8) Maningamuwa in Galkadawala Tulana of Nuwaragam korale; bounded on the east by Weddagama, west by Arippu Pinpara, north by Parasanpotana, south by Ehatugahahinna.
