## MUNICIPAL COUNCIL NOTICES.

### MUNICIPALITY OF KANDY.

The Minutes of Proceedings of a Meeting of the Municipal Council of Kandy held in the Town Hall on Saturday, August 15, 1896, at 8.30 a.m.

*Present:*—Hon. Allanson Bailey, Chairman ; J. B. Siebel, Esq. ; J. H. Sproule, Esq. ; E. Beven, Esq. ; B. de Alwis, Esq. ; W. D. Gibbon, Esq.

1. The Minutes of Proceedings of the Meeting held on July 18 were read and confirmed.

2. The following documents were submitted :—(General Statement not ready) Special Statements of Receipts and Disbursements from close of 1895 to July 31, 1896, in respect of the General Revenue, Police Assessment, and Water-rate Accounts ; Progress Report of Work done brought up to the same date ; Report of Work done by the Municipal Magistrate, and of Cases instituted by the several Inspectors during the month of July ; and Health Officer's Report.

Resolved,—That the several documents, as required by section 90 of the Municipal Councils' Ordinance, No. 7 of 1887, with the Minutes of Proceedings of this Meeting, be forwarded to the Colonial Secretary, together with the Health Officer's report, for publication in the *Government Gazette*.

3. Letter No. 15131 dated July 27 from the Government Agent, on subject of the acquisition of land along the banks of the Mahaweli-ganga, required for the extension of the new road from Lewella ferry towards Katugastota, was submitted. The letter and connected papers had been circulated, and a reply sent to the Government Agent (No. 41 of August 6) in accordance with the recorded opinion of the Members.

Resolved,—That the terms of the reply be confirmed.

4. Read letter dated July 17 from Mr. E. Beven, respecting the tenders received for scavenging, and rejection of same on recommendation of the Standing Committee ; also memorandum by the Secretary explaining that the vote taken under the head "Scavenging" included wages of a watcher and latrine caretakers, which a contractor was not required to provide, and a deduction had to be made for amount received for private work.

5. Read letter No. 9 dated June 24 from the Colonial Secretary, in reply to the Chairman's letter No. 20 of May 2, stating that the Governor is disposed to hand over to the Municipality, for public purposes, the Crown land

situated between the lake and the market on condition that the lands will be levelled with the silt from the lake, and inquiring whether the Council will accept the land on these terms. Read report by the Secretary and Superintendent of Works on the quantity of earth required to fill up the hollows, the quantity of silt likely to be available for the purpose, and cost of carrying out the work.

Resolved, on the motion of the Chairman, that the Colonial Secretary be informed in reply that the Council is willing to accept the offer of Government; and that Government be asked to advance a sum of Rs. 50,000 at 4 per cent. interest per annum with 2 per cent. towards sinking fund, in order that the work may be expeditiously completed.

The motion was unanimously agreed to.

6. Read report by the Health Officer, Surgeon-Captain Hardy, and also by Surgeon-Major Allport on the state of lafrines on premises No. 14 A. to V., King street.

Resolved, under provisions of section 33 of the Ordinance No. 1 of 1896, that the Chairman be specially empowered to require the owner of premises No. 14 A. to V to close the three cesspits situated on the premises and to substitute dry-earth closets on an approved site.

The motion on being put was carried unanimously.

7. Read recommendation by the Standing Committee, on an application by the market-keeper for compensation for loss by exchange as granted to other subordinates, "that compensation be granted as from July 1."

Resolved,—That the recommendation be approved.

8. Read recommendation of the Standing Committee, on application of the Secretary of the Station Hotels Company, dated July 17:—

(1) That permission be granted to the Station Hotels Company of Kandy to a portion of the porch of the hotel being built on the land the Council has agreed to lease on the conditions stated in the application.

(2) That permission be granted to the construction of a sub-way on approved plans, and provided it is substantially built, and properly drained.

(3) That the present temporary huts and lines near the site of the hotel be removed; and that to provide for the housing of such of the occupants as are in the employ of the Council a vote be taken under a Supplementary Budget for building a set of cooly lines at Mahaiyawa.

Resolved,—That the several recommendations be approved of and adopted.

9. Dr. F. Keyt having ceased to be a Councillor by failing to attend three consecutive meetings, it was unanimously resolved that he be restored to his office.

10. The Chairman submitted Supplemental Budget No. 2, which had obtained the approval of the Standing Committee, and a copy of which had been furnished to each Member, as required by section 113 of the Municipal Councils' Ordinance, No. 7 of 1887.

It was unanimously resolved that the Supplemental Budget No. 2 be sanctioned as follows:—

## LOCAL BOARD NOTICES.

THE following by-laws made by the Board of Health of the town of Kurunégala, under and in pursuance of the provisions of section 35 of "The Local Board of Health and Improvement Ordinance, 1876," and submitted to and confirmed by the Governor, acting with the advice of the Executive Council, are published for general information.

### *By-laws referred to.*

1. From and after the passing of these by-laws no horse, cattle, sheep, goats, or pigs shall be tethered or grazed upon any public ground vested in the Board without a license signed by the Secretary, Local Board. Such license shall be issued annually or quarterly at the option of the Chairman, Local Board, upon prepayment to the Secretary, Local Board, of Rs. 3 per annum, or 75 cents per quarter; and such license shall be in force during the period for which it is granted.

2. It shall be lawful for any person thereto authorized in writing by the Chairman, Local Board, to seize any cattle, horse, sheep, goat, pig, or other animal, for which no license has been taken out under these by-laws by the owner, and which he may find tied, tethered, straying, or driven or tended upon any public ground vested in the Local Board, and to impound the same.

3. Any animal seized and not claimed in six days may be sold by public auction on an order of the Chairman.

2. සහාවේ ප්‍රධානකූහනේ ලැයවිල්ලකින් මේ සඳහා අවසරලන් කෙනෙකුට, මේ උපව්‍යවස්ථාවේ අස්දමට අයිතිකාරයා තිසින් ගෙනකාලද අවසර නැති අශ්වයින්, කරකුන්, එළවන්, බැව්ලන්, උරුන් සහ වෙන්තුන් එක් සහාවට අසින් ප්‍රසිඛ ඉමිම්වල බැඳුන්යන්ට, ද්‍රාවයින් හෝ දැක්කා ගෙනකාන්ට ගෙයෙන් දුටු විට අල්ල, යාලේ බිඳීන්ට පුතුව නිවේ.

3. අල්ලගන්නේ යෙදිදාව් හෙතු අඩුලාඩි අශ්වයිවාසිකම් පෙන්වන්ට නොයෙදෙක යම් සහෙක්, ප්‍රධාන කූහනේ අවසර පිට ප්‍රසිඛ වෙන්දේසියේ විභුජන්ට යෙදේ.

3. பிழக்கப்பட்டு ஆறு நாளைக்குள் உறுத்துச்சொல்லப்படாத எந்த மிருகமும் நகரசபாபதியுடைய கட்டனைப்படி பிரசித்த வெந்திசில் விற்கப்படும்.

NOTICE is hereby given to persons residing within the limits of the Local Board of Matara that the Board, acting under the provisions of section 3 of the Ordinance No. 9 of 1887, has imposed an annual tax payable in six days' labour upon all persons residing within the limits of the Board who would have been liable, under the provisions of the Ordinance No. 10 of 1861, to the performance of labour for the maintenance of roads or

other public means of communication by land or by water if the Ordinance No. 7 of 1876 had not been passed. Such labour may be commuted by a money payment of Re. 1·50 on or before February 28, 1897.
