Our Mission


Recreate a future of love, opportunity and happiness for all those who have suffered and continue to suffer from the civil strife.

Dear Partners,



Cottage industries such as poultry, palmyrah industry, etc. have lots of potential but due to the war and other country situations lacked concentration and pushed to the brink of extinction. Reviving these industries with modern technology and paving our people the way to success through training, initial capital provisioning, aiding on marketing and sales is the long term strategy of MNT for our homes, our people and our own children.

I would like to thank all our committed volunteers, staff, partner NGOs, supporters, trainers and the fellow trustees for all their hard work and dedication. In the same spirit, I would request all our well-wishers to continue extending to "Love for Humanity" their support and encouragement. We pray to god to give us the strength and capability to achieve the tasks that we have set for ourselves.

Siva Poomi

Home for Differently Abled - Jaffna

Number of mentally challenged was increasing in the region with the effects of war and malnutrition. However, parents remained with conservative thoughts and kept such children behind doors for the fear of ridicule by the society. Cognitive ability of mentally challenged may range from very low to extremely high and the dependency and their demands also vary accordingly. It is important to identify capacity of each individual and provide training on various aspects such as writing skills, reading skills and behavioural skills, etc. based on that. However, if left unattended chances are high for further deterioration of their self confidence and inferiority complex.

Siva Poomi Home for Mentally Challenged was established in 2004 with the intention of improving the life of those who need additional attention. And we were able to change the attitude of society and parents to certain extent through showing outcomes. Caring of these children are very closely monitored and planned. Teachers with enormous dedication, involvement and high tolerance study the individuals carefully and employ various mechanisms to educate these children and continuously assess the improvement to make sure progress happens. Concentrated classes than traditional classroom environment is essential to pay special attention, hence, Sivapoomi receives the services of 15 specially trained teachers to look after 215 of its inmates. Unlike normal children a separate bus donated by MNT is being used to transport special children up and down the school.

In addition to normal education, special exercise classes and training on sports are also provided. Further, to equip them with special life skills, vocational training to mention few, envelope making, sewing, etc is being taught and MNT contemplate plans to take this in larger scale and incorporate livelihood projects to develop it as a community where marketing efforts will also be carried out. This would ensure the inmates who take off the hostel grounds though continue to be dependant will leave with added confidence and some financial freedom. MNT at present supports the home with a monthly contribution of Rs. 200,000/-

We are proud that one of our nestling, an 18 year old, Sri Lanka national gold medal winner of the 100 meter sprint, Thushyanthan Sivarajah is selected to participate in the Special Olympics in Athens, Greece. This selection for the Special Olympics is a commendable achievement and we sincerely thank all our honorable donors who had made this a reality.

Hindu College Boys Hostel Sakthi Illam

Hostel for Needy Girls - Colombo

Ratmalana Hindu College Hostel came under the patronage of Manitha Neyam Trust since 1999. Accommodating 280 boys and girls from all over the country facing different faces of life's challenges, this is one of the initial projects of Manitha Neyam Trust and one which continues to make many achievements for MNT to feel proud of.


Children of Ratmalana Hindu College are blessed to receive special coaching classes for subjects such as Science, English & Mathematics which indeed, have lead to several other developments as a consequence. Now they are slowly learning to read, write & speak in English which they themselves proudly boast about and with enabled more comprehension they actively participate in gaining computer literacy.

It brings pleasure to see the computer lab donated by MNT is under optimum usage and a Teacher regularly visit to give proper training. To eliminate the feeling of separation from the family, in order to make them feel at home, MNT goes an extra mile to celebrate their birthday once a month of all those children belongs to the same month of birth.

Mahadeva Ashram

Kilinochchi

Responsibility of a charity does not end with making a person happy. Its efforts should reach the depth to achieve development of the community and thus build the nation. Just a flick of fire is perfectly enough to yield such achievement.

Manitha Neyam resumed its funding from last year to Mahadeva Ashram which revived after complete destruction in the evil hands of war. It now accommodates 283 children from Kilinochchi, both boys & girls who still laments the loss of either both parents or single parent. Some of the children belong to families whose parents do not earn enough to support their development. These are the youngsters with full of energy and talent who if wasted without proper guidance and direction will become just an additional burden to society. Children who range from age 3 - 18 years are enthusiastic and determined not to let happen what they experienced to others in future where MNT sees the actual happening of developing the backbone of future generation, that flick of fire.

MNT contributes GBP 20,000/- p.a. for meals. In addition, with the firm belief of long term stability of the Ashram MNT has provided Rs 4 million for a cattle farm project. Capitalizing on their 100 acres of available land further to several other cultivations such as coconut tree, banana, etc. with the donation of MNT cattle shed was constructed, pasture land created and a Manager hired to run this as separate project so that financial independency and sustainability for future will be assured. This project which was started last year has began to yield profit and within 5 years the home is expected to become self sufficient. MNT contemplate this to be a flagship project and have an intention of replicating where ever there is a need.

Sivapoomi Eldes Home Jaffna

Sri Lankan population is about 20 million to date and it is ageing day by day. It is estimated that by year 2020, one in four will have reached the age of sixty. Moreover, number of reasons has awakened the need of Homes for the Elders; More than 52% of Sri Lankan population is below the poverty line. Younger generation/ the work force of the country who should be looking after their elderly parents; have either moved to main cities or abroad leaving behind their elderly parents, in search of healthier employment opportunities, due to the conditions in the country or looking for better prospects of life. Also there are elderly people who neither have children or anybody else to look after them nor can look after themselves on their own.

If we have to make it more comprehensive Elders basically are another category of special children thus extended arm of Sivapoomi home was established in 2006 in Sulipuram, Tholpuram, Jaffna and it accommodates 58 inmates at present. They are at varying level of physical and mental ability necessitating provision of more than just basic facilities such as shelter, food, clothing and medical care. That is where Sivapoomi differentiates itself by offering regular doctor visits, in-house nursing facility for bed ridden elders and facilitate the search of love, peace and spirituality through making available a library, daily prayers and soft hearted, service oriented maids. The touch of love is all what matters for an elderly and people to converse, an environment to feel the presence of peace and may be god where feeling of safety is also incorporated therein would be heaven being felt on earth. Heart and face filled with happiness of all our elderly is what we boast as our achievement and thanks to all our Donors, MNT is committed to take it further infinitely.

Sithi Vinayagar Hindu College

This project takes care of the lodging, meals and tuition fees of 171 children both boys and girls either whose parents are under the poverty line or those who have lost both or one of their parents. All of them are from Vanni It came under the umbrella of Manitha Neyam Trust since 2002. MNT, UK funds the maintenance of 75 students while 20 students are looked after by Anpuneri, USA. Maintenance of further 30 students is financed by MNT, USA and 46 students is financed by MNT, Canada. In addition to that, Manitha Neyam Trust donated Rs. 1,124,200 for 10 computers and accessories to the Sithi Vinayagar Hindu College, Mannar. More than 500 students under hardship are benefitting from this. MNT celebrates our student Tharmaraja Thishakini of Sithi Vinayagar Hindu College, Mannar entering Ramanathan Acadamy for Dance after completing her A/L. Each stepping stone of our students towards success reassures our path & meaning of continuous dedication.

Pre schools Mullaitheevu

The years before a child reaches kindergarten are among the most critical in his or her life. Over the past 50 years, researchers have accumulated a large body of evidence regarding the effects of preschool education on children's learning and development. This evidence has proven that children gain tremendously from attending preschool and the gain is largest for children that are lower on the socioeconomic ladder. Anyone can imagine the necessity of preschools for children from areas affected by war and hence, 30 years behind in development, if to achieve rapid improvement and match their competences to their mates from other areas. In the villages, Thanniyoottu, Mamoolai and Kanukerny we are currently operating three preschools for 122 students which provide a safe and nurturing environment that enrich each child's cognitive, social development with 5 caring, experienced teachers. Another two preschool are in the pipeline to be launched by January 2012.

Jaipur Centre for Disability Rehabilitation Jaffna

Amputation creates psychological withdrawal from life, family and community. It makes the individual to think they have lost their whole life. Manitha Neyam joint hands with JJCDR, which is one of the very few which provides prosthetics, to offer a fresh start to people in crutches. JJCDR identified 12 people with the need of artificial limbs of which 3 needed above knee prosthesis (at the rate of LKR 39,600) and 9 needed below knee prosthesis (at the rate of LKR 22,450). Request was sent to MNT and within a short span of time, new meaning was added to those deserved by JJCDR who carried through the project. Project costs total funds amounting to Rs. 320,850/-. We extend our heartfelt thanks to both our Donors and JJCDR for making MNT part of such worthy program.

Nuffield School for Deaf & Blind

Learning experience of humans happen through all six senses, however, eyes and ears play a major role in that. One can engage in learning at any age, but, youth excel in the ability of learning. It would be unfortunate not to have one of these powers of sense at such young age and MNT promptly recognizes this fact by donating hearing aids to students at Nuffield School for the deaf and blind. There are 80 children and 20 in a batch benefitted from the phase one of this project and the phase two of the project roughly estimated to cost Rs. 551,000 per batch totalling Rs. 2.2m.

Eye Camps

According to the recent statistics of the WHO, more than 37 million people are blind and more than 124 millions are visually disabled. Ninety percent of these live in developing countries. In spite of all the efforts being made to address this problem, blindness increases annually by two million and is expected that by the year 2020, there would be 90 million blind and 200 million partially blind people. Especially, cataract cases account for almost 50% of the world's blindness.

Keeping these in mind, Manitha Neyam together with Thanniyoottu Sai centre and the Dept. of Ophthalmology, General Hospital, Vavuniya, conducted an eye camp on 28th June, 2011. Initial registration for the camp escalated the number contemplated would attend thus understanding the requirement of the society, serving the need of people being the sole reason for the existence of MNT, another camp was arranged on 24th of September, 2011.

Out of 515 patients screened on both the camps, 42 underwent cataract surgery at Vavuniya hospital. MNT donated 376 reading glasses to the needier and a three wheeler to transport the patients from Mullaitheevu to Vavuniya. Moolai, Jaffna Manitha Neyam along with Moolai Cooperative Hospital continues the mission of alleviating blindness. Patients are screened for eye disorders at constant intervals by a Doctor who visits regularly and MNT provides surgical instruments, lens implants and staff costs or fund the total costs of delicate eye operations wherever necessary.

Passport to Employment - Jaffna

The dream of every desperate and hard working student is an easy access to a good job or rather the best. Education alone cannot be the job winning factor in all cases. MNT identified this essential need that would turn around the lives of youngsters who have undergone long term suffering. In order to harness the full potential for economic growth in the North and North East of Sri Lanka, a potential driven by re-development motives, Manitha Neyam Trust pioneered an employment programme. The objective of the programme was to better position the participating graduates to secure employment with some of the supportive employers, which included well known local institutions and businesses seeking to recruit skilled graduates for employment in the North, North East and elsewhere in Sri Lanka.

During phase I of the programme, around 120 graduates from the Faculty of Management from the Jaffna University were selected for training over an initial two week period. From this group, around 50 graduates were selected for further intensive and focused training during Phase II of the programme during April of this year. During these final training weeks, individual graduate's skills were matched to employer pre-defined requirements with added emphasis on certain critical skills including communication, interview, business etiquette and IT amongst other skills.

To date most of the graduates have secured employment with the probability of the remaining graduates who attended Phase II of the trust's programme securing employment with employers participating in the programme remaining very high. The trust anticipates running a similar programme for a further batch of graduates so as to satisfy both employers' business needs, but more importantly to gradually return the region's young to regular life.

Computer Labs - Kilinochchi

Manitha Neyam screens the environment not only for society's need also to find out the needy's future needs that may arise. On the average, four out of one hundred household's in Sri Lanka posses a computer. There are nearly two million internet users in Sri Lanka, representing 14 percent of the population. We recognize the present trends towards computer literacy and world of internet. Future of young generation will be thrown in to a big question if Dharmapuram Mahavidhyalayam and Muruganantham Mahavidhyalayam situated in Kilinochchi, the most affected area of war is left to suffer without basic facilities. Realizing this fact MNT donated Rs. 785,000/- worth of 5 computers to each of 2 schools, that is, a well equipped, fully fledged computer lab with internet facilities. MNT is always looking for opportunities that would safeguard and strengthen the budding generation.

Vocational Training Centre - Mannar

The Vocational Training Centre offers a variety of courses in areas as diverse as animal husbandry, farming, facial care, fabric painting and sewing. The graduates have gone on to live independently and have become respectable members of the community in which they live. In Mannar its vary difficult to find vocational training center of such nature, hence, students are actively participating for the program. So far, around 150 people have benefited from this project.





Displaced University Students University of Jaffna & Eastern University

Several families have lost their bread winners to the war and continuing education has became unimaginable to many at all ages. Since 2002, over 100 university students have been regular beneficiaries of the work of the Manitha Neyam Trust. At present, 133 students from the University of Jaffna and 30 students from the Eastern University are receiving a contribution of Rs. 5,000/- per month. Majority of the beneficiaries of this project are women who are married with child but have lost their husband to the war and have nobody to aid their future. Generosity and continuous support by our Donors to help these university students fulfill their dreams of higher education is ever remembered with heartfelt gratitude.

Livelihood Projects - Mannar

Aftermath of war and Tsunami is where subsistence of people turned out to be a question. Basic infrastructure is destroyed. The development of affected areas slid back by 30 years. Only two years have elapsed after cessation of war. Thus while improvement takes time, people who are mostly fisherman and farmers are in dire need for livelihood. Timely intervention felt essential by MNT. 16 people benefitted from the Thiruketheeswaram, Mannar livelihood project worth of Rs. 485,000/-. 8 sewing machines, 3 water pumps, 3 carpentry tools and 2 grinding mills were donated by MNT to the less fortunate's of Thiruketheeswaram. In addition, in Kandawalai, cows, goats, water pump and agricultural equipment worth of Rs. 335,000/- is donated to 16 most deserved people. This project is still in pipeline and MNT hopes to carry out lot more activities in the region.

Flood Relief - Eastern Province

MNT's continuous dedication and commitment to see the people through their troubles was very much evident in recent disaster that struck the people of Eastern province who were already overwhelmed with the various faces of life's test including war, Tsunami & now the flood. Batticaloa district recorded the highest rainfall. In Batticaloa district alone 421,851 persons from 112,039 families were affected. Several thousand villagers including uprooted and sheltered in transit camps in Trincomalee district awaiting resettlement in Champoor in Moothoor East were again displaced and sought refuge at various places and desperation prevailed in many divisions of the Eastern Province.

Education of children was brought in to stand still and parents were not in a position even to think about it. That is when the timely intervention of MNT happened. With the help of the Department of Education, MNT identified 100 schools that were the most affected in the district. Manitha Neyam coordinated its efforts with the local YMHA (Young Men's Hindu Association) and was able to distribute school uniforms, exercise books, boxes of instruments, colour pencils, rulers, erasers, sharpeners, ball point pens, pencils and school bags to children in need.

Over 5,000 students benefited by the project and returned to their respective schools. Manitha Neyam's relief effort helped these children continue their education instead of dwelling on the trauma. The total cost of this project was Rs. 5 million. Over 5 million was spent as immediate relief. But it was not over just with it. MNT continued to look after the flood victims by paying Rs.200, 000/- to flood victims of Eastern province through Alayadi Vembu Hindu Association and kept watching them walk steady. MNT took responsibility not to let down the people by helping only at the beginning when the news was freshly heard and let them ruin where no other aiding hands turn up after sometime.
