(1). *Religion*: is a Sinhalese of the Duraiwa caste; *religion*, Buddhist; *occupation*, cultivator; *age*, 37 or 38 years; *height*, 5 ft. 5 in.; *make*, stout; *complexion*, dark; *nose and mouth*, ordinary; *teeth*, regular; *eyes*, black, and *nary*; *hair*, tied in a knot; wears full beard, partly grey; *back*, bare; *chest and parts on shoulders*, is tattooed; *general residence*, Medapitiyagama, Willem's Gama, Kalvumbura, Nagolla, Ekirialepota. *Language*, Sinhalese; *family*, is unmarried; keeps a mistress at Nagolla; has no children; *friends*, Sattu of Nagolla and Kalvumbura, and Bakeravampola, is well known to Tissamahelli and to A. Peris of Kalvumbura.

(2) *Chelodactylus*. Don Elias Chayaratna alias Don Elias alias Telayaratna; a Sinhalese of the British Indian Army, retired; occupation, trader; age, about 30 or 35 years; height, 5 ft. 5½ in.; make, stout; complexion, dark brown; eyes, and mouth, ordinary; teeth, well set, small, 12, 12; hair, black, tied in a queue, which will grow; has a cut scar on forehead and hairless on the forehead; birthplace, Kotte in Colombo; general residence, Kandy, Mattele, and Pussagawwa; speaks, Yalkumbura and Tannakala; is unmarried; brother, Perera of Colombo relations, Gravet Arachchi of Kandy and M. A. Peris of Yalkumbura; is well known to Mr. Kiri Banda Arachchi and Police Constable Sava of Badulla.

(3) **Appu** : is a Sinhalese of the Wellala caste ; religion, Buddhism ; occupation, tinner ; age, 35 years ; height, 5 ft. 3 in. ; naked ; complexion, fair brown ; nose and mouth, ordinary ; teeth, regular ; eyes, small, black ; hair, partly gray, tied in a knot ; wears full beard, partly gray ; has hair all over the body ; is a sunback ; birthplace, Kiribatgoda, Siyana, Korala ; present residence, Medapanyagama in Wellasa ; parents, Yalkumbura, Lunugala, Batticaloa, and Puliyanaduwa ; is unmarried ; keeps a mistress at Welagahawatta ; friend, Appuhamy of Yalkumbura ; is well known to the late Arachchi of Yalkumbura.

Rasnaggadera *alias* Kasiwatte, Mudiyanse ; charged with causing grievous hurt at Yatimahna on December 8, 1897 ; is a Sinhalese of the Wellala caste ; religion, Buddhist ; occupation, cultivator ; age, 20 years ; height, about 5½ ft. ; make stout ; complexion, fair ; nose, flat ; mouth, ordinary ; teeth, well set ; eyes, brown, large ; hair, dark brown, tied in a knot ; wears a slight beard ; has a scar on face ; birthplace, Yatimahna in Galboda korale, Kegalla District ; general residence, Yatimahna ;

ON December 12, 1897, from a kitchen, at Union place,
Slave Island: 1 silver hairpin, 1 silver brooch, 1
silk handkerchief, 6 jackets, 2 cambayas, 1 banian, and
Rs. 8-50 in cash. Owner, Susana.

On December 15, 1897, from the owner's compound at Kattaimunai: a large copper pan about $1\frac{1}{2}$ ft. in diameter and about $1\frac{1}{4}$ ft. in height. Owner, Santia Katirimalai.

On December 16, 1897, from a cattle shed at Panchikawatta, Maradana: a black wylie bull branded  on left side; horns, short and pointed; age, 6 years and 3 months. Owner, Rāmen.

On December 16, 1897, from a cattle shed at Panchikawatta, Maradana: a black bull, white on legs and tail, branded "H. G. K." on right side, ၁၁၁ on left side, also some other marks; horns short; age, 7 years and 9 months. Owner, Ramen.

On December 17, 1897, from the owner's outer verandah at MacCarthy place; a toilet table without drawers. Owner, Mrs. Mory E. D. Kroes, MacCarthy place.

On December 18, 1897, from the owner's house at Cemetery road, Borella : a jakwood lounge. Owner, F. W. Nicholas.

On December 18, 1897, from a kitchen at Base Line road: 1 lamp, 1 kitchen knife, and an earthen bowl. Owner, W. G. Martin.

On December 18, 1897, from a shed at Madandawela, Matala: a single-barrel led cap gun, bearing No. 53,608, marked "W. H. Edwards, London" on barrel. Owner, Bardasim, Kandy.

On December 20, 1897, at Pettah: a second-hand rickshaw, English make, bearing No. 829, painted black. Owner. Darma Kanno.

On December 24, 1897, from a cabin of the ss. Fredrick de Grosse whilst in the Colombo Harbour: an 18-carat gold keyless hunting watch, an 18-carat gold chain ornamented with a diamond and a horse-shoe, also a double sovereign purse (gold). Owner, Mr. Harold Gossstein, ss. Fredrick de Grosse.
