MASSIVE DEMONSTRATION

AGANSTEUEF

Huge crowds numbering 50,000 people demonstrated opposite the Jaffna Secretariat demanding that the fifty percent cut imposed by the Government of Sri Lanka on relief assistance granted to displaced refugees from Sri Lankan Army occupied Tamil territory be rescinded on Wednesday, September 9.

Earlier the confederation of various public organisations in Jaffna called out a demonstration protesting against the Sri Lankan Government's decision to reduce by half the dry rations issued to displaced refugees presently living within Jaffna peninsula. The confederation said that the number of displaced refugees now living in Jaffna Peninsula numbered 400,000.

Responding the confederations call all shops in Jaffna remained closed on Wednesday. Work in other establishments grinded to a halt as working people and others joined the procession and demonstration organised by the confederation.

About 9-00 a.m. processions from various places started and converged at Nallur from where the demonstrators shouting various slogans proceeded towards the office of the ICRC at Jaffna and from there to the Jafffna Secretariat

and handed over a memorandum to the Acting Govt. Agent Mr. T. Vaithilingam to be forwarded to President Premadasa.

The confederation's memorandum to President Premadasa said:

"There are over four lakhs of displaced refugees living in the peninsula now. These refugees have not only lost their homes but also their belongings and employment. The Government's relief assistance while being inadequate is not given to all displaced persons. Most of the immediate requirements of these refugees are met by NG00.

The Government has announced its decision to reduce by half the relief assistance. This would mean that the refugees will not be given weekly relief but only bi-monthly relief of the same amount of dry rations they now receive weekly. The cut hey are already attending to

in relief assistance would drive the refugees to starvation.

The relief presently given by the Government is inadequate and the refugees are dependent on NGOO for most of their immediate needs. Even the Consortium of NGOO have voiced their opposition to the reduction in relief assistance."

The memorandum called upon President Premadasa to rescind the order for reducton in relief assistance and to have the army withdrawn from villages so that the refugees may re - settle in their homes.

It also called upon Prei sident Premadasa to take steps to remove the blockade on consumer goods to Tamil areas, to provide all amenities to refugees and to open the doors for a political solution instead of war.

At one stage when the lea ders of the confederation went to hand over the memorandum the demostrators became restive and threw stones breaking a few windows but were soon calmed at the intervention of the officials of the confederation.

All segments of the people participated in the demonstration and procession - the largest number being the displaced refugees.

NGOO Tell President Premadasa:

GOVT. MUST CONTINUE RELIEF WITHOUT REDUCTION

The Co-ordinating Committee of NGOO functioning in Jaffna District has in a memorandum told President Premadasa that the cut imposed by Government on its relief assistance to displaced persons in the peninsula would aggravate the already bad situation in Jaffna.

The Co-ordinating Committee to which 14 NGOO are affiliated has said that their own resources are insufficient to meet further demands of refugees' needs.

the needs of refugees in various ways.

The cut announced by Government will have adverse effects on the needs of the

displaced refugees. The Coordinating Committee has therefore requested President Premadasa to rescind the order imposing fifty percent cut on relief assistance to displaced persons in Northeast.

Ferry and Army

A Sri Lankan Army truck carrying 24 Sinhala soldiers was damaged and all soldiers killed when the truck which was being ferried across a river in Kiliveddy in Trincomalee District struck a mine. 16 civilians who were being taken in the ferry are also reported killed.

Truck Damaged

According to a Colombo report Sri Lankan Army sources said that at Kiliveddy in the Trincomalee District the Tigers exploded a bomb in a ferry which was being used to ferry an army truck. 24 soldiers were travelling in the truck. The Army also had taken 16 civilians along with them on the ferry. All are reported dead.

Mr. A. C. S. Hameed, Sri Lanka's Justice and Higher Education Minister has expressed his regrets with the UNO. Delivering his inaugural address at a seminar on "Federalism, Devolution and Provincial Councils - a re-appraisal?' organised by the Council for Liberal Democraey he said that he regretted that while the World Bank was stressing on de-pationalisation of the economy the UNO had failed to talk about the de-nationalisation of the national minorities.

Nation States identical with majority communities

Mr. Hameed has clearly xplained what he meant. According to Mr. Hameed after the Second World War many former colonies and imperial possessions became independ at. These newly independent countries began to 'nationalise' the cultures of minority communities. The new states had come to be identified with the majority communities. Nation states were equated to national majorities. Mr. Hameed continued to say that all minority groups want to retain their dentities, their roots. Mr. Hameed also made an urgent

appeal for a solution to the ethnic problem based on federalism, devolution or the doing away of the three subjects lists worked out by India and the Jayewardene Government and the substitution therefor of a single list containing the subjects allocated to the provinces.

Kumaran

Well Mr. Hameed is one of the senior politicians on the Government side. But seniority does not seem to have made him any wiser until after the event has occured. Because in the same speech Mr. Hameed comes out with certain facts which were hitherto unknown.

Hameed's Opposition

According to Mr. Hameed he had opposed the sixth amendment to the Constitution passed in the wake of July, 1983 pogrom; he had all in vain opposed the proportional representation system introduced by Mr. Jayewardene

Mr. Hameed also says that an opportunity to settle the problem was missed by the former Government in 1984 when the All Party Conference met for six months. He also

regrets that an opportunity to meet Prabakaran along with MGR in Bangalore was missed.

Mr. Hameed is a Muslim: His religion is Islam and his mother tongue is Tamil. His home is at Akurana in the Kandyan hill - country He is not a Baudha - Sinhala Goigama man. He could not therefore have been very happy with the series of legislative and administrative acts of the various governments, since 1948 which were designed to make the Island - Baudha-Sinhala - 'nationalisation' is the unfortunate choice word Mr. Hameed has found for Sinhala chauvinism.

Sinhalisation Mildly Described

While one can feel happy that Mr. Hameed looks accross the globe and even finds fault with the UNO for its acts of omission one cannot be happy at the reluctance and trepidation with which he approaches the problem at home.

Is it necessary to remind Mr. Hameed that it was Sinhala chauvinism that was reigning supreme when Lion Flag was thrust on the Tamils and Muslims? Does he not remember another Muslimmember of Parliament then, Mr. Abdul Azeez, pleading with the Government on the floor of the House of Representatives to at least remove the yellow border of the Lion Flag separating the orange and green stripes representing the Tamils and and Muslims respectively so that the flag may be an integrated one? Does he not remember the late Mr. A. E. Gunasinghe, then Minister without Portfolio and mentor of present President Premadasa telling his Sinhala audience to roll the orange and green stripes with the flag staff and fly only the pure Lion Flag, if they did not want the stripes representing the Tamils and Muslims to find place in the national flag? Wasn't Mr. Gunasinghe pampering to Sinhala chauvinism?

What about the Citizenship Act and the decitizenisation and desenfranchisement of Tamil plantation labour? What are the Government leaders talking today? What about planned colonisation of the Tamil Homeland? What about the more blatant Sinhala Only? This is an Island where all principal religions

are practised by substantial numbers of the peoples. Yet Buddhism enjoys the foremost position and is entitled to special protection constitutionally. These are all acts of Sinhalisation - though Mr. Hameed has very mildly called these acts 'nationalisation'.

Hameed Reluctant to come to grips

Now that Mr. Hameed has even ventured to look beyond the the thrice blessed Dhamma Dipa' we might tell him that current events make it clear that you cannot build a single nation out of two or more nations. As far as this Island is concerned it is the home of two nations - one Sinhala and the other Tamil and therefore there cannot be one single nation.

Mr. Hameed might to day be a devalued Member of Parliament by the proportional representatation election system which he opposed within the Government but which he could not prevent from becoming law. Yet he has a duty to act forthrightly.

Unfortunately, though Mr. Hameed opened his mind a little he is still reluctant to forthrightly tell the Sinhalese that they should not continue to claim the right to rule the Tamils.

Deeds not words Required

The Sinhala response to the Tamil claim has been re-

pression - a reign of terror and genocide. The Tamils have paid and are continuing to pay the price any freedom movement pays at the altar of imperialism - and the Premadasa government of which Mr, Hameed is Justice and Higher Education Minister and the J. R. Jayewardene government of which he was Foreign Minister, have committed genocide against the Tamils on a big scale.

People do not cut much ice by mere eloquent expression of generalities, when nothing is shown in action.

The Tamil students are suffering under the order recently made by Mr. Hameed as Higher Education Minister to treat the G.C.E. (A/L) examination 1990 (Special held in April 1991) as a separate examination and cause the release

of the cut off marks according to which a candidate from Kilinochchi District (a District classified as an educationally backward district) has to score even more marks than the student from Metropolitan and educationally advanced Colombo District for entry to the Engineering Faculty because Sinhala chauvinist Dinesh Gunawar dene made an unjust surore in Parliament. Tamils would like Mr. Hamsed to oppose injustice then and there and not later to say 'I opposed it but my opposition was not heard'. That is poor consolation. He may also remember that the first victims of Sinhala chauvinism were the plantation Tamils, now it is the Eelam Tamils and the turn of the Muslims cannot be far away.

A Cruel Decision

The large crowd that participated in last Wednesday's demonstation in Jaffna clearly indicated the common man's angered mood against a vicious government.

The Srl Lankan Government's decision to cut down by half the relief measures it undertakes for the refugees in Tamil Eelam is most detestable and deserves down - right condemnation.

The Government's relief measures for the wartorn Tamil Eelam territory is based on computations by the Director of Social Services for relief during natural calamities such as flood and consists of dryrations issued to each family computed on basis of the number of members of a family. The maximum relief is fixed at Rs. 315/- worth of dry rations per week for a family consisting of 5 members or any number more than five. Families with lesser members than five are given relief on a down scale depending on the number constituting each family, the minimum is as low as Rs. 84/-.

This relief is being given in Jaffna to families that have been uprooted and displaced from their homes and normal occupation from time to time because of the government's aggression and occupation of various parts of Tamil Eelam territory.

The people displaced from their own homes have been so displaced because an alien army has occupied their land and homes. They have lost not only their homes and other belongings but have lost their normal means of livelihood. According to reports some families are living even along roadsides. All these miseries have been caused to the Tamil people because the Government of Sri Lanka has decided to keep the Tamil people under Baudha - Sinhala rule at the point of the gun now that all their efforts to rule them by deceit have failed.

Even while fighting to retain a blatantly imperialist rule the Sri Lankan Government is trying to tell the world that their Government is a democracy and trying to picture Tamil freedom fighters as terrorists. Hence the rhetoric that the war is against LTTE terrorists not against the Tamil people.

If as the Government claims the Tamils are also citizens of the Sinhala country then it is the duty of the Government to look after the needs of the Tamils as well.

The Government has never discharged the duty cast on it by its own false claims. Wnatever relief that has been provided by the Government has been provided only grudgingly. However the Government has been very enthusiastic in seeing to it that the Tamil people do not raceive their normal requirements.

The Government achieves this objective by a system of b'ocking goods to Tamil Eelam through its military from the commercial city of Colombo. Nobody need have any doubts that Colombo is a city that exports military - ware. Only ordinary consumer commodities of the people are brought from Colombo, But many impediments have been placed by the government on the ficw of goods which has resulted in scarcity.

Added to this scarcity is the fact of loss of employment and displacement from homes for the Tamils. Yet the Government has decided to cut by half the meagre relief it was giving only to a section of the displaced persons. For example pensioners and others in employment are not entitled to the relief assistance even if they are displaced refugees.

That the Government's decision to cut down relief is unjust is borne out by the opposition the NGOO functioning in Jaffna have voiced against the Government's decision. The NGOO are directly involved in relief work amongst displaced refugees.

The opposition of the NGOO to the Sri Lankan Government's decision, it is hoped, will be taken Government. All foreign relief must be channelled through NGOO directly to the affected people.

As far as the Government of Sri Lanka is concerned its pretended concern for the Tamils is only a ruse to obtain further aid from foreign lands and to hoodwink world opinion that it is a democratic government ruling the Tamils with their consent.

How well the Sinhala state can rule the Tamils when it even robs Tamil refugees of the meagre food supply is something that can be easily inferred without any effort at exposition.

2 SRI LANKAN SENTRY POSTS DESTROYED

Tigers destroyed two sentry posts of the Sri Lankan Army near Palampotta Aru in the Trincomalee District. killing six Sri Lankan soldiers on Wednesday, September 9.

Reports from Trincomalee state that on Wednesday, September 9 at about 6-15 a. m. the LTTE opened fire on two sentry posts of the Sri Lankan Army, situated between Palampotta Aru and Monkey Bridge. These sentry posts were situted about 150 yards from the Palampotta Aru Sri Lanka Army Camp.

The Tigers killed six Sri Lankan soldiers in this attack and destroyed the two sentry posts. Many more were injured They also recovered arms, ammunition and other military - ware from the Sri Lankan soldiers. LTTE lost fighters.

A survey of didactie poetry in ancient world literature bears testimony to the statement of Dr. Albert Schweitzer that "there hardly exists in the literature of the world a collection of maxims in which we find such lofty wisdom."

The uniqueness of Thiruvalluvar is that his polity is universal and does not relate

to any particular state or kingdom. His ideas are based on a sense of values which are again universal and are not circumscribed by the conventions of a static society. Thiruvalluvar's concern was with an ideal state in the modern sense.

Thiruvaluvar has been acclaimed a realist with a universal out look; this was one of the fundamental traits of classical Tamil writing. He came in this traditional back-
