The Press Release states: The Sri Lankan Government, which is experiencing a crisis by its own attempts defeat our liberation struggle, by military means, is now planning to put in motion a scheme of sabotage activities to cause destruction to our people.

"The steps taken by the Sri Lankan Army at Vavunia, as part of this scheme to cause explosions targetting our people, has been exposed.

Kanthasamy omanthai and M/s. Navaratnam Rasamany are ordinary civilians who frequent Vavunia for purposes of trade.

Sri Lankan soldiers stationed at Vavunia had contacted these two persons with a view to procuring their assistance for their sabotage plan. The two Tamils who had understood the motives of the Sinhala soldiers had carefully moved with them and exposed their plan.

Explosives and other materials had been given to these two Tamils to mine the Omanthai-Semamadhu Road used by the public. The high explosives and other material were kept hidden in flour bags and biscuit parcels and sent over to the north on October 21, through these two Tamils.

We congratulate these two Tamils who handed over to us these explosives and other material which had been given

to them by the Sri Lankan Army and thus exposed the enemy's plan.

We also warn all our people to be careful against such sabotage plans'?.

Ten Sri Lankan Sentry Posts Destroyed

Large Haul of Arms Recovered

The LTTE carried out an attack on Sri Lankan Army Sentry posts in Mannar District and destroyed 10 posts and captured a house occupied by the army and recovered a large haul of arms.

The news in this connection states that at 2.15 am October 26, Monday, LTTE launched an attack on Sri Lankan Army sentry posts between Uyilankulam and Karambaikulam in the Mannar District. The attack lasted for thirty minutes.

While the attack was in progress Sri Lankan troops from the Uyilankulam and Adampan Sri Lankan Army camps moved forward with Buffel armoured vehicles for

Lightening Attack at Vav

Ten Sentry Posts-Buffel Armoured Vehicle Destroyed

In a lightening attack carried out by the LTTE agains Sri Lankan Army positions in Vavunia, the LTTE destroyed 10 Sri Lankan Army sentry posts, killing eight Sri Lankan Soldiers. The LTTE also recovered a haul of arms and ammunitions.

The news in this connection states that on Friday, October 23, about 11.40 p.m the LTTE carried out a lightening attack, on a chain of Sri Lankan Army sentry posts between Mamadu and Madukande, in the Vavania District. The attack lasted for ten minutes.

The news further states that the LTTE captured ten Sri Lankan sentry posts in the chain and destroyed them. wight Sri Lankan soldiers Eere killed. The LTTE also

recovered a haul of and ammunitions from Sri Lankan forces.

A buffel armoured vehicle from the Madukande Sri Lankan Army camp, which was rushed to relieve the Sri Lankan soldiers under attack was damaged by the LTTE exploding a mine. A number of Sri Lankan soldiers are believed to have escaped to other sentry posts or camps with injuries.

Discrimination against Tamil children in education.

Ask a chi'd in any lower class at school what are the essential basic requirements of man and promptly the child will answer "Food, clothing and

Ironically it is these fundamental basic needs of man that the Sinhala government tries to deny to the people in Tamil E-lam.

The latest gr vernment news is that the government's plan to issue free uniform coth to school children will not be implemented in schools functioning outside the areas occupied by the Sri Lankan Army in the North The ove whelming majority of school children in the North - almost all - are attending schools functioning outside army occupied areas in the North.

The government of Sri Lanka in its wisdom-we shall net say bounty - has decided to issue free uniform cloth to school going children throughout the island but not to children attending schools in areas not occupied by its army in the Tamil homeland. It is the Tamil he meland that has been laid waste by war and econ mic blockede and the needs of the children in this area are greater and ought to receive priority but unfortunately because of the Government's machinations prompted by ulterior metives Tamil children are deprived of all facilities to pursue their education.

Schools are bombed. Many schools are converted into Refugee camps oft and on. Some children attend houses temporarily converted into schools with no facilities whatsnever for imparting education. Books are not given in time. Public examinations are not held along with examinations in other parts of the island The cases of the G. C. E. (O/L) and (A/L) examinations are examples. When public examinations ere held belatedly the examination condidates are scared by aerial bombardment and artillery shelling, which have adverse effects on the candidates.

The injustice does not end there. When special examinations are held in place of examinations not be'd along with others as in the c se of the G.C.E. (A/L) examinations the Tamil c id dates, who sit the special examination because the government has failed to conduct the normal examinations for them are required to score marks still higher than candidates from Sinhala areas to compete with them for selection to admission to universities. And when Tamils protest against this discrimination, Higher Education Minister A.C.S. Hamed announces that he would no more hold special examinations as if such examinations had to be conducted because of the fault of the Tamil students! Should Tamil students be penalized because the Ministries of Defence and Education of the Sri Laskan Government cannot co-ordinate their activities is a question that he has failed to ponder over.

But again these are not matters that should surprise anyone. The penalising of Tamil students started under one time Education Minister, Bad - ud din - Mahmud in the SLFP government of Mrs. Srima Bandaranaike who required that a Famil student must score more marks to get into a university than his Sinhala counterpart. This notorious 'standardisation' continues to date in other forms. The denial of school uniform cloth to famil children in the Nonth is but a blatant in ance of racial discrimination.

While the government practises discrimination in educational institutions directly under its control or supervision, during the last two decades a large number of institutions are providing higher education in such fields as textile technology, printing, engineering etc. most of which may not have been even heard of by the students of Tanil Eelam, leave alone their joining those institutions for higher education. The stark fact of the matter is both peoples - Tamils and Sinhalese have gone their separate ways,

The government does not want to accept this openly but wants to oppress the Tamils by denying everything to them. Well if the Government leaves the lamils alone, we shall have no need to ask this and that from a government which does not want to treat all peoples alike.

Horror Killings in Batticaloa

Tamils Shot and Hacked to Death and Chased out of Villages

At least 10 Tamils died and over 12 were injured and all the villagers were chased out from their villages by the Sinhala Army, when it surrounded the villages of Kakkachchiveddai and Palacholai in the Batticaloa District.

The news from Batticaloa in this connection states that the Sinhala soldiers from the Army Camps at Palayadiveddai and Vellaveli in the Batticaloa District. surrounded the villages of Kakkachchiveddal and Palacholai on the morning of Saturday, October 24. They fired shells and bullets indisceriminately all over the two villages and then entered the villages and cut and stabbed villagers with knives. All villagers were driven out of the two villages.

Men, women and children came in for the attack by the Sinhala Army. Reports say that ten persons died and over 12 have been seriously injured, while still a large number escaped with injuries.

Some of the dead have been identified. They are Leduchmy (40) of Kakkachchiveddai, a mother of six children. Krishnapillai Panchadcharam (40), a father of seven children, Kathirkamathamby Annakesari (30), a father of 3 children, a married man Thamotharam Bhaskaran and Kandumany (70) all of the 37th colony and Palipody Thillaimohan (17) of Vellaveli.

Avarankal Bombed -Extensive Damage Caused 4th Day Bombing within One Week

Four Sri Lankan Air Force bombers bombed Averankal on Saturday, October 24, injuring many persons and causing extensive damage to property.

The news in this connection states that four Sri Lankan bombers dropped seven bombs near Avarankal junction on Saturday, October 24 about 11.15. a.m.

Two bombs hit a shop building and a garage causing damage to the value of several lakhs of rupees. Five bombs hit the gardens lands in the vicinity. Many people were injured.

This was the fourth day in the week ending October 24 when Jaffna peninsula was bombed. Bombings that took place on three other days were reported in the Hot Spring on October 25.

BOMBING ON DEEPAVALI DAY TOO

Sri Lankan Air Force planes bom ed Maruthankerni in the Vadamaradchy East division of Jaffna district on the Holy Deepavali festival day too.

The news in this connection states that on Sunday October 75, four Sri Lankan Air Force bombers dropped Six bombs at Maruthaukerni in the Vadamaradchy East division

LTTE Destroys Army Sentry Posts in Manal Aru

LTTE att-cked several Sri Lankan Army sentry posts near the Mankindi Sri Lankan Army Camp in Manal Aru area and destroyed them.

The news in this connection states that on Saturday, October 24, about 5.30 a.m. LTTE attacked the Sri Lankan sentry posts near Mankindy Sri Lankan Army camp. The attack lasted for 30 minutes.

The LTTE captured several Sri Lankan sentry posts and destroyed them. They also recovered some ammunitions and other military - ware.

While the attack was going on, shell attack was launched from the Sri Lankan Army Camps at Mankindi and the Sinhala colony by the Sri Lankan forces.

According to the news three LTIE fighters died in this attack.

October, 25th. happened to be the Deepavali festival day. Deepavali is the holy festival of light, celebrated by Hindus all over the world.

The bombing took place at 10 a.m. Ten houses were damaged.

The first two bombs hit the house of Velupillai Ramadas of Maruthankerni. The house was completely damaged with all the household belongings including a motor - cycle.

Two other bombs were dropped on the Thalaiyady-Maruthankerni Road. Two other bombs hit fields but damaged adjoining houses and a bakery.

There was no report of injury to persons.
