GOVERNMENT'S MILITARY

OPERATIONS A FLOP

The Sri Lankan Government suddenly announced an indefinite curfew in the Batticaloa District from 5.00 a m. on Sunday, November, 8. Intense military activity was promised.

The announcement of an indefinite curfew in the same style in which it is proclaimed in the North, seemed to suggest that all claims by the Government that the East had been brought under the Government's control were absolutely false.

As a matter of fact the declaration of curfew and Air Force operations following thereon made many independent media men opine that LTTE was a strong factor in the east.

The JOC also announced code military operations 'Jayapara'. News named from Batticaloa stated that as it does in the North, the Sri Lankan Air Force started extensive and heavybombing. There was however a difference. While in the North, Sri Lankan planes bombed civilian dwellings, in Batticaloa the bombing was done mostly in the jungles and some villages close to jungles. People from villages close to jungles were displaced from their villages in large numbers. Heavy bombing and helicopter strafing continued for a full day but details of damages were not known.

On the second day the Government announced the withdrawal of curfew rom some areas of Batticalon District effective from 11.30 p. m. the previous day! But curfew continued in areas which the other in fact were the larger and extensive areas of Batticaloa District. Curfew was, however, lifted in these areas too from seven p. m. on the second day i. e. November 9. And the operations codenamed 'Jayapara' were closed. In the meantime Sri Lankan forces lost one helicopter near Uhana forests. One officer was killed and three others were seriously wounded on Monday, November 9.

The Commander of the Air Force, Terrence Gunawardhene, who rushed to the area ordered investigations.
The Government forces never accept LTTE action as causing loss to its Air Force planes and helicopters.

In the meantime, independent news agencies said that the operations in Batticaloa were not successful to the Government and quoted

New Bishop of Jaffna

The popular Hymn 'Anjathe' (Fear not) which was taken in refrain by the whole congregation, was a faith inspiring phenomenon.

HEAVY RAINS AND STORM IN TAMIL ERLAM

Heavy rains accompanied by a storm affected the entire Tamil Eelam.

Reports from all parts of Tamil Eelam indicate that there was heavy rain on Thursday and Friday, November 12 and 13. Weather forecasts indicated a cyclone in the Batticaloa area. According to reports there was a storm the effects of which are still not known. Heavy rains poured in Batticaloa,

Trincomalee and other Northern Districts causing floods. Some houses were damaged due to the storm. According to reports a storm entered through Batticaloa south area and passed out through the Puttalam area.

In Jaffna displaced persons living as refugees under trees in Churches, temples and schools were very badly affected by the heavy rains on Thursday and Friday.

Elaborate arrangements are being made in Jaffna and other free Tamil Eelam territory to commemorate the War Heroes' Week from November 21 to 27.

As a prelude to the War Heroes' Week the period between November 15 and 21 would be celebrated as 'Resurgence Week' when voluntary social service activities - ranging from tree planting to restoration of tanks and ponds will be undertaken.

J. O. C. — SUPREME DEITY In Supply of Drugs to the North

A Press Conference was convened by the Regional Director of Health Services at the Regional Health Secretariat on 28.10.92.

At the outset of the Conference the Director said that his intention was to establish a closer rapport between the Press and the Directorate with a view to iron out certain misconceptions appearing in the Press from time to time which created some embarrassment to the local Directorate and sometimes ill-will among the higher echelons of the Health officials during their periodical tete - a tete in Colombo. He said it was his aim to enlist community participation in achieving tangible results'.

The Regional Diructor said that in accordance with the latest directive of the Health Ministry issued on (03.9.92) it was imperative for the Orders of Drugs-placed with the Medical Supplies Department (MSD) in Colombo to be channelled through the Ministry of Health.

This stricture further enjoins that no request for drugs, equipment, transport be made direct to any Non-Governmental Organisation which includes the International Committee of the Red Cross (ICRC) and the Sri Lanka Red Cross (SLRC).

It appears that, in the matter of Supply of Drugs etc. to the North the 'Presiding Deity' is the Joint Operations Command (JOC) which is the stern, quantity-pruning Pater Familias of the Health Ministry.

Here is a resume of some of the important drugs etc. received in the North:-

Wintomylon for Dysentry-500 received - a quantity not sufficient for even a day.

Anoxacillin (Anti - biotic) 2000 (requested qty.535,000)

Cloxacillin (anti - biotic) 14,000 (requested qty 58,000)

Penicillin (Anti - biotic) 58,500 (requested qty. 1,970,000)

Ampicillin (Anti – biotic 25,000.

Anti – Rabies Vaccine (5,000 millilitres). It must be mentioned that the required quantity for a person is nearly 50 mls.

A cursory glance by the discerning reader will reveal that in the supplies of drugs the JOC has its fingers in the supply pie of drugs.

(1) Health

According th the Regional Director:-

Leprosy- this disease is on the increase and is pronounced in the areas of Manipay and Chulipuram 67 new cases of leprosy have been reported in the Jaffna Region while last year there were 110.

(II) Tuberculosis -

Is also on the increase and is more pronounced in the Puttur area.

(III) Hydrophobia

There have been 25 cases of death to date where as

last year there were onl

It may be recalled that the available quantity of Anti-Rabies Vaccine is 5,000 mls and the required dosage per person is nearly 50mis.

The lethal drug - Strychnine - required for the elemination of rabid dogs has not been made available. Injection of drug against rabies is

Betrayal-The Watchword

"The forces are not fighting with confidence. It is because the Government is not showing interest in them. As a result, they are undergoing defeat after defeat in the war. We want the help of India to win this war. Why should not we obtain the help of India to defeat the Tigers?". This is what D. M. Jayaratne, a senior SLFP member of Parliament said in parliament recently.

D. M. Jayaraine represents the feudal, aristocratic, elitist interests of the Kandyans. When the last Kandyan ruler of Sinhalese ethnicity bestowed the Kingdom to the Nayakars in 1739, it was done with the blessings of the Sangha. Sri Vijaya's rule was sponsored by the Buddhist monk, Saranankara. The Kandyan aristocracy glossed over the fact because they were not united and opposed anyone from their rank coming to power as king. But during the reign of Kirti Sri, when the administration of the country was in the sole hands of his father supported by a Tamil from Jaffna, the Kandyan aristocracy could not bear it. It was well known that during this period the Sinhalese nobility encountered several humiliations. It is because of this they plotted against the king. They wanted power and prestige bestowed on them, So they went to the Malwatte temple and took a resolution to put a Prince of Siam upon the throne of Kandy. The Kandyan elite was prepared to sell the kingdom even to a foreign country, viz, Siam, in order to win back their positions of authority. This plot was called the famous 'Moladande Rebellion' of 1760. Even they did not succeed, and Samarakodi. Second the Adigar was executed, one could understand the volatile and mercenary nature of the thinking of the Kandyan elite.

Ceding Kandyan Kingdom

This is not the first occasion the Kandyan elite betrayed their kingdom to safeguard and preserve their own power and authority. The Britishers conspired with the Kandyan nobility to oust the king. In order to alienate the common people away from the king. the Britishers, in a proclamation addressed to the people in collaboration with the nobles notably Pilimatalawa, the first Adigar said the reason for their campaign against Sri Wickrama Rajasinghe was to deliver the Kandyan people from their oppressions, for the subversion of the Malabar dominion which during three generations had tyrannised over the country. Mind you, this proclamation was made, while the British army was marching towards Kandy. They, as well as the Kandyan Chiefs knew the ordinary people would not support the Britishers. To the people, Portuguese, Dutch or the Britishers were all foreigners. The ordinary Kandyan identified the intersts of the king, sasana and himself as one - composite

and indivisible. If at all, the Kandyan peoplehated anyone. it would have been Kandyan aristocracy who was directly controlling the people socially, economically and administratively on behalf of the king and exacted Rajakariya and feudal dues with extra profits for themselves, to divert the common man and to alienate the king from them, John D'oyly and the Kandyan nobles had to bring in the ethnic factor with all its historical associations. One could understand the attitude of the Kandyan people on this point only if one could visualise how the entire people of the Kandyan kingdom spontaneously rose in rebellion against the Britishers in 1818 due to their passion for monarchical restoration. When Sri Wickrema Rajasinghe asserted his royal overlordship in the administration of the kingdom by appointing his own men, the Kandyan aristocracy conspired with the Britishers and sold the kingdom by signing the Kandyan Convention, hoping to get back power and authority which they enjoyed earlier. In this respect they were losers as subsequent events proved.

Federal Constitution?

A community cannot be blamed for furthering its selfinterests. But the elites of that community are composed of only a very small fraction. Their whims, fancies and selfin- terest should not be forced on the rest of that community. The Kandyan elite in the early twentieth century came from the few who had an English education and those who had entered the liberal professions, While the Kandyan people were poor and were a toiling mass bewildered as a result of transformation from the feudal system and unable to

cope up with the plnatation that was being forced on them, the elite of this community was thinking of its past glory and to get back the powers and authority they had enjoyed once. They felt uncomfortable by the influx of British planters, missionaries, low country Sinhalese traders, the Indian immigrant labour etc. They had also a firm conviction that they were the survivors of a lost patrimony. They were correct. But they forgot the fact that it was their forefathers (elites) who betrayed the country to the foreigners. They wanted to set the clock back. They

hated the low country Sinhalese, This resulted once again in the Kandyan elite leaning on the British and attempting to beat back low

"National unity" can be brought about in the island of Sri Lanka by converting Tamil Hindus to Buddhism and getting Muslims to give up Tamil and adopt Sinhala as their mother tongue according to Baudha Sinhala - Chauvinism.

A news report from Vavuniya states that Sri Lankan Army personnel at Cheddikulam and some Buddhist priests are settling Sinhalese in large numbers there. They also have asked many young Hindus to embrace Buddhism and be ordained priests with promise of all comforts.

Then again Wilson Hettiaratchi of Kotte has called upon the Muslims to give up Tamil and adopt Sinhala as their mother tongue for 'greater harmony, unity and peace'.

Writing in the Island of 22-10-92, he says, "...why the Muslim community has so far failed to accept Sinhala as their language and have adopted Tamil as the day to day language... if Sinhala had been accepted by the Muslims as their mother tongue, the harmony and goodwill between the twocommunities would have been doubled or trebled by now? This being the case it is my view that this Dr. Jekyll and Mr. Hyde policy should cease at least now. It is time for our Muslim brethren, specially the elders to do a little rethinking on this matter, taking into consideration the present day developments and advise their followers to adopt Sinhala, the language of the

majority, as their mother tongue for greater harmony, unity and peace in our Country."

Britain Turns A Blind-Eye

The latest decision of the UK Government to lift the ban on shipments of military - ware and release certain types of military - ware such as planes, battle tanks and spares but exclude bombs and explosives, to Sri Lanka is most unfortunate.

It is clear that the commercial interests of UK, require a lift on the ban and therefore the UK Government is not bothered that its non - supply of ammunicions and explosives alone is sufficient to ensure non - escalation of the Tamil - Sinhala war, if it is indeed its concern. Arms manufacture is said to be the most lucrative industry in the world today and the 'nation of shopkeepers' (hark back to past!) do not want loss of profits - even if the 'wretches' who kill each other were its subjects a few decades ago!

Britain c nnet plead ignorance of the state terrorism of the Baucha - Sinhala Government or the genocide, it has been committing for decades - against Eelam Tamils.

The Sinhala government practises discrimination against Tamils not only in ordinary civilian life but also in war. Sinhala 'rebels' are called 'subversives' -Tamil 'rebels' are called "terrorists". While aerial bombardment, shell attack and cannon fire are liberally practised in Tamil Eelam-such atrocities have been happily and conspicuously absent in the south against the J.V.P.

Though from the time of the First Colonial Secretary downwards British Resident heads had amply explained to their Home Government the existence of two different nations - occupying two different territories and peoples speaking two different languages following two different faiths in the and Island British imperialism preferred not to see the two countries - Tamil Eelam and Sinhala Rata - but created a stra egical entity to safeguard its own imperialist interests. The present blood bath in the island between the l'amils and Sinhalese is directly traceable to this.

One would in these circumstances expect Britain the present day Britons - to do something to salvage the Tamils who are today being ruled by the Sinhalese, thanks to the British gift! But the decision of the UK government clearly makes out that it is least concerned about its moral responsibility and always conscious of its profits

Britain must take the sole responsibility for the plight of the Tamils and help in the restoration of Tamil Eelam, which it had obliterated from the map of the world. Though it is generally gall and wormwood for any government to look upon with favour any rebellion from any quarter, the Eelam Tamil Rebellion is necessitated by British imperialism and we must re-iterate that the Government of UK at least as far as Eclam is concerned must instead of tredging the beaten tracks of all governments be pragmatic and help the lamlls restore their ancient Tamil Eelam

The British government's latest decision spells out the utter and callous disregard it has for its own moral responsibilities. We are constrained to say that turning a blind - eye to its moral responsibilities speaks very poor of British statesmanship which prided itself of its empire at one point of time.

Tamil Eelam is not an innovation. It is only an urge to be reborn. We would therefore reiterate the moral responsibility that UK owes the people of Tamil Eelam and call upon the UK government to forget the politics of profit and loss commercialism and discharge her obligations which political morality demands of her and help Tamil Eelam - a separate nation which she took over - rank with other nations.

ATTACK

Seven S. L. Soldiers Killed - Arms Recovered

In a lightning attack carried out by the LTIE at Manal Aru, LTTE fighters killed seven Sri Lankan soldiers, recovered arms and ammunition and destroyed a sentry post of the Sri Lankan Army.

The news in this connection states that on Monday, November 9 about 4.30 p. m. a group of LTTE fighters attacked a Sri Lankan Army Sentry Post between Somavil and Thennamaravady S.L Army Camps. The attack lasted for four miautes only. Seven Sri Lankan soldiers were killed and a number of others who sustained injuries escaped to the Army Carps

The LTTE fighters recovered all arms, ammunition and other military ware in the post that fell under

LTTE attack and destroyed it completely. The LTIE suffered no casualties.
