TO VACATE

INTERNATIONAL ORGANIZATIONS NOT IN FAVOUR INDIA ALSO SAYS: NOT HUMANE

Tamil Refugees in the Island by the Government of Sri Lanka.

After the outbreak of Church Refugee hostilities a large number organizations Camp in the Mannar District Tamils left their villages out have been asked to vacate of fear for the Sri Lankan the camp and proceed to Army. A large number of Vavuniya town or the Mannar refugees came to Madhu where a Refugee centre was set up.

Independent international like the UNHCR and ICRC undertake relief work amongst these refugees. In fact the Government of Sri Lanka suggested Refugee Camps under supervision by

organizations and the Indian Government also welcomed the suggestion. But right from the beginning the Tamil people objected to any refugee camp under the protection of the Sri Lankan Government forces under guise of providing security. international The people also objected to

being classified as refugees in their own home land.

Now the Government of Sri Lanka has asked the refugees in Madhu Church camp to vacate the camp and proceed to Vavuniya or the Island of Mannar.

Hand bills to this effect have been printed and dropped all over Madhu Church area from helicopters.

Explaining the decision of the Government to issue quit notices to the refugees in the Madhu Church Refugee Camp, Sri Lanka's State Minister for Defence has said that there are LTTE 'hideouts' close to Madhu from where LTIE cadres function. It was from this area that the LTIE planned and executed an attack at Kondachchi a distance of over 40 miles from Madhu. which claimed the lives of 49 soldiers the Sri Lankan Army last month Therefore the Minister said that aerial bombardment of the area has been planned by the Government and therefore the refugees should vacate the Camp.

The Minister has said that there are about 10 000 refugces in the Camp.

But independent organizaions like the UNHCR and ICRC have disputed the Minister's figures and said that the refugees number well over 20.000.

They have also said that the evacuation of these refugces is not feasible. All India Radio in its news bulletin quoted an official of the Indian Foreign office as saying that the Sri Lankan Government's plan was not humane.

Navy harasses

After the killing of 49 soldiers of the Sri Lankan Army at Kondachchi in Mannar District on the 17th of last month, large Naval Vessels have anchored both on the Northern and Southern seas of Mannar Island.

Naval ratings chase fishermen going out to sea for fishing making use of smaller boats.

Naval boats with cannons are anchored very close to coastal villages such as Vidathalthivu, Erukalampiddy, Talaimannar, Old Birdge, Olai Thoduvai, Vankalai and Arippu.

A certain Kumar wrote a 'reply' to Mr. Mariadasan in the SUNDAY TIMES OF 10TH. February. He had given his name as G.G. Ponnampalam (Jr.). It is fully appreciated, as Kumar already, coes that he would only be given a hearing not in his own right but only by the man le he wears. Right from the beginning Mr. K. mar it as tried to gain place by 'reflected glory.'

If this Colombo Tamil has restricted himself to defending his present political playmates at the so called A.P.C., one need not bother. On the other hand he had chosen to speak more and shown his true colours, as he inevitably must.

Mr. Kumar has said that one thing must be said in favour of the EPDP and that is, if the EPDP had decided to sell its soul and itself for a livelihood, it was doing so openly and completely. How true is the same comment about this Kumar also.

So, Doesn't Kumar, run with the hare and hunt with the hounds, all for treasure? Isn't he guilty of the same charge he levels against this "sophisticated Tamils"?

Mr. Kumar ends by saying that if he is further disillusioned, he will kick himself and tell himself - "Serves you bloody well right". He need not bother himself. The Tamil people have already told him so.

If Mr. Kumar and the sophisticated Tamils think that they can conjure up emotions for political gains and betray the Tamil people and Eelam, they will have nothing but disillusionment. But a Tiger even when he takes his own life with cyanide, is not dislussioned but very hopeful that Eelam will be restored. Even in death the tiger is peaceful and unagitated because he has an ideal - not selfish personal gains - which motivates him. Let Mr. Kumar remember that the Colombo Tamil leadership of Eelam Tamils has been buried long

IRAQ and AFGHANISTAN

What may you ask have these two countries in common? Quite a great deal if one takes a close look at them both. They are both moslem nations and have their own share of troubles, which like a night flame has attracted many extraneous months.

In Afganistan the Russian

armed forces went into that country in great numbers to prop up a regime that was not too popular and which the outside world thought was a PUPPET of the Russians. The unpopular Afghan regime was opposed by a terrorist organisation called the Mujahideen, who operated from neighbouring Pakistan, a stooge of the Americans and via this stooge, the Americans began to supply the Mujahideen with the most sophisticated armaments that a terrorist organisation could ever dream of. The Mujahideen made good use of the American weapons, especially the Stinger Missile and brought down many Soviet planes and other aerial machines that were widely used by the Russians, thus causing a severe dent in the Russian war effort in Afghanistan and also causing heavy loss of Russian service personnel running into the thousands. An open letter to His Excellency Bishman Narayan Singh Governor of Tamil Nadu

Sinhala Imperium Extends over Tamil Nadu

Your Excellency appointed Governor of Tamil by constructively Mr. Barnala forcing out from that position solely to appease President Premadasa and the Sinhala Sri Lanka.

Will Your Excellency recall to mind certain facts of the not distant past.

- (a) Prime Minister Rajiv Gandhi was given a thrashing with the butt-end of a gun by a Sinhala naval rating at a parade on the day he signed the Accord with Sri Lanka.
- (b) Be that, this naval rating who was convicted and sentenced to jail for this act was given a reprieve and thereafter he revealed that higher authorities were aware of his intention to assault Prime Minister Rajiv Gandhi.
- (c) That President Premagave ample indications of his contempt for this Accord and Prime Minister Rajiv Gandhi.
- (d) That he made a summary Quit Order to the Indian troops as his election plank in late 1988
- (e) That he announced his intention to issue a Quit Order to the Indian troops at a temple ceremony without any prior consultation with India and that he issued a peremptory Quit Order as announced by him.

- (f) That the wording in the provisions of the Accord relating to withdrawal of troops laid down that the troops should be withdrawn when requested by the President of Sri Lanka instead of the conventional phraseology that the troops would be withdrawn as mutually agreed upon between the Governments of India and Sri Lanka. That Prime Minister Rajiv Gandhi did sign this stupidly worded agreement without any consultation with his Cabinet.
- (g) That Prime Minister Rajiv Gandhi's pompous pronouncement asserting Sri Lankan Sovereignity over the North-East and consequent territorial integrity stopped him from pursuing any steps to effect any settlement for the ethnic problem by making the ethnic conflict an internal affair and denying India a locus standi on the
- (h) That President Premadasa told Prime Minister Rajiv Gandhi that devolution and other matters mentioned in the Accord were internal matters and that India had no status to raise these issues
- (i) That Diplomat Dixit had frankly confessed that among the middle and younger ranks of India's Armed Forces there was some bewilderment at their being ordered to shoot and kill the Tamils when in reality they went to Lanka under the

impression that they were to protect the Tamils.

- (j) That the Commanding Officer of the Peace Force did not enjoy unity of command in the North-East of Lanka where he was given a Mandate to protect the citizens of all communities and that in the event Sinhala Armed Forces remained in sixty to seventy Camps there in over which the IndianPeace Force was only nominally given complete jurisdiction. That at several places on public highways posters and sign-boards appeared annoupeing out of bounds for the Indian Peace Force,
- (k) That Sinhala colonists objected to the Indian Peace Force setting up Camps at various places and that the Indian Peace Force sheepishly withdrew from such camping sites.
- (1) That the incident at Palaly aerodrome, at the very beginning, when the Indian Commander surrendered to the Sri Lankan Air Force and agreed to hand over the seventeen senior men of the LTIE cadres to be taken for torture to Colombo was contrary to the General Amnesty and other provisions of the Accord.
- (m) That Diplomat Dixit offered to transport Sinhala investigating officers and their equipment to Jaffna to enable them to carry out their interrogation

- (n) That it was Prime Minister Rajiv Gandhi who personally ordered the surrender of the seventeen LTTE men to be tortured by the Sinhala Air Force and this led to the LTTE refusing to observe a cease-
- (o) That the first act of the Indian Peace Force was to blast two popular newspaper establishments in Jaffna.
- (p) That as a reuslt of the action of the Peace Force the judicial function completely collapsed in the North - East and the civil administration came to
- (q) That the Indian Peace Force, far from making any efforts to restore normalcy, treated the Tamil people as enemies, issued a peremptory Quit Order for more than a lakh of people to leave their homes immediately on pain of being shot
- That the Indian Peace Force declared an indefinite curfew lasting more than a month and ruthlessly enforced a curfew ignoring all human rights and decency of conduct.
- That nearly ten thousand civilians were killed and a large number injured by the action of the Indian Peace Force.

- (t) That the Indian Peace Force indulged in raping, looting and senseless destruction of assets.
- (u) That for the bulk of the period the Indian Force was there, freedom of the Press was denied and for months there were no newspapers.
- (v) That this war against the Tamils compelled - the Tamils to appeal to to President Premadasa to send out the Indian troops thus giving the Indian Government no excuse to remain in the North - East of the Island.
- (w) That Prime Minister Rajiv Gandhi's Sri Lankan policy was absolutely disgraceful and did untold damage to India's image.

Mr. K. C. Adiapathan of on 04-12-90. The Bank Valvettiturai is a customer and account holder of the Bank of Ceylon, Point Pedro Branch. Mr. Adiapathan had not been able to draw his own money from his account since the North-East war broke out. The last time he drew money from his Bank was on 15-5-90.

Despite repeated requests and representations, even to the Head Office, Colombo, Mr. Adiapathan could not draw money from his account and in desperation he obtained a Pay Order from the Point Pedro Branch of the Bank

promptly debited Rs. 50/to Mr. Adiapathan's account for issuing the Pay Order though the issue of a Pay Order was necessitated by the failure of the Bank to discharge a fundamental conditon of the contract a Bank enters into with its customer - viz. to pay cash when a customer presents his own cheque, if funds are available to his credit in his account.

In the case of various Banks in the North, they are unable to carry out this fundamental contract obliga-

to be carried out. So the Bank of Ceylon issues Pay Orders where requested instead of cash.

Mr. Adiapathan, after waiting for 6 months, was compelled to at least obtain a Pay Order from his Bank, as the Bank had no liquid cash to pay. But the Bank charged a Commission of Rs. 50/- on the Pay Order and debited the Commission charges also to Mr. Adiapathan's account. That Mr. Adiaphathan again had to pay Rs. 50/- to someone else to encash the Pay Order is another story.

Mr. Adiapathan took up the propriety of the Bank levying a Commission on a Pay Order which it made available as a poor alternative to payment of cash.

National Identity Cards

Dear Sir,

Kindly publish this letter in your magazine of understanding and social justice to spotlight all forms of injustice, discrimination and other anomalies which are common in this land.

There are a large number of persons whose national identity cards have been lost stolen, damaged, burnt, and most shamefully to be eaten by the owners themselves at gun point by some security personnel since 1983.

To obtain a duplicate identity card, the holder has to lodge a complaint at a police station and to attach the complaint extract certified by the OIC of the Police Station on a ten rupee stamp. The Police Stations are not functioning and all the police meant for the North are operating at Colombo from the Police ranging down to the Constabls D I G of the range.

It is humanly impossible for a person to go to the Police Station in the country without the said identity card. If he goes with a temporary identity card signed by the AGA of the division such card is not hounoured and the said person will be the guest, who has to face inumerable hardships, which are well known to the readers.

To ease the present situation to get duplicate identity cards, May I suggest that the Gramaseva Officer be empowered to record the complaint and to issue the certificate of the entry extract, counter signed by the area AGA at least for the time being to help the people who are desperately in need of such cards to transact their various business.

The relevant form RPT 7 U may also be signed by the AGA of the area instead of the OIC of the police in column police certificate on

The Gramaseva Officer is the sole authority in handling these identity card system. There is nothing wrong to entrust the police aspect of the case in view of the present pitiful scenes.

It is sincerely hoped that the Commissioner for the Registration of Persons, Colombo 5 will be pleased to consider this reasonable request to ease the sufferings of the affected people. It is also impressing to learn that the said Commissioner is fair to all castes and creeds and has cleared an appreciable number of applications which were pending for a long time.

The present authorised officer of the said department, attached to the Kachcheri, Jaffna, (Mr. Carthi-

gesu) has also sent his retirement papers. It will be appreciated if a kindhearted and hospitable officer like Mr. Carthigesu is sent in his place in order that the work of the said instituition may be continued without interuption.

Electoral Registers

The Editor Dear Sir,

It is saddening to observe that the annual revision for the electoral registers of the north east province has not been properly done since 1987 enumeration, as statutorarily done by the Department of Elections throughout the Island.

As a result of this lapse plenty of youths who have reached the required age of 18 years on first of June 1987 and those who have returned to their homes from many parts of the island and from abroad, mostly on retirement, have been deprived of their civic right. It is estimated that more than 125000 eligible voters have been deprived from the said registers, since 1987.

The election department simply copied the original certified voters list at Colombo for the years 1987, 1988, 1989, 1990, just to show that the electoral revisions have been completed and certified. This may be another world record, in the entire election system of the whole world. Some arrangements should have been made to enumerate the said unfortunate people.

Most of the people are not at all interested to get their names registered in the voters registers. But they are very very interested to get the provision cards even under the air attacks, hot sun or rain. The department of election may assert that they gave the maximum publicity through the mass media to register the voters in the respective elections offices. It will be appreciated if the people are to compelled to register their franchise on a specified form with deterrnt punishment, as done in many countries. The presentGramaseva Officer and special enumerators system to register the voters is an eye wash and there are plenty of loopholes. I know a gramaseva officer who was out of the country was able to return all his enumeration documents earlier the dateline. He simply signed all the relevant forms and gave it to his wife and some trusted friend. They completed all the particulars from the previous year registers, forged the signatures of the chief occupants, bundled

wards and returned it to the regional elections office. They had only to add one year more to the previous year enumeration forms.

There had been incidents of willful omission of the voters with some petty excuses to take political revenge. Plenty of nonexistant names were also found in the said voters lists. of SriLanka-have been targets of direct attack by bombers of the Sri Lankan Air Force.

The Mullaitivu Base Hospital was ransacked by the heroes of the Sri Lankan Army. Drugs, medicines, equipments and furniture were robbed by these heroes - staff and patients having fled the hospital at the approach of these marauding murderers.

Not content with the havoc already done, the Sri Lanka Air Force planes bombed this hospital [causing heavy damage to the buildings. This hospital - the premier hospital in the Mullaitivu District-does not function.

So too the Mankulam Base Hospital was subject to severe air bombing by Sri Lankan Air Force planes.

This hospital has been completely destroyed.

The Iranai Illuppaikulam hospital was also subjected to bombing from the air. This hospital does not function now.

The hospital at Mallavi too was hit by Air Force planes on a number of occasions, Semehow staff are carrying out very restricted treatment from those portions which escaped the wrath of the bombers.

Kilinochchi Hospital was also bombed but is now functioning with difficulty.

So all these five hospitals in the Vanni District were all direct targets of Air Force

- about the air Q: What raids?
- A: I told you, air raids are only against identified LTTE targets.
- O: There is evidence that civilian places like temples and schools have been bombed?
- A: Temples and schools are not targets. There might be accidental hits somewhere. The problem is they cannot be identified.
- Q: In the past six or seven days, five or six temples and schools have been hit. There is no question of making mistakes.
- A: We have told our officers that they should be careful. They know the area quite well and there should be no question of any mistake.
- There are instances of refugee camps being hit?
- A: Where?
- Q: At Kokuvil, at Mullaitivu, Is it not deliberate?

- The following are excerpts A: Never, It might be by mistake. We will convey this to the Commanders, so that such mistakes will not be repeated.
 - Q: So many such accidents have happened. It looks as though it has become a practice. Have you no control over your men?
 - A: We have control over our men. We are at war. Remember that we are not playing marbles.
 - In the process you are killing civilians?
 - A: I have said we are fighting a war. In a war it sometimes happens. What is happening in
 - Q: We are not talking about Iraq. We are talking about Sri Lanka.
 - A: War is war everywhere. We are fighting a war. We are fighting to a finish.

Mr. Ranjan Wijeratne, State Minister had met the Press and excerpts from the Questions and Answers at the Press Conference are given above.

It would appear from answer to question one above that air raids are only against IDENTIFIED LTTE targets.

We take it that the forces have indentified their targets before the attack and they have identified them as LTTE 'hideouts'. Surely the forces must be congratulated for their skill at identification of LITE hideouts when as Mr. Wijeratne himself pathetically admits that they have no control of the territory.

The Sri Lankan Army and Navy are confined to a few camps in the North and from the safety of these camps launch artillery shell attacks when and where it pleases them. The Air Force only roams the skies and bombs from above. There is not even the Police functioning. In these circumstances, the forces deserve congratulations, if they really indentify LTTE 'hideouts and targets'.

But when one is inclined to congratulate the Sri Lankan Forces for the reported skill at identification, the Minister himself dampens that enthusiasm with his own statement.

In answer to question 2 above, Minister Ranjan Wijeratne has said: "The problem is they (meaning temples and schools) cannot be indentified".

Hindu temples as much as other temples are easily identifiable. Most Hindu Temples have structures that are called 'Gopurams' which are very tall. A Temple or a School is the most easily identifiable place in any locality

and this is known even to a child. But Minister Wijeratne says that these public places cannot be identified and he wants the press to believe that his men identify 'LITE hide - outs' but not public places of worship or education. It is beyond anyone's comprehension how the Sri Lankan forces that connot identify temples and schools, are able to identify LTTE 'hide - outs' and carry out air raids against those

So when one reads Mr. Wijeratne's answers to the pressmen's questions, one is convinced of the charges made by the public in the North that air bombing is ind scriminate, carried out only on civilian dwellings, business places or other like public institutions and that the Government of Sri Lanka carries out a war of destruction of Tamil Eelam and its people and not against the LTTE, as it makes out for public consumption to hide its heinous crime. The questions and answers above show the jumbles in which Mr. Wijeratne found himself at the Press Confer-

When Pressmen said that there was no question of making mistakes, he said that he had told his officers that they should be careful but hastened to add that his men knew the area quite well and there should no question of any mistakes:

Does this answer not expose the Government? Does this answer not substantiate the public charge that air bombing of civilian targets is deliberate? If Mr. Wijearatne's men knew the area well and there should be no question of mistakes, were not all the bombings of civilian targets delibeate?

What happened at Valvettiturai? Over thousand houses, temples, schools and hospitals were damaged. Even according to the Government Agent of Jaffna ninety percent of civilian houses in that small town were damaged. Not a single LTTE target came in for attack.

Mr. Ranjan Wijeratne says his men know the area, they identify LTTE targets, they cannot identify public places such as Temples or schools, they cannot make mistakes, but if co nered with questions, he will pass off everything as a mistake and justrify all his 'mistakes' - nay misdeeds -as inevitable consequences of a major war - as the Gulf War - but if some foreign nation draws attention to what is happening here - to the genocide of the Tamils - he and his Government will promptly saythat the matter is an internal affair in which oth-. ers need not poke their fingers

So much in this muddled thinking of a Baudha Sinhala imperialist head!

Three Houses Completely Destroyed by Bombers

Evacuation or Emigration?

Mr. Ranjan Wijeratne, State Minister for Defence of the Government of Sri Lanka is reported to have repeated his call to the people of the Jaffna District to move out of their homes. He is reported to have made this call at a Press Conference held in Colombo in the first week of last month.

Reports have also been received that the State Minister has called upon the refugees in Madhu Church to move out of the Refugee Camp there and go to the Island of Manuar or Vavuniya town and that his Air Force helicopters have dropped notices to that effect from the skies.

These reports also say that independent international relief organisations like the UNHCR and the ICRC have said that the Government's call, asking the refugees in Madhu to vacate that area, is not a feasible proposition.

The State Minister has also said at the Press Conference in the first week of February, 1991 that if the people of Jaffna 'want to live', they must move out. According to him the whole of Jaffna should be vacated.

He has also given a grim reminder to the Tamil people that they should 'understand by now that it is not safe to be in areas where the LTTE is operating'. According to Mr. Ranjan Wijeratne, the evacuation of the whole of Jaffna by all the people is necessary to carry out his 'fight to the finish' with LTTE.

Of course Mr. Wijeratne has also boasted that they (the Government) have already looked after a million refugees.

According to Mr. Wijeratne the people of Jaffaa are being used as hostages by the LTTE. They are being used as human shields. The LTTE is hiding behind old men and children.

We shall not grudge Mr. Wijeratne carryng out his tirade against the LTIE for his self-satisfaction.

But we ask Mr. Wijeratne what right he has to ask us Tamils to leave our own homeland- a land where not only we but our forefathers had lived and died from days beyond human memory? What right has this man from Ruhuna to ask us Tamils to leave our homeland of Eelam? We are not in his country to be kicked out and chased by him as he desires.

A naked aggressor may ask a people to get out of their homeland - but Mr. Wijeratne does not admit he is an aggressor. On the other hand he reiterates his being a democrat. What democrat will ask the people of a country to leave their own country?

We tell Mr. Wijeratne and his Government that they have no right whatsoever to ask the people to evacuate their homeland.

We reiterate that Mr. Wijeratne and his Government have on moral or legal right to rule Tamil Eelam or its people. The Government of Sri Lanka claims the right to rule Tamil Eelam ans its people only by perpetrating a fraud. We have not submitted to Sinhala rule by consent or conquest.

If Mr. Wijeratne and his Government wants to 'fight to a finish', the unfortunate decision is theirs.

We know the atrocities committed on Tamil refugees in refugee Camps in the Amparai, Batticaloa Trincomalee Districts.

We, however, ask Mr. Wijeratne why the civilians should evacuate their homes when the Sinhala Army may try to win the LTTE by fighting them. LTTE is not hiding behind 'old men and children' They are before the very eyes of the Sri Lanka Army which is confiend in the security of its camps.

So the only thing Minister Wijeratne has to do is to get his men move forward to get at the LTTE and not refreat by the backdoor as he ordered his men to do in Jaffna Fort and said something quite different to the Sinhalese people.

We reiterate that the LTTE and the Sinhala Army may fight the war, if it is the unfortunate choice. But the civilians used not evacuate. Nor need their houses, shops and other possessions destroyed by bombing and artillery shell attacks.

The combatants are face to face. Why should the non-combatants suffer?

Students' Demonstration -

PROTESTS AGAINST KILLING

Students and Teachers from all over the Jaffna District including students attached to the University of Jaffna, walked out of their classes on Friday the 1st March to join in a demonstration and rally to protest against the wanton killing of some school Principals in the Mannar District.

Following the killing of 49 soldiers of the Sri Lankan Army by the LTTE in Kondachchi in the Mannar District, the Sri Lankan Army arrested a large number of Tamil persons on whom they could lay their hands. Those arrested, included three principals of some schools in the Mannar District.

These three principals who were from the village of Vankalai, had gone to Mannar town to draw the salaries of teachers. On the way they were nabbed by the Army and taken to Army Camp. They were killed there in retaliation to the killing of 49 soldiers. The fate of others so arrested, is not known.

Earlier there were similar demonstrations in the Mannar District, protesting against the killing of school Heads.

Friday's demonsration was called out by a Students' Organization. The All Ceylon Tamil Teachers' Union also exhorted its members to

participate in the demostration and support the students.

Reports from other Divisions within the Jaffna District indicate that there were similar demonstrations in Vadamaradchchy, Thenmaradehehy, Islands Division and also in the Killinochchi Dist-

The demonstrators carried placards and slogans calling for a stoppage of killings. The demonstrators also shouted slogans calling for the holding of G.C.E. Examination Advanced Ordinary Levels which not held in August and December, 1990 when they were respectively due.

The demonstration was followed by a rally.
