INDEFINITE CURFEW

DEPENDE MINISTRY VS EDUCATION MINISTRY

An indefinite curfew was announced over the Colombo Radio on the morning of Thursday, 15th April, 1991 throughout the Jaffna Peninsula though the specially fixed G. C. E. (A/L) Examination for wuddenly on the 25th April, North East had already begun on the 23rd instant and is continuing and will be continued till the 13th May 1991.

But even before the curfew was announced, the combined forces of the Sri Lankan Government, commenced an attack on the Island of Karaitivu at about 4.30 a m. the same day. The whole of that night- i.e. the niget - of the 24th and very early hours of the 25th twitnessed a barrage of shell and connon fire attack on the Karaitivu Island. On the morning of the 25th the Sinhala Army encamped at Palaly and Kankesan urai. started shell attack as also did the Army at Kayts. The Army started a major offensive from the various camps in the Jaffna Peninsula.

Reports reaching Jaffna stated that at Naranthanai near Kayts eight persons died

The offensive operation launched by the Sri Lankan Armed orces on the 25th instant. have created a lot speculation. The operations, coming as they do whihin less than one week of

Thirty Tamils (all males) who were living as refugees in the Karaitivu Refugee Camp in the Amparai District who had gone to work as hired labourers in paddy fields belonging to Muslims have been abducted and killed.

The same report adds that these Tamil refugees were abducted and killed by Muslim thugs though these Tamils had gone to work on paddy tields belonging Muslims.

The incident is reported to have happened on the 25th of March, 1991.

President Premadasa's message to Parliament wherein he categorically stated he wanted to end war and enter into peace negotiations with the LTTE, have caused grave doubts on the bona tides of the President who speaks and preaches peace, while his Armed Forces are engaged in active war operations.

"There is another aspect of this war", said a resident of Jafina, "The G.CE(A/L) Examination which should have been held in August last year, was not held then. When reprresentations were made that this examination should be held, the local education Department officials were told that the Government had no objections to holding the Examination but that the Department officials in the North East must obtain the LTTE co-operation and see that they do not do anything to disturb the examination. Of course, there was no question of the examination being disturbed in anyway by the LTTE. The Government having been assured that the examination would not be disturbed in anyway and in consultation with its

Army, scheduled the examination between the 23rd. without any advance information, an indefinite curfew was imposed and millitary operations started by Government even before the announcement.

There is the possibility that the Government launched on this offernsive operation because it expected the LTTE to observe peace during the period of the examination and that therefore, it could have some military advantages'.

The announcement of the curfew created confusion in the minfs of the candidates for the G.C E (A/L) Examination, parents and department officials. The examination was being held throughout the North East. The curfew was imposed in the Jaftna Peninsula.

So if the examination was cancelled in Jaffna, there was no likelihood of another examination being held and candidates from Peninsular Jassna will suffer.

They will in effect have lost one year completely. So the department officials decided to continue with the examination - curfew or no curfew. The examinations were held and students answered the papers. Some candidates who sat for the examination papers on the 25th instant stated that they answered the papers, while explosions were heard nearby. They had no alternative as otherwise they would lose completely. Certainly there concentration was affected by the noises, they said. "People are getting used to carry on their normal work inspite of the military activities in their homeland", said ahother resident of Jaftna.

Shell Attack

Deth toll of an Entire Family Tragedy at Naranthanai

An artillery shell believed to have been launched from the Army Camp at Palaly hit a house at Naranthanai South in Kayts killing eight persons who were at the house. Three others were injured. The house was severely damaged. The combined forces of the Sri Lankan Government commenced offensive operations from their camps in Karainagar, Kayts, Palaly and Kankesanturai from the early morning of 25th April. 1991. While the Air Force and the Navy were engaged in the offensive operations at Karainagar, the Army at Palaly, Kayts and Kankesanturai started launching aimlessly directed artillery shells.

One of these shells - believed to have been launched from the Palily Army Camp hit a house at Naranthanni killing 8 persons, injuring three others and severely damaging the house.

Seven of the eight deceaseds were members of the same family who were at their house which was hit by the shell. There are Lazarus Leenappu (45). his wife Vrisittammah (40) and their five children Julius (16), Rita (13), Eugene (10), Swarna (8) and Theresa (5) The other girl who died. Aloysius Matilda (12) is also a relation of the deceased family.

The injured include Saveri Raphial (75), father of the deceased Vrisittammah and another boy named Aloysius Arulseelan. (15)

Jaffna Citizens' Committee Writes to President Premadasa

"Time and again it is declared and announced by Your Excellency that a military solution is untanable for the present crisis and that an early peaceful political solution will be found. But these declarations are immediately followed by intensive military operations" - So states a letter sent by Jaffna Cltizens' Committee to President Premadasa.

The letter goes on to state that every aspect of life of the entire Tamii-speaking people in the North East, has been paralysed and the people deliberately allowed to vegetate, starve and perish and gives the following figures as a close approximation of the actual figures of damage wrought by the war during the last ten months:-

In addition the people have been deprived of all essential day to day needs.

The Citizens' Committee's letter concludes hoping that the President will lose no time in finding a solution o ending the crisis.

Prosecution or Persecution

Bailey London's Old Courthouse ruling in March, 1991 in the case in which six persons who were in prison for 16 years were exonerated and let free, came as a rude shock to all persons the world over.

The simple facts of the case are that in November. 1974 bombs exploded in two pubs in Birmingham, killing 21 people and injuring over The Irish 160 persons. Republican Army claimed responsibility for the bombings. The IRA also denied that the six men now freed sixteen years imprisonment were invloved in the bombing. These men were arrested just hours after the bombing in 1974.

They were charged in Court, convicted and sentenced to life imprisonment in 1975. Ever since, they were making all attempts to have themselves exonerated of the charge. The attempt succeeded at last after 16 long years in prison. For sixteen long years innocent people have been suffering in prison.

Who is responsible for the prosecution of innocent people on false charges? The British claim to the honesty and integrity of its Police Force, is seriously affected by the ruling of the Old Bailey given last month.

But what is intriguing is that this is not the first time that innocents have been falsely prosecuted, when incidents connected with the IRA arose. About two years ago, an Appellate Court set free four other persons convicied in another set of IRA bombings also in 1974 in Guildford. The Government itself ordered in August, 1990, the review of the convictions of seven others in a case in which they were charged of running an IRA bomb factory. By the time the Government made this o.der, the persons concerned had been set free after completing prison terms!

When some incident connected with the IRA arises. does the Police prosecute or persecute innocents? Time has come for the British Government to allay the fears arrosed in the minds of the people all over the world

The sufferings of the innocents in Britain naturally arouses anxiety for the fate of those persons in the jails of Sri Lanka too. Here too a large number of persons are in prison without even being indicted.

The six now set free are Richard Mcilkerney (57), Patrick Hill (45), Hugh Callaghan (60). Gerard Hunter (45), William Power (44) and John Walker (55).

Relief - After Occupation

Security forces will capture all areas in the Vavuniya District very soon. Items of food will be sent to the people there through the Cooperative Branches, only after completion of the occupation by the Army. So said Additional Govt. Agent Vavuniya. Ratnayake to a question posed by the Gramasevakas of the region.

Since last September, no food relief had reached the thickly populated areas of the District where the Tamils reside.

A meeting of the Gramasevakas was held at the Vavuniya kachcheri on 18th April where the Addl G.A. Vavuniya addressed the mecting. 'The occupation of the rest of the Areas of vauniya District' referred to by the Addl. GA is apparently the territories adjoining Mannar District near Madhu Church and the Refugee Camp run by the UNHCR which is housing over thirty thousand Tamil refugees from Vavuniya and Mannar.

Is it because he is the best friend of the Tamils that he took back Mr. Cyril Mathew into the U. N. P. Committee, when he was pushed out by President J. R. Jayawardane, for his anti-Tamil outbursts and actions?

If President Premadasa is indeed the leader who plays fair by all, will he bring back into the Constitution, Article 29 of the Soulbury Constitution, the Article that prohibits Parliament from

pasing any legislation that will benefit or hamper any one community but will not benefit or humper all the other communities; the Article that induced poor Mr. Suntharalingam and Mr. Sithampalam to wholeheartedly support the idea of a united Ceylon. Words may satisfy Donor Countries (they do indeed, because in those countries, the leaders say what they mean) but only actions will satisfy the Tamils.

The 13th Amendment to Constitution the reads. "2. Tamil shall also be an official language. 3. English shall be the link language, 4. Parliament shall by law provide for the implementation of the provisions of this Chapter," (One cannot understand why Parliament should pass a law to give effect to 2 & 3 above). This 13th Amendment was certified on 14th November, 1987 and President Premadasa has, months back completed two years in office but Parliament has not passed any law to give effect to 2 & 3 above and Sinhala continues to be the Sole Official Language of Sri Lanka.

Yet again in Appendix II of the 13th Amendment clause 2.5 reads 'The distribution of all allotments of such land in such projects will be on the basis of national ethnic ratio. In the distribution of allotments according to such ratios, priority will be given to persons who are displaced by the project, landless of the District in which the project is situated and thereafter landless of the Province.' This prohibits the distribution of land in a Province to any one in the other provinces. Nevertherless in the Eastern Province, thousand and thousands from the other Provinces are being allotted land - probably not a single Tamil or Muslim from the June 10, 1990.

President Premadasa says the war is not against the Tamils but it is against the L.T.T E. The North and East are bombed at random and the spokesman for the Air Force declares, as if on oath, that they bomb only L.T.T.E. targets. But what about the Aartillary Shell attacks from Army camps that hit here, there and everywhere? Can the Army men say that they are hitting only L.T.T.E. targets.

Again what about the Economic Blockede of the North. Is this not an example of the Fairplay that President Premadasa so loudly proclaims?

Come, Come President Premadasa! Back up your pious pronouncements by action! Or else sooner or later the cat will be out of the bag even in the donor countries. Also you have to assume that the LTTE might get tired of playing fair by the rules of war and start hitting at Sinhalese Civilians as is being demanded by Kith & Kin of the Civilians who have been murdered by your Bombs and Artillery Shells!

Delay in issue of Passports

Kindly publish this letter in your magazine of understatnding and social justice to spotlight the grieveances of the oppressed suppressed and depressed classes of this racially torn Island, Sri-Lanka. (Crylon)

Some 675 completed passport applications have been sent by the regional office attached to the Kacchcheri, Jaffna to the Controller of Immigration and Emigration Department, Galle Buck, Colombo I, before the civil war broke out on 10. 6. 1990.

Upto date the said passport applicants have not been issued with the passports; some of their applications have been sent to the said office in January 1990. I think this lapse is another world record in the delay of issuing such travel documents. It is reliably learnt that the said department is not willing to send the passport by registered posts for security reasons. They insist

the applicants to come to Colombo to obtain their passport with the relevant receipts and other proofs.

It is humanly impossible for all the passport applicants to go to Colombo to obtain their passports. It will be highly appreciated if the said passports are sent by the ships under the care of the ICRC and to be issued by them or the Government Agent It will be recalled that liquid eash in millions are being sent to the local banks by ships; and so far there had been no such attempts to threaten them. The people of good the particulary passport applicants will be very grateful for such largehearte-

It will also be greatly appreciated if the said office at the Jaffna Kachcheri is reopened to receive the passport applications to ease the untold sufferings of the applicants to go to Colombo to submit their applications. The security arrangements at the said Kachcheri have been commendably tightened and the people also give their. cooperation to enable them to discharge their duties allotted to them efficiently and sincerely.

It is sincerely hoped that this case will receive the most sympathetic consideration of the leaders of the Government and the pasport officials. It is unwise to suspect all the people, most of them want to live in peace and harmony and to mind their own business.

However these lapses have been published in the local newspapers and representations to the relevant minister concerned.

Palayadivettai Army continues atrocities

The villages of Kalvettai, Kalimadu, Nediyavettai and Vilanthoddam in the Batticaloa District were rounded up on the 3rd. March, 1991 by the Sinhala Army stationed Palayadiveddai opened fire indiscriminately in several areas.

Two persons were killed, some injured and six persons arrested. The injured were pushed into the lagoon by the soldiers and the arrested persons were taken away. Of those pushed into the lagoon some who could swim, escaped.

The two dead persons have been indentified as Nagamany Kirupai (50) male of Kalvettai and Thangarajah Nesiah (45) male of Aliyar-

One of the injured is Muthusamy Nirmalan (35) male of Pillai Aliyarvettai.

Five arrested persons are identified as -

- 1. Parisaripody Kannamoorthy, male, father of two children of Aliyarvettai.
- 2. Kalikutti Sangarapillai (60) male of truvettai.
- 3. Murugupillai (18) of Aliyarvettai.
- 4. Murugappan Mamangan (30) male of 35th colony and father of 6 children
- 5. Samithamby Thedchanamoorthy (56) male of 35th colony and father of 4 children.

In the same area on the next day the Sinhala soldiers went on the rampage and opened fire on the civilians working in their paddy fields. Thereafter the soldiers gave vent to, their 'anger' by ripping open the bicycle tyres of these peasant farmers and throwing the bicycles

Peace is far away

Last week we had occasion to publish a late news conveying President Premadasa's message, to Parliament wherein he stated that he wanted to talk peace to end the war. We had our comments then also to make.

But before the news of the President's speech reached us, we commented in this column how people are being led up the garden path about reported peace moves here and there and stated as follows:

"There is no sign at all that the war is receding in action. Still less is there any indication that the Government or the Sinhala political leaders have begun to bave fresh thought in the matter of Sinhala - Tamil conflict in the Island. Deceit and treachery with the object of imposing Baudha - Sinhala rule on the Eelaw Tamil Nation is only augmented by military power'

What we stated last week has been amply proved by the events of this week.

A sudden Radio announcement on the early morning of 25th of this month stated that a cuifew had been imposed all over the Jaffa Peninsula As usual the period of duration was unlimited Even as we write this editorial on the 26th morning the curfew has still not been relaxed and is in force. How long it will be in force, we cannot say.

But even before the curfew was announced, the combined forces of the Sinhala Governmen had begun their operations at Karainagar. Artillery shell attacks and cannon fire attack from naval boats directed towards the Island of Karainagar were made throughout the night of the 24th and from early hours - around 4 30 a m on 25th, Sri Lankan Air Force planes and helicopters begun attack on Karainagar.

Simultaneously artillery shell attack were launched from the Palaly Army Camp Kays Camp and Kankesanturai Army Camp on the 25th

It is be noted that the G C E. (A/L) examination which should have been held in August, 1990 was not held in the North East because of the war situation then. This is a highly competitive examination held to admit candidates for admission to the Universities. While the examination was held in Sinhala areas of the Island in August, 1990, the examination was not held in North East Later, however the I ducation Department took up the matter with the Government and the Government after consultations with the Defence Ministry also fixed this examination to be held in the North East from the 23rd. of this month. This examination is scheduled to be over on the 13th next month.

But the Sri Lanka Army started its artillery shell attack from the Palaly Camp just on the day of the commencement of the examination directing attack towards Vadamaradcy including an examination centre Fortunately the shell did not explode in the examination centre itself but in the vicinity. Then on the 25th savage air attack started on Karainagar and other Islands. and is continuing even as we write this on the 26th.

There is no provocation for this attack. Neither the Karainagar Army or Navy Camps nor Palalay Army Camp or any other came in for any attack just prior to the commencement of examination or thereafter. Shortly and simply this is an unprovoked war of aggression which the armed forces of the Sinhala Government have commenced.

The outbreak of these offensive operations by the armed forces of the Sichala Government makes it very clear that the President's message to Parllament was a calculated step to cheat to cheat not only the Tamils but the world at large.

Why should the Government commence offensive military operations, when it had earlier decided and in fact had started holding the G.C.E. (A/L) Special examination in various centres in the North East? Whom is the Government fooling? How does the Government expect students to sit for a highly competitive examination, when its armed forces ravage the area?

As a matter of fact the people were feeling some what safe with the news of the President's quest for peace coupled with the conduct of the examination. People thought they would be free of attacks at least during the course of the examination. They have been proved

The charge levelled against the Government that it does not want peace - that President Premadasa indulges in peace exhortations only to cheat the world, stands proved.

Woes of Amparai Tamils

No work - No Houses - No Food Some Missing

in many small villages here and there all over Amparai District. Most of these people were daily wage earners. These Tamils in the Amparai District who lived in small hamlets, have been the worst affected people after the current war broke out in June, 1990.

Quite apart from the large numbers done to death in this District by Muslim thugs and the Special Task Force (TF), those who have escaped death, are undergoing immense hardships. They have no properties; their houses exist no more. They have no work and they have to live in constant fear of death both at the hands of Muslim thugs and the Sinhala Government's armed forces.

About 245 Tamil families from Kannakipuram, Ninthavur and Vinayagapuram have been taken into a refugee camp set up by the ICRC Altoge her at Panankadu. About 1,944 persons from other areas also are accomodated in the Panankadu Refugee Camp.

These refugees have to depend for their food envirely on the government ration supplies which are totally inadequate The refugees are thus less than half sed. As far as basic sanitary and other amenities are concerned they are very poor and many retugees have been the victims of contagious diseases. These refugees are unable to go to work like wood cutting or work in the fields because

Helicopter Attack

A Sri Lankan Air Force helicopter fired on a lorry transporting paddy at Thumpankerni in the Batticaloa District on the 7th March, 1991 killing the cleaner of the lorry on the spot and also injuring three other pedestrains. The lorry was completely damaged.

The dead cleaner of the lorry has been identified as S. Amarasingam (30) of Periyakallaru.

There were about 850 students at Kannakipuram. Temporary arrangements have been made by the ICRC for these children to continue their studies in an improvised Rural Development Society Hall at Panankadu but the lack of facilities and more so the pathetic conditions in which these refugees-especially many having lost their tathers or mothers or both - live retards any growth in education. Many children do not go to this temporary school.

There are about 810 familes from the villages of Alayadivembu, Periyakulam, Karung-

kodittivukulam, Navatkadu and Ward 7 of Akkaraipattu AGA's in Alayadivembu Division who have lost their dwellings and are rendered refugees Most of these villagers were principally ngriculturists primarily engaged in the cultivation of manjoc almost for the entire year. Recently when the refugees attempted to return to their villages and engage themselves in manioc gardening, the STF prohibited planting maniocs. So they face starvation.

But the most distressing feature in the lives of these refugees is this. Some of the refugees were invited to return to their villages and when they returned accordingly, some of them from the 4th Colony in the Central Camp area have been taken away by the STF Nothing is known as to what had happened to those who had been so taken away.
