Murder Mission Again-

Sinhala Air Force Bombs Pannai Jetty

After a respite the Sinhala Air Force bombed the vicinity of Jaffna City at the Jaffna Pannai Causeway damaging the jetty on the Mandativu side on Friday, 23rd. August, 1991 at about 2.00 p.m. Two Sri Lankan Air Force bombers dropped four bombs.

Two Air Force bombers which were sighted over

Jaffna Town suddenly swooped and released four
bombs at the Jetty on
the Mandativu side of the
Jaffna Pannai causeway. One
person was killed and six
were injured. Some minibuses, some shops, push
bicycles and a lorry belonging
to the Multi - Purpose Co -

operative Society of Pungudutivu were severely damaged.

The person who died has been identified as Kurusu Thavam (28) of Eluvaitivu. The injured include a child of 4 years. The injured are Rasaratnam Sumathy (17) female of Pungudutivu, Remegius Pameetha (4) female,

Thiagarajah (26) female, Edward Michael (30) male of Allaipiddy Jalini Theiventhiram (13) female of Chava-

kachcheri and E. Rajakumar (35) male of Jaffna.

The dead and injured were passengers from Jaffna.

Karaitivu Refugees Express Solidarity with other Refugees

The refugees living in the Kallady Vipulananda Maha Vidiylayam in the Batticaloa District expressed solidarity with other refugees living elsewhere in the District, when they refused to allow the Asst. Government Agent of Karaitivu to re-register the names of the refugees resident in the camp. The Asst, Government Agent returned without registering the names of the refugees.

The members of the Special Task Force (STF) came to

the camp to compel the registration of the refugees but the refugees said that all refugees should be provided with relief and until then they shall not have themselves registered afresh.

This agitation arose as a result of the Government's directive to issue relief supplies only to the those living in approved Refugee Camps but not to other refugees and displaced persons living elsewhere out side refugec camps.

Sinhala Police and Muslim hoodlums kill 19 Tamils One of the deceased has has still not been estal

News has been received from the Amparai District that on the 14th of this month, some Sinhala Policemen and a gang of Muslim hoodlums arrested 19 Tamil persons from the village of

Chavalakadai in the Amparai

District and later killed them.

The news in this connection further state that the Sinhalese Police and Muslim hoodlums arrested these persons who were in fields and took them along with them. Later in the night 15 of these were taken to a place near a Pilaliyar temple. All the fifteen Tamils were hacked to death.

The other four persons were taken to the cemetery where they were also hacked to death and later burnt.

One of the deceased has been identified as Thambirajah (28) of Chavalakadai. The identity of the others

has still not been established but some of them are believed to be refugees from other villages.

Vanni Protests against Economic on the people of the N Province. The process

Two massive processions were taken out by the people of Vanni in protest against the economic embargo on the North on Tuesday 20, 1991.

Reports received from Vavuniya District indicate that large numbers of people assembled at the village of Rambaikulam in the Vavuniya District at about 10.00 a.m. and marched in procession carrying banners and shouting siogans protesting against the food embargo placed by the Government of Sri Lanka

on the people of the Northern Province. The processionists marched to Omanthai where a public meeting was held at which the local leaders denounced the Government of Sri Lanka for its anti-Tamil activities.

The reports further add that a similar procession was taken out from Poovarasankulam at about 2.00 p, m. the same day. This procession marched to Kunchukulam. The protesting demonstrators demanded the lifting of the food embargo. A puplic meeting was held at Kunchukulam also.

S. L. Army Moves out of Pullaveli

A contingent of the Sri Lankan Army which came to relieve the Elephant Pass Sri Lankan Army Camp stationed itself at a place called Pullaveli enroute to Elephant Pass from the coastal village of Vettilaikerni. Pullaveli is in the chain connecting Elephant Pass to Vettilaikerni. It is learnt that Sri Lankan Army came in for repeated attacks from the LTTE in the area. At the same time reports from Colombo state that the

Government of Sri Lanka proposes to withdraw its major camp at Elephant Pass. But the reports cannot be confirmed because there are conflicting reports from the Government.

Endless Search for Peace

It is learnt that 43 members of parliament have been nominated to the Parliamentary Sub-Committee selected to find ways and means of solving the Sinhala-Tamil problem.

Twenty members of this Sub-committee are to be from the Opposition Parties and twenty three from the Government.

The Chairman of the Sub-committee will be Mr.

Mangala Munasinghe of the SLFP who proposed a Private Member's motion calling for the resolution of the ethnic conflict.

It is interesting to note that this Sub-committee will not have the majority representa tives from the North East who were elected under the farce elections held earlier because the EROS group of members who were elected in the majority have resigned their membership from Parliament.

In the meantime reports received from Colombo also state that an Opposition Member of Parliament had called for the withdrawal of the Emergency from all areas barring the North East. In other words the Opposition had called for the continuance of the State of Emergency in Tamil Eelam.

Army Media for Communication with Tamils

Message in Kobbekaduwa's press Interview

interview to a Colombo Weekly, Major Gen. Denzil Kobbekaduwa has, among other things, exhorted the Tamil people to revolt against the Liberation Tigers of Tamil Eelam (LTTE)

Kobbekaduwa is an Army Officer of high rank. The Army keeps out of politics in any state except where an Army junta in fact rules the country. In such a State, course, the Army is It decides omnipotent. everything; but in other states the Army's function is completely limited to one of carrying out the orders of the State. The Army does not indulge in imparting political advice to the people.

But Maj.Gen.Kobbekaduwa has sought to advise the Tamii people that they should revolt against the LTTE. This is a very serious matter.

The Sinhala chauvinists never fail to proclaim loudly that the Island is one country and the Eelam Tamils are an integral part of the socalled Sri Lankan Community. Mr.R.Premadasa, the president of Sri Lanka, in particular has been aggressively vociferous in saying that the on-going conflict is an internal matter and has warned the whole world to keep off what in his estimation is a purely internal matter. The implication is simple. The Tamil people are part of the polity.

If that were so, one ventures to pose the question, how did the President permit his Army officers to speak politics or does he have no contro! over them. It is nothing but simply politics to exhort the Tamil people to revolt against the LTTE.

The Sri Lankan Army and other Security personnel and also Vigilante groups carried out large scale massacres of Sinhalese people themselves in their hunt against the Janata Vimukthi Peramuna (JVP). The reports are that about 60,000 people were killed in these operations. The 3ri Lankan State's operation against JVP has a long history. It started in 1971, when Mrs.Bandaranayake was Prime Minister. It continued even under her successors including her present-day successor to the office of the Head of Govt. State, President R.Premadasa. The war against the JVP continued under three governments-those of Mrs. Bandaranayake, J.R.Jayewardene and R. Premadasa.

The hunt for the JVP is by no means still over and occasionally you find reports of the Armed forces of government conducting a raid here and there and people are told this and that had been found or recovered.

But in all these operations one never heard an Army Officer telling the Sinhalese people-especially those in Ruhuna where the JVP was popular that they should revolt against the JVP. The Army was not brave enough to tell the Sinhalese people side they should support politically. Nor was any government head prepared to obtain the services of the Army to put a political message across to the Sinhalese people and the Colombo based "democratic national press" could have even dreamt of such "military intervention" in a purely political question affecting their "democracy".

However, Maj. Gen. Kobbekaduwa has thought it fit to make gratuitous advise to the Tamil people that they should revolt against the LTTE. The "national democratic" press of Colombo has given publicity to the political views of a Major-General in the Army.

Herein lies the gravity of the situation. Kobbekaduwa's message cannot be taken as one of a tired general who is battling for a long time Tamil Eelam with no positive results and is only seeing death and destruction both to Tamil Eelam and its people as well as to the Sinhalese themselves. He cannot be regarded as one who feels remorse seeing all the havoc the Armed Forces wrought during the war. If that were so, he would not have ventured to come out with a political message only to the Tamils.

The LTTE has been decried by many others too. Many more reople have advised the Tamils to shun the LTTE. But unfortunately no one has done anything to remove the causes that led to the popular support the LTTE has amongst the people. J. R. Jayewardene had all the chances to do something to remove the discrimination the Tamils were subjected to. He had all the opportunities to grant the Tamils their several rights and allow both the Sinhala nation and the Tamil nation to co - exist peacefully. He did not do it. On the other hand, he utlized every opportunity to deny the Tamils more and more rights and conspired to annihilate them. He continued to the last to deny the Tamils what he himself had earlier agreed to, as legitimate aspirations of the Tamils. His successor, Mr. R. Premadasa, after starting

off well, talking directly to the LTTE, again resorted to the old game of the Baudha . Sinhala imperialistsspeak sweetly by word of mouth but send the dagger in the back.

Why are the Sinhalese politicians so shy to come out with their own specific political solutions instead of dabbling in nonsensical generalities which would take no one anywhere? If

they think the Tamils can be fooled. they must at least have now realized that no one would trust them or take them seriously.

Mr. Premadasa's government started war on a full scale. For one year it has battled., During this long period nothing but devastation, destruction and death have been caused. Mr. Premadasa and his government have not been able to change the Tamil mind even a wee bit to their side of thinking. On the other hand, the Tamils have become more and more convinced that their salvation depends not on Sinhala generosity but on the restoration and reconstitution of Tamil Eelam.

It is in this context that Maj. Gneral Kobbekaduwa's "political advise" becomes instructive. Sinhala politicians have tried without avail to get the Tamils to submit. Are the Sinhala politicians now threatening the Tamils through their Army men and seeking the Tamils to conform to Sinhala rule?

If, as Mr. Premadasa often repeats, he considers the Tamils as people entitled to all rights equally with the Sinhalese, he can not permit an Army Officer to speak politics and tell the Tamils whom they should suppost or rebel against. Surely, Mr. Premadasa would not permit his Army oflicershowever highly placed they may be - to tell the Sinhalese people whom they should support to throw out. If the Army cannot indulge in political preaching to the Sinhalese, by what standard of equality of treatment to the Tamils, can the Tamils be preached politics by the Army?

Maj. General Kobbekaduwa's press interview naturally leads the Tamils to the conclusion that the Sinhala State has decided that it would employ only its armed forces as media of communication between itself and the Tamils. This is the message contained in the press interview given by Major General Kobbekaduwa.

Towards Organic Agriculture

Adversities often bring changes for the better. There were unhealthy trends in the agricultural practices of the Northern farmers which would have led to disastrous consequences if allowed to continue unchecked. Welcome changes caused by the prevailing war situation are now taking place. This should be encouraged and the farmers properly guided so that our valuable natural resources are protected and preserved for sustained agricultural productivity.

Motivated only by quick profits, Soil and water conservation, protection of the ecological balance and the environment were all neglected by the farmers in the recent past. No proper croping systems were followed. The rotations consisted of either tobacco, chillies, potato or tomato (all belonging to the same family) in Kalapokam (rainy season cultivation) followed by two or more successive crops of onions in Sirupokam (dry season cultivation.) None of these crops fix atmospheric nitrogen. So high yields were maintained by heavy chemical fertilisation with the help of pesticides and herbicides that fought the pests and weeds which ordinarily thrive on the endless repetition of the same crops. Excessive chemi cal fertilisation was also having its adverse effects on the structure of the soil and polluting underground water. Unrestricted and indiscriminate use of herbicides and pesticides were resulting in the breeding of resistant strains. Of course, chemical companies were there to offer newer and more potent chemicals only to start the same thing again. Excessive and frequent irrigations from shallow and deep wells with the use of high volume fuel and electric pumps were already running up against

ground water limitations in addition to endangering the quality of water.

It was the same story as far as the ricelands are also concerned.

Now, desirable changes are beginning to take place in the croping systems due to market limitations for the usual' cash' crops consequent to the complete breakdown of the transport system after the fuel embargo and other restrictions. Meaningful rotations with the inclusion of more useful crops like pulses are now being followed. Pulses not only provide the much needed protein for the population but the bacteria in their root nodules enrich the soil fertility. By the inclusion of pulses and other leguminous green manure or fodder crops the farmer need not depend on banned fertilisers like urea for the manufacture of which nitrogen is extracted from the air by the burning of natural gas in huge factories. Millions and millions of bacteria do the same thing for him-free.

Nonavailability of pesticides has necessitated the adoption of at least some aspects of intergrater pest management practicer otherwise the farmers would have continued to rely solely on chemical methods which would have, in addition to the breeding of tougher strains, destroyed the beneficial fauna not to mention contamination of produce and direct hazards - now that even soap is not available for the farmer to wash himself after each "operation spraying"; The embargo on fuel and electricity is also having beneficial effects on irrigation practices. Judicious irrigations are now being given to crops using manual and animal power and by improving the water retention capacity of the soil with increased applications of organic manures.

These trends provide a good opportunity for all concerned to promote the practice of "Organic Agriculture" which appears to be an appropriate system for the region especially under the prevailing circumstances.

The fundamental issue that divides "organic" farmers from their "chemical" counterparts is whether the farmer should be primarilly concerned with feeding the SOIL or the PLANT. The organic position is that if the farmer keeps the soil in good condition the plants will pretty much take care of them-

Musings

There is much scare and excitement about Rajiv Gandhi's death. When one of U.S. A's outstanding Presidents, Kennedy was killed, the United States did not get excited. The excitement is most in Tamil Nadu. There may be reason for Chief Minister JayaLalitha being excited because she hoped she could achieve much through Rajiv Gandhi.

Investigators do fail to take note of the elementary fact of human psychology. Rajiv Gandhi is tall, handsome and youngish looking and no woman (certainly not a young woman) would make her mind to do death to Rajiv Gandhi. unles of course. under tremondous emotional stress, she was bent on wreaking vengeance. There are instances of would - beassasins dropping their weapons and running away for no other reason than that of being overwhelmed by the personality of the person sought to be assasinated. No amount of group terrorism would induce a young woman to kill Gandhi unless of course, as mentioned earlier, she was goaded by the urge for revenge,

So many days of intensive investigation did not give any reliable clue to the identity of the young woman. There is also a press report that when the woman was strugilng to get a place in the queue of those seeking to garland Rajiv Gandhi, the latter beckoned her and that is how she was allowed to proceed towards Rajiv Gandhi without being subjected to examination by the metal detector. This raises a doubt whether Rajiv Gandhi knew her earlier. No one can answer this question.

Rajiv Gandhi was the Premier who wanted to interfere in the affairs of others and play the role of the Policeman of the neighbourhood. He intervened in Maldives with much subtlety. He intervened in Ceylon quite openly. He caused the killing of, according to Indian Press reports, between six and seven thousand innocent Tamil civilians within a few months under circumstances which no one could excuse. He ordered an indefinite curfew for about one month in a highly urbanised area and issued a peremptory order asking almost a lakh of residents to quit their homes; those who did not quit their homes were shot dead by the Indian Peace Keeping Force.

At Chavakachcheri Market Square Indian planes were

circling above. The people thought that the Indian planes would not indulge in aerial attack and were gazing at the planes. Suddenly the planes bombed and nearly a hundred persons were killed or injured. Rajiv Gandhi did not merely kill the Tamils but he indulged in trecherous betrayal of the Tamils and killed six to seven thousand innocent civilian Tamils and about a thousand freedom fighters solely for the purpose of giving time and opportunity to the Sinhalese to regroup and - rearm themselves. If Rajiv Gandhi's assasin is a young woman from Tamil Eelam as is suspected then, in all probability a lover or husband of her or her entire family might have been massacred during the IPKF operations.

Probably she has made representations to Rajiv Gandhi personally and that is how Rajiv Gandhi knew her and beckoned her to come ahead of the others with the garland,

Parameters for Peace

(1) Peace makers appear to be over busy in seeking to bring

peace in the Island between Tamils and Sinhalese. There are certain parameters which cannot be ignored. Dialogues took place and Accords and Agreements were reached on a number of occasions. The Sinhala Governments always defrauded these Agreements because another political party would exploit the agreement as a surrender to the Tamils. Hence any Accord and Agreement should be the award of an umpire or arbitrator whose moral authority would prevent political parties seeking to exploit the Agreement.

(2) The word minority and majority should be banned in any talk or dialogues. No word signifying minority or majority ever appeared in Mahavamsa, Chulavamsa or other Sinhalese chronicles. These words got into coinage only after the Britisher lumped together the Sinhalese and Tamil nations. Now that the Britisher had gone these counterfeit coinages must get out of circulation. - (A) Do the Sinhalese regard or behave towards the Tamils on the footing of fellow citizenship?
- (B) Do the Sinhalese cherish any sense of fellowship towards the Tamils, Are not the Sinhalese guided by age old superstitions and faiths which have sunk into their minds and which are nourished and nurtured by the Buddhist Bhikkus?
- (C) Commencing from the Sinhala Only Board of Ministers of 1936, the Sinhalese have persistently pursued a Sinhala Only policy concept. Can anyone deny this?
- (D) Why should not the peace - makers meet the aspirations of the Sinhalese for a Sinhala Only polity instead of shackling them with the Tamil linguistic group in two Provinces?

Let the peace - makers grant the aspirations of the Sinnalese by granting a Sinhala Sri Lankan polity in the seven Sinhala provinces which voted for the creation of the Republic of Sri Lanka. The viable solution is very simple; leave the Tamils alone in their barren and dry North - East.

Peace makers should look to current history. Belgium. Netherlands and Luxumberg formed the Benelux and had the benefit of a customs union. This was the precursor to the European Economic Community entering into a customs union and later on into several agreements so that the once warring nations of Europe now operate a peaceful and flourishing union. There is much greater unity between the States of the European Economic Community than there is between the States of the Indian Republic. If a customs union were to be formed the basis of accord between Eelyom and Sri Lanka will eventually lead to a similar customs union and internal free trade between the members of the SAARC organization and the SAARC organization become a tangible union as the EEC is. Why cannot the people think ahead and take a broad view of the question?

There is an enormous potential in this area for composted human sewage. In organic oriented farming suitable cultural practices keep weeds and pests under tolerable

relatively levels. Chemical methods of control are resorted to as a last step. The fine tilth and the organic content of the soil not only increases the water retension capacity but also eliminates the necessity for big tractors and deep ploughings which disturb soil life. Shallow tillage with bullock drawn light implements is sufficient.

Tamil Kelam Refugees Safe and Sound in Europe But not in Madras

Intellectual Honesty and Moral Courage Need

Respected Friend,

I write this letter in connection with the latest arrests made of the suspected Tamil Eelam LTTE Militants and other Tamil activists, presently living as refugees in Tamil Nadu. All the newspapers have simply reproduced the information doled out by the Government sources and blared through the electronic media. Accordingly one gets the impression that about 450 Tamil Refugees have been flushed out, of which some 81 have been discovered as the hard core LTTE Militants on 14th December 90.

By a coincidence I happened to meet some of these respected gentlemen who were arrested and released on 14th evening. I am really surprised to note that none of our newspapers have given the names and details of the persons taken into custody and those released on the same day. Some of the known persons released on 14th evening include persons like Mr. R. Namasivayam aged 78 years, an attorney at - law and his brother - inlaw aged 71 years, a Canadian passport holder, and Mr. Thiagarajan aged 61. Another gentlemen known to me. is my neighbour Mr. M. K. Ezhavendan (IELF Secretary) aged 58 years:

I understand, a majority of the young men arrested are students enrolled in various

educational institutions and continuing their studes in Tamil Nadu. Others are those waiting to proceed to the Western Countries in the near future.

Even though Mr. M. K. Eezhavendan has been releasocial or anti-Indian activity.

To the best of my knowledge most of those outside the refugee camps are leading respectable lives out of the generosity of their prosperous relatives living abroad who send foreign exchange to this

sed, to this day. I see a group of constables waiting at his home, posted on guard duty. As a neighbour I am an eye witness to this spectre.

I understand, the police had extended exemplary treatment to these men. They also conducted themselves very decently while making searches in the residences of theae refugees.

All these Eelam Tamils are not in any ways responsible for various troubles that India is going today. They are not in any way responsible for the caste and communal riots. (in many states outside Tamil Nadu) nor for Ramajanma Bhoomi -Babri - Mszjid controversy. They are not propagating any seccessionist ideology. in any Indian state. They are neither engaged in class conflicts nor in any anticountry for their sustenanca. Some of them depend on the good - will of their relatives and friends living in Tamil Nadu. A few of them were lucky to bring with them whatever they could salvage before the worst things happened in Sri lanka. Yet, I firmly believe that these unfortunate Tamil Sri-Lankans are being used as pawns in the dirty game played by some Indian leaders, engaged in the so called profession of public life.

Certainly they are not expecting any unflinching support from the Indian Prime Minister unlike his Pakistani counterpart who pronounced all-out support, moral as well as material, to the insurgents fighting against Indian forces in Kashmir and Punjab.

Unlike the PLO, they are not seeking any recognition or status for their presence in India. The honourable Indian politicians and men of the fourth esta'e go all out in shedding tears for the victlms of apartheid in South Africa. They are ever ready to shed tears for the victims of Military dictatorships all over the world. Yet their eyes are dry when it comes to the Tamil victims of genocide and state terrorism practised by the Sri Lankan Government

What amuses me most is the superior diplomatic skill and the intelligence of the top ranking Sri Lankan politicians visa-vis the Indian leaders in Delbi and Madras. My hats off to Jayewardene who dexte. rously used Indian political and military power to achieve his "dirty job" in Sri Lanka. His protege and successor Premadasa used the LTTE power and exerted pressure on Indian political authority to ease out the Indian Military presence from Sri Lanka. This was done in the name of Sri Lankan sovereignty and self - respect.

The very ideals of soverei. gnty and self - respect were once again used effectively by Premadasa to blackmail the LTTE and Tamil aspirations. As a result the Indian political forces today are

very much scared both of Premadasa and Prabhakaranfor different reasons.

While politicians are fidd. ling in Colombo and Deihi. the Tamil areas in Sri Lanka are burning.

The victims of this sordid Indian drama are the poor stranded Tamil Eelam refugees in India. I have seen la Paris and London ordinary and humble Tamil refugees from Sri Lanka, capable of leading safe and secure and prosperous lives. whereas, I see even affluent Tamil refugees from Sri Lanka, living under pathetic condltions in Madras City.

When responsible and reputed papers like yours are not in position to publish the truth, then certainly there is no use for people like me to pride over the lingering remnants of our democratic structure and hope for a future, dreamt by the founders of our Republic. Certainly I may not be in a position to guide and prepare my students when voices like yours, that sounded louder than Bofors guns, mysteriously remain silent, at a time when we need intellectual honesty and moral courage.

A WELCOME DECISION

A local Tamil daily carried a report to the effect that the British Government has suspended financial aid to Sri Lanka as the latter is involved in human rights violations.

According to this Daily, the British Government's decision was made known to the London Sunday Times by the British Minister concerned.

The paper further reported that the British Foreign Minister has also said that Britain proposes to seek the co-operation of European countries also in implementing Britain's decision to suspend aid to Third World countries which practise human rights violations such as Sri Lanka, Burma, Sudan and Somalia.

We welcome the decision of the British Government.

In regard to this Island of Ceylon, all the war, death and destruction that is now taking place between the Tamils and Sinhalese, is the direct consequence of British occupation of the Island.

When Britain captured the Island, it was careful not to disturb the national divide but as time went by, the British seemed to have forgotten the fact that they captured not one country but three different countries within the geographical expression called the Island of Ceylon and that the Tamil country differed from other two in every respect, including race, religion, language, culture and customs. The result was the imposition of a unitary state comprising many different states. After the British left, the inert differences between the different countries became acute and today we witness war and destruction.

The Tamils who lived independently in their own state with their own army for the defence of their country and for the protection of their people. are today pathetically left with no protection what-soever. Their country - Tamil Eelam - is being robbed from them and all efforts are being made to convert the Tamil country into Sinhala territory. The Tamlls are being destroyed and their land is being laid waste by the Sinhala army. The Tamils have no army to defend themselves and their land. The Tamiis in this country face total annihilation - genocide. This is because Britain failed to hand back the Tamil country to the Tamils, when it left Ceylon.

It is in this context that we say that Britain has a responsibility towards her former subjects the Tamils of Eelam, and we are happy that Britain, having realized her responsibility, has thought it necessary that she should discharge her responsibility.

Human rights involve both individual human rights and individual group rights. As a group of people the Eelam Tamils qualify for nationhood from what ever angle one chooses to look at the matter. This right includes the right of the Tamils to exercise their right of self-determination and regain and reconstitute their state.

Though the Eelam Tamils have expressed their option to regain and re-constitute their state on several occasions - this right has been denied to the Tamils at the point of the gun. The Tamils have now been compelled to carry on a war on unequal terms. The Sinhalese imperialists not only have larger numbers and larger territory but they also hold the state machinery. By the cruel manipulation of the machinery of the state, they are carrying out genocide of the Tamils - though they have no moral or legal right to do so. are nevertheless emboldened in their campaign because they think that the comity of nations will accept them as the lawful state - which in fact they are not. Relying on this, they establish foreign relations and obtain various forms of aid from foreign countries and invariably use such foreign aid for the aggrandisement of the Sinhala state over the Tamils.

It must be remembered that the Baudha Sinhala imperialist State is able to carry on a ground, sea and air battle against the Tamils with sophisticated weapons because it is able to obtain foreign aid. The stoppage of foreign aid will act as a deterrent against the Baudha Sinhala chauvinism and imperialism which hopes to achieve a military conquest over the Tamil nation which still has no state machinery to protect itself from foreign aggression.
