SRI LANKAN GOVERNMENT'S

Attacks for Political

War is raging on in Manal Aru area for a full week now between the combined forces of the Sri Lankan Government and the Liberation ligers of Tamil Eelam (LiTE).

Manal Aru area is strategically important as the geographical link area between the North and East. Last week's "Hot Spring" reported the contents of an interview given by Major - General Denzil Kobbekaduwa of the Sri Lankan Army to "Asia Week" wherein he had said that the Sri Lankan Army's next operational task was to cut off the North and East. The aim of such an operation is more political than military.

Politically, the Sinhala 1mperialists have always consistently worked to cut off the geographical contiguity of the Tamil homeland. All Sinhala governments have taken great pains to achieve this end imperceptibly by settling Sinhala colonists in Tamil areas under pretext of "agricultural development". This genocidal move was conceived by the first Prime Minister, the late D. S. Senanayake and systematically carried on by everyone of his successors. The military operations to achieve the same end is the result of the failure of completely political actions carried through with the help of the administrative

machinery of government under the control of the Sinhala Imperialists.

Strangely some news reports say that the Government has ordered the army not to give press reports about the war except those approved by Government. So we do not have much news reports.

Though the war is on for one full week now, reports from Government state that 14 soldiers of the Sinhala Army died and some 40 were injured. Of course, the tall claim has been made that the Government forces have killed over 200 LTTE fighters. The LTTE has said that 21 of its cadres died and fighting is going on.

The Government has further said that its Air Force Is bombing the area all the 24 hours of the day. In addition, large number of troops have been landed by sea and the infantry is trying to fight its way towards LTTE positions. At the same time the Sri Lankan Navy is firing cannon shells from the sea directed towards the

Already the people in the villages of Chemmalai, Kokkuthoduwai, Alampil, Nayaru, Kumulamunai and other places have left their houses and run as refugees.

Reports from Manal Aru area state that the cannon fire from naval ships reach a distance of over 5 miles from the coast and that smoke could be seen from areas subjected to heavy air bombardment.

The most important aspect of the war at Manal Aru is that it isunder taken to achieve the political objective of dividing the geographical contiguity

of the Tamil homeland. In this context Britain and other countries must ask the question themselves whether they should permit the Sinhala imperialists to use violence as a weapon to achieve political objectives before asking the same question and pointing an accusing finger at the LTTE.

Swami Vipulananda Centenary Year

The greatest contribution made by Swami Vipulananda was his researches in music. There was in the ancient Tamil country a musical instrument called "Yarl". There were several forms of this instrument which were played by the musicians of yore. None of them is extant today.

Swami Vipulananda made extensive research studies in relation to this instrument and wrote his book "Yarl Nool" which was acclaimed of Ceylon also.

Prevaricating from what they have promised during pre-husting campaigns is a thing of the past. Those were the days when politicians promised many things from public platforms and canvassed the voters as votaries of truth. Mob oration induced the voters to cast their votes to that particular candidate no matter how he would translate his promises to reality. Those were the days when the popularity of a candidate was fathomed by the crowd that attended the meeting. For every word of promise made, thunderous applause rent the air with the shouts of "jayawewa" 'jayawewa''. And at the end of the meeting as the crowds walked out of the venue, remarks of the member having spoke well, filled the lips of the crowds. The Semantics of Terrorism

Rajiv Gandhi's assassination burst upon the world like the bomb blast that it was - not only the end of a dynasty that had ruled over the world's largest democracy like a hereditary monarchy, but also a danger to the future political stability of the sub-continent. Laboriously built up to ensure contimuity by some of the most knowledgeable constitutional pandits in India, the constitution itself has come under stress. There are so many disparate and fissiparous national and social interests in the country. Only federal in name, but in fact unitary, can India survive without the all - India glamour of the Nehru family? A terrorist bomb has set off this question of vital importance to India. Is this the beginning of the end of India as a united single nation?

Not the first time it happened

This is not the first time in India's post-independence history-that one of her leaders has met with a violent death. Even the great Mahatma was shot by a Indira was Hindu fanatic. killed by her own Sikh bodyguards: and now her son, Rajiv. Ihree dynamic and popular leaders in the forty odd years of India's Independence. Is this the saintly India of our dreams?

Roman terrorism

What is the place of terrorism in the story of nations; The assassination of Julius Caesar, immortalized by Shakespeare, in his play of the same name is the most notorious of the time, and comes into the mind as an example of terrorism in the Roman world. The assassin came of Patrician families, the bluest blood of Rome. Not one assassin, but a group; and their leader, Brutus was no common assassin. He was an idealist, the noblest Roman of them all, and yet with his dagger be stabbed Caesar, his friend and patron of many years, to save Rome. as he believed, from a tyrant and to preserve the republic; and what was the outcome of that murder? Exactly the opposite of what Brutus wanted-an emperor Augustus Caesar, succeeded to the control of the state and that was the end of the Roman republic.

Reign of terror in France 1789

Terrorism under different names has contributed its share to the movement of

history, not always evil. The ten months of violence that burst over France in 1789, known as the Reign of Terror, actually heralded a new era of hope and democracy which has come to be known as the French Revolution. It freed Europe, not France only, from the thralldom of The Reign of feudalism, Terror, that brief period of lawless savagery, was terminated by another act of The last of the violence. leaders of the Terror, Robespierre was stabbed to death by a young woman, Charlotte Corday. Her only claim to be remembered in history is that killing.

She did not kill him because of her political convictions. It was an act of personal revenge. Robesnierre had condemned her lover to the guillotine. Oddly enough it was that girl's angry response that freed France from the Reign of Terror. A terrorist act puts an end to

establish White supremacy by methods of terror. They abducted, whipped or even hanged Blacks and coloureds to force them to their former submissiveness to the white race. Over the years the KKK has been guilty of very cruel crimes against the Blacks and of general hosti-Catholics, lity to Roman Jews, foreigners and even organized labour. Today this lunatic fringe of white chauvinism has lost its old time popularity. In 1965 four Klansmen were arrested for the slaying of a white civil rights worker in Alabama and President Lyndon Johnson denounced the Klan violence in a nation - wide television Fortunately for address. human rights, this group of terrorists on the extreme right is on their way out and will be only an unpleaasant memory in the years to come.

a period of terror. History is not without such exampled of the assassination of a single, hated tyrant opening the floodgates of freedom to millions of oppressed people. A recent example is the liberation of Pakistan from the 11-year dictatorship of Zia by a terrorist bomb planted in his plane.

Assassination of Abraham Lincoln

Abraham Lincoln, one of the noblest statesmen of all time, was essassinated in a theatre as he was watching a play. Even to this day it is not known for certain who the killers were. Security was so lax that anyone could have done it, and escaped detection. There were interested groups who had planned it all, The Security men could have been aware of it. but may have been bought over and collaborated in the murder by keeping their eyes shut. Can those security men be called " terrorists" because of their negligence or secret collaboration in the murder of the President they were paid to protest?

The Kuklux Klan is a secret terrorist organization of some of the sourthern states in the U.S.A. It was first formed after the Civil War in opposition to sharing power with the Blacks: The Klansmen wanted to re-

The killing of Lord Mountbatten

Ireland is well - known in

the history of terrorism. She was imperialistic Britain's first colony, and the Irish had to put up a long struggle for their independence. The Irish Republican Army (IRA) was their underground organization that by its extraparliamentary struggle finally compelled Britain to move out. But Northern Ireland is still part of the United Kingdom. Today the IRA has a special status as an unofficial semi - military organization dedicated to the freedom of North Ireland. Many Irish within Ireland and abroad support the IRA in their struggle to free N. Ireland. The IRA has been involved in many acts of terrorism including the assassination of the Earl Mountbatten- As long as there is a divided ireland they will continue to kill and destroy. Where is one to draw the line?

Once Britain terrorized Ireland a time reminiscent of the 'pacification, of India during the 'Quit India' days. Britain's coercive measures were conducted by an army of roughs known as the Black and Tans, set up by Britain to terrorize the Irish into submission. Those were the dark days of British imperialism and the Irish

nationalists felt the iron heel of the conqueror as much as India did during her fight for freedom.

The Mahatma tried the passive resistance way fight for the freedom of India. People believe that it was his ahimsa struggle. the soul force generated by some mystical power that won India her independence, It is ironical that this saintly land. Holy Mether India, today ranks as number one among the purchasers of arms. She might as well manufacture them herself and save foreign exchange and reduce unemployment. But her image as a moral force must not be blurred.

It is true that the Gandhian method did generate a lot of sentiment in favour of a united, independent India. But there were additional factors too, terroistic urges among the youth that persuaded the British Raj that they could no longer sit on an erupting volcano. Political murders and arsassinations were increasing. A young girl had flung a bomb at a British governor who was presiding at her university graduation function. These and other terrorist incidents forced the Raj to think seriously about whether they could hold India by force, while rival nations would always offer arms to fuel her freedom struggle. It wasn't all terrorism. But terrorism did play a sizeable role in persuading the British to abandon their empire.

Jomo Kenyatta, a terrorist?

Hitler in his day terrorized Europe and accounted for six million Jews and twenty milion Russians dead, all civilians. Yet no one ever reffered to him as a terrorist. Only Churchill once called him a guttersnipe - which he never was. J.R.'s government in *83 was responsible for the pogroms that killed thousands of Tamils, his own subjects in Sri Lanka. Yet no one has ever called J. R. a terrorist. Strange that much better men than these two have been called by worse names. The Mahatma himself was once called an anarchist. Jomo Kenyatta, the father of Kenya's independence, was jailed by Britain for seven years for managing the Mau Mau terrorist organization Nelson Mandela spent half his days in prison charged on the Suppression of Terrorism Act of South Africa, the blackest repressive legislation in the world.

The caste system in Jaffna particularly untouchability, had been sitting over the lives of the depressed classes for centuries, like an immovable incubus. The Jaffna Youth Congress had tried to break it without much success. It was only when the untouchables themselves took to unconventional methods of coercion, and threatened to assault high caste resisters that the tea shops, eating houses and even the Hindu temples opened their doors to untouchable Tamils. Years of privilege tumbled in days. Is it correct to call that social breakthrough, terrorism? Do all social changes have an element of terrorism?

The denial of equal seating in schools to children of the untouchable castes, is another story. It was the Sinhalese government in Colombo that decred that all children be seated on equal terms in all schools. Resistance came from the high-caste Hindus in Jaffna. There was a spree of school buildings going up in flames by high caste terrorism? Respectable men torching the cadjan roofs of school buildings in the country side to protest the government order. A respectable form of terrorism?

Killed by [a Buddhist priest's bullet

When the Tamils performed Sathyagraha in front of Parliament for thier language rights in 1956, a gang of government sponsored roughs attacked them, Ethreatened them and even urinated on them. Sinhala thugs seem to have a flair for that kind of exhibitionist spraying. That gang was hired by the S. W. R. D. Bandaranaike Government to humiliate and intimidate peaceful Tamil protesters. Government terrorism? |Later government too organized antiTamil pogroms periodically. This kind of organized terror, master-minded by successive Sri Lankan governments, has done no good to anybody. not even to the Sinhalese. It has only widened the cleavage between the two

As a footnote to this story of Banda's terrorism, it may be added here that the same Bandaranaike who terrorized the Tamil Sathiagrahis on that historic occasion, was himself killed by a terrorist bullet from the hands of a Buddhist priest.

MUSINGS BY NESTOR

During the days of the British Government there was in the old Chief Secretary's Office a series of files known as War Graves Files. There was a file for each soldier. The graves were at Diyatalawa, commencing from the Boer War days. Each file contained full particulars of the individual soldier, his rank where and how he was killed, particulars of the next of kin, the date of death etc. Wreaths were laid on the anniversary every year. Relatives would correspond about the wreath In some instances whenever any relative came to Ceylon a special officer would accompany them to Diyatalawa, enabling to pay his respects at the grave of the dead soldier. Well-to-do relatives might remove the coffin and remains to their homeland to be buried in the family grave-yard. The Chief Secretary's Office

attended to all correspondence and wreath laying with utmost promptness and much solemnity.

Human creatures, unlike other specices of the animal kingdom had certain traits unique to human nature. Man is individualistic; he is acquisitive; and has a strong urge to leave a progeny behind him and provide adequate for the progeny. The individualistic nature of man is reflected in his having a name of his own. Such a name is a proper noun. The word proper is derived from latin word proprius meaning 'one's own'. This individualistic trait has resulted in friend and relatives holding with certain regards a dead person. In fact, there is a tradition that no one should speak ill of the dead person unless of course he was a politician. these lead to the concept

of the dignity of human personality. A gazette of the 19th century (particulars of the gazette are given in James T. Ratnam's works). in which Thamby Muhandiram Jayewardene is gazetted as a cast guard who performed meritorious service to the British Imperial masters.

Today there is no poblic record of the individual soldiers of the Sri Lankan Army who laid their lives in the cause of Sinhala imperium over Tamils. No body many seldiers knows how were killed and what their are. Golda Meir. The Israeli Prime Migister religiously paid a visit to the house of every soldier who was killed. The standards of Sri Lanka are of course quite different. The names of the dead soldiers are not made known. In fact the Government is now

refusing to accept their remains from the L. T. T. E. On the other hand the LTTE pubilshes periodically in the news papers the names of every soldier dead, their date of death and the circumstauces under which they died. Special days of remembrance are held with great solemnity. The Government of Sinhala Sri Lanka has no regard for the individual soldier who forms the rank and file. Of course much publicity is given for the funerals of the Officer Grades and Commanding Officers.

The Chief Minister of Tamil Nudu Miss Jaya Lalitha is in a piquant position. Not many moons ago she exhibiting hysterical support for the Indra Congress and allotted a large number of seats for the congress. In reality the Congress by itself has no support in Tamil Nadu. It is only in elliance with some regional party that Congress can hope to win a few seats. The Congress of Tamit Nadu has no support over

the issue of Kaveri water supply and the Kachchativu issue which has rendered the lives of Tamil Nadu fishermen unsafe. Kachchativu belonged to the Rajah of Ramnad: Tamil Nadu as a successor State of the Rajah of Ramnad-has an unimpeachable right to Kachchativu. Delhi has no legal right to hand over Kachchativu to Sri Lanka New Delhi was fully aware that the Sinhala Naval gunboats would play havoc with Tamil Nadu fishermen and their catch.

The Semantics of Terrorism

The last day's sessions were open to the public. Thousands attended, all of them Tamils. a Tamil people in a Tamil country, gathered to listen to the great literature of the Tamil language. Without warning or provocation the Jaffna Police tear-gassed and baton-carged the audience. Shots were fired to break up even the electrical circuits and pluage the place in darkness. They were all Sinhalese policemen under a Sinhalese police officer. Nine Tamils were killed. A demand for an official inquiry by the Tamil M. P.'s was dismissed by the Sinhalese Prime Minister. The offending police officer was promoted. That opened eyes of the Tamils. Support for the armed struggle of the Tamils swelled. Just because a disgruntled police officer couldn't stomach the Tamils meeting to discuss the glories of their ancient literature, the two nations have gradually drifted into war. A case of police terror - stupid.

The JVP rebellion of 1971

The JVP rebellion or revolution, or insurgency as it may be termed according to the sympathies of the writer, has ripped through the Sinhalese country since it first blew up in 1971. Prime Minister Sirima had to receive military assistatce from more than one foreign source to stem that explosion. When Junius Richard came to power, he pardoned the JVP on condition that they would abide by the democratic process. But when J. R. himself broke the democratic process by extending the life of his stooge parliament by six years, the JVP broke faith with him and returned to a systematic orgy of killings. The government retaliated. Thousands perished in the terrorist killings on both sides.

Here is an extract from the Lanka Guardian of 1, June, 1990. by Eduardo Marino who quotes from the Guardian, London, of 26-th Sept. 89 "... driving from the airport tn Colombo we found the road was blocked over the Kelani river. Peole had stopped their vehicles and a small crowd was gazing at the muddy monsoon waters twisting below. What are they looking at? Bodies. They came here to see the corp ses floating down the river. Everyday the bodies float past, and one day this week fifty were seen drifting together. They were always youths. Bodies are found everywhere in Sri Lanka on the beaches, along the roadsides, in the jungles and in the towns. It is now customary to prevent recognition by burning the bodies with tyres, but others are thrown in the river as a warning to the living."

Whose terrorism was

Whose terrorism is this? This was the gruesome fare dished out by the 'dharmista' government of J. R. for all the world to see. It was the old tyrant's way of wiping out what he called 'subversion, carefully avoiding the term 'terrorism', which description he reserved for the Tamil Tigers only. It was an old

man's fancy, perhaps. His semantics?

The Sri Lankan government's war on the JVP is a war by a Sinhalese government on their own Sinhalese subjects. But the same government's war on the Tamil Tigers is a war by a Sinhalese government to crush another nation, the Tamils, who are fighting for their freedom from an alien Sinhalese government.

One of Sri Lanka's best-known journalists, Richard de Zoysa, was kidnapped from his home last year, and the next day his body was recovered from the sea with two gun - shot wounds int he head. Suspicion rested on the security forces; apparently a case of government sponsored terrorism. A fearless journalist, he raised his voice in defene of democracy. Who but the Government would have wanted to silence him?

Ranjan's definition

The late Ranjan Wijeratne once said in Parliament that the Amnesty International was a terrorist organization. Funny that a man so knowledgeable on terrorism should have himself succumbed to a terrorist bomb. Speaking in parliament on the subject of Tamil rights in Sri Lanka this gung - ho guy also said that he would like to see all the Tamils driven into the sea. Could that have been a terrorist wish or urge the minister could not conceal? Or is it a Sri Lankan Minister's privilege to curse his own subjects?

Secret Services

How much terrorism is involved in the under-cover activities of the great powers of the modern world? The CIA, the KGB, the RAW and their like? They have unlimited secret funds to spend, or for the smarter guys to steal. It is impossible to check them by public audit. How many murders have crushed, so many destablilized and countries so many other dastardly deeds that cannot face the light of day. That is their record. Can the term "terrorism" fully describe the incredibly disgraceful work of these shadowy men of the secret service?

Terrorism against Tamils

The Buddhists hate killing; It is against the teachings of the Buddha: So the government of Sri Lanka have had to adopt other methods of coercion to bring the Tamil rebels to heel. The shit bomb is their answer. Quite an innovation. Never before in history has human excrement been used as a weapon of war. The Chinese have used the stuff to fertilize their rice fields, but not to attack their enemies. President Premadasa and his military advisors deserve to be decorated for having thought out such a bloodless method of warfare. How simple no killing at all, conformity with their Buddhist religious tradition. Only the trouble of collecting the stuff, storing it in big barrels, loading them into the planes transporting them into the Tamil country and just dumping them overboard. A neat kind of bloodless offensive. President Premadasa has always shown much originality and resourcefulness. It is the Sinhalese Air Force men that

have to bear the stench. That may be the reason why the commander in chief has now suspended his shit operations. Since there has been no shedding of blood, this skunk-type warfare may not be characterized as terrorism. The president may even claim that it is a humanitaraian form of attack. It is not poison gas, though some gas has to be generated because of the raw material used.

Terrorism has two faces: one the heroic face which the men and women who back the terrorist associate with the noble objectives for which he kills and destroys. The other face of terrorism is what the power establishment see - the danger to the system that keeps them at the top of the social pyramid. Every person who hurls a bomb, or kills or abducts, may not be termed a terrorist. The aim is all important. The aim of one is personal gain, loot, revenge, ransom or blackmail. The aim of the other is liberation of his people from foreign rule or tyranny. Both cannot be measured by the same yardstick.

President Premadasa is continuing to carpet bomb the Jaffna peninsula; an unarmed civillan population have been exposed to this kind of terrorist warfare, since the Eelam War II started in June last year. A year of these attacks from above doesn't seem to have broken the spirit of the Tigers, nor of the people behind them. The Tamil people can survive the Permadasa terror.

pied territories reveals the inappropriateness of words used to describe the occupation. Phrases such as 'rubber bullets', 'tear gas' and 'beatings' are innocuous euphemisms for deadly practices.

In fact, 'non-lethal' bullets have killed hundreds of people during the intifada. Tear gas was responsible for the death of 66 Palestinians in 1988. And beatings often result in broken bones and death.

At the beginning of the intifada soldiers fired live ammunition indiscriminately at demonstrators. Since then. international outcry has induced the army to change its means of repression. First the army changed to sniper

Visiting the Israeli - occu- fire, then to shooting at the jegs of protesters, then to plastic bullets, and finally to rubber bullets.

> Today Israeli authorities seem to think that public relations are under control as a consequence soldiers have reverted to indiscriminate use of high velocity bullets. The means of repression have come full circle.

In reality, all ammunition used to repress the intifada has been deadly. The distinction the Israeli government makes between lethal and non - lethal is overstated. As one Makassed hospital nurse commented. "All the bullets used during the intifada kill''.

There are four types of 'non - lethal' bullets used by the Israeli millitary - the plastic bullet, two types of rubber bullets, and the 'tourist bullet'. Only the last may be called non - lethal - they are seldom used against Palestinians.

Plastic and rubber bullets were introduced in August and November 1988 after an international outcry over civilians killed by live ammunition. These new bullets were supposed to be non-lethal and their main purpose was to defuse international criti-

However. armed with these bullets soldiers resorted to gunfire more readily and aimed primarily at the upper body and head. The bullets are used frequently; children in refugee camps collect buckets of them. As a consequence, casualties rose markedly and in the month following the introduction of rubber bullets the casualty rate was one of the highest since the intifada began.

Despite their innocuous sounding names - plastic, rubber, marble-these bullets. when shot at close range.

and kill. Plastic bullets are especially pernicious because they shatter upon hitting a bone, and many of the fragments do not appear on an X-ray "When you look at un X-ray of a plastic bullet injury you see only the metal fragments" a Makassed hospital doctor explained.

'Marbles' easily penetrate the skull, and once inside, they move through the brain owing to their weight. The coating of the cylindrical rubber bullets breaks on impact, and its steel core easily penetrates the body or skull.

Since plastic and rubber bullets were first in roduced they have been 'improved'. Bullets used today are more dargerous than earlier versions. The plastic and rubber coating of these bullets has steadily become thinner, to the point that the 'plastic' or 'rubber' names are incongruous.

Recently, soldiers have given up the pretence of shooting only non - lethal bullets, and there has been increased use of high velocity and dum - dum bullets. According to Makassed hospital staff, in the past few months penetrate the body. break these bullets top the list of

causes of injury and death. The second cause of death or major injury is plastic bullets, followed by 'marbles', cylindrical rubber bullets, and tear gas.

From the time the intifada started until December 1990. 895 Palestinians were killed. For every fatality, there are some 90 severe injuries requiring hospitalisation. This is part of Defence Minister Rabin's policy 'to increase the number of wounded among those taking part in violent demonstrations, but not to kill them.

In 1988, Physicians for Human Rights reported that there was an epidemic of violence in the occupied territories. Although the intifada has faded from the US media the epidemic shows no signs of abating. Only the nature of the violence seems to have changed.

More Palestinians are now killed or maimed with 'nonlethal' bullets instead of the lethal variety. The legacy of the repression mounts every day with hundreds killed, thousands maimed, and the prospects for peace ever more distant.

THE KITTU AFFAIR

Reports from London state that Mr. Kittu (Sathasivam Krishnakumar), one of the top leaders of the Liberation Tigers of Tamil Eelam (LTTE) has left the United Kingdom. There is no information about his present whereabouts.

The Kittu affair arose as a result of the British government declining to extend the validity of his stay - visa in that country.

The British government's decision not to extend Mr. Kittu's visa raises some important questions.

It is stressed that Mr. Kittu obtained his visa to UK for medical treatment. What is not even mentioned is the fact that Mr. Kittu obtained his visa before the war between the LTTE and the Government of Sri Lanka broke out. The two parties were negotiating at that time.

Admittedly, Mr. Kittu is a senior leader of the LTTE. The UK Government's refusal to extend Mr. Kittu's visa has to be regarded as an attempt to hand over a warring party to his enemy. The need for Mr. Kittu not to be caught in the hands of the murderous Sinhala Government should be explicit to all. It is beyond comprehension how the UK government could not understand this.

It is not a case of legal quibbling or discussing legal niceties and subtleties. It is a case of making a political decision.

During the time of the war between the LTTE and the Indian Army, the Indian government arranged to release Mr. Kittu and some others of the LTTE, who were in Tamil Nadu in India, at Jaffna without reference to the government of Sri Lanka. Britain has not chosen to take similar action either.

The plight of Tamil Eelam and its people is solely due to British bungling. No less a person than Lord Soulbury himself, who recommended a constitutional set-up for Ceylon on which basis Dominion Status was later granted, had stated that had he had the knowledge and experience which he later gained, he would have made "other recommendations."

In 1972 the Sinhala government made a unilateral decision to overthrow the British - made constitution despite the opposition of Tamil Eelam. Ceylon became Sri Lanka but with the Tamils opposing the Sinhala coup. Britain did not come forward to discharge its responsibilities towards its Eelam Tamil subjects.

The first Colonial Secretary to Ceylon, Sir. Hugh Cleghorn, explicitly told his Home Government in 1799 that the possession of the Island was divided between two peoples differing from other in language, religion, culture and customs and occupying divided territories.

The Treaty of Amiens by which the Island of Ceylon was ceded as a British Crown Colony, had attached to it the Arrow Smith map which clearly defined Tamil Eelam, Sinhala Rata and the Kandyan Kingdom. The British, when they decided to quit the Island, should have restored to the different peoples their different territories. Instead they left the Eelam Tamils to the tender mercies of the Sinhalese because of their own tack of "knowledge and experience."

Not only Mr. Kittu, there are thousands of other Eelam Tamils in the U.K.-most of them seeking refugee status there. The problem would not have arisen at all, had Britain acted with foresight in the forties and restored the different states in the Island as it found to have existed in the Island before the advent of Western Imperialism.

It is unfortunate that the Government of the UK instead of making amends for its earlier faults, should continue to commit further mistakes-which are foul deeds, as far as Eelam Tamils are concerned,

The decision of the UK government to ask Mr. Kittu to leave Britain invites condemnation by Eelam Tamils. Eelam Tamils have no reason to run to UK, if the lost Eelam Tamil state, is restored. Till then the Tamils have right to expect protection from Britain.

It is hoped that Britain would at least now-having witnessed the death and destruction which inevitably have resulted from its rule over the Island - realize her responsibility and take suitable steps to support the Eelam Tamil Cause.

Aerial Bombardment—Relief Organization Office and Stores Completely Damaged Refugees problem mounting in Vadamaradchy East

The Vadamaradchy East Branch office of the Tamils Rehabilitation Organization (TRO) and its Stores both situated at Thalayady were completely damaged as a result of home-made barrel bombs being thrown on them on the 19th of July at the time of the peak military operations in the area undertaken to relieve the Sinhala Army at Elephant Pass. The TRO has sustained severe loss of property.

The office of the TRO is now functioning from Nagar-coil because relief and rehabilitation in the area have become further accentuated by the recent war there.

It is reported that the entirety of the population from Chundikulam to Maruthankerni covering a distance of 30 km in length - have been displaced from their homes after the recent military operations undertaken by the Government in this area.

Seventy percent of the displaced persons are living as refugees in the villages between Chempianpattu and Manalkadu. There are no big common buildings to enable these families to be accomodated. Already there are refugees from Vetrilaikerni and Elephant Pass areas also in these villages. In addition there are other refugees from outside who

the war broke out last year.
The refugee problem has become acute. Refugees are just living under tree shades.

Food and sanitary problems have arisen.

The Maruthankerni Hospital and Mulliyan Dispens-

pital and Mulliyan Dispensaries have ceased to function after the recent military operations. There is only one dispensary at Ampan.

This is grossly inadequate to give medical attention to the refugees living half-fed and under insanitary conditions. The problem is likely to be aggravated with the monsoonal rains expected shortly.

Premadasa's Predicament

President Premadasa virtually received a bolt from the blues when Speaker, Mr. M. H. Mohamed broke the news of an impeachment motion presented to him by a majority of Opposition MPS and a substantial number of UNP MPs against the President.

Since then, hectic activity has begun on both sides of the divide. Some MPs seem to be on the fence or more correctly giving a long rope to both sides. This is clearly visible by the claims made by both sides that each will become the ultimate victor.

In this process, interesting allegations are being made. Lalith Athulathmudali is reported to have blamed President Premadasa for allegedly giving arms to the LTTE to fight the Indian Army. This is a clever counter propaganda by the Lalith group to meet the allegation that India is behind the destabilization efforts in Colombo Lalith group hopes to achieve two things from this line of propaganda - alienate mass Sinhala support for President Premadasa and also acquire support and sympathy for their group from India.

The old fox, J. R. Jayewardene, appears to play his
cards well-this time too.
Both groups seem to leave
him alone. But the eulogies
heaped on him by the Lalith
group-despite their vow to

praising him personally but condemning his system - the other group praising his system of government but saying nothing personally about him - a funny situation indeed!

Premadasa has said that if necessary, a referendum could be had on the question of the office of Executive President. Does it exhibit a weakness or cunningness?

Lalith has called for a secret ballot. Why? Weakness combined with cuningness?

In the meantime, President Premadasa has said that the move against him has been engineered by the "elite upper class" which apparently appears to carry conviction with the people because the Lalith group formed part and parcel of the subservient parliamentary pro-Jayewardene group who ushered in

the Executive Presidential System of Government and as Mr. Ranil Wickremasinghe has said Lalith did not so much as even open his mouth until now against the Executive Presidential form of Government. Mr. Lalith Athulathmudali's call for secret ballot has been rejected by Premadasa's side. Mr. Lalith Athulathmudali's statement that his group would win in the event of a secret ballot, seems to be more an acknowledgment of ultimate defeat for his side.

In the meantime, President Premadasa appears to have won for him the support of the Buddhist clergy - a formidable power bastion in Sinhala Rata. He seems to rely on them heavily, refusing to learn from the history of the late Mr. Bandaranaike's position in the fifties.
