SUPERSONIC JETS AGAIN CHAVAKACHCHERI BOMBED

Two supersonic jets of the Sri Lankan Air Force bombed Madduvil North in Chavakachcheri on Tuesday, January 12.

12 two Supersonic jets of the Sri Lankan Air Force dropped 3 bombs near the Madduvil Mahavidyalayam but as all the three bombs fell in a bare land there were no deaths except for an old woman who lived near the area who died as a result of the shock she received. At 8.00 a.m. on January mah (45) suffered injuries as splinters hit her and is admitted to the Chavakachcheri Hospital.

About six houses in the vicinity were damaged by the tremor caused and splinters hitting them. Most people had taken shelter under trenches and thus escaped injuries.

Exploiting the Fiction of Prestigious Schools

The system of the Government holding an examination in two subjects at the end of the 5th year, at the termination of the Primary school level, has given an opportunity to some schools with vested interests to the fiction of prestigious schools to indulge in anti-social practices. A supposed prestigious school collected Rs. 2,140/- from each child who was misled by this fiction of prestigious school but gave a receipt for only Rs. 5/which was membership subscription for a co - operative canteen. Chancellor Kohl of West Germany had been taking all steps to have former President, Eric Honecker of East Germany punished for his ordering the killing of East Germans who tried to cross into West Germany. Who is going to take the necessary steps to have President Premadasa punished for his ordering the killing of innocent Tamil civilians trying to cross into the mainland from the Jaffna Peninsula?

On the 2nd of this month, the Sri Lankan Navy at the sight of three small boats, had shot at these boats at random and then tied them to their boats and removed them to the area under their control. So far the death toll has been counted as forty. It might be much more, it you include the corpses in the boats and the bodies which got washed ashore in areas under the control of the Sri Lankan Forces.

Election Postponed-Big Brother Says

'Hold Them'-Leninism-New Thought

am the greatest", President Premadasa, beating his chest, said "No one can beat me". He, thereby, indirectly said that 1993 would be the election year for Provincial Councils, Parliament and for the Presidency. Some Lake House newspapers came out with the advantages that would favour Premadasa for a landslide victory in all areas and gave the causes why the Opposition could not win. It even showed the percentage of votes he would get, the futility of the obstructionist attitude of the Opposition on the assumption that the elections were round the corner etc. But suddenly Premadasa has changed his tactics and announced that Presidential Election will be held only in December. 1994, two years hence Even though the Opposition says that these new tactics are to put them off the track and take them by surprise, the actual reasons are somewhat different. Before the change of tactics. President hoped that he could fool both Sinhalese and Tamils with 'his' Siinivasan's proposal. Political climate in the Capital changed immediately. Tamil groups operating from Colombo were taken by surprise. Their future became a blind alley. New Delhi was alerted. Thondaman who was vacillating at first, got out of the initial shock and there was a unified voice against the outcome of the Select Committee. Things moved fast. CWC resigned from the Select Committee, Premadasa who was banking, as the UNP always did, on the votes of the Tamils and Thondaman, got perturbed. The militant chauvinist elements in the SLFP also brought terror to Premadasa. Hela Urumaya and the MEP showed signs that they could sway Sinhala votes. President also knew that even Tamil votes outside the North East could be depended only by the grant of some solution or other to the problem.

Like Mohamed Ali alias achieve because the majority of the top rung in the hierarchy of the armed forces who are not involved in the actual war, but were on the periphery and enjoying the 'fringe benefits' directly or indirectly because of the continued existence of the war, is opposed to any political solution. DESPERATE KICKS OF A DYING DONKEY

Recent weeks have witnessed an acceleration in the process of killing Tamil civilians by the tottering racist Sinhala State.

On Christmas Day, a Christian family which had got together to celebrate X'mas were the victims of a heinous crime against humanity, committed by a rabidly Sinhala State, when its Air Force bombed their dwelling house at Ariyalai, Jaffna.

It is rather strange that some Christian countries are aiding and abetting this murderer by providing militaryware and financial aid. Some of these countries are playing fiddle to the swansong of "Territorial Integrity' of the Sri Lankan State to encompass the Tamil homeland.

On Saturday the Second of January, 1993, when civilians were crossing the Jaffna Peninsula after celebrating the New Year with their families, the Sri Lank*n Navy exhibited their true cowardly character by deliberately attacking the civilian convoy of boats. According to eye witness accounts, when the Navy gun - boats approached, the civilians had cried for mercy. Yet these beasts in human form have lobbed grenades into the civilian boats, fired at them and even indulged in stabbing and chopping the defenceless civilians. Many of the bodies were found to have been mutilated.

Again on Wednesday, 7th January, supersonic jets bombers of the Sri Lankan Air Force had thought it fit to fire recket mortar and bomb the village of Sithankerny in Jaffna, without any rhyme or reason. They fired over two dozen rocket mortar all over the village. They succeeded in killing ten civilians and wounding over twenty others. Most of the victims were passers - by on a public road and those working at a rice mill.

The genocide of the Tamils is being carried on with undue haste and the supersonic jets are also used liberally for this purpose. All sorts of atrocities on Tamil civilians, including an increasingly tightened economic blockade are being perpetrated, while the Sinhala President Premadasa, as usual, is pretending to be a Buddhist Apostle preaching peace, harmony and nonviolence. Day in and day out he relentlessly preachesprofusely quoting from Buddhist Scriptures, speaks of 'noble weapons' to achieve lasting peace instead of lethal weapons. His obsession for preaching seems to have reached such a mental state that he cannot be without constantly preaching and preaching concepts he never practised and never intends practising.

He only preaches to others. What he himself practises, can be gauged by the number of Sinhala youths who were made to 'disappear' by his killer squads and the frantic efforts his government is making to procure Bukkhara bombers, MI 8, helicopter gunships and many other lethal weapons to accelerate the annihilation of the Tamils.

Tamils are convinced of the evil colonial intentions of the Sinhalese and are not going to be deterred by Sinhala State Terrorism. The barbarous and brutal methods adopted by the Sinhalese to keep the Tamils under subjugation, abusing their hold on the State apparatus, has gained notoriety all over the world. The Sinhalese seem to fail to understand the fundamental nature of the human spirit and the urge throughout the ages to rid itself of ail oppressions.

The Tamils as a nation are determined to preserve their national identity and are not prepared to forsake their ideals under fear or cowardice. We are sorry and ashamed to see the petty-mindedness of the Siphala chauvinists and the enormity of racism and bigotry in which they are engulfed and the depths to which they descend to militarily subjugate the Tamils.

We can only say to the Sinhala President Premadasa that you do your worst to perform your impossible aim of militarily maintaining your fast collapsing illegitimate rule over us and we Tamils will do our best to liberate ourselves and re-establish our own independent Sovereign State of Eelam.

3 More Bodies Washed Ashore

Three more dead bodies of massacred civilians who crossed the Kilali sea on Saturday, January 2, were washed ashore near Alankerni on Monday, January 11.

The bodies were highly decomposed and could not be identified except as male bodies.

With these three new bodies the number of dead bodies found has increased to 31. Accordingly the following day, Monday, January 11, the Sinhala prisoners of war were presented to the Rt. Rev. Kenneth Fernando. Two of them were released and handed over to Rt. Rev. Kenneth Fernando. The released prisoners are Police Sergeant K. L. M. Bandara (44) of Kandy and Police Driver S. K. Edward Perera (40) of Kegalle.

Rt. Rev. Kenneth Fernando who received the freed prisoners said he was very grateful to the LTIE leader who readily agreed to his request to be allowed to see the Sinhala prisoners and also to release two of them. He also said he would take along with him the freed Sinhala Police Officers to Colombo and also present a written memorandum to the President.

Police Sergeant Bandara, speaking at the release ceremony said that they were looked after well by the LTTE during their captive days.

It is learnt that during the two and a half-hour long discussion Rt. Rev.

Kenneth Fernando had with Mr. Pirabakaran, many matters were discussed including the difficulties the civilian population in Jaffna undergo, and creation of a peace atmosphere.

the settlement of an issue by war, is the central task and the highest form of revolution. The Tigers are engaged in a revolutionary war to oppose the counter revolutionary war imposed on Eelam by the Sinhalese elites. They are engaged in a just war which is opposed to the unjust war thrust on the people of Eelam.

Transfer to Anuradhapura

It is of significance that the Tigers, inspite of being in a commanding position regarding the war, have shown many an indicator that they are prepared for negotiations. Release of Sinhala prisoners from time to time and various other gestures of goodwill shown by the Tigers, should not be considered by the Government as weakness. The Government, no doubt, understands that they are weak internally and internationally, both military-wise and economically. But it wants to show a bold face.

President Premadasa wants to muddle the situation and hoodwink the Sinhalese. The Government wants to shift military operational command to Anuradhapura. This move too is a multipronged manoeuvre to defraud the Sinhalese. Whether it is Colombo or Anuradhapura, what difference would it make? It is only to bolster the morale of the soldiers at the forward defence line and for them to think that their commanders too are with them. But actually, it is to safeguard those top rung officers in the armed forces who are now susceptible to risk and danger in Colombo that the command is being shifted to Anuradhapura. Among the Sinhalase, there seems to be none who could visualise the hollowness of the strength and tactics of Premadasa's war manoeuvres and expose them to the ordinary Sinhalese. No one seems to be worried because after all, it is the ordinary Sinhalese lad who has joined the Army for his economic benefit but who isgetting killed in the battlefield.
