S.L. Army Retreats With Heavy Loss

ENCOUNTER AT ELEPHANT

The third attempt of the Sri Lankan Army entered the Karukkaitivu sea to occupy further free Tamil Eelam territory failed on Wednesday, April 21, when LTTE fire directed towards Tiger forced back the moving Sri Lankan Army. the same time four 'water -

The news in this connection states that on Wednesday, April 21, at 6.30 am. Sri to the Sri Lankan Navy Lankan Army soldiers encamped at Elephant Pass stepped out from their Forward Defence lines near the Elephant Pass Railway station in battle tanks and tried toadvance on two fronts to wards Karukkaitivu.

Within 800 yards from the Forward Defence Line Sentry points, the LTTE started to attack the Sri Lankan Army which tried to move forward.

As the S. L. Army tried to move, heavy artillery shells were tired towards Tiger positions from the S.L. Army Camp at Elephant Pass. At

Shell Attack in **Batticaloa Village**

The Sri Lankan Army encamped at Karadikulam in the Batticaloa District launched shell attack from its camp directed towards the village of Alankulam. According to the news in this connection the shell attack started early in the morning at 4-30 on Wednesday, April 21 and continued for some time. Report of details of damage has not been received.

At the same time three bombers and a helicopter belonging to the Sri Lankan to its position at 11, 30am.

Air Force joined in the battle pounding Tiger positions. But the LITE held its own and carried out counter - attack against the combined forces of the Sinhala state.

Heavy fighting went on for about 5 hours. The Sri Lankan Army, unable to carry on its push forward, retreated

According to Government sources two Sri Lankan soldiers are reported to have died in this battle which took place near Elephant Pass. There was no casuality on the LTTE side.

The Government enforced a curfew in the Jaffna and Kilinochchi Districts but announced its withdrawal in the afternoon, the same day.

Opening of closed letters still persists in Colombo. Even foreign letters sent to addressees in Jaffna are subject to strict censorship at the Naval Camp in Colombo, prior to being sent to their destinations by ship.

Although an assurance was given earlier to Mr, Sethukavalar, the Deputy Post-Master General of the Northern Province by Mr. Cyril Ranatunge, the former Defence Secretary, that henceforth etters sent to the North

would not be tampered with. This assurance was given in Mid March this year, yet the opening of private letters has again been resorted to.

But now the local postal authorities instead of inviting in writing the addressees of such tampered letters to call over at the PostOffice to collect them, the letters are being delivered like the normal mails by the postal Peons. Since the responsible officers attached to the Postal Department are thus passing the 'baby' on to the minor employees, there

has developed labour unrest amongst the minor staff, as they have to face the blame for illegal tampering of foreign mail.

In the meantime even the number of mail bags receitoo has dwindled to less than one hundred, whereas normally for the duration of a week, the number of mail bags received by ship should average two hundred.

Picketing by Displaced Persons

Displaced persons from Erlalai, Punnalaikattuvan and Kuplan have not been given dry ration relief from February this year. There are over 940 displaced families from these areas, living as refugees in the Uduvil AGA's division.

These displaced persons are picketing the office of the Uduvil AGA at Chunnakam demanding the restoration of the supply of relief dry rations to them. The picketing is going on for five days now.

Red Cross Work Hampered

Following the wanton kill-ing of the Vice President of the Jaffna Branch of the Red Cross Society, Mr. Kandiah Puvanendran, in Valikamam East on Saturday, April 10 by firing from a 'Puccara' bomber belonging to the Sri Lankan Air Force, the Jaffna Red Cross Society has suspended its activities of providing transport to hospital of injured or sick patients.

It is learnt that the ICRC advised the Jaffna Red Cross Society to obtain clear instructions from Colombo in regard to the movement of its

Sinhala Buddhist chauvinism has once again bared its venomous fangs. WHOSE PROBLEM?

The BBC is reported to have commented that the Parliamentary Select Committee (PSC) has turned out to be a Sinhala Committee.

One does not know whether the comment was spurred by the telephone interview Mr. Mangala Munasinghe, the Chairman of the PSC, gave the BBC.

Mr. Mangala Munasinghe has told a BBC questioner that the war must be won in the Eastern Province by clearing it of 'terrorism' and peace restored. It should be followed by rehabilitation and development works. He said he believed that peace cou'd be restored in large parts of Ceylon by this.

What he meant by all this rigmarole is that the Tamil homeland should be divided. He probably was imagining that he was speaking in diplomatic language!

We have had no doubts at anytime as to what was going to be the outcome of the deliberations in the fraud called the P.S.C. But the P.S.C. was President Premadasa's shield and cover to do nothing to solve the problem - reminiscent of the All Party Conference and what not.

Nevertheless the appointment of the PSC was made out to be an honest attempt on the part of President Premadasa to find some solution to end the current war. Regretably even some well-meaning outsiders believed all the hoax of the Sinhala imperialists - forgetting the fact that the Parliament was the instrument which the Sinhala imperialists utilized to consolidate and extend their rule of the Tamils.

We have never found fault with the Sinhalese people as a race. They are as good as any other but their politicians - the chief of whom were and are in Parliament - always plotted to establish Baudha - Sinhala imperium over all peoples and throughout the island.

As a matter of fact Sinhals politicians vied with one another for votes using the Tamil phobia as their sheet anchor and the more communal a Sinhala politician was, his chances of election were the better secured. In these circumstances it would be sheer madness for any-body to expect any solution from a select committee of the Sinhala parliamentarians more or less represented proportionally to the parliamentary strength or each party in parliament. The mere fact that there are some Tamil members too in the Select Committee matters not at all for even some Tamils are in the parliament too.

However the audacity of Mr. Mangala Munnsinghe in presenting a report exposes all the hollowness of the claim of the PSC to work out any colution. Who wanted the PSC and whose problem does the PSC hope to solve?

According to reports, the PSC has recommended the division of the Tamil homeland and devolution of subjects on the Indian model. The Tamil members of the PSC have not accepted the majority view and some have even pulled out of the PSC. In this context how did Mr. Munasinghe purport to forward a report on behalf of the PSC? After all, he should have said that President Premadasa's 3 Cs have no place whatsoever in the PSC and presented no report at all!

Mr. Munasinghe by presenting a report which did not have the blessings of even the Tamil members of the PSC is only providing another armour to the spread of Sinhala imperialism.

If Mr. Munasinghe or for that matter anybody else believes that they can fool the Tamils, they are sadly mistaken.

Skeletons in the

Employees of the Chavakachcheri Urban Council who were digging the ground to erect electric posts were shocked at the discovery of human skeletons, skulls and rags of clothes and even jewellery. This happened on Tuesday, April 20.

The shock and amazement was the greater because these were unearthed not in a cemetery or other lonely or abandoned area but right at the centre of the town in the Chavakachcheri Model Market.


Immediately the first pieces of remains were accidently

found, the Chavakachcheri Police was informed. The police arrived and the digging continued in their presence.

In all, six skulls were found. There were other bones as well as pieces of clothes and some items of jewellery worn by ladies including Thali (symbol of wedlock) ear-rings and rings. Also a holy thread was found bundled in a small parcel.

This area was under occupation of the Indian Army during 1987. A Brahmin temple priest and his family were reported to have disappeared at Chavakach-cheri during this period. Investigations are afoot to determine whether the skulls and other skeletons belonged to that priest and those of his family. The skulls also had bulletmarks.

NEWS ROUND UP

April 12 - Monday

Sri Lankan Army encamped at Kalmunai fires at fishermen out for fishing in the Jaffna lagoon. One fisherman named Santhiyapillai Jeyam of Navanthurai North was severely injured in the leg and has been admitted to the Jaffna hospital. About 15 fishermen went out fishing on three boats. Santhiyapillai Jayam was one of them. Other fishermen returned safely with their boats abandoning their work for the day.

Sri Lankan helicopters fired from the sky over the villages of Kattuvan and Erlalai for about 20 minutes. Damages have not been verified.

Sri Lankan Army at Karainagar started firing towards the sea at Ponnalai. Damages not verified.

Battle broke out between the S. L. Navy and the Sea Tigers at 9.30 P.M. when S.L. Navy tried to attack civilian passengers. Sea Tigers carried out a relentless attack and sent S. L. Navy back to their positions. Thereafter the S. L. Army fired at civilian passengers from the coast.

Heavy artillery shell attack from Palaly Army camp directed fowards Thondamannaru, Paththameni and Idaikadu. No damages reported.

April 13 - Tuesday

A 'Puccara' plane belonging to the S. L. Air Force bombed thrice in the villages of Irrattaikulam and Katkanthakulam in the Murunkan Division of Mannar District about 8.00 a.m. Damages not verified.

Confrontation between Tigers and Navy at Kilali. Following the battle Sri Lankan Navy sent volleys of cannon fire directed towards the coast. No damage was reported.

At the auspicious time of 7.45 p.m. when New year began according to Hindu calendar S. L. Army at Valikamam North fired 5 shells which exploded at Alaveddy and Tellipoalai. This was followed by firing from sentry posts of the Forward Defence Line of the Sri Lankan Army at Valikamam North. No damages reported.

April 15 - Thursday

Artillery shell launched from Palaly hit Panipulam, Chulipuram and Kattupulam in Valikamam West, An elderly person named K.

'Puccara' bombers dropped 8 bombs in Periyapandiviri chchan, Kattaiyadampan and Murunkan areas in Manoar District. Damages not known.

Sri Lankan Navy fires at fisherman engaged in fishing at Munai in Point Pedro. One fishermen, S. L. Mariyana-yagam (age 40) was injured in the leg when a bullet hit his leg, piercing the boat. He was admitted to the Manthikai Hospital.
