News from Mannar state that consequent to the withdrawal of the Sri Lankan Army from some areas of Mannar mainland in August, normal life in those areas is beginning to take


When the Army invaded those areas the people there left their homes and took refugee in Madhu refugee Camp. The Army

### LTTE RESCUES 40 TAMIL Prisoners in Poonakari

The LTTE rescued for 40 Tamils from prison cells at Ponnakari to which they had been confined by the Sri Lankan forces before the smash - up of the Sri Lankan military complex.

### OUR HOMAGE

The whole of this week saw solemn homage being paid to the Tamil national heroes all over Tamil Felam territory-freed of the Sinhala Army of occupation.

The first Tamil hero of the Liberation Tigers of Tamil Eelam fell fighting for the Tamil Eelam cause on a November 27.

As the numbers of Tiger martyrs kept on increasing, the LTTE called for the week ending November 27 to be observed every year as the Heroes' Week and Tamil Eelam has been observing this week as the Heroes' Week ever since.

This year's Heroes' Week commemoration programmes assumed greater significance for the people as the Heroes' Week was preceded by a glorious victory for the Liberation Tigers at Poonakari just ten days before the commemoration week began.

Just ten days before the programme began over 300 names were added to the long list of national heroes. Sad though it was, adequate compensation was there in the form of the complete smash-up of a Sinhala Military Complex at Poona-kari having Army and Naval bases. The Poonakari Sri Lankan military complex was a major one and it was from this complex-the Nagathevanthurai Naval Base-that the Sinhala Naval murderers went out whenever they desired and killed innocent civilians undertaking the arduous and perilous journey across the sea simply because it was inevitable that tney should travel for purposes of their normal existence.

The happiness of the people at the Tiger victory at Poonakari knew no bounds and perhaps the enthusiasm displayed by larger participation of the people in the Heroes' Week, may partly be due to this victory.

The LITE has put up structures housing the pictures of the national heroes at various places and from all reports it is clear that large numbers of people piled up to pay their respects to the heroes at the various centres.

It would be wrong to conclude that the great enthusiasm displayed by the people to pay their homage to the heroes, arises from the victory at Poonakari-though it probably added to the enthusiasm.

Beginning from the first Tiger martyr, Sathianathan, upto now over 8000 Tigers have laid their lives in the cause of Tamil Eelam. Eight thousand odd Tamil Tigers have sacrificed their youthful lives for the sake of their land and people. Eight thousand odd youth - martyrs mean about 50,000 of the nearest kin-parents, brothers and sisters. The outer periphery of relations, uncles, aunts, cousins, nephews, nieces etc. would bring the figure to two hundred thousand or more. All these people are here in Tamil Eelam irretrievably drawn to the cause by the sacrifice of their own children. This probably explains the enthusiasm behind the people's participation in the Heroes' Week.

It would be correct to state that Heroes, apart from performing feats in themselves most astounding and heroic, have ensured that the Tamil Eelam cause is enshrined in every Tamil's heart by their own self-sacrifice.

No one will end his own life by the cyanide capsule, or in a Black Tiger assignment or in a fast like that undertaken by Thileepan or blow himself up in his own vessel as Kittu and his men did on the seas, if he is a terrorist as the Sinhala chauvinists try to make out the Tamil freedom fighters to be.

The Tamil national heroes are the flowers of our land imbued with the noblest qualities of humanity.

We join the people of Tamil Eelam in paying our homage to the National Heroes of Tamil Eelam.

# Local Elections-Some Reminis

One is reminded about prior to the pogrom of July, the results of the elections to Local Authorities held on May 18th, 1983, when President D. B. Wijetunge announced the nomination date for the holding of the elections to the local bodies in the East and Vavunia in an area purported to be under the occupation of the Security Forces.

What happened then in May, 1983, when former President J. R. Jayewardene held the elections to get the Jaffna Municipal Council and the Urban Councils of Chavakachcheri, Point Pedro and Valvettiturai elected? On the appeal made by politicians of yester - years, the voters of Tamil Eelam had already exercised their right of self - determination by converting the General Elections held on July, 1977 for the election of a New Parliament into a Referendum and had by an overwhelming majority opted to restore and re - constitute the lost State of Tamil Eelam. So in keeping with that wish of the Eelam Tamils, the Libe. ration Tigers of Tamil Eelam asked the people to boycott those local elections. This happened just two months 1983. The rate payers too, of those four local bo lies -The Jaffna Municipal Council and three other Urban Councils of Chavakachcheri, Point Pedro, & Valvettituraifell in line with the LTTE request and boycotted the elections. Polling took place with full security arrangements provided by the joint forces of the Sii Lankan State - the Army, Navy, Air Force and Police. Yet not even ten percent of the voters made up their minds to cast

their votes, even though the Tamil United Liberation Front (TULF) itself had fielded its candidates to contest that election. The worst thing that happened for the TULF and the Government of J. R., was that even those who were returned as city-fathers themselves, declined to take office. To this day, by special arrangement, the administration of all those four local bodies are being run by permanent State Employees.

Fools do not learn any lessons from the experiences of others and in the process allow history

itself. repeat Opponents of the present President play pun with his initials and call him in a derogatory manner as 'Deaf and Blind' Wijetunge. People who have ears to hear and eyes to see, will not venture to repeat their past mistakes. But will D. B. Wijetunge learn any lessons from the past?

Colombo Tamil political parties and even the Muslim Congress have opposed the holding of any elections in the East, be it local, the proposed Referendum or any other. The situation there is not conducive to the holding of any elections in their view. The reason being given is that, even though the Government and the forces claimed to have established full control over the East and Vavunia town, yet these areas are not beyond the reach of the LTTE. They cite the reports of incidents taking place there as proof. Furthermore, thousands of displaced voters have not vet been rehabilitated in areas where they resided earlier. No one can assure whether their names are included in the cooked-up (Continued on Page 3)

### Another Church Attacked

The Church of our Lady of Mount Carmel at Gurunagar, Jaffna was attacked by a shell, launched from the Sri Lankan Army at Mandaitivu on the midnight on Saturday, November 20.

This is the second attack on a Roman Catholic Church in Jaffna within one week. Earlier on November, 13 the large St. James' Church was bombed by Sri Lankan Super Sonic bombers which

resulted in the destruction the Church, death of ten people and injury to over 30 which prompted the Bishop of Jaffna to lodge a strong protest with President Wijetunge and call for compensation both for the Church and for the victims and their families. Despite the public criticism against such wanton bombing, the Church of Our Lady of Mount Carmel has now been shelled which

caused heavy damage to the church and a house nearby.

Residents living in the coastal area said that an Army vehicle was seen being driven near Mandaitivu junction from which shells were fired about midnight on Saturday towards Gurunagar. It is one of these shells that hit the Church of Our Lady of Mount Carmel.

#### **NEWS IN BRIEF**

#### November 7- Sunday

Artillery shells directed towards Chulipuram and Pannakam areas from the Coastal areas of Jaffna Palaly about 7.50 a.m. fell and exploded in residential areas causing severe damages to several houses in the vicinity. Inmates of those houses escaped without any injuries.

In an ambush carried out by the S. L. army at Kaluvantanveli in the Batticaloa District about 9. a.m., one LTTE militant lost his life.

#### November 8 - Monday

Sri Lankan army camps in the boundary villages of Pavatkulam, Palayoor and the Second Unit Colony in the Vavuniya District carried out continuous barrage of artillery shells and gunfire from 5 a.m. around the surrounding villages.

#### November 9 - Tuesday

Sri Lankan Army Base at Town were subjected to heavy artillery shelling by the S. L. army. During the attack, a shell fell and exploded at Passaiyoor killing two persons-a mother and son-Krishnadas Malarrance (42) and Krishnadas Jesurajah (05). Two others, Sebastiampillai Soosaidas(44) and his wife Soosaidas Pushparanee (40) were injured. Another shell fell and exploded at Gurunagar causing damages there.

### November 13 - Saturday

A shell directed towards Jaffna Town from the army camp at Mandativu, fell close to the junction at Konanthottam on the Manipay Road but failed to explode. One house was damaged by a shell which exploded in an area near Sivanpannai road at 3 p.m. November 14 - Sunday

A shell attack was made within the Jaftna Teaching Hospital safety zone from the Army camp at Madativu at 10 p.m. Some houses were damaged in the explosion caused by the shells which fell within the safety zone. In another incident shells directed towards Colombuthurai from the same camp 2.45 p.m. injured two females, Subagini (9) and Annammah (75). The injured were admitted to the Jaffna Teaching Hospital for treatment. The attack was resumed about 10 p.m. but this time the shells were directed towards the Jaffna Clock Tower within the safety Zone of the Jaffna Hospital where the super-sonics had hit earlier in the day. Three houses were damaged.

# Confederation of People's Organisations tells D.B.W:

# Stop Indiscriminate Bombing and Shelling

Mr. Solomon S. Cyril, President of the Jaffna District innocent Public Organisations, has sent a letter to the President D.B. Wijetunge with copies to all embassies and the ICRC protesting against the indiscriminate bombing and shelling calling for the immediate cessation of death and destruction that is being caused by the armed forces of Wijetunge's government.

The letter reads:

The Jaffna District Public Organisations Federation wishes to lodge its vehement protest against the bombing of the Jaffna Kachcheri, St. James Church, Jaffna the vicinity of the and General Hospital, Jaffna which had been declared a Security Zone by the I. C. R. C.

On 12.11.93, round about 8.45 a. m., the Jaffna Secretariat was bombed, causing extensive damage to office equipment, official records and files. The Govt. Agent himself was injured. 25 people were injured.

On 13.11.93 at 7.20 a. m., the 136 year old St. James' Church was bombed. killing 11 people. Over 25

### Saiva Paripalana Sabhai Protests Blasphemy to a Hindu Venerable Leader

The Saiva Paripalana Sabhai Jaffna has sent a protest letter to the President and passed a resolution on the detention of Nallai Thirugnanasambanther Aatheenam by the Seeduwa Police.

The Sabhai's letter says:

"The most reprehensible manner in which Venerable Maha Sannithanam of Nallai Aatheenam was detained and treated undemocratby the Colombo Police between Negombo and Colombo on 22.10.1993. blasphemous and unnecessary interference. The entire religious world has been amazed at this brazen conduct of the Police, a bullying act. Nothing short of a Presidential Commission of inquiry into this anti-religious interference can allay

Hindus' feelings all over the world. Hence the request for such a commission of inquiry as embodied in the following resolution passed by our Sabhai:-

"The Saiva Paripalana Sabai Jaffna condemns the detention and undemocartic treatment of Nallai Thirungna sambanthar Atheenam SriLa Sri Somasundara Paramachchariya Swamikal on his way back from Negombo to Colombo on 22.10.93. by police and request for a Presidential Commission of Inquiry."

seriously injured and hospitalised. On same day at 2.25 p.m., the Hospital, Jaffna, General which is within the Security Zone, was bombed, causing extensive damage to the hospital buildings and injuring the inmates. On the same day, there was aerial bombing in the vicinity of the Nandavil Temple in which more than 10 innocent devotees were injured.

People in the Jaffna Peninsula are living in constants fear and danger. The schools, places of worship and other public Institutions are unable to function due to indiscriminate bombing. It clearly shows that the Govt. is not willing for a political solution by its action of destroying innocent public purporting to be taking antiterrorists activities.

On behalf of the public of Jaffna, we urge your Excellency to order Security Forces to immediately the indiscriminate bombing and shelling of Jaffna. We would also like to appeal to you to lift the ban on the movement of traffic during curfew hours, as this hampers voluntary organisations from providing medical relief and aid to the injured and the supply of food.

If your Excellency fails to take the appropriate steps, we fear there will be very unfavourable mass reactions.

Combined Attack on Thondamannaru

The three combined armed forces of the Government of Sri Lanka indiscriminately attacked Thondamannaru and adjoining areas causing severe damage to civilian property and injury to per-

On Tuesday, November 16, morning between 7.00 and 9.00 Sri Lankan Naval gun boats sent volleys of cannon Sakkottai, Inparuddy, Supparmadam and Point Pedro.

At the same time Sri Lankan Air Force bombers pounded Thondamannaru and Udupiddy. While the combined naval and air force attack was on, the Sri Lankan Army fired shells directed towards these areas from its Palaly Base. A four-month old infant, Amirthalingam fire towards the coast of Uthayarani of Authikovilady Thondamannaru, Polikandy, received a serious injury in

> Injured Fisherman Arrested by Navy

Sellathurai Raveedran (34) a fisherman from Gurunagar (father of 2 children) is believed to have been captured by the Sinhala Navy.

Three fishermen from Gurunagar went out fishing on the night of Sunday, November 7, about 8.00. As they were fishing in the Mandaitivu - Kalluvantivu area, Sinhala Navy men fired at them.

Sellathurai Raveendran was injured. The other two fishermen who escaped injury returned home. They are F. Collin and R Sushi.

Collin said that he and Sushi jumped from their boats and swam. They also heard Raveendran crying out that a shot had hit him. They saw Navy men with torches.

Collin further said that they believed that Raveendran had been taken by the Navy. Their boats and other implements too, have gone into Navy hands.

# Weighty Memorandum of Religious Heads

The memorandum sent to ment officials apart from the President by the Heads of All Religions in Jaffna on the indiscriminate and and barbarous bomber attack being carried out in the North by the Sri Lankan Air Force is a weighty one.

It is very different from the memoranda normally sent to the Head of Government on the atrocities committed by the Government and its armed forces in the Tamil areas. The memorandum of the Heads of All Religions has transcended the ambit of usual memoranda which condemn government atrocities, lodge protests or demand relief or compensation.

The memorandum of the Heads of All Religions did not stop with expressing regret, condemnation and describing incidents and losses. Nor did it stop with merely narrating the tragedies and sorrows caused by the atrocities committed on the Tamils by the Government contrary to human The Heads qualities. Religions have effectively and boldly let known the extent to which the political status of the Tamils have been adversely affected by government thuggery.

That memorandum eloquently expresses the State Terrorism let loose by the Government against the Tami-Is for the last so many years.

The Heads of Religions have logically argued that what the Government does to the Tamils is naked State Terrorism. This is a slap in the face of Wijetunge who describes the Tamils' struggles for their rights as terro-

It is nothing but state terrorism that attacks government institutions and govern-

public institutions and the Tamil public. This is comparable to an act of abdicating the Government's administrative responsibilities in Tamil areas.

This is patently and effectively underlined in the memorandum of the Heads of All Religions. They have boldly asserted the fact that the Sri Lankan government has lost its moral responsibility to rule the Tamils.

When people are oppressed, it is the duty of Religious Heads to unite and boldly proclaim on behalf of the people the truth to ring in every ear. It is felt that the Religious Heads have correctly discharged that duty this time.

This memorandum is not solely for Wijetunge. Copies of this memorandum should be immediately sent to world leaders, world organisations, world religious bodies, world press and other world mass -

It is then and then only that the world can be made to appreciate the struggles the Tamils are engaged in, are not acts of terrorisation but are struggles for their rights and that the Sri Lankan government has lost its right to rule the Tamils in as much as it unleashes terrorism against and on the Tamils.

The Colombo government is destroying the Tamils by terrorism. Therefore it is clear that it regards the Tamil territories as a different country. Therefore it is necessary to enlighten international opinion that the Tamils must be granted their right to rule their country.

# LTTE drives back Sri Lankan Army

The LTFE opened fire on Sri Lankan Army that tried to move towards Verugal- Mukathuwaram area in the Trincomalee District, in order to disturb the Heroes' week celebrations that were organised in that area. The Sri Lankan Army retreated after 45 minutes of gun battle.

The news in this connection from Trincomalee said that on Sunday, November 21, Sri Lankan Army encamped at Verugal, Eechilampaththai and the 49th mile

post left their camps and proceeded towards Muttichenai and Valaithottam.

The Verugal Mukathuwaram area was decorated to commemorate the Heroes' Week. Had the Army moved into this area it would have disturbed the commemoration programmes.

At Muttichenai Bridge LTTE opened fire on the moving Sri Lankan Army at 9.40 a.m. The battle lasted for about 45 minutes at the end of which the Sri Lankan Army retreated to Muttichenai.

# PATIENTS WELFARE SOCIETY CONDEMNS HOSPITALS' BOMBING

In a letter to the President, the Patients' Welfare Society has condemned the reckless bombing of hospitals. The text of the letter is as follows:-

Patients' Welfare Society condemns in unequivocal terms the wanton and reckless destruction caused by the random bombing in rapid succession by "Supersonic planes" in the area just in front of the main entrance to the Jaffna Teaching Hospital within the safety zone of the International Committee of the Red Cross on 13th Nov. 1993, the "festival of light" (Deepavali - the Holyday of-Tamils).

A young boy aged 7, Parameswaran Prasad and Aseerwatham Jesurajah (30) suffered injuries. One of Jesurajah's hands was severed. Both are admitted to the Jaffna Hospital.

Two Sri Lankan Air Force bombers carried out an aerial attack in Puthukudiyirupu area at 11.35 a.m. These two planes bombed Iranaippalai area twice. Three persons were injured including a female child. The injured were admitted to the hospital for treatment. Many coconut palms were damaged.
