## THE NORTHERN PROVINCE IN 1902

The Administration Report of Mr. R. W. Ievers. Government Agent, for the year 1902 affords; as usual, much interesting reading. As regards the condition of the Province, Mr. Ievers says that "there was neither epidemic nor scarcity of food, and the general health of the people and cattle was good; much money was introduced by the railway works, and wages ruled higher than in previous years."

The revenue returns show an increase of Rs 293 in the gross revenue collected in 1902 compared with the revenue collected in 1901.

The Increase was chiefly in sugar (import), arrack, salt, ferry tolls, revenue stamps, District Court fines, Government Agent's fines, judicial stamps, survey fees, recoveries on irrigation works, Police rates, fees for title deeds, postage stamps, Government Railways, rent of Government buildings, interest, unclaimed de posits, firewood, and land sales. There was a decrease in grain (import) cotton, manufactured spirits, exports of chanks, elephants, port dues, road tolls, bridge tolls, Police Court fines, warehouse rent.

As to weather, crops, and food supply Mr. Ievers writes as follows:-

WEATHER. The rainfall registered in the Jaffna district was 47.46 inches, while that registered for 1901 was 40.11 inches. The total rainfall registered in the Mannar and Mullaitivn Districts were respectively 55.21 and 81.55 inches.

The grain crops of the Jaffna District for the year 1902-03 were satisfactory, and would have been more so had the rain fallen earlier during the sowing season in Jaffna. In the Mullaitivu District the yield was very good. Food Sopply.

According to the headmen's reports the outtnrn of the paddy crop of the Province was estimated at 956,993 bushels of paddy, which would produce 478,496 bushels of rice; the "varagu" crops amounted to 10,738 bushels, and the other dry grains yielded about 66,367 bushels, making in all 1,034, 098 bushels local crop:-

Taking the usual estimate of two bushels of paddy to one of rice, these figures show a quantity of 1,323282 bushels of rice. This does not, however, include the balance of rice in stock at the end of the preceding year, nor does it exclude the balance at the end of the year under review.

To this should be added Kurakkan, paddy, gingelly, &c., brought from the Vanni and the North-

Central Province by land, and whose quantity is unascertainable.

The yield of cocoanuts was good, and the demand for them was great.

The supply of garden produce, vegetables, fish, turtles, &c., was satisfactory. There has been a continuous rise in the price of vegetables, fowls, and eggs for some years past, ch.efly owing to the larga export of these articles to Colombo and other places.

The yield of the palmirah produce was not so good as in the preceding year. The demand, however, is

A regards the health of the people and Sanitation we extract from the report as follows:

HEALTH OF PEOPLE.

Fever, which generally prevails during the latter part of the year, was less virulent than in previous

There were two cases of smallpox, one in Jaffna and the other in Kankesauturai; both were treated successfully.

In January there were 29 persons remaining at Kayts suffering from cholera, which had broken out in December, 1901, of whom 5 recovered, and 24 died. Since then there were no cases of cholera during the year.

SANITATION.

The Sanitation of the town of Jaffna is maintained by the sanitary officer and coolies under him at an expenditure of Rs. 4,000 granted by Government for the purpose. The usual sanitary measures were carried out with special precaution at the places of pilgrimage. The measures required by the Plague Committee were continued throughout the Province. Rats were destroyed in Jaffna to the number of 3,348 in 1900, 6,305 in 1901, and 11,830 in 1902; total, 21,473.

The towns of Point Pedro and Valvettiturai, Mannar, and Mullaittivu were brought under the Small Towns Sanitary Ordinance. Scavenging was carried on to a limited extent. The moneys collected were accumulated until sufficient funds exist for the erection and maintenance of permanent latrines and for providing an adequate scavenging staff.

The sanitation of villages was enforced through headmen, and as a result villages are generally clean, excepting the fishing villages. There were several complaints made to me by the villagers that their dwelling compounds were flooded during the heavy rains, and steps were immediately taken to drain the water off as far as possible, but in many cases it was not possible.

The water supply of the villages was satisfactory. It is solely derived from wells. I am glad to say that the project for the water supply to the town of Jaffna, which has been long under consideration, had so advanced that arrangement was made for preparation of estimate and fixing of the sites of the reservoirs early in 1903.

## LOCAL & GENERAL

Dr. Rockwood-The Hon Mr. Dr. Rockwood who was in our midst for a few days left this for Colombo on the 15th Instant.

A boy saved from being run over by train-On the 18th Instant when a passenger train was coming near Kockuvil the Engine Driver saw a boy standing in the line without moving. He tried to stop the train but as the distance was too short he was not able to do so until it touched the boy and hurt him a little. He was taken in the train and brought to the Jaffna Station.

Suicide-A Pariah man of Chunnagam who was trading in cloth at Pt. Pedro drowned himself a few days ago in the Nilavery well at Navakeeri. He is said to have been largely involved in debt.

Obituary-We regret to chronicle the death of Mr A. Ponnampalam which took place at his residence at Vannarponnai East on the 17th Instant. He was the eldest son of late Mr. Arumugam who was well-known as a big cigar trader. We tender our heartfelt sympathy to the bereaved widow and others who bemoan his loss.

Cotton growing in Ceylon-An experiment at cotton growing is likely to be made near Anuradhapura. Preparations are being made to plant 25 acres of land with cotton before the North-East monsoon commences. A European or an American Superintendent with two Indian Kanganies of Indian cotton experience is to be appointed. One Mr. Willis has gone to India to get a further supply of good seed and to study some of the conditions under which Indian cotton is being grown.

Wireless Telegraphy-A Draft Ordinance is published in the Government Gazette providing that no one should use wireless telegraphy in Ceylon without Government licence and that a fine of Rs 50-00 will be inflicted on any one contravencing this ordinance.

Inspector-General of Police-Major De Wilton, Inspector General of Police, was here a few days ago on inspection duty.

Jaffna Kachcheri-We hear that Mr. Claaz of the Jaffna Kachcheri has sent in his papers for retirement.

Damage by Fire-A mill in the city of Bombay was struck by lightening during a storm that blew there on the morning of the 16th Instant and caught fire. Several Machines and a large quantity of cotton were destroyed. The damage is estimated at three lakhs of rupees.

A foot ball Match-An interesting foot ball match played on the Jaffna ex-planade on Thursday the 17th Instant between the Central College and the Winners Team ended in a win for the latter by 4 goals to one- Well done Winners Team.

COLOMBO.

The Northern Railway and Buddhist Riot-H. E. the Governor has arranged, it is said, to give all facilities to the Buddhist priests when travelling in the railway, and if possible to reserve a special compartment for them.

A Most Shocking Death-The sad and untimely death of Miss Elsie Peries the only daughter of Mr. Charles Peries well-known in connection with the Peries Will case threw the whole of Colombo into mourning on Friday last. She was only fifteen years old at the time of her death and was perhaps the richest heiress in Ceyton. It appears that her death was predicted by Mrs. North a famous Pal-

mist while in Colombo a couple of years ago.

A Patriot Priest is no more—We regret to chronicle the death of Rev. Korrothodda Sobitha a wellknown Buddhist priest of Colombo.
Though he had certain failings in as much as he did not much care to regulate his conduct in all respects in conformity with the strict rules laid down by Buddha for the clergy, still his love for his country was undoubtedly very great. He had many friends among Europeans and Burghers and

took a leading part in all Buddhist undertakings. The last public appearance of his was in the recent Buddhist Congress where he proposed the resolution asking the Government to give a reserved compartment for the Buddnist priests when travelling in the Ceylon Government Railway. But unfortunately about a week before the concession was granted he fell into the cruel hands of death. It may be added that his benefactions were extended even to many a Tamil. The deceased must have visited Jaffna in the early sixties. He possessed a good knowledge of Tamil, and could sing Devaram to its proper tune. In him the poor and the helpless Sinhalese have lost a great benefactor.

The Smallest Pension-The smallest pension extant is believed to be that paid to an old sailor in Portsmouth Workhouse. It comes to four pence a year, paid quarterly. Each quarter therefore, he duly receives a penny stamp wherewith is enclosed a stamped envelope for the receipt. He is then granted leave of absence to convert his little Eldorado

into cash.

An Ingenious Lawyer-A gentleman dying left all his estates to a religious Association on condition that on the return of his only son who was then abroad the worthy recluses should give him whatever "they should choose." When the son came here he went to the Association rooms and received but a small share, the wise recluses choosing to keep the greatest part for themselves. The young man consulted his friends, and all agreed that there was no remedy. At last a Barrister, to whom he h uppened to mention the case, advised him to sue the Association and promised to gain his case. The gentleman followed this advice, and the suit ter-minated in his favour through the adroitness of the Advocate who grounded his plea upon this reason-

NORTHERN RAILWAY. Progress Report for Half-year ending 30th June, 1903.

THE CHIEF RESIDENT ENGINEER, Northern and Uds Pussellawa Railways, to the Hon. the Col NIAL SECRETARY. Railway Extension Office,

Kandy, August 26, 1903. SIR-I HAVE the honour to submit the following report upon the progress made with the work on the Northern Railway up to 30th June

2. With this report the following papers are forwarded:-

Seven certificates showing quantities of work done, marked A, B, C, D, E, F, G. Copy of report by Mr. Kindersley, Chief

Assistant Engineer, masked H. Classified statement of expenditure, mark-

ed I.

Statement showing for each item in the classification the estimated cost, the amount expended, and the value of the work done, marked J. The value of the work done is obtaind by multiplying the quantities of work done by the respective rates of the es-

3. The total expenditure at the end of last Junn was Rs 7,885,276 (this includes Rs 183,076 for extraneous charges); of this, Rs 3,455,411 was lucal expenditure, and Rs 4,429,865 was expended in England by the Crown Agents for the Colonies for permanent way, bridge, and other material. The total expenditure to date is 71 per cent. of the estimate. During the last half-year the oxpenditure has been #s 1,150,842-Rs 634,191 in Ceylon and Ra 516,651 in England.

4. Under the different heads shown in the classification of expenditure, what has been done up to the end of last June will be briefly re-

ferred to.

SCHEDULE Nr. 1.

5. A. Felling Trees and Clearing Land-This

work is now nearly all done.

6. B, Earthwork .- The total quantity of earth work done to date is 1,754,725 cubic yards; 133, (195 of rock and 1,621,630 of earth. The scheduled quantity for the whole line is 1,636,343 cubic yards. It is probable that when the line is finished the total quantity of earthwork will exceed the scheduled quantity by 30 per cent.; the reasons for this, v.z., deviations of the line, the raising of formation in many places to keep embankments above flood level, and the considerable washaways which have occurred in banks made of sandy material have been given in previous reports.

7. The earthwork done during the last halfyear is 416,694 cubic yards; 42,864 of rock and 373, 830 of earth. This is the largest quantity

of earthwork done during a half-year since the work was begun.

8. C, Bridges .- Nearly all the principal bridges are now finished or in hand. Of 103 bridges to be built, varying in length from 15 feet to 300 feet, 70 are finished or are well advanced. There are four large bridges now in progress, the Mi-oya, two spans 120 feet and one 60 feet, at 37 miles 57 chains; the Siyambala-oya, one span 100 feet, at 47 miles 55 chains; the Kala-oya two spans each 150 feet, at 48 miles 57 chains; and the Malwatta-oys, three spans of 100 feet, at 67 miles 32 chains. The masonry of the Mi-oya bridge in one bier and two abutments, all founded on wells, is nearly finished, and the girders are rivetted up. At the Siyambala-oya bridge the masonry is finished and and girders are revetted up. At the Kala-oya bridge the masonry is finished, the wrought-iron cylinder piers are being erected, and the staging for the erection of the girders is ready. At the Malwatta-oya bridge the masonry is nearly done.

9. The amount expended upon work in bridges is considerably more than the value of work done according to the estimate rates. This is due to the heavy expenditure in bad foundations, to the cost of transport of stone, cement and in some cases, of water, and to the necessity of doing some of the work in the unbealthiest places by day labour.

10. The quantity of concrete and masonry in bridges done to date is 10,486 cubic yards; of this, 2,400 cubic yards have been done dur-

ing the half-year.

11. D, Culverts-The culverts are practically finished on about 120 miles of the 200 miles of the Northern Railway. The quantity of concrete and masonry done to date is 11,601 cubic yards; of this 1.839 cubic yards were built during the last half-year. Masons are still difficult to get at the northern end of the line, and suitable stone is also scerce; consequently, the culverts and bridges on the part of the railway are being built of cement concrete.

12. On the whole line the number of culver's will probably be about 620; there are now 374 finished or in hand. Most of the bridges and culverts are built after the rails have reached their sites, in order that material may be trans-

ported as economically as possible.

13. E, Permanent way—At the end of June last the rails were linked in at the Southern end up to 49 miles from Kurunegals, and at the northern end to 57 miles from Kankesenturai. In addition to these lengths there are 51 miles of eidings laid in. The total length is 1111 miles; of this, a length equal to 80 miles was ballasted and finished. The progress of the work in permanent way has been interfered with at both ends of the line during the half-year: at the southern by some heavy cuttings on the Kala-oya deviation, and by having to wait for the erection of temporary bridges over the Siyambala-oya and Kala-oya, two important rivers; and at the northern end by the earthwork.

14. I have in previous reports referred to the scarcity of suitable material for ballast. I am now glad to be able to report that a little to the south of Parantan a large quantity of good gravel has been found which will be sufficient for some miles of road. At the southern end the stone crusher, which was mentioned in my last report, is now working and supplying good ballast; this ballast will, how-

ever, be somewhat expensive.

15. F, Switches and Crossings.-The switches ings are put in at all stations on the mileage given above of permanent way lin-

16. G, Fencing,-No fencing has been erect-

ed during the last half-year.

17. H, Level Crossings; 1, Metalling Roads.-Very little work remains to be done under these headings. The bulk of the work scheduled was in the Jaffna peninsula.

18. J, Stations.—There is not much work remaining to be done at the stations. The larger and most of the smaller ones are completed. The principal work still to be done is at Galgamuwa, Talawa, Madawachchi, Mankulam, and Parantan -all small stations.

19. K. Miscellaneous Works.-These are the residences and cooly lines for the maintenance staff of the Way and Works Department. A little more than half of this work is now done.

20. General Charges on Construction Work .-This expenditure is for superintendence, which would have been borne by the contractors if the line had been made by contract, for cooly lines, temporary quarters, &c., and will be charged to the different items in Schedule No. 1.

21. General Stores .- This amount is the value of plant on the work and stores not yet charged

for or issued from store.

22. Medical Expenses. This expenditure is for hospital and dispensary charges and the salaries of medical officers and apothecaries.

SCHEDULE No. 2.

23. M, Electric Telegraph.—No work has been done to the telegraph during the last half-year. 24. N. Land and Compensation.-There has been a small expenditure under this head, Rs

25. O, Engineering and Administration.-The amount expended during the half-year was Rs 46,341. Now that the staff is being reduced this

expenditure will decrease.

26. P, Pa, Pb, Pc, Pd., Steel and Cast Iron in Bridge and Culvert Superstructure, Cylinders, &c.-The steel and iron work for bridges and culverts for 175 miles have arrived in the Colony and have been partly paid for.

27. Q, R, S, T, Permanent Way Material .-The permanent way material received in the Co-

lony is also sufficient for 175 miles.

28. U, Rolling stock .- The sum expended during the half-year ou rolling stock, Rs 134,840, is principally expenditure through the Grown Agents.

29. Extraneous Charges-These are the cost of works charged to Northern Railway funds but which were not excluded in the estimate, such as the extension of the carriage shop at Colombo station, the survey and construction of feeder roads to stations, &c.

General Remarks-The local expenditure for each half-year from the 1st July, 1900, is as

31. The progress in earthwork during the half year has been good, and there is now nothing to stop the permanent way between the Kala-oya and the Malwatta-oya, near Angradhapura, and after a temporary bridge over that river has been erected the rails can be laid on to 80 miles from Kurunegala, where the Kanadara-oya has to be crossed.

32. I regret to have again to report that there has been a great deal of sickness amongst the staff and work-people. All the Engineers and Foremen have suffered more or lees, and of course work has been consequent-

ly delayed. Bridge Foreman Cann, who had done good work since he came to the Colony in 1901, becam so ill in June that he was ordered to return to England by his doctor.

33. The following Assistant Engineers have left the Department during the half-year -Mr. A. O. Edwards, Mr. D. K. MacMinu, Mr. N. de C. Walker and Mr. J. N. Tew.

34. It gives me much pleasure to be able to report in very favourable terms of the manner in which the work has been supervised and carried out by the members of the staff. both on the works and in my office.

Report by Mr. A. E. Kindersely, Chief Assistant Engineer.

Miles 63-140, Talawa-Kokkavil. 1. Felling Trees and Clearing land-The whole of this work is completed with the exception of about 5 miles on the Mankulam section.

2. Earthwork-The progress in earthwork has been satisfactory on the Talawa, Anuradhapura and Madawachchiya sections, ie., miles 52-63, 63-79 and 79-91, respectively, while but little remains to be done on the Vavuniya section, miles 91 to 109, the bulk of the work having been completed in the former half-

The Kanakarayankulam section, miles 109-123, is especially backward, though an improvement has been made in progress in the last three months, and as the Vavuniya work flaishes labour is drafted on this section.

There is still a good deal to be done on the Mankulam section, but progress thereon is steadily made.

3. Bridges and Culverts-Progress on these works have been slow. On the Anuradhapura section there are five bridges to be put in hand the largest being a single span of forty feet, while numerous culverts, mostly of 1 foot 10 inches open type, have also to be built.

No. 2 pier of the bridge over the Maiwattaoya, consisting of three spans of 100 feet, gave great trouble. Before any concrete could be put in last year the foundation was flooded out

and was filled up with silt. It was not until the 18th April that the water could be got down in the foundation sufficiently to begin reexcavating. On 1st May the foundation was again flooded out, and rainy weather continuing till 18th May good progress in excavation could not be made, and excavation to the original depth was not completed till 3 th May, when it was found that a good deal more excavation was required owing to the rotten nature of the rock at the west end. Concreting was begun at one end on 2nd June, but the final excavation was not completed till 14th June.

On 30th June the concrete had been brought up to within 2 feet 6 inches of the water level in the river, and the heavy flow of water and quicksand had been largely stopped.

The pumps were constantly breaking down during the whole time, which caused the progress to be slow.

On the Madawachchiya section a commencement only has been made, as this section was practically only taken up after the beginning of the year.

There are three bridges only on this section of 20 feet, 120 feet and 40 feet spans, and they are all situated within a short distance of each other in the valley of the Kanadara-oya which has the span of 120 feet. They will all entail a considerable amount of work, being in high banks. Every effort will be made to get these well in hand before the rains.

On the Vavuniya section the bridges are more numerous, and generally of larger spans than prevail on the other sections referred to. There is much to be done still on this section both in the bridges and culverts, though in the cases of the culverts remaining to be done a great number of them are pipe culverts, for which all the pipes are ready.

On the Kanakarayankulam section practically nothing has been done, owing to the lack of quarries and the lack of labour. There are

no bridges on this section.

On the Mankulam section a commencement has been made with some calverts, and the bridges will shortly be put in hand, of which there are four, two of 20 feet and two of 15 feet spans.

4. Ballast-A small quantity of sand ballast has been collected at Anuradhapura, and when the earthwork is complete the labour will be employed in stacking ballast where

procurable. 5. Permanent Way-The linking in has not yet got as far as mile 63 from the south end or mile 140 from the north end, rail head at the south end being about 14 miles distant and at the north-end about 5 miles distant.

6. Buildings and residences-With the ex ception of permanent way cooly lines, all reeidences and station buildings are well in hand or complete, except those at Madawachchiya and Mankulam stations .- At Madawachchiya the station building is up to floor level. and the outhouses are well forward. At Mankulam the foundations of the station building are in progress.

The engine shed at Vavaniya is almost complete as regards the masonry, and the

turntable is in progress.

The goods sheds at Anuradbapura and Vavuniya are complete, also the horse and carriage docks and platforms, and earth closet and urinals, except the slates of the latter.

7. Station Appliances-The weigh bridges, tanks, water columns, &..., can only be put in hand when rail head reaches the various sta-

8. Approach Road-The formation of the passenger and goods approach roads at Anuradhapura, Vavuniya, and Mankulam stations is in hand.

Fencing-The palisade fencing at Vavuniya has been erected.

10. General-Progress in general has been fairly good considering the difficulties encountered. Local skilled labour, such as masous, &c., is almost non-existent, and the further from railhead the greater the difficulty in get ting such labour.

The Government Agent of the North-Jentral Province has shown great interest in the work, and through his influence a good deal of earthwork has been done that would otherwise be still incomplete.
