

Written primarily as a tribute to Professor Ashley Halpe, the essays reflect the academic rigor and imaginative depth that Halpe himself insisted on as a teacher and scholar.

8. AUTONOMY & ETHNICITY: NEGOTIATING COMPETING CLAIMS IN MULTI - ETHNIC STATES. Edited by Yash Ghai. Cambridge, Cambridge University Press, 2000. 312p.

This book deals with one of the most urgent problems of contemporary times: the political organisation of multi-ethnic states. Most major conflicts of our time are internal to the state and revolve around the claims of access to or the redesign of the state. Responses to ethnic cleansing to accommodations of ethnic claims through affirmative policies, special forms of representation, power sharing and the integration of minorities. One of the most sought after, and resisted, devices for conflict management is autonomy.

9. CAPACITY-BUILDING IN CONFLICT ZONES: A FEMINIST ANALYSIS OF HUMANITARIAN ASSISTANCE IN SRI LANKA, by Malathi de Alwis and Jennifer Hyndman. Colombo, ICES, 2002. 64p. C. Rs. 200.00; US \$ 15.00

This report seeks to advance, both in theory and practice, the delivery of humanitarian assistance in Sri Lanka while simultaneously analyzing the links between gender, conflict and displacement. The report focuses on "capacity building" conducted by international NGOs and UN agencies to build and sustain institutional capacity among local/national organizations in Sri Lanka. It specifically assesses the existing resources and potential for

institutional capacity building in three areas; the prevention of violence against women and support for those affected; the provision of facilities and information on women's health issues; and the promotion of income security options which serve to stabilize household economies.

Mervyn de Silva became one of few, sober voices of sanity in a country gone mad with hatred and violence. His death, a month before Dr. Neelan Tiruchelvam's assassination and a year after Charles Abeyesekere's death, left Sri Lanka bereft of a towering intellectual personality whose ideas wielded influence and whose writings could guide the political leadership in new directions. Many people will miss Mervyn de Silva in the corridors of power and in the press briefings, asking the unaskable questions and providing a coherent analysis of our turbulent political reality. This volume is an attempt to keep his voice alive so that the next generation will have the benefit of his analysis.

They make fascinating reading as they give an insight into the numerically minor, yet vibrant communities of this country which go to make Sri Lanka truly cosmopolitan in nature.

Comprising four substantial essays, this book provides insights into the nature and dimensions of the confrontation between ethnic minorities and dominant majorities in Nepal, Sri Lanka, India and Malaysia.

'Fifteen' is, as the title implies, a debut collection of fifteen short stories. The stories make an impact because of the writer's skill in depicting women's responses to male chauvinism. Women suffer in these stories but hit back too, often in self-destructive ways.

The last ten years there have been considerable efforts to look at comparative analysis of the different peace processes and the international armed conflicts in Latin America. The effects of violence have been devastating as it has corroded every cornerstone for a possible implementation of nation-building processes based on democratic values; furthermore, the proliferation of small weapons continues to be alarming in several countries. This publication attempts to collect some materials elaborated in Latin America particularly Peru and Colombia, in order to disseminate them among researchers and students, Government officials and NGOs, in order to generate discussion and new approaches regarding the present situation in Sri Lanka.

28. GENDERING HUMANITARIANISM: AN ANNOTATED BIBLIOGRAPHY ON GENDER AND CAPACITY BUILDING IN ARMED CONFLICT. Compiled by Bhawani Loganathan, with a foreword by Malathi de Alwis and Jennifer Hyndman. Colombo, ICES, 2001. 210p. C. Rs. 200.00; U.S \$15.00

This is a compilation of resources on gender-based humanitarian assistance, to women affected by armed conflict. Special reference is made to the situation in Sri Lanka – internally displaced women, women refugees, women from 'border villages' and the 'war widows'. The bibliography also has a chapter on women involved in conflict resolution and peace-making efforts.

29. GENDERING THE TSUNAMI: WOMEN'S EXPERIENCES FROM SRI LANKA. by Neloufer de Mel & Kanchana N. Ruwanpura. Colombo, ICES, 2006. 56p. Rs.250.00; US \$ 7.50

This report focuses on how the tsunami affected Sri Lankan woman in particular. Studying the affected areas and people of the south coast of Hikkaduwa and the eastern coast of Batticaloa, the report presents analysis and the views of Sri Lankan women on their experiences, regaining livelihoods, aid distribution, service delivery relocation and strategies of coping and survival.

30. GLOBALIZATION AND THE TRANSFORMATION OF PLANETARY RITUALS IN SOUTHERN SRI LANKA, by A. Premakumara de Silva. Colombo, ICES, 2000. 122p. C. Rs.275.00; US \$15.00

This provocative work is a study of religious change in southern Sri Lanka, concentrating on ideas and rituals

surrounding astrology, specifically focusing on the popular ritual known as the Baliya.

To commemorate Anne Ranasinghe's 50 years in Sri Lanka, 50 writers from here and abroad have contributed texts to this volume. All the texts, except a few, are original unpublished writings specially produced for Anne.

34. IDENTITY CULTURE AND POLITICS: AN AFRO ASIAN DIALOGUE. (Vol,2, No.1, 2001) Editors: Imtiaz Ahmed and Ousmane Kane Dhaka. ICES & CODESRIA, 2000. 104p. C. Rs.200.00; US \$ 15.00

A biannual publication. It aims at dissemination of knowledge and exchange of ideas and projections amongst African and Asian scholars and activists.

35. IDEOLOGY AND THE CONSTITUTION: ESSAYS ON CONSTITUTIONAL JURISPRUDENCE, by Radhika Coomaraswamy. Colombo, ICES, 1996. 178p. C. Rs.350.00; US \$ 20.00

The collection of essays on Constitutional Jurisprudence is an attempt to understand the process of constitutional decision- making and political action from a framework of human rights, democracy and social justice.

36. THE INDIAN INTERVENTION IN SRI LANKA, 1987-1990: THE NORTH-EAST PROVINCIAL COUNCIL AND DEVOLUTION OF POWER, by Dayan Jayatilleka. Kandy, ICES, 1999. 79p.

The monograph reveals hitherto unknown aspects of Indo-Sri Lanka relations in the establishment and functioning of the North-East Provincial Council.

37. THE INSTITUTIONS OF ANCIENT CEYLON FROM INSCRIPTIONS, (Volume I) by Lakshman S. Perera. Kandy, ICES, 2001. 322p.
K. Rs.1, 600.00; US \$ 30.00

This massive dissertation, an exhaustive study of the gradual evolution of the Island's institutions (political economic and religious) beginning from the 3rd Century BC to 1016 AD, i.e., the Anuradhapura period of Sri Lanka history, is an exceptionally important work.

38. THE INSTITUTIONS OF ANCIENT CEYLON FROM INSCRIPTIONS. (Volume II Part I) by Lakshman S. Perera. Kandy, ICES, 2001. 408p. K. Rs.1, 600.00; US \$ 30.00

This is the middle volume of Dr.Lakshman Perera's three volume treatise on the institutions of Ancient Sri Lanka based on a comprehensive study of inscriptions.

39. THE INSTITUTIONS OF ANCIENT CEYLON FROM INSCRIPTIONS, (Volume II Part II) by Lakshman S. Perera. Kandy, ICES, 2001. 408p. K. Rs.1, 950.00; US. \$ 30.00

This three volume work is an exhaustive study of the island's institutions (Political, Economic and Religious) beginning from the 3rd century BC to 1016 AD, i.e., the Anuradhapura period of Sri Lankan history.

40. INTERROGATING THE NORMS: WOMEN CHALLENGING VIOLENCE IN AN ADVERSARIAL STATE, by Farida Shaheed. Colombo, ICES, 2007. 145p. C. Rs.300.00; US \$ 10.00

While the political ambience of the Zia years in Pakistan impacted on the civil freedoms of citizens in general, it had a more direct impact on women and minorities and consequently on the working dynamics of the women's movement which set it apart from concurrent movements in South Asia. The three chapters in this book have been shaped by this context. Chapter one is based largely on a narrative account of the Zia government, chapter two, which is more sharply focussed on the history of the women's movement and chapter three speaks about different women's organisations.

41. LIVING WITH TORTURERS AND OTHER ESSAYS OF INTERVENTION: SRI LANKAN SOCIETY, CULTURE AND POLITICS IN PERSPECTIVE, by Sasanka Perera. Colombo, ICES, 1995. 89p.

All essays in this collection deal with some aspect of Sri Lankan culture, politics and society. The essays are brief, the language is economical and eminently simple and as the writer professes to, he vividly raises "some basic issue rather than provide comprehensive answers or solutions."

MIDDLE OF SILENCE, by Ruwanthi De Chickera. Colombo, ICES, 2001. 75p.

'Middle of Silence' was awarded the British Council International New Playwriting award For South Asia in 1997, and the Gratiaen award for the best English creative writing in Sri Lanka in the Year 2002.

43. MILITARIZING SRI LANKA: POPULAR CULTURE, MEMORY & NARRATIVE IN THE ARMED CONFLICT, Neloufer de Mel. New Delhi, Sage, 2007. 329p. C. Rs.1000.00; US \$ 20.00

A study of the militarization that has buttressed the war between the Sri Lankan state and the LTTE for over two decades. It highlights militarization as a process through which the ideology of militarism is shaped and shared in a manner that makes militant solutions to conflict a part of institutional structures and ways of thought.

44. MINORITY PROTECTION IN SOUTH ASIA, by Amena Moshin. Colombo, ICES, 2003. 436p. Rs.700.00 US \$ 15.00

This makes an attempt to present to the reader information on the state of minorities through country-specific papers on minority protection and national standards in Bangladesh, India, Nepal, Pakistan and Sri Lanka.

45. MISTAKING POLITICS FOR GOVERNANCE: THE POLITICS OF INTERIM ARRANGEMENTS IN SRI LANKA 2002-2005, by Charan Rainford and Ambika Satkunanathan, Colombo, ICES, 2008,198p. C. Rs. 350.00, US \$

This book examines the origins, structures and outcomes of interim arrangements, proposed and implemented in Sri Lanka between 2002 and 2005. The use of interim arrangements as a means to guide a peace process towards a final settlement has become an accepted strategy in peace processes following its employment in the Israel-Palestine conflict.

The garden's healing & sustainability is rooted in continuous interpersonal and intrapersonal story making through forms of artistic expression in clay, paint, sculpture, song, poetry, dance, and theatre springing from the imagination of children in eastern Sri Lanka.

"Paradise Poisoned" draws crucial lessons from Sri Lanka's civil wars to demonstrate that violent conflict and terrorism are both predictable and preventable. 51. This volume addresses the need to understand both the indepth reality of each particular conflict site – Sri Lanka, the Philippines, Japan, Ireland, Yugoslavia, South Africa, the Indian subcontinent – and also the experience of women peace-workers across these different sites in a comparative perspective.

52. THE PEOPLE IN - BETWEEN: INTER - ETHNIC RELATIONS AMONG INTERNALLY DISPLACED PEOPLE TRINCOMALEE DISTRICT, SRI LANKA, by Jessica Skinner. Colombo, ICES, 2005, 89p. C. Rs.200.00; US \$ 7.50

This book looks at the relationship between ethnicity, (dis)placement from the co-existence in the context of the Sri Lankan conflict.
