

# Message from the Dresident Silver Jubilee Year The Jaffna Cricket Umpires' Association MR. Z. SINGARAYER J. P.



It gives me the greatest pleasure as the President of the J. C. U. A. to give this message on the occasion of its Silver Jubilee. I am sure all lovers of Cricket will rejoice at this achievement of the Umpires' Association. Cricket has now become as popular a sport as Soccer in Jaffna. Judging from the crowds at various matches, especially the big ones (which at times have drawn unprecedentedly mammoth crowds) it is obvious that it has been the Jaffna man's 'Raison d'etre' for the continuance of the 'Gentlemen's Game' It is therefore my firm belief that the future of this great g me despitie prohibitive costs, (a game with a touch of elegance about it besides its popularity

as is evident from the incredible interest it evokes the world over chiefly during the test matches) here in this part of the country is very bright indeed.

The. J. C. U. A. was first formed wav back in December 1961 in compliance with a desire expressed by a large number of cricket playing schools to have a uniform, neutral and efficient umpiring at school matches. Earlier, the schools has their own umpires drawn from the members of their own staff or from members of their O. B. A. which led to a number of unpleasant incidents and even ended in fracas. As a founder-member of the Association I would like to take this opportunity to recount some of its activities and achievements. The first president was Dr. A. C. Arulpragasam followed by Dr. E. A. Champion It was these two Presidents who really gave the impetus to the Association which at that time had a very modest membership. If not for the valiant leadership of these two men the Association would have died an early death. They conducted regular week-end classes on the laws of the Game which were very lively and well-attended. Credit for the success of course should go to the energetic secretary Mr. K. Sabaratnam and his successor Mr. A. Shanmuganathan. Seminars too were with representatives of the Cricket Umpires' Association of Colombo being present. Dr A. C. Arulpragasam, Dr. E. A. Champion, Mr. V. D. Jeyaratnasingam and Mr. A. Shanmuganathan was the life wire of this seminar. The laws of the game were explained with meticulous care and studied with the minutest detail. Every doubt and every incident from the experience of umpires on the field were cleared and thrashed out at these meetings, so that umpires went out into the field with confidence.

Tracing the activities of the Association during the past twenty-five years I find that it has been one of scintillating activity. Since its inception the Association has been affiliated to the M. C. C. and is in constant contact with it. The M. C. C. has all its bulletins and circulars regarding new rules or changes in the laws posted to us which in turn are circularized to all cricket playing schools and clubs. In this connection I would like to remember with gratitude the late Mr. P. Thiagarajah one time Prefect of Games of Jaffna Hindu College who designed the Umpires' Crest. Mr. Thiagarajah was a giant in the field of sports and contributed in no small measure to the advancement of cricket and to the uplift of our Association. The J. C. U. A. is certainly grateful to many like him who are no more.


As President I have the fullest cofidence in our Umpires who are fully qualified. Only those who have passed the qualifying examination with a pass mark of 75% are allowed to umpire. Hence, the standard of umpiring is always maintained. Very soon umpires will be graded according to their theoretical and practical knowledge of the game. I am happy that the Jaffna Schools' Cricket Association places a lot of confidence in our umpires and has always acceded to requests for the raising of the Umpires' fees. As we all know cricket is played under the swelling heat of the months of March and April and hence an Umpire's job is an unenviable one. Although the fees are immaterial as most of the umpires do it for the love of the game and its promotion, yet it is nothing but proper that they should be adequately remunerated.

In conclusion may I be permitted to give a few words of advice to Umpires, Coaches, Players and to all Cricket Enthusiasts. It is a paramount factor in the interest of cricket, that everyone should know the laws of the game and their interpretations. Such a knowledge would certainly go a long way not only to enjoy the game but also in avoiding a lot of misunderstanding and heartburns when certain decisions are made by umpires thus eliminating many an ugly scene. To make this possible the association is prepared to help the schools in conducting classes to which I suggest even the public be invited. In the alternative the coaches and masters could attend the classes conducted by our association for our umpires.

It is my earnest desire that all those connected with cricket should take an active part in the activities of our association and thus foster this men and make it flourish so that posterity may benefit. May the Jaffna of cricket Umpires' grow from strength to strength and serve all lovers of





An Umpire is a man, throughout the year devotes his leisure time to enabling twenty two other men to enjoy themselves.

He is a man who on the hottest dry day becomes a human clothes stand, and on a cold rainy day thankfully moves from square leg to straigh behind the wicket in order to keep his circulation going

He is a man who knows from the time he walks out on to the field of play that he is sure to displeasure someone, but bravely walks on.

An Umpire endures the scowls and curses of many of those he has dedicated himself to serve, with great self-control.

An Umpire must have thorough understanding of every Law of the game of Cricket and act as jury and judge for both the prosecution and the defence Passing sentence in approximately three seconds

An Umpire has to be an expert in Meteorology, Mathematics, to optics, Time keeping and Drainage.

He has to be impartial and independent, yet friendly to all.

An Umpire is unobtrusive, yet at the same time, all-important in our game.

An Umpire is in fact a man without whom the game of Cricket would find it most difficult to survive.

Among the many varieties of adjudicator with which this world is ucrsed, and who, in their different capacities control our every move, you'll

find that the much-maligned impartial champion of fair play, that unobtrusive all-perceptive incorruptible creature-the Cricket Umpire.

Umpires are found whenever cricket is played, discussed or listened to; measuring creases, haranguing grounds nen, Lost in Law Books, snoozing off at square, huddled arround transistors, and-since the advent of closing. in the nearest pub after the game.

Umpires have very restricted vocabularies; "Play", "Over", "Wide", "No Ball", "Dead Ball", "One short "Not out", Middle and Leg", "Two to come", "Left arm over", "Take that bowler off forthwith", "Time gentlemen' and "I am sorry, I cannot give a decision in your favour when you run in front of me like that".

An Umpire may be A-Class Test material, respected by those who know the Laws; abused by those who don't and always fair game to the gentlemen of the press; he may be a Z-grade Number.

Ten batsmen filling in time until his turn comes to take strike hands in pocket, hoping that a few judicious LBW"s might relieve his silent boredom. An Umpire might be a veritable acrobat in motion always in position for that sharp return, always positioned to answer that imploring or Demanding appeal. Or-he may be a lathargic, semicrippled old codger blessed with vivid memories of Umpiring glories past, and ever willing to disclaim-usually over a pint of bitter-that the standard of Umpiring today isn't what it used to be. Or-he may be a raw recruit who thinks he knows the lot, until the first ball is lost in a flurry of pad, bat and just dust and might have "got an edge", might have touched the pad might have...... or was it that box of matches in the batsman's hip, pocket?

An Umpire likes plumb LB's, Chanceless centuries, afternoons free from appeals, correctly marked creases, stumps of equal length, seamless balls, players who walk, two right (or Left) handers in together, fine weather, polite groundsmen, sawdust on hand, tea intervals and early finishes. He is not so keen on leg-side catches, crumbling pitches, bowlers who obliterate bowling creases, broken bails, trees overnanging the ground, boundary ditches, Captains who declare foruteen minutes before a tea interval, bowlers who cut up a pitch, teams with five left-handers, hat-tricks with two LBW's, pigeons at long-on, the setting sun, three men behind square, spectators who appeal and bandy stumps.

Captains tolerate him and sometimes chat with him; the press see only his faults, the public urge him to "Get thee to an optician"; small boys ignore him when he orders them away from the sightscreens; other Umpires rely on him and wives fail to understand what he sees in it.

An Umpire needs the patience of a praver-pole aesthetic, the wisdom of a full bench of magistrates, the staying power of a southerly gale, the concentration of a dead man's eye, the hearing of a high-frequency sound detector, the eye sight of a mother-in-law, the discretion of a public servant and the



hide of an anesthetized rhinoceros. Only then will be able to look back without too much self-reproach on a season that has earned him more adverse criticism that Sir Thomas Beecham ever dished out at a rehearsal, more unsighted appeals than obstacles encountered by a seven-nights-a-week sonambulist, and more frustrations than an impotent groom on his wedding night, but, when all is said and done, when he's beginning to wonder if he is really out to be an Umpire, he can turn despair to joy for some unsettled batsman and make a friend for life with those two life giving words-"NOT-OUT".

How much of a player's clothing should an Umpire hold or look after?. We see some officials in a ridiculous situation, weighted down with 3 or4 sweaters adorned around their person (bowler's, fielder's and batsmen's), player's caps stuck in their pockets even being asked to hold a box. On one occasion a batsman even took off his thigh pad and handed it to the Umpire. All this after probably being asked before the game started to look after keys, rings, loose money, box of matches and other miscellaneous valuables. I can just see the reaction of officials in other sports if they were asked to hold participants' clothing.

Whilst one could expect to hold a bowler's sweater while he is bowling, why should we be expected to hold (and especially in hot weather) all these other garments and accourrements? I even had the case of one player coming over to me before "play" was called to start the march and being handed a sweater with the words "would you hold that please Ump.,?" and being asked if he was going to bowl at my end, he replied, "No, but I might want it later on if the weather cools" Needless to say he had the sweater back again in double quick time with a polite request it elsewhere.

Whilst one might hold a sweater discarded by a fielder or batsman during an over, they could quite easily be disposed of in the pavilion when over is called. We have plenty of items of our own that we are required to carry. We are also on the field of play for every minute of the game and to do our job of controlling the game properly within the framework of the Laws (remembering that the Captain run the game) we must be comfortable at all times-but we cannot be if we are encumbered by players' "unwanteds". Whilst there are regulations cancerning players' helmets we really do not need or want legislation on the matter in discussion. Education of the players is the secret. Something along this line must be happening in the first class game. Umpires on the first class list now seems to be a lot less cluttered than they used to be. Let us hope that his (like the antics of many top class players seem to do) can permeate down to all levels of the game.

If no play takes place on the first day of a match or 2 or more days' duration, the above shall apply in accordance with the number of days' play remaining from the actual start of the match.

#### LAW 23. DEAD BALL

- 1. The ball becomes dead, when:
  - a. It is finally settled in the hands of the Wicket-Keeper or the Bowler.
  - b. It reaches or pitches over the boundary.
  - c. A Batsman is out.
  - d. Whether played or not, it lodges in the clothing or equipment of a Batsman or the clothing of an Umpire.
  - e. A Ball lodges in a protective helmet worn by a member of the fielding side.
  - f. A penalty is awarded under Law 20: (Lost Ball) or Law 41.1: (Fielding the Ball).
  - g. The Umpire calls "Over" or "Time".
- 2. Either Umpire shall Call and Signal "Dead Ball", when:
  - a. He intervenes in a case of unfair play.
  - b. A serious injury to a Player or Umpire occurs.
  - c. He is satisfied that, for an adequate reason, the Striker is not ready to receive the ball and makes no attempt to play it.
  - d. The Bowler drops the ball accidentally before delivery, or the ball does not leave his hand for any reason.
  - e. One or both bails fall from the Striker's wicket before he receives delivery.
  - f. He leaves his normal position for consultation.
  - g. He is required to do so under Laws 26.3: (Disallowance of Leg Byes), etc.
- 3. The ball ceases to be dead, when:

The Bowler starts his run up or bowling action.

#### LAW 24. NO BALL

1. Mode of Delivery
The Umpire shall indicate to the Striker whether the Bowler intends to bowl over or round the wicket, overarm or underarm, right — or left — handed. Failure on the part of the Bowler to indicate in advance a change in his mode or delivery is unfair and the Umpire shall call and signal 'No Ball'.

2. Fair delivery - The Arm.

For a delivery to be fair the ball must be bowled not thrown-see Note (a) below. If either Umpire is not entirely satisfied with the absolute fairness of a delivery in this respect he shall call and signal "No Ball" instantly upon delivery.

3. Fair Delivery - The Feet.

The Umpire at the bowler's wicket shall call and signal 'No Ball' if he is not satisfied that in the delivery stride:

- a) the Bowler's back foot has landed within and not touching the return crease or its forward extension, or
- b) some part of the front foot whether grounded or raised was behind the popping crease.
- 4. Bowler throwing at striker's wicket before delivery.

If the Bowler, before delivering the ball, throws it at the Striker's wicket in an attempt to run him out, the Umpire shall call and signal 'No Ball'. See Law 42.12: (Batsman Unfairly Stealing a Run) and Law 38: (Run Out).

5. Bowler attempting to run out non-striker before delivery.

If the Bowler, before delivering the ball, attempts to run out the non-striker, any runs which result shall be allowed and shall be scored as no balls. Such an attempt shall not count as a ball in the over. The Umpire shall not call 'No Ball', See Law 42.12: (Batsman Unfairly Stealing a Run).

6. Infringement of Laws by a wicket-keeper or a fieldsman.

The Umpire shall call and signal 'No Ball' in the event of the Wicket-Keeper infringing Law 40.1; (Position of Wicket.Keeper or a Fieldsman infringing Law 41.2: (Limitation of On-side Fieldsmen) or Law 41.3: (Position of Fieldsmen).

7. Rovoking the Call

An Umpire shall revoke the call 'No Ball' if the ball does not leave the Bowler's hand for any reason. See Law 23.2; (Either Umpire shall call and signal "Dead Ball").

8. Penalty

A penalty of one run for a no ball shall be scored if no runs are made otherwise.

9. Runs from a No Ball



The striker may hit a no ball and whatever runs result shall be added to his score. Runs made otherwise from a No Ball shall be scored no balls.

10. Out from a No Ball (H. H. O. R.)

The Striker shall be out from a 'No Ball' if breaks Law 33: (Handled the Ball) or Law 34: (Hit the Ball Twice) or Law 37: (Obstructing the Field) or either Batsman may be Run Out — Law 38.

11. Batsman given out off a No Ball.

Should a Batsman be given out off a 'No Ball' the penalty for bowling it shall stand unless runs are otherwise scored.

#### LAW 25. WIDE BALL

1. Judging a Wide

If the Bowler bowls the ball so high over or so wide of the wicket that, in the opinion of the Umpire it passes out of the reach of the Striker, standing in a normal guard position, the Umpire shall call and signal "Wide Ball" as soon as it has passed the line of the Striker's wicket.

The Umpire shall not adjudge a ball as being a wide if:

- a) The Striker, by moving from his guard position, causes the ball to pass out of his reach.
- b) The Striker moves and thus brings the ball within his reach.
- 2. Penalty

A penalty of one run for a wide shall be scored if no runs are made otherwise.

3. Ball coming to rest in front of the Striker

If a ball which the Umpire considers to have been delivered comes to rest in front of the line of the Striker's wicket, "Wide" shall not be called. The Striker has a right, without interference from the fielding side, to make one attempt to hit the ball. If the fielding side interfere, the Umpire shall replace the ball where it came to rest and shall order the Feldsmen ro resume the places they occupied in the field before the ball was delivered.

The Umpire shall call and signal 'Dead Ball' as soon as it is clear that the Striker does not intend to hit the ball, or after the Striker has made one unsuccessful attempt to hit the ball.

The Umpire shall revoke the call if the Striker hits a ball which has been called "Wide."

#### 5. Ball not Dead

The ball does not become dead on the call of "Wide Ball" - See Law 23.4: (The ball is not Dead).

#### 6. Runs resulting from a Wide

All runs which are run or result from a wide ball which is not a 'No Ball' shall be scored 'Wide Balls', or if no runs are made one shall be scored,

#### 7. Out from a Wide (H. H. O. R. S.)

The Striker shall be out from a Wide Ball if he breaks Law 35: (Hit Wicket); or Law 39: (Stumped). Either batsman may be Run Out 'Law 38): and shall be out if he breaks Law 33: (Handled the Ball), or Law 37: (Obstructing the Field).

#### 8. Batsman given out off a wide

Should a Batsman be given out off a wide, the penalty for bowling it shall stand unless runs are otherwise made.

#### LAW 26. BYE AND LEG-BYE.

#### 1. Byes

If the balls, not having been called "Wide" or "No Ball" passes the Striker without touching his bat or person, and any runs are obtained, the Umpire shall signal "Bye" and the runs shall be credited as such to the batting side.

#### 2. Leg - Byes

If the ball, not having been called "Wide" or "No Ball" is unintentionally deflected by the Striker's dress or person, except a hand holding the bat, and any runs are obtained the Umpire shall signal 'Leg Bye' and the run or runs so scored shall be credited as such to the batting side.

Such leg-byes shall only be scored if, in the opinion of the Umpire, the Striker has:

- a) attempted to play the ball with his bat, or
- b) tried to avoid being hit by the ball.
- 3. Disallowance of Leg Byes

In the case of a deflection by the Striker's person, other than in 2 (a) and (b) above, the Umpire shall call and signal "Dead Ball" as soon as one run has been completed or when it is clear that a run is not being attempted or the ball has reached the boundary.

On the call and signal of 'Dead Ball' the Batsman shall return to their original ends and no runs shall be allowed.

LAW 27. APPEALS

LAW 28. THE WICKET IS DOWN

LAW 29. BATSMAN OUT OF HIS GROUND

LAW 30. BOWLED

Out Bowled

The Striker shall be out bowled if:

- a) His wicket is bowled down, even if the ball first touches his bat or person.
- b) He breaks his wicket by hitting or kicking the ball on to it before the completion of a stroke, or as a result of attempting to guard his wicket. See Law 34.1: (Out Hit the Ball Twice).

Alteration to Law 30-Bowled

If the Striker plays the ball, then his or kicks it onto, and breaks his wicket and, in the Umpire's judgement, an attempt to protect the wicket has been made: the Striker will be given out on appeal-Boweld Stroke completion therefore will not be considered if an attempt is made to protect the wicket.

#### LAW 31. TIMED OUT

#### 1. Out Timed Out

An incoming Batsman shall be out Timed Out if he wilfully takes more than two minutes to come in — the two minutes being timed from the moment a wicket falls until the new batsman steps on to the field of play.

If this is not complied with and if the Umpire is satisfied that the delay was wilful and if an appeal is made, the new Batsman shall be given out by the Umpire at the Bowler's end.

#### 2. Time to be added

The Time taken by the Umpires to investigate the cause of the delay shall be added to the normal close of play.

#### LAW 32. CAUGHT

The Striker shall be out Caught if the Ball touches his bat or if it touches below the wrist his hand or glove, holding the bat, and is subsequently held by a Fieldsman before it touches the ground.

#### LAW 33. HANDLED THE BALL

Either batsman on appeal shall be out Handled the Ball if he wilfully touches the ball while in play with the hand not holding the bat unless he does so with the consent of the opposite side.

#### LAW 34. HIT THE BALL TWICE

#### 1. Out hit the ball twice

The Striker, on appeal, shall be out Hit the Ball Twice if, after the ball is struck or is stopped by any part of his person, he wilfully strikes it again with his bat or person except for the sole purpose of guarding his wicket: this he may do with his bat or any part of his person other than his hands, but See. Law 37.2: (Obstructing a Ball from Being Caught).

For the purpose of this Law, and holding the bat shall be regarded as part of the bat.

2. Returning the ball to a Fieldsman

The Striker, on appeal, shall be out under this Law, if, without the consent of the opposite side, he uses his bat or person to return the ball to any of the fielding side.

3. Runs from ball lawfully struck twice

No runs except those which result from an overthrow or penalty, See Law 41: (The Fieldsman), shall be scored from a ball lawfully struck twice.

#### LAW 35. HIT WICKET

The Striker shall be out Hit Wicket if, while the ball is in play:

- a) His Wicket is broken with any part of his person, dress, or equipment as a result of any action taken by him in preparing to receive or in receiving a delivery, or in setting off for his first run, immediately after playing or playing at, the ball.
- b) He hits down his wicket whilst lawfully making a second stroke for the purpose of guarding his wicket within the provisions of Law 34.1: (Out Hit the Ball Twice).



#### LAW 36. LEG BEFORE WICKET

1. OUT L. B. W.

The Striker shall be out L. B. W., in the circumstances set out below:

a) Striker attempting to play the Ball

The Striker shall be out L. B. W., if he first intercepts with any part of his person, dress or equipment a fair ball which would have hit the wicket and which has not previously touched his bat or a hand holding the bat, provided that:

- 1) The Ball pitched, in a straight line between wicket and wicket or on the off side of the Striker's wicket, or in the case of a ball intercepted full pitch would have pitched in a straight line between wicket and wicket, and
- 2) The point of impact is in a stright line between wicket and wicket, even if above the level of the bails.
- b) Striker making No attempt to play the Ball.

The Striker shall be out L. B. W., even if the ball is intercepted outside the line of the off-stump, if, in the opinion of the Umpire, he has made no genuine attempt to play the ball with his bat, but has intercepted the ball with some part of his person and if the circumstances set out in (a) above apply.

#### LAW 37. OBSTRUCTING THE FIELD

1) Wilful Obstruction

Either Batsman, on appeal, shall be out obstructing the field if he wilfully obstructs the opposite side by word or action.

2) Obstructing a Ball From Being-Caught

The Striker, on appeal, shall be out should wilful obstruction by either batsman prevent a catch being made.

This shall apply even though the Striker causes the obstruction in lawfully guarding his wicket under the provisions of law 34. See Law 34.1: (Out Hit the Ball Twice).

#### LAW 38. RUN OUT

#### 1. OUT RUN OUT

Either Batsman shall be out Run Out if in running or at any time while the ball is in play-except in the circumstances described in Law 39: (Stumped) - he is out of his ground and his wicket is put down by the opposite side If, however, a Batsman in running makes good his ground he shall not be out Run Out, if he subsequently leaves his ground, in order to avoid injury, and the wicket is put down.

#### 2. "No Ball" called

If a 'No Ball' has been called, the Striker shall not be given Run Out unless he attempts to run.

#### 3. Which Batsman is Out

If the Batsman have crossed in running, he who runs for the wicket which is put down shall be out; if they have not crossed, he who has left the wicket which is put down shall be out. If a Batsman remains in his ground or returns to his ground and the other Batsman joins him there, the latter shall be out if his wicket is put down.

#### 4. Scoring of Runs

If a Batsman is run out, only that run which is being attempted shall not be scored. If however an injured Striker himself is run out, no runs shall be scored. See Law 2.7: (Transgression of the Laws by Injured Batsman or Runner).

#### LAW 39. STUMPED

#### 1. Out Stumped

The Striker shall be out Stumped if, in receiving a ball, not being a No Ball, he is out of his ground otherwise than in attempting a run and the wicket is put down by the Wicket-Keer er without the intervention of another Fieldsman.

#### 2. Action by the Wicket-Keeper

The Wicket-Keeper may take the ball in front of the wicket in an attempt to Stump the Striker only if the ball has touched the hat or person of the Striker.

#### LAW 40. THE WICKET-KEEPER

#### 1. Position of Wicket-Keeper

The Wicket-Keeper shall remain wholly behind the wicket untill a ball delivered by the Bowler touches the bat or person of the Striker, or passes the wicket, or until the Striker attempts a run. In the event of the Wicket-Keeper contravening this Law, the Umpire at the Striker's end shall call and signal 'No Ball' at the instant of delivery or as soon as possible thereafter.

#### 2. Restriction of Actions of the Wicket-Keeper

If the Wicket-Keeper interferes with the Striker's right to play the ball and to guard his wicket, the Striker shall not be out, except under laws 33: (Handled the Ball), 34: (Hit the Ball Twice), 37: (Obstructing the Field), 38: (Run Out).

#### 3. Interference with the Wicket Keeper by the Striker

If in the legitimate defence of his wicket, the Striker interferes with the Wicket-Keeper, he shall not be out, except as provided for in Law 37.2: (Obstructing a Ball from Being Caught).

#### LAW 41. THE FIELDSMAN

#### 1. Fielding the Ball

The Fieldsman may stop the ball with any part of his person, but if he wilfully stops it otherwise, 5 runs shall be added to the run or runs already scored; if no run has been scored 5 penalty runs shall be awarded. The run is progress shall count provided that the Batsman have crossed at the instant of the act. If the ball has been struck, the penalty shall be added to the score of the striker, but otherwise to the score of Byes, Leg-Byes or Wides as the case may be.

#### 2. Limitation of On-Side Fieldsmen

The number of On-side Fieldsmen behind the popping crease at the instant of the Bowlers' delivery shall not exceed two. In the event of infringement by the fielding side the Umpire at the Striker's end shall call and signal 'No Ball' at the instant of delivery or as soon as possible thereafter.

#### 3. Position of Fieldsmen

In the event of a Fieldsman contravening this Law, the Umpire at the Bowler's end shall call and signal 'No Ball' at the instant of delivery or as soon as possible thereafter. See Law 40.1: (Position of Wicket-Keeper).

#### LAW 42. UNFAIR PLAY

1. Reponsibility of Captains

The Captains are responsible at all times for ensuring that play is conducted within the spirit of the game as well or within the Laws.

2. Responsibility of Umpires

The Umpires are the sole judges of fair and unfair play.

3. Intervention by the Umpires

The Umpires shall intervene without appeal by calling and signalling 'Dead Ball' in the case of unfair play, but should not otherwise interfere with the progress of the game except as required to do so by the Laws.



# AN UMPIRE - A MAN WITH A SENCE OF RESPONSIBILITY

MR. A. SUBRAMANIAM

(Onetime Active Umpire)

Of all the people who go to make up a game of Cricket, there is no doubt that the men who receive the greatest abuse and least praise are the TWO GENTLEMEN IN WHITE COATS.

Bad Umpiring can ruin a match for all and at Test Level, it can easily lead to International incidents. Thus it would be seen that a good Umpire is a priceless asset to the game. Unfortunately, Umpiring is not an easy job, a fact readily forgotten by those who criticize the Umpires.



The Cricket Umpire is a man with enormous responsibilities for the Laws of the Game tell us that.... "Two Umpires shall be appointed one for each end to control the game as required by the Laws with absolute impartiality".

First of all, it is important that an Umpire should have a first class eye-sight and hearing, with physical resources to cambat the long periods of standing during which, his concentration must never lapse.

Secondly, he must be a man of absolute intergrity, with judicial mind and the ability to give sound decisions under pressure. He should perform his duty with dignity.

The Umpire must have an intimate knowledge of the Laws of Cricket and the practical "Know How" to apply this knowledge on the field. The Two Umpires on the field should always work as a TEAM, with mutual confidence in each other. They have a vital part to play in the game and they deserve the respect and the encouragement of players, the officials and the spectators.

There are so many points in the rules which often cause young Cricketers to argue and the Umpire is well advised to know the rules by heart.

A Catch is deemed taken if the players hands are over the boundary provied his feet are inside the playing area, thus if a fielder catches a ball while leaning against a fence, that catch is valid.



A Wide ball is a ball out of reach of the batsman from where he normally stands at the crease. The Umpires must wait until the ball has passed the batsman before calling wide or the Umpire may have the humiliating experience of seeing the batsman chase it and hit it.

A batsman can be out from a "WIDE" ball in these ways: "Handled The Ball'; Stumped'; 'Hit Wicket'; 'Run Out'; or 'Obstructing the Field.' If a batsman is out in this respect, the penalty still counts and one run is added to the batting side total.

Most young Cricketers misunderstand the Law involving the breaking of a wicket in attempting run outs and stumpings. If one bail is off, it is sufficient to dislodge the remaining bail for a stumping or a run out. If both bails are off, a fieldsman may pull up a stump provided he has the ball in hand (or hands) so used. If both bails are off and the fieldsman pulls a stump out of the ground, that would constitute a run out should the batsman running to that end be out of his ground.

Another point which causes great debate is whether a batsman has deflected a catch from his bat or arms, to a behind the wicket fieldsman. The main issue here is that the Umpire should use his eyes as well as his ears. Remember, that the fact that a ball has struct the strikers person before or after touching his bat, does not rule out a catch. There have been instances of a ball striking a batsman's pad before he hit a catch to the fieldsman.

The most talked of rule "in the making" is the front foot 'No Ball' rule. The rule which is law says that in the delivery stride the bowler must have the front foot behind (not touching) the batting crease and the back foot within the return crease or its forward extension.

Last but not the least, the most controversial law between the Umpire and the batsman, is the 'Leg before wicket' rule. A batsman is only out under this law if all the four following questions are answerd in the affirmative.:-

- a. Would the ball have hit the wicket?
- b. did the ball pitch on a straight line between the wicket and wicket or did it pitch on the off said of the strikers wicket?
- c. Was it part of the strikers person other than the hand, which first intercepted the ball?
- d. Was that part of the strikers person in a straight line between wicket and wicket at the moment of impact irrespective of the height of the point of impact?



HISTORY OF J. C. U. A,

The formation of the Jaffna Cricket Umpires Association took place in December 1961 with vital necessity to improve the standard of Umpiring by Education, Training and Examination and with the sole motive of Service to Cricket. Now we are proud of our Record of Service with dramatic improvement in the standard of Umpiring over the last 25 years, but there is still much to be done in maintaining the highest level of field work.

### NECESSARY QUALIFICATIONS FOR AN UMPIRE

An Umpire must possess first class Eyesight; General Good Health with well developed hearing; and ability to concentrate is vital. Complete concentration leads to anticipation and gives just that much more time for correct positioning and judgement.

An Umpire must be a person of Intergrity and Character, one of responsibility and Dignity; remain calm; completely neutral and unbiased when under pressure. Absolute impartiality is of course essential with even temper which will enable the game to be controlled firmly, but with good humour. He must learn to overcome personal sensitivities and remain undistrubed and impartial, fearlessly continuing to control the game according to the Laws of Cricket. The essential, truth is that an Umpire is the only person who, alone can make or ruin a game of cricket. Yet Umpiring is far harder, even for a man who has played some cricket.

What a Critic or a Reporter or a Player forgets is that an Umpire is a Human being and are not infallible.

# WHAT ARE WE EXPECTED OF?. HOW GOOD ARE WE GOING TO BE AND WHAT CONSTITUTES A GOOD UMPIRE?

Umpires are Ordinary men, subject to Human fallibility, and consequently in the nature of things are bound to be guilty of the occasional error. Notwithstanding this it may be taken for granted that Cricket Umpires strive at all times to give their very best, for little reward under extremely difficult circumstances.

But the players, Spectators and the Press alike, all find it impossible to recognise this fact and accept the situation with good grace and understanding.

After all Cricketers are Human Beings too. At times they make batting look as impossible, hazardous and sterile understanding; Bowlers can deliver Wides, full pitches and Noballs; Fieldsmen fumble catches and allow the ball to pass between their legs when it would often have been easier to stop it!. These indifferent performances by players are accepted as part of the game.

But these same "Human" Players, Critics and the Press, will tolerate no such shortcomings on the part of the Umpires. Let any Umpire be guilty of an error of judgement either real or imajinary and the wrath of players, spectators and critics alike will desend upon the head of the poor unfortunate Umpire like a ton of bricks, let alone the mistake of the players in the field.

Let us remember that Umpires are mere Human Beings. They must therefore Umpires as best as they could and give their decisions on what they see and hear and what they believe they do. This is exemplified by the constantly told story of the Batsman who played at the fast bowler; there was a clear and distinct sound of a nick and the entire field went up in a "Shout" for a catch at the wicket. The Umpire said "NOT OUT" and at the end of the over, beckoned the wicket-keeper and pointed to a red mark near the top of the off stump. The ball had touched it without disturbing the bail. Complete concentration leads to the smallest detail of action to a prediction of what is going to happen. Each Umpire must strive to become just that little bit better.

The umpire must remember that he is a servant of the game in which he is standing and an autocrat in the matters within its jurisdiction. A batsman is out caught at the wicket not because he has or has not touched the ball with his bat or hand holding the bat, but because the Umpire has formed the opinion, that he has. The Umpires opinion is everything-the witness of others means nothing.

There are many potentially tricky incidents possible where a Captain has to be made aware of the limits of his authority. Players have to be warned of unfair practices. In some instances even the occasional "No Ball" for foot faulting is received with bad grace.

Players expect, and have a right to expect, the highest standard of Umpiring. Umpires are not infallible and occasionally make mistakes. Very seldom are mistakes made through lack of knowledge of the Laws, but rather, on the judgement of facts. The word 'UMPIRE' first used in sport as long as 1714, is a development, of the old middle English word "NUMPERE"-meaning MAN ABOVE ALL." One of the oldest and most treasured traditions of cricket is, and must always be, the immediate and unqualified acceptance of the Umpires decision.
